Cllr. P. Breen sought an explanation as to why letters with erroneous information about amenity grants were issued by Cllr. F. Ó'Súilleabháin. Cllr.'s M. Farrell, O. Walsh, and W. Kavanagh all expressed their annoyance that incorrect information circulated in Cllr. Ó'Súilleabháin's letters turned what should be a positive story about the amenity grants into a negative story. Cllr.'s Farrell and Walsh highlighted a group who were told they were receiving €14,500 when they are actually due to receive €500.

In response, Cllr. F. Ó'Súilleabháin explained that he was working off two excel spreadsheets which led to the error. Cllr. Ó'Súilleabháin advised that he believed there may have been five groups who were given incorrect information and he has contacted them to apologise, and he offered a further apology at the Council meeting.

1. Presentation - National Broadband Ireland on the rollout progress

T.J. Malone, CEO of National Broadband Ireland Deployment gave a presentation outlining NBI's network design and build process, progress made in delivering the national broadband plan, broadband services offered by NBI, County Wexford fibre to the home update, and broadband connection points and school's update. Mr. Malone and his team responded to a wide range of queries from the Elected Members. Cathaoirleach J. Fleming thanked Mr. Malone and his team for their presentation and addressing the Member's queries.

4.2 LAC2402 – This development involves the protection of approximately 300m of cliff frontage at Seaview, Co. Wexford, with integrated ramp access to the beach. This protection consists of rock armour revetment to the existing cliff face. The reinforced concrete ramp will be integrated into the rock revetment. This development also consists of a low earth mound on the cliff crest immediately behind the revetment works. A small vehicle turning area is included, adjacent to the existing access road at the top of the ramp at Seaview Beach, Seaview, Co. Wexford.
