The parking will include two disabled spaces 4no. electric charge bays, picnic tables, bike rack & repair kiosk and a zebra pedestrian crossing.</p> <p>Ballyteige Burrow Road: On the western side of the road, construction of a 2m wide concrete cycle and pedestrian roadside path, 325m long from the Pump House Cottage to the entrance of Sofrimar Plant. On the eastern side of the road, construct a 2m pedestrian footpath, 525m long from Castle View (L30561) to Ard na Ba Road (L30564).</p> <p>Recreation Trail: Construct a 3m wide cycle and pedestrian trail along the drainage channel towpath from Sofrimar to Ballyburn Crossroads. The off-road trail will be 1.78km gravel path with 23m long prefabricated footbridge at sofrimar, 4no. concrete slab farm crossing points, stockproof fencing & gates, culverts and signage.</p> <p>Ballyburn Crossroad Carpark: Construction of a 23 space carpark with access off Ballyteige Burrow Road (L3056). The parking will consist of two disabled spaces, 4no. electric charge bays, picnic tables and bike rack and repair kiosk. The proposed development impacts on a number of designated European Sites and a Natura Impact Statement (NIS) was prepared for this planning application.</p>
