1. Welcome and Introductions

Chief Executive Eddie Taaffe acted as Interim Chair and gave a welcome address offering the full support of WCC to the partnership.

This was followed by a video recording of Mr. Jim O' Callaghan T.D. Minister for Justice, Home Affairs and Migration welcoming the establishment of the partnership and thanking members.

Chief Superintendent Derek Hughes addressed the partnership offering the full support of An Garda Síochána.

2. Election of Chairperson and Vice-Chairperson

On the invitation of the Interim Chair Liam O' Donovan explained the election process. The Interim Chair confirmed only one candidate was nominated for the position of Chairperson which was Mary Farrell who was therefore deemed elected.

The Interim Chair also confirmed no nomination was received for a Vice-chairperson. Councillor Oliver Walsh proposed Councillor Ger Carthy. This was seconded by Councillor Joe Sullivan. Councillor Ger Carthy was therefore deemed elected to the position of Vice-chairperson.

Mary Farrell convened the meeting as the new Chair and thanked members for their nomination to the role. The Chair highlighted Wexford LCSP being the first partnership to be established and looked forward to working together with all members.

3. Terms of Reference and Standing Orders

On the invitation of the Chair Liam O' Donovan confirmed the ToR and Standing Orders were circulated in advance. Liam explained the draft was developed under

the guidance of the National Office for Community Safety and are standard for all partnerships.

The Chair put it to the floor for a proposer to agree and approve the ToR and Standing Orders.

Proposer Cllr. Barbara Anne Murphy. Seconded Cllr. Aoife Rose O' Brien.

ToR and Standing Orders agreed and adopted by the partnership.

Cllr. Barbara Anne Murphy asked if 10 day's notice for questions applied to all meetings. On the invitation of the Chair Liam O' Donovan confirmed 10 days notice applied to Public Meetings only.

Cllr. Ger Carthy asked if the ToR and Standing Orders could be amended by the members.

This was confirmed by the Chair.

Lisa Robson asked if the meetings are remote. This was confirmed by the Chair.

4. Local Community Safety Plan

The Chair briefly outlined the Terms of Reference to be agreed for a Steering Group on the Local Community Safety Plan and sought nominations to the group. The following members put themselves forward:
