Foreword

As Chief Executive of Wexford County Council and Chairperson of the Wexford Age Friendly Alliance and Cathaoirleach of Wexford County Council it gives us great pleasure to present the 2nd Wexford Age Friendly Strategy which builds on the success of our first strategy. In 2017, Wexford Age Friendly Alliance published their first Age Friendly Strategy for the county.

That document set out a range of ambitious recommendations and actions which when delivered would help to improve the quality of life of older people in the county.

Following on from this a range of exciting and important new initiatives were delivered in the county including the expansion of the Meals on Wheels Service countywide, establishment of the Ferns Befriending Service, community supports during the pandemic, expansion of rural transport services from TFI Local Link Wexford, IT and technology projects including the Telehealth pilot project and the rolling out of Age Friendly Libraries, the Age Friendly Business Recognition Programme, Accessibility initiatives, Sports Active Wexford programmes and a walkability audit of Enniscorthy to name but a few.

Working on this strategy has given us an opportunity to listen to older people and find out what it's like to be an older person living in County Wexford, the good things as well as the challenges and issues.

This strategy is the culmination of an extensive consultation process that brought together the older residents of Wexford and the key service providers from the statutory, voluntary, community and private sectors to identify how we can make Wexford a better place in which to live, work, enjoy life and grow older.

Figures from the Central Statistics Office (CSO) show that in 2016 almost 15% of the population of Wexford was over the age of 65 with a projection that this will grow to 22% in the South East by 2031. We must be ready to face the challenges that such an eventuality will bring to society and the services required to support this ageing population.

We want to commend all members of the Age Friendly Alliance and the Older People's Council who are our partners in the Wexford Age Friendly Programme, for embracing the collaborative approach to establishing this strategy and their commitment to ensuring that no section of the local community is left behind when it comes to the delivery of services.

We ask everyone to play their part in helping us to bring the vision and goals of the strategy to life and continue to make Wexford a great county in which to grow old.

1.1 Context

Each local Age Friendly Programme operates with the same structure which relies on an active Older People's Council, Age Friendly Alliance, Age Friendly Programme Manager and Age Friendly Housing Technical Advisor and Interdepartmental Team within the Local Authority.

The local Age Friendly Alliance is a high-level cross-sector group, chaired by the Chief Executive of the local authority (or an independent chair).

The member agencies of the local Age Friendly Alliance form a strategic partnership to develop and oversee the Age Friendly

Strategy. Members include the Local Authority, the Health Service Executive (HSE), the Education and Training Board, An Garda Síochána, the Chamber of Commerce, the Third Level education sector, other relevant stakeholders including, in some cases, the participation of an elected member representing a Strategic Policy Committee.

The Older People's Council is a representative group of older people, established by the Local Authority as part of the local Age Friendly Programme.

The Older People's Council is a two-tier structure with an elected Executive Committee and a wide membership base. Older People's Councils identify priorities areas of need, raise issues of importance and influence the decision-making process of the local Age Friendly Programme, and also participate in national level structures.

The key purpose of the Older People's Council is to provide the authentic voice of older people representing the diversity that exists among our ageing population. Older People's Council representatives are key collaborators and stakeholders who co-design the actions and objectives of the Age Friendly Strategy.

1.2 International Framework

Local Age Friendly Strategies are aligned to the eight domains of the World Health Organisation's Age Friendly Cities and Communities Framework. However, the Alliance in County Wexford include an extra domain focusing on safety and security. The nine domains are illustrated below.

This Strategy 2022-2026 follows on from the first Age Friendly Strategy in County Wexford 2017-2021 and incorporates national and international best practice and research findings. It aims to deliver a range of ambitious new initiatives that will greatly enhance the lives of people in Wexford as they grow old over the next five years.

1.3 Age Friendly Ireland

National Shared Service

Age Friendly Ireland is a shared service of local government hosted by Meath County Council. The shared services manage the national Age Friendly Programme, affiliated to the World Health Organisation's Age Friendly Cities and Communities Network. The national programme is operated through a team-based framework of 31 local Age Friendly Programmes hosted in local government.

"The national Age Friendly Ireland Programme supports cities, counties and towns across Ireland to prepare for the rapid ageing of our population by paying increased attention to the environmental, economic and social factors that influence the health and well-being of older adults.

Age-friendly programmes work to provide walkable streets, housing and transportation options, access to key services and opportunities for older people to participate in community activities. By doing so, these communities are better equipped to become great places, and where appropriate lifelong homes, for people of all ages."

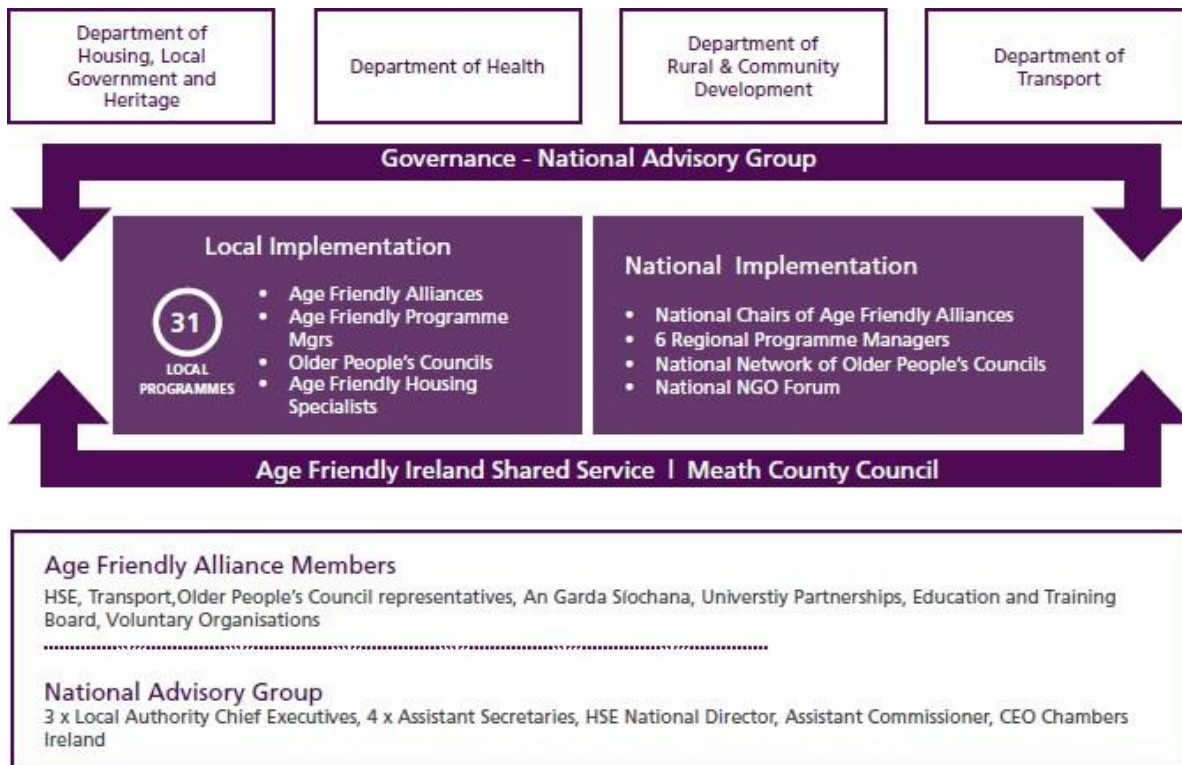

Local Age Friendly Programmes are informed by a positive ageing perspective and seeks to enhance and improve the lives of older people across the country by giving them a voice in the decision-making processes that affect their ability to live full and active lives. Initiatives focus on areas such as housing, transport, caregiving, community engagement, volunteering, social inclusion and combating isolation among older citizens.

1.4 Older People's Council

Arising from the Age Friendly Strategy 2017-2021 an Older People's Council was formed in 2017. The Older People's Council is a representative group of older people, established by the local authority as part of the local Age Friendly Programme. The Older People's Council is a two-tier structure with an elected Executive Committee and a wide membership base. Older People's Council identify priorities areas of need, raise issues of importance and influence the decision-making process of the local Age Friendly Programme, and also participate in national level structures.

The key purpose of the Older People's Council is to provide the authentic voice of older people representing the diversity that exists among our ageing population. Older People's Council representatives are key collaborators and stakeholders who co-design the actions and objectives of the Age Friendly Strategy.

This Council was instrumental in overseeing the implementation of the first Age Friendly Strategy and also guiding the research and recommendations which are detailed in this Strategy.

Members of the Older People’s Council are drawn from a cross-section of interests and geographical areas within the county as illustrated below.

1.5 Wexford Age Friendly Alliance

The Wexford Age Friendly Alliance was formed in June 2015 and it is a high-level cross-sector group, chaired by the Chief Executive of WCC. The member agencies of the Age Friendly Alliance form a strategic partnership to develop and oversee the Age Friendly Strategy.

The Alliance brings together the statutory, private, voluntary and community sectors to deliver services effectively and efficiently, so that Wexford can be a great place for all citizens to grow old.

Members include the Local Authority, Local Link Wexford, the Health Service Executive, the Education and Training Board, An Garda Síochána, the Chamber of Commerce, the third level education sector, other relevant stakeholders and Wexford County Council elected members.

The members of the Wexford Alliance are committed to providing the resources and supports to ensure this Strategy is delivered over the next five years.

Strategic Partnerships

Wexford Age Friendly Alliance is a strategic partnership for the county to create new initiatives and services as well as enhance existing services for older people in the county. The key of the Alliance is the cross-sector co-operation that finds ways to improve the lives of older people in terms of their health, housing, built environment, social and personal wellbeing. WCC is the lead agency for the Alliance.

Interdepartmental Team

There is currently no Interdepartmental Team within WCC but this is something that will be addressed in the Action Plan of this Strategy.

- ✚ Make Wexford a great county in which to grow old.
- ✚ Make Wexford a place in which older people have a say in how their county develops.
- ✚ Increase the participation of older people in the social, economic and cultural life of the county.
- ✚ Look at how Alliance partner organisations and communities can work better together to create a more age friendly environment.
- ✚ Seek solutions to concerns/issues raised by older people.
- ✚ Embed age friendly messages and practices into all partners structures and operations.
- ✚ Build general support and pride among the people of Wexford to be an age friendly place to live, through the successes and high profile nature of the project.
- ✚ Lead the way in demonstrating the processes that are required, the benefits to be gained and lessons to be learned from implementing an age friendly county initiative by sharing and disseminating information as the project develops.

1.6 Age Friendly Strategy Review: 2017-'21

In 2017, the County Wexford Age Friendly Alliance published their first Age Friendly Strategy for the county. This set out a range of ambitious recommendations to enhance the quality of life for people as they grow old in Wexford (aged 55+ years). This resulted in the delivery of a range of exciting and important new initiatives in the county which are outlined in appendix 4 and illustrated below.

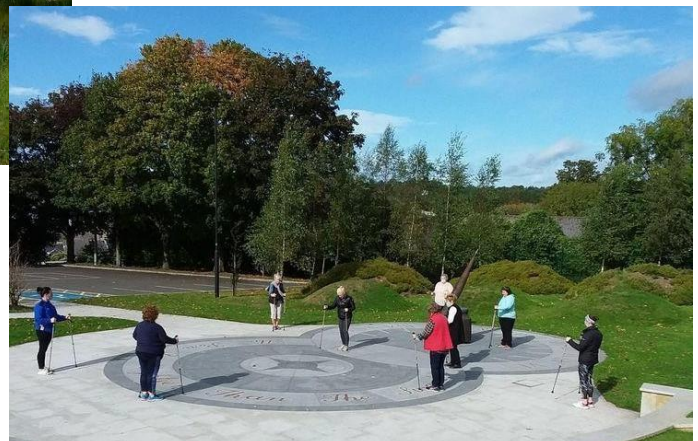
Figure 14. Age Friendly Business Training with Enniscorthy Chamber of Commerce

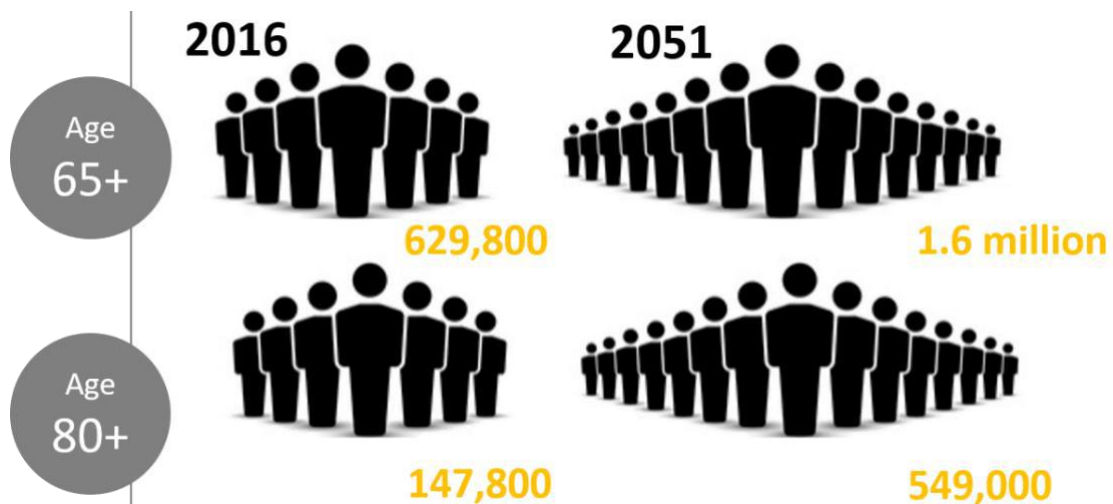


1.7 CSO Data Nationally

In Ireland, it is projected that people aged over 65 will increase significantly from the 2016 level of 629,800 persons in the state to between 1.5 million and 1.6 million by 2051 depending on different growth scenarios. This is over double the current number of people aged over 65 based on the Central Statistics Office (CSO) 2016 data.

The older population, aged 80 years of age and over, is also set to rise dramatically by 2051, increasing from 147,800 in 2016 to over 500,000. (CSO, 2021) This represents a 3-fold increase which will have a significant impact on resource allocation as these people will need greater levels of support as they grow old.

Figure 17. Population Projections – People Aged 65+



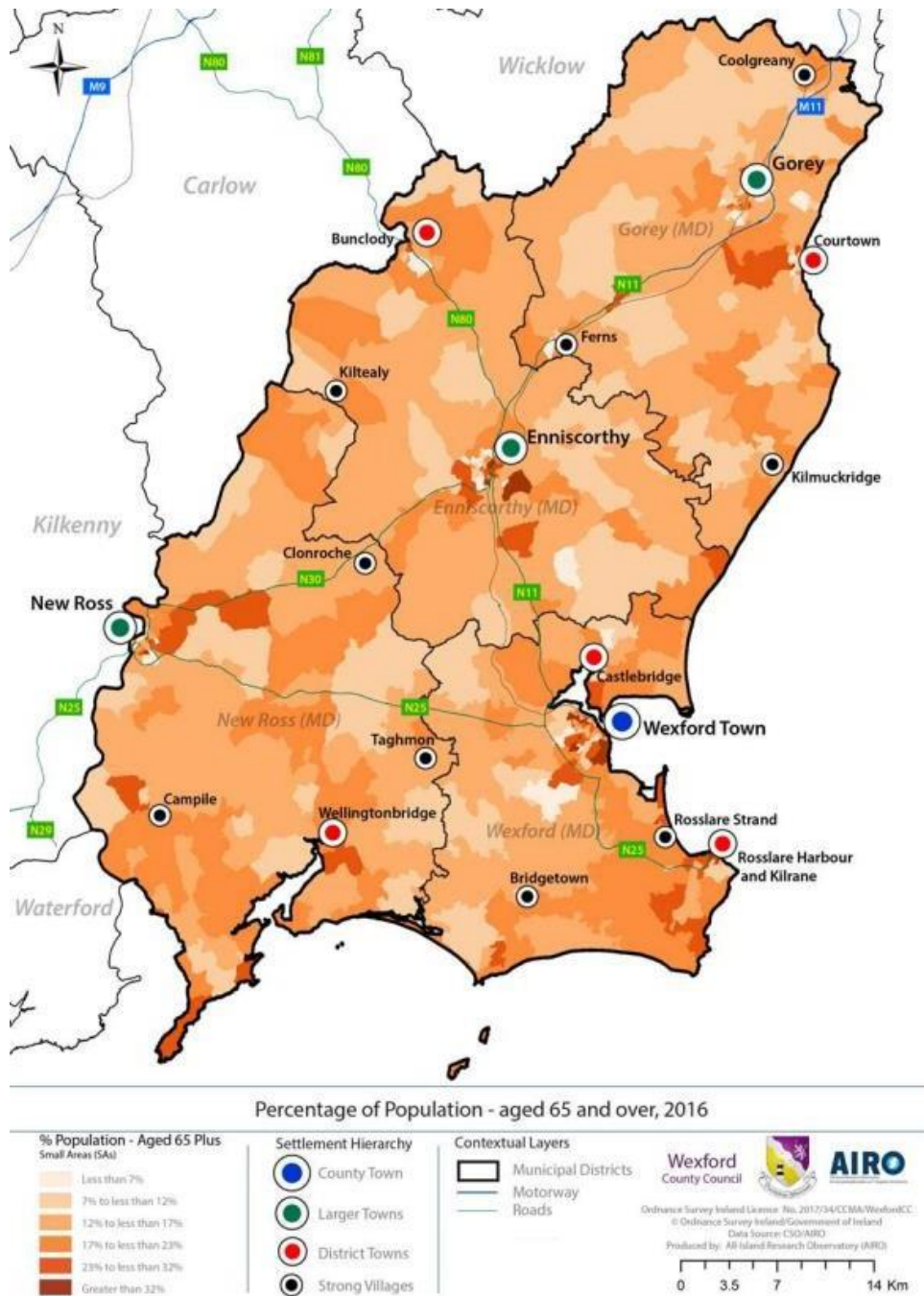

1.8 Socio-Economic Data: County Wexford

In 2016, there were 21,985 people (14.7%) aged 65+ living in the county based on CSO data, representing 14.7% of the population.

This compares to 18,367 people in 2011 or 11.6% of the total population. The map overlaid illustrates the geographical areas with the highest proportion of over 65s in 2016. The highest rates of older people live in the peripheral areas of the county or in the urban cores of the towns.

The Wexford and New Ross Municipal Districts have the highest rates of older people (this geographical area is also likely to include the Rosslare Municipal District but data for this was not available in 2016). Settlements of particular note include Wellingtonbridge, villages on the Hook Peninsula, Rosslare Harbour and Kilrane, Rosslare Strand, Campile, Courtown and Coolgreany.

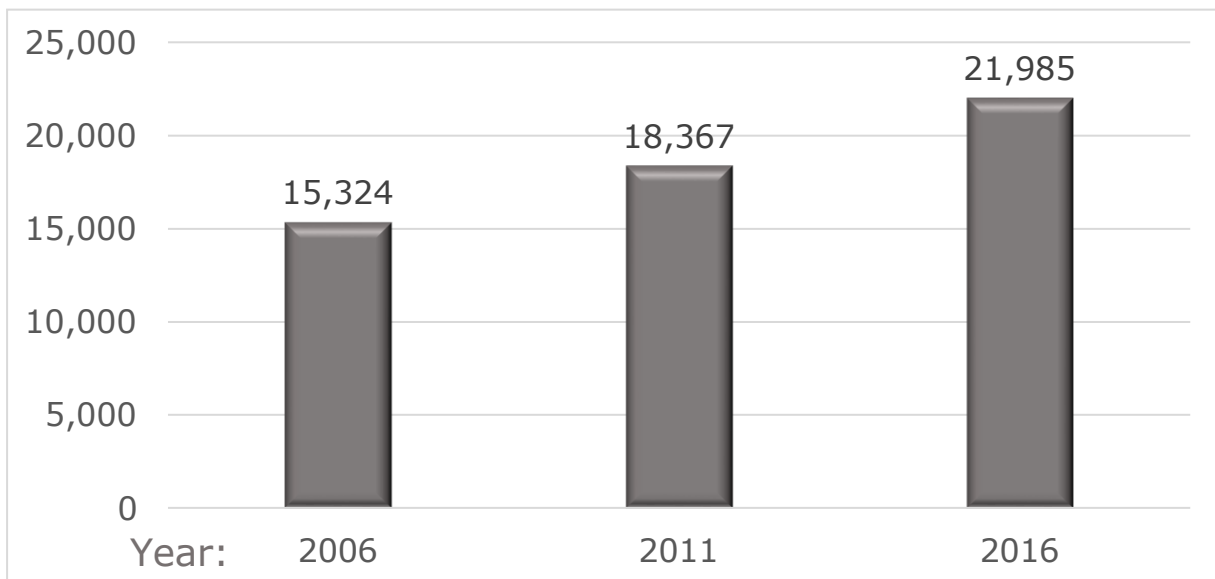
County Wexford has a higher proportion of older people at 14.7%, compared to the State average of 13.4%. (CSO,2016)

These statistics assist the Alliance members in planning for this population growth and informs policy makers on the geographical locations with the highest demand for service provision.

It can be concluded from these projections, that there will be a significant increase in demand for services for older people and so there is a real need to plan for this now. In addition, in future analysis of CSO data it is recommended that mapping of people aged 80+ is completed as this population cohort are likely to have the greatest needs.

The graphs below and overleaf illustrate how the number of people living in County Wexford, aged over 65, has increased over the last ten years.

Figure 19. County Wexford Population Trend: People aged 65+



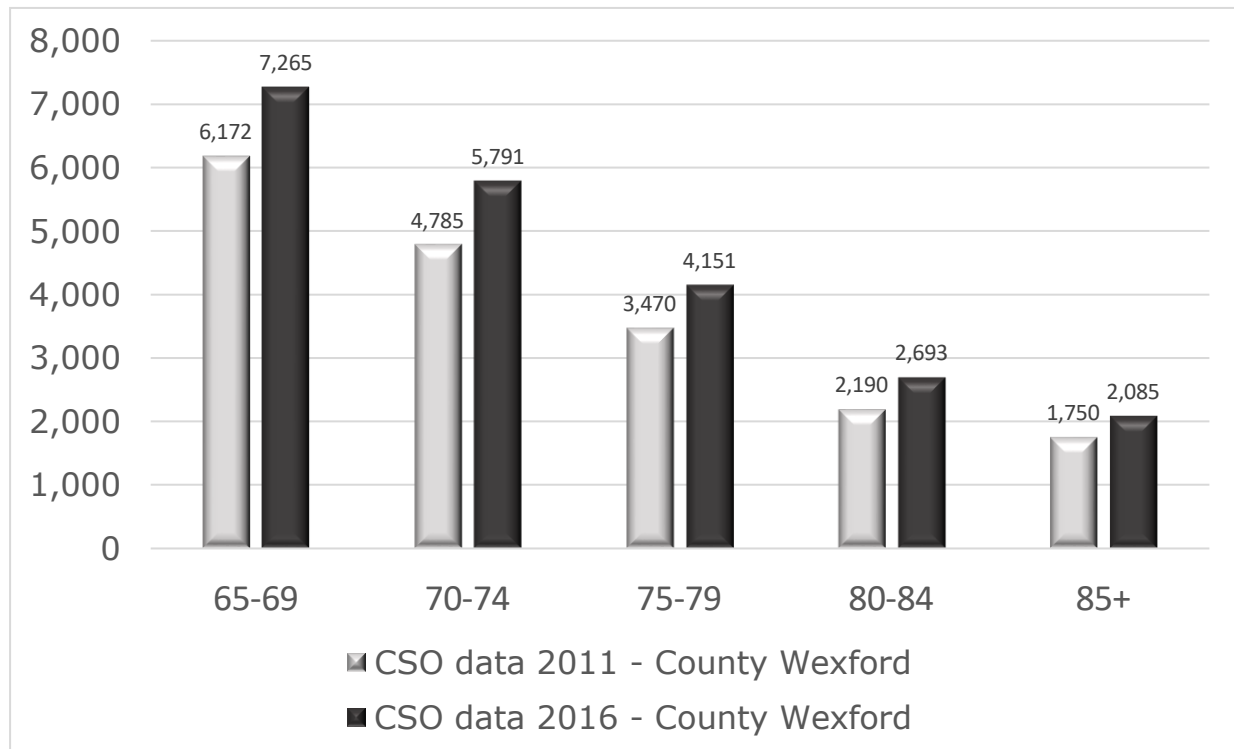

This graph demonstrates that over ten years the number of people aged over 65 has increased from 15,324 in 2006 to 21,985 in 2016.

The graph below illustrates how the number of older people has increased in every age cohort over 65 years of age over the period 2011 and 2016.

Evaluating the data more closely, it reveals that the percentage of people aged 80+ has increased from 2.7% of County Wexford’s population in 2011 to 3.2% in 2016.

Deprivation

According to the All-Island Research Observatory (AIRO) report 2018, Wexford is the 4th most disadvantaged county in Ireland, an improvement of one position (3rd most disadvantaged) in 2011. The majority of Wexford’s population live in areas classed as ‘Marginally Below Average’ (56% or 84,039 people).

HaPAI Survey

In 2015, over 500 older people in County Wexford participated in a Healthy and Positive Ageing survey. The survey findings are detailed comprehensively in the first Age Friendly Strategy for County Wexford and in summary this research found that 94% of people liked living in their neighbourhood.

Ethnicity / Cultural Background

In the 2016 Census there were 13,244 people identified as non-Irish nationals which represents 8.9% of the population. This compares to the state average of 11.4%. The largest non-Irish national groups in Wexford are UK (3%) and Polish (2.7%).

Wexford had 1,508 Travellers in 2016, representing 1% of the total population, and this compares to a State average of 0.7%. Within the county some geographical areas have much higher rates of Travellers and these include settlements such as Clonroche (20.5%), Taghmon (14.1%), Bunclody (11.1%), New Ross (3.5%) and Enniscorthy (2.5%).

Health and Disability

In 2016, there were 22,650 people who stated they had a disability in County Wexford representing 15.1% of the population. This is the second highest rate in the State.

In terms of general health, the AIRO report noted that 8.7 out of every 10 respondents in County Wexford stated that their general health was either 'Good' or 'Very Good'. This rate is the 14th highest in the State. The AIRO research also noted the correlation between failing age and health.

*An important point to note here is the projected increase in elderly population (65 plus) in Wexford and the State between now and 2031. With numbers expected to increase in the region of 56% (South East, CSO Regional Population Projections 2016-2031) there will be an increase in numbers with 'Bad' and 'Very Bad' which will result in significant pressure on health services."
(AIRO, 2018)*

Housing

In 2022, WCC Housing Department analysed their housing stock profile for older people and this is summarised below.

1.9 Summary

This section has illustrated the national framework and local support structures which collaborate to implement the Age Friendly programme in County Wexford. It also demonstrates the range of new initiatives that resulted from the first Age Friendly Strategy and this learning will be utilised to inform the strategy recommendations in this report.

Finally, the analysis of the CSO data shows that both the number and percentage of people aged over 65 in County Wexford has increased over the last ten years. This has resource implications and demonstrates the real need to further enhance facilities and services for people as they grow old.

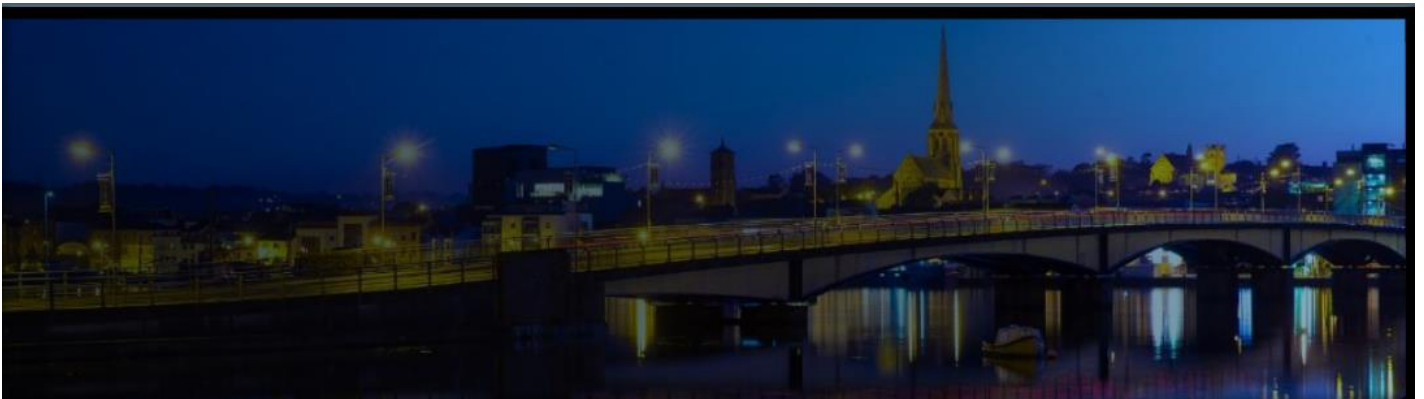

2.1 Compatibility with National / Local Plans

This section will present a brief overview of relevant national and local plans to ensure the compatibility of this Age Friendly Strategy to other policy frameworks.

2.2 International / National Policies / Plans

United Nations 2030 Sustainable Development Goals

This plan outlines 17 Sustainable Development Goals that integrate economic, social and environmental themes as illustrated below.

The implementation of many of these goals are supported through the execution of actions outlined in this Age Friendly Strategy. Goals of particular relevance include:

- ✚ Good Health and Well Being;
- ✚ Reduced Inequalities; and
- ✚ Sustainable Cities and Communities.

European Green Deal

This strategy seeks to transform the European Union into a fair and prosperous society where there are no net emissions of greenhouse gases in 2050. It aims to improve the well-being of people and protect the natural environment, which is good for people, the planet and the economy. This Age Friendly Strategy seeks to support these aims through ensuring no person and no place is left behind. It also aims to support the reduction greenhouse gases through improved housing measures and sustainable transport initiatives.

Climate Action Plan 2021

This strategy sets out Ireland's ambition to achieve a 51% reduction in emissions by 2030 and to net-zero by 2050. This will be achieved through major investments in home energy retrofits and also active travel initiatives. These recommendations are endorsed in this Age Friendly Strategy.

Programme for Government 2020: Our Shared Future

The Wexford Age Friendly Programme will support older people to live in their own home with dignity and independence, for as long as possible as outlined in the Programme for Government 2020.

TILDA

The Irish Longitudinal Study on Ageing (TILDA) is a large-scale, nationally representative, longitudinal study on ageing in Ireland, the overarching aim of which is to make Ireland the best place in the world to grow old. The results of their work will be studied and used as part of the work of the Wexford Age Friendly Programme.


Healthy Ireland (HI) Strategic Action Plan: 2021-2025


The Healthy Ireland Plan provides a roadmap to support good health, access to services, healthy environments, and the promotion of resilience. This helps to ensure that everyone can enjoy physical and mental health and wellbeing, to their full potential. The HI Plan identifies a need for a '*whole of Government*' and '*whole of society*' approach to support health and well-being.

This philosophy has been recognised in this Age Friendly Strategy which acknowledges the importance of partnership and collaboration to ensure the efficient and effective delivery of facilities and services to older people.


The HI Plan has prioritised these areas which directly complement the actions identified in this Age Friendly Strategy.

Regional Spatial and Economic Strategy (RSES) Southern Region

The Regional Spatial and Economic Strategy “Seeks to unlock the latent potential of less developed areas while increasing the competitiveness of the more developed areas. Quality of life for all and safeguarding our environment for future generations is at the heart of its ambition.” This philosophy is embraced in this Age Friendly Strategy which seeks to enhance the quality of life for people as they grow old.



Housing for All: A New Housing Plan for Ireland

This strategy aims to address Ireland’s many issues in the housing system. In particular, it aims to assist older people and people with a disability through increasing funding for Housing Adaptation Grants. This objective will be actively embraced in this Age Friendly Strategy which seeks to support people living in their own homes for as long as possible.

Our Rural Future: Rural Development Policy 2021-2025

This strategy recognises that Ireland has an ageing population and that a larger proportion of older people live in rural areas in comparison to urban conurbations and that this trend is growing. “Continuing demographic trends, with remote rural areas in particular experiencing ageing populations and high dependency ratios; this will have implications for the provision of local services for older people and succession issues for farm families.” (Our Rural Future, 2020)

Some initiatives that support this Age Friendly Strategy include:

-  Engagement of Approved Housing Bodies with responsibility for older people to develop accommodation in town centres more suited for those with reduced mobility.
-  Support the development of Smart Towns and Villages which use innovative solutions to explore how local services, such as health, education, social services, renewable energy, transport and retail, can be enhanced and sustainable through community-led actions and projects.

- ✚ Improvement and further integration of rural public transport services to enable people to continue to live in rural areas and to access work, education and social activities.

National Volunteering Strategy 2021-2025

The purpose of the Volunteering Strategy is to recognise, support and promote the unique value and contribution of volunteers to Irish society. It sets out five objectives and of particular relevance to this Age Friendly Strategy is its objective to *“Facilitate, develop and support the Volunteering Environment so that it contributes to vibrant and sustainable communities.”*

This Age Friendly Strategy recognises the huge, positive contribution volunteers can make to society. As a result, a range of exciting new initiatives have been identified in the Action Plan in this Strategy based around volunteering.

Project Ireland 2040 Southern Region

This is the Government’s overarching policy initiative to make Ireland a better country for all and to build a more resilient and sustainable future. The Project Ireland Strategic Goal to *“strengthen rural economics and communities”* is supported by the actions identified in this Age Friendly Action Plan.

2.3 Local Policies / Plans

Local Economic and Community Plan (LECP) 2016-2022

There are six high level goals (HLG) and this report complements the HLG2. *“Support and promote the development of socially inclusive, sustainable communities in County Wexford and ensure that all citizens enjoy optimal health and well-being.”* Under this LECP goal there is a priority to support the implementation of the Wexford Age Friendly Strategy.

County Development Plan (CDP) 2021-2027 (Draft)

There are 15 chapters in the CDP and the *‘Sustainable Communities and Social Infrastructure Strategy’* sets out the goal and strategic aims to enhance the quality of life of all residents in the county. *“It is the goal of the Council to ensure that County Wexford has a strong network of socially inclusive sustainable communities, where all residents and visitors enjoy equal opportunities to participate fully in the economic, social and cultural life of the county.”* This Age Friendly Strategy seeks to specially address the needs of older people to ensure they can meet this goal in the CDP.

Let's Talk about Disability in County Wexford (PPN)

County Wexford has over 15% of the population (22,650 people: CSO, 2016) with a disability which is one of the highest percentages in Ireland. The Disability Report recommends seven actions and the findings in this Age Friendly Strategy supports the implementation of these actions, in particular Action 4: *"Incorporate accessibility in the key areas of environment, housing, transport, independent living and employment."*

2.3 Age Friendly Publications

A comprehensive suite of publications are available on the Age Friendly website (<https://agefriendlyireland.ie/>). Some examples include: Age Friendly Towns Toolkit; Public Realm Guidelines; Rightsizing Guide; Age Friendly Planning Guidelines; Age Friendly Seating Template; Age Friendly Home Rating Tool; Universal Design Features; Towards an Age Friendly Hospital; and Older People Council's Guide.

2.4 Summary

These international, national and local strategic plans provide a broad policy framework for this Age Friendly Strategy. The goals highlighted in these plans, in conjunction with the consultation process, determine the actions identified in this Age Friendly Strategy.

3.1 Vision


To make County Wexford a great place in which to grow old.


3.2 Core Values


The values underpinning the work of the Age Friendly Programme in County Wexford are guided by the national programme values outlined below.

 **"Commitment to Action** *Active, engaged, practical, pragmatic implementation of local Age Friendly Ireland Strategies which are firmly based on the expressed views and priorities of older people and which enhance their quality of life and participation in Irish life.*

 **Future Proofing our Infrastructure and Key Services** *Age Friendly Ireland programmes make economic as well as social sense and foster the creation of more liveable, sustainable, resource effective and enabling environments. By future-proofing our county, towns and villages we will help to ensure that our policies, strategies, infrastructure and key services do not become outdated or outmoded in the near future and that they are friendly and accessible on many different levels, to all ages and groups, whether in an urban or rural setting.*

 **Collaboration** *Fulfilment of the Age Friendly vision through combining a bottom-up participatory approach at local and community level with top-down political and agency-led commitment and resources.*

 **Inclusion** *Informed by the views and opinions of the diversity of older people and enabling the direct and active involvement of older people in local-level decision-making in a solution focussed way thus ensuring that the complex challenges older people face as they age, at varying degrees of ability, is reflected in what we prioritise and deliver on.*

 **Innovation** *Commitment to employing new thinking, methods and approaches in response to the challenges and opportunities identified by older people."*

4.1 Public Consultation Process

An in-depth and comprehensive public consultation process was undertaken between May and October 2021. This was to ensure that older people had a real say in what happens to their lives and what happens in the areas in which they live. This consultation process was undertaken during the Covid-19 pandemic and varying restrictions were in place over this six-month period, which determined how we could engage with older people.

This section will summarise the key findings that were shared by older people and which form the basis for our recommendations in this strategy.

4.2 Workshops

WCC collaborated with the Older People’s Council, TFI Local Link Wexford and the Rural Development Consultant to organise 28 online workshops during May 2021. This involved participants from a cross-section of villages and towns in the county and the full schedule is listed in appendix 1. The summary of the key findings are presented overleaf.

What's Good?

- Fantastic community spirit and friendly people
- Slower pace of life than living in the city
- Weather – Sunny South East
- Nice parks, walking trails and tracks, beaches
- Well serviced towns and some villages
- Transport accessibility to major cities good – excellent road network
- Major routes well serviced by public transport
- Variety of sporting, cultural and heritage events
- Valued supports from agencies / community during Covid pandemic (GAA, Macra na feirme, WCC, Gardaí, Neighbours, Community – befriending/ meals on wheels)

What's Challenging?

- How to reach the people in need?
- Isolation and loneliness
- How to support people after Covid-19 and how to get communities to socialise post-pandemic?
- Poor broadband in certain areas (geographical variations)
- Difficulty in getting to hospital appointments in Dublin / Waterford
- Access to GP services can be limited due to a lack of rural GPs
- Difficulty accessing services online for some people e.g. banking
- All services delivered more and more by machines – there is a real need for personnel interaction
- People not aware of services and how do you publicise them effectively?
- Lack of public toilets
- Dog fouling on footpaths in the towns
- Pedestrian / cycling on roads can be dangerous
- Parking in rural coastal villages during summer too busy
- Parking in towns can be difficult
- New Ross and Enniscorthy Town can be challenging with steep hills
- Closure of shops, post office and banks in some villages a real challenge – loss of community interaction

Outdoor Spaces

Key features valued by older people

- Bus shelters
- More frequent bus stops
- Public toilets
- Smooth and well-maintained footpaths
- Wide footpaths – not cars parked on them
- Appropriate time for pedestrians at traffic light crossing
- CCTV – in towns
- Public seating
- Car parking close to town centre
- Slipways at beaches too steep and slippery – need railings
- Outdoor recreation, parks, beaches, forests, walking trails, beach boardwalk for wheelchair users
- Parks with covered areas (band stands / canopies) and agility equipment
- Heart of the village: Shop, Post Office, Pub, Bank – fear of them being closed in recent years

Potential Solutions:

- Walkability audits with Age Friendly Programme Manager, Accessibility Officer and local people. (Towns and Wexford General Hospital)
- Additional infrastructure noted above to be installed where possible
- Better promotion of facilities: e.g: Beach wheelchair, CCTV, walking tracks & trails, public toilets etc.

Transport

Key difference in experience between those who do and don't drive.

There are large geographical variations in service provision. However, there is a great appreciation of the TFI Local Link Wexford Service and the frequent Bus Services on major routes. Older people highlighted the comfort of travelling by train with access to toilet facilities which is very welcomed, although they would like more services.

Potential Solutions:

Public Transport

- Better rail services / up-grade physical appearance of some stations / open old stations (e.g. Ferns, Camolin)
- More bus shelters & stops where they are needed. Need the right times
- Local community to promote public transport and demonstrate need

Road Infrastructure

- Dangerous roads for pedestrians / cyclists – particularly difficult in Rosslare Harbour village
- Need for pedestrian crossings and ramps to slow the traffic
- Need for more footpaths and cycleways
- Concerns over the new motorway routes in communities potentially affected
- Insufficient parking for older people with accessibility issues in towns, beaches or at hospital

Housing

Most respondents comfortable in their own homes but they were aware of some older people needing additional supports.

Potential Solutions:

- Interest in sheltered housing – Community / Volunteer led – right location is key e.g. Rathangan or Kilanerin
- Down-sizing relevant – many older people in homes which are too large for them
- Need to secure planning permission for younger people so they can live near to older people – keep rural villages alive and create / maintain extended family structures
- Cash flow issues with claiming housing adaptation grants – make the grant process easy, faster, better and approachable. Can credit unions be part of the solution? More help and publicity required for the grants – too daunting
- Advertise housing supports through facilities such as meals on wheels, GPs, daycare centres etc.
- Climate change and energy efficiency will become increasingly important – many living in older properties and have difficulty heating their homes
- Leniency for septic tank issues
- Need more publicity and information on security alarms
- Home / garden maintenance can be an issue

Social Participation

The range of social activities varies widely between different villages and towns.

Potential Solutions:

- Mapping of communities – funding / facilities / services
- Training up local Leaders in areas where social activities are missing

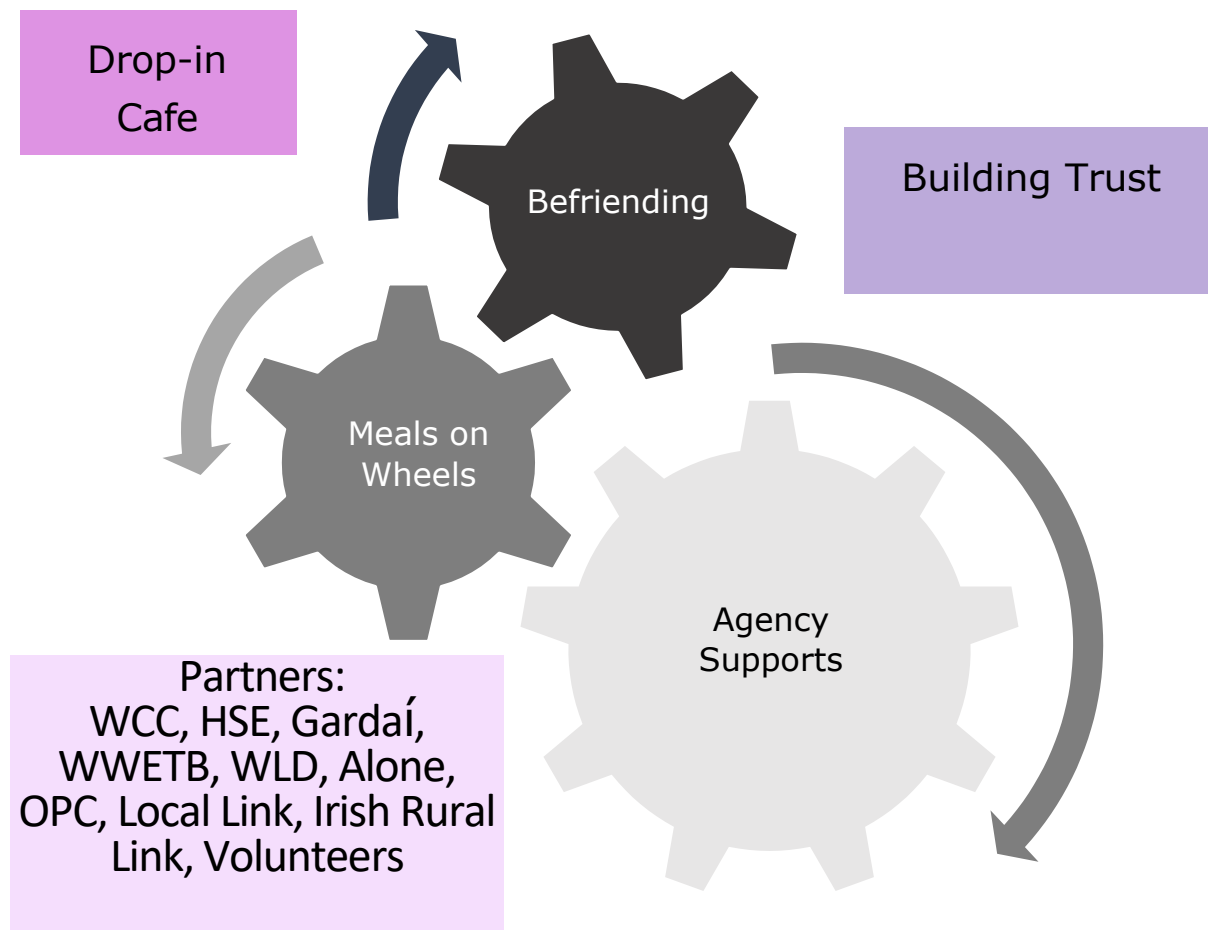
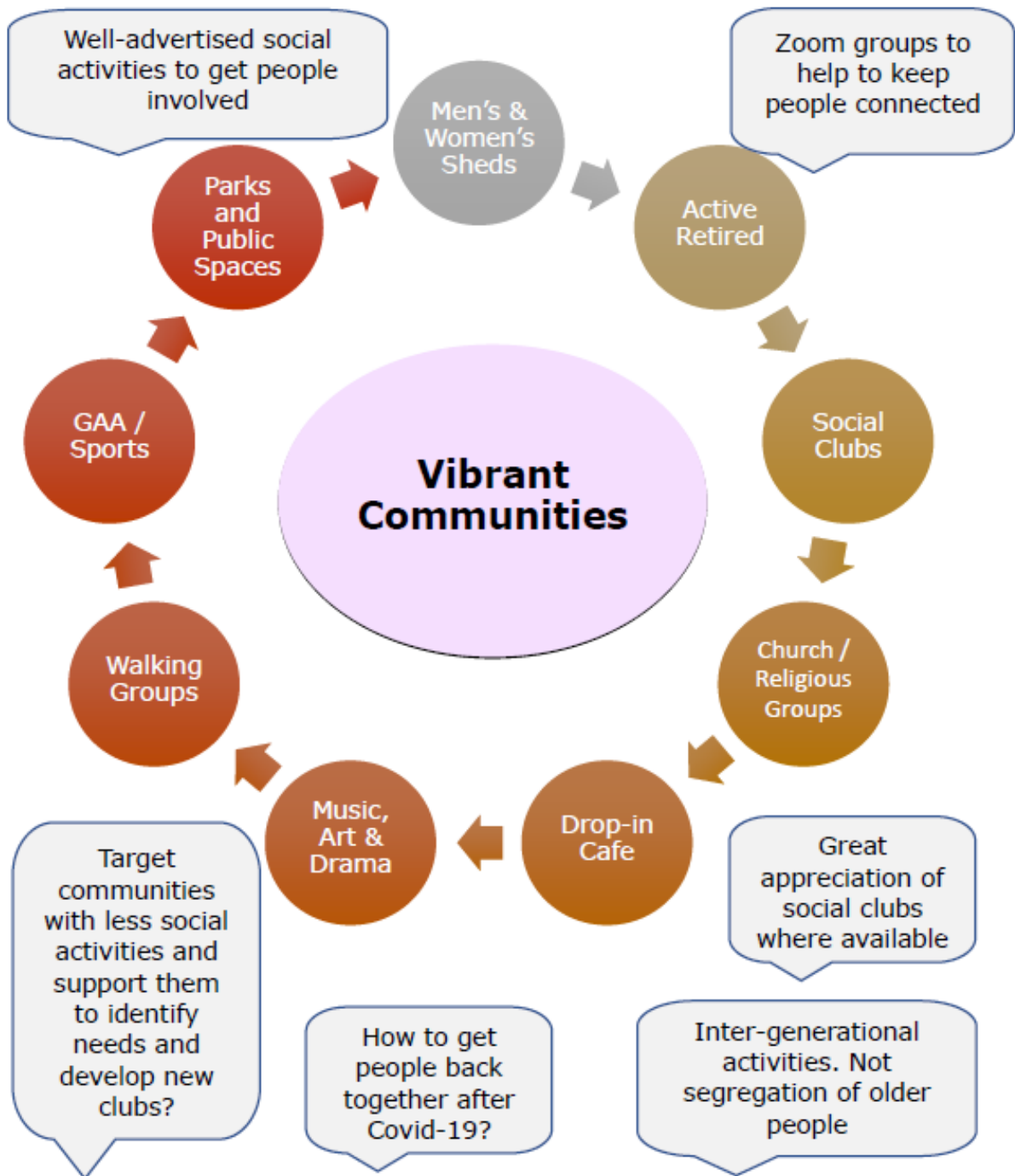

Respect and Social Inclusion

Older people really value integrating with all age-groups within their community.

Issues

- Concern that many older people are feeling isolated and lonely which has been exasperated by the Covid-19 pandemic. (Observation: Not likely to have reached that target group through the workshops so specific focus groups were arranged to capture the views of vulnerable older people).
- People missing visitors calling to their homes.
- Older people's isolation amplified by more services moving on-line and the closure of shops / post offices within their village.
- Levels of isolation vary according to people's home situation (living alone or with partner).
- Communities have very different levels of social activities and local services.

Potential Solutions:

- Great interest in inter-generational activities – linked to National and Secondary schools / youth clubs etc. Exchange of skills – IT / crafts / folklore / music.
- Dynamic community networks greatly help people to feel included in society and also supports the informal sharing of information and advice. Need for drop-in social club / café located within the community.
- Under-utilisation of community buildings and this presents an opportunity for older people to use this facility – particularly during the day-time.
- Importance of providing comfortable and attractive outdoor spaces where people can socialise.
- Expand key services to reduce isolation: Be-friending, Meals on Wheels, Daycare Centres, TFI Local Link Wexford, increasing accessibility to the Gardaí.

Civic Participation & Employment

Many older people are highly skilled and interested in sharing their knowledge with the wider community.

- Significant interest in participating in training courses, particularly IT.
- Valued this consultation process and keen to be continued.

Successful communities have local leaders!

Communication & Information

Ensuring everyone is informed about the wide range of services in the county is essential.

Older people greatly value local shops, post office, bank, community centre, GP Surgery.

When they are lost it creates a breakdown in communication and the informal sharing of information.

Potential Solutions:

- IT training – smart phones, ipads, tablets, Personal Computers – linked to schools (Transition Year), GAA or peer to peer learning in person / 1 to 1 with trainer at Day Care Centre (go to where the older people are rather than making them travel)
- WCC – Age Friendly Website Page; Older Person’s Directory; Newsletters – Volunteer led
- Irish Rural Link training courses in community facilities
- Inter-generational activities linked to National Schools – sharing of skills
- Get GP surgeries / pharmacies / daycare centres to promote other services e.g. meals on wheels, TFI Local Link Wexford etc.
- Engage at a national level to address difficulties in accessing banking facilities, broadband, telephone services, GPs
- Older people value their Post Offices and there is a real need to keep them open in rural areas – explore opportunities for them to provide a greater range of services
- Publicise the digital ambassadors scheme in the libraries to assist older people access services
- Community / Church notice board, local leaflets to publicise community facilities

Community
Champions

Community Support & Health Services

Access to health care can be an issue for older people.

Issues

- Some doctors not taking on new patients
- Difficulty getting appointments with the GP
- Closure of rural GPs and then have to travel further to access a doctor
- Difficulty of accessing medical appointments in Dublin or Waterford Hospitals if you don't have access to a car
- Two tier medical system with public patients experiencing long waiting lists
- Variability in health service provision and limited integration between different services
- Little interest in telecare or on-line medical appointments
- Older people nervous to socialise even after they have been fully vaccinated

Potential Solutions:

- Operate outreach health facilities to rural areas e.g. physiotherapy, chiropody etc.
- A change of names on prescriptions can be confusing for older people, may use a generic name instead of a brand name that people are use too – ideally include both drug names
- Greater access to the public health nurse or operate community based health centres
- Public awareness campaign related to the vaccines and Covid-19 to reassure people
- Improve parking at hospitals to facilitate people with accessibility issues

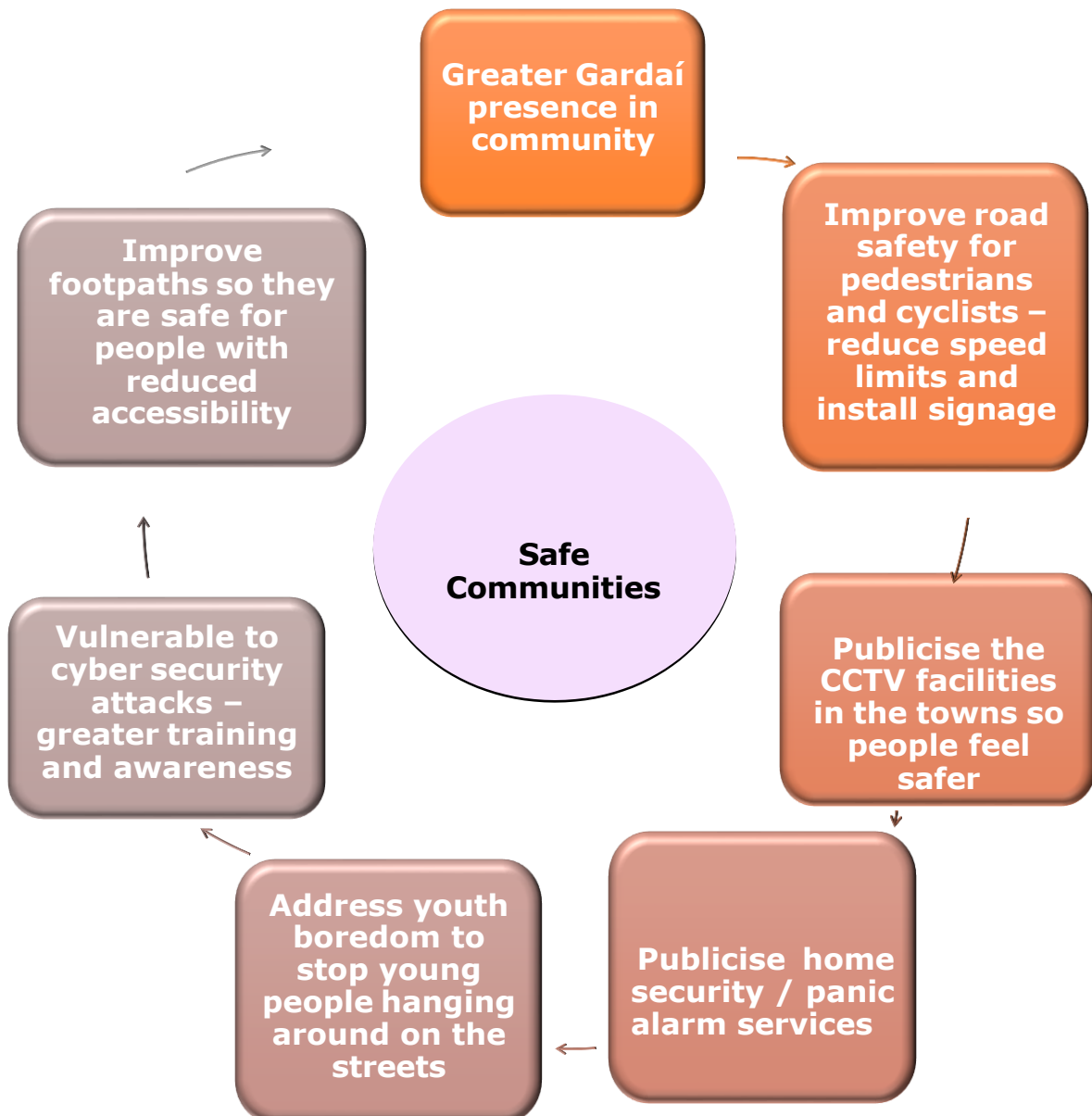
Safety & Security

Most people felt safe in their homes and in the community and older people really value the Gardaí services.

4.3 Surveys

A survey with 24 questions covering the nine Age Friendly themes was circulated to older people in County Wexford between June and September 2021. A copy of the survey is in Appendix 5 and the corresponding results are shown in Appendix 6. 582 surveys were completed and the results will form the basis for our recommendations in this strategy and the corresponding action plan for 2022 to 2026.

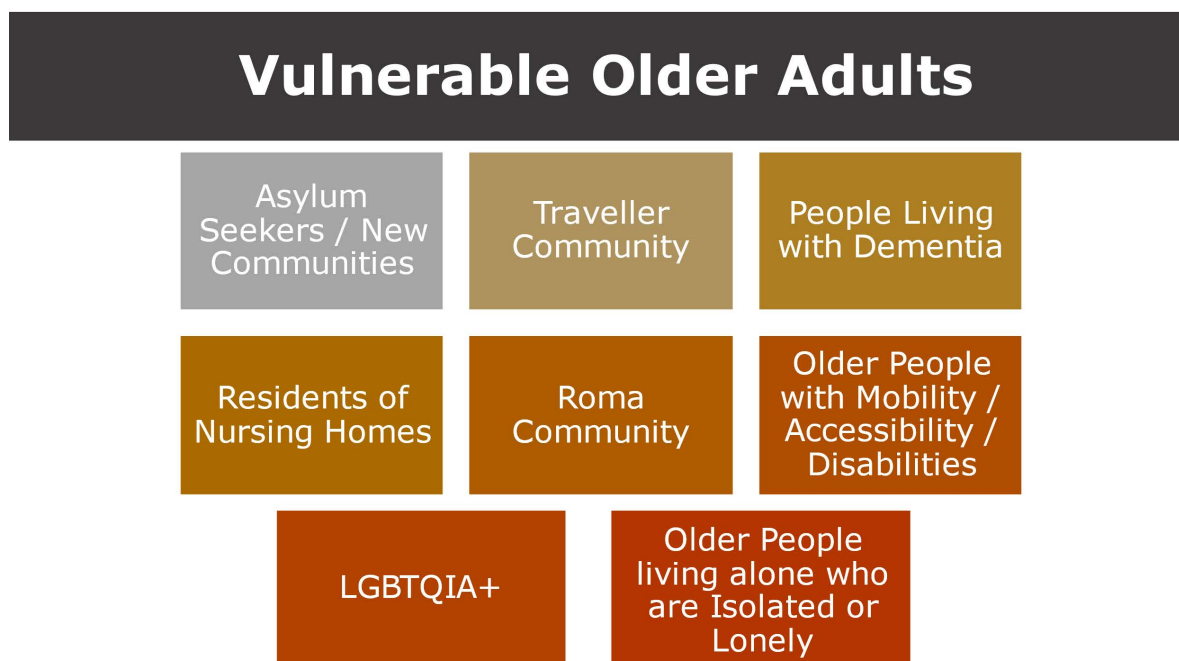
Figure 34. Public consultation with farming community at IFA event



4.4 Focus Groups

What Opportunities?

The Call Centre operated by WCC during Covid worked well and if that could continue it would be very helpful. Alternatively, use another organisation to operate a one stop shop where people can be referred or signposted to what or who they need.

Establish a network of Local Leaders & Champions.

Support the transition towards integrated care packages.

Expand collaborative links between voluntary organisations and state agencies to get information and supports out to older people.
Collate a directory of services (not just age-related).

Use the media to promote positive attitudes towards ageing and encourage older people to get out of the house (post Covid pandemic).

Establish community cafés where people can meet and chat, many older people don't want to do courses, go to pubs, join groups they just want to hang out.

Establish Age Friendly Parking spaces in towns or establish one free parking day a week.

Older people would like an expansion of the TFI Local Link Wexford budget for route expansion.

Support for elderly in banking – make banking easier for older people e.g. in person supports one day a week.

Support the social prescriptions initiative to combat mental health issues and isolation / loneliness.

Deliver more mobile services e.g. post office or other services to rural areas.

Focus group sessions were held with individual vulnerable target groups to identify their specific needs and these are detailed below.

Asylum Seekers / New Communities

Context:

There is one Direct Provision Centre in County Wexford with 114 residents currently from 29 nationalities. 87% have good spoken English and literacy classes are on-going. Asylum Seekers have a weekly allowance of €38.80. There are clusters of asylum seekers living in Rosslare Harbour; Bridgetown; New Ross and Gorey. The opportunity to restore Yola Farm in Tagoat as an initiative involving people from the Direct Provision Centre is currently being explored.

Challenges:

- ✚ Access to GPs and dentists difficult
- ✚ Transport is costly
- ✚ Access to clothing / footwear difficult
- ✚ Language barriers and different cultural backgrounds make integration difficult
- ✚ Older people can be left behind
- ✚ Length of time to get a work permit too long
- ✚ Difficulty of securing accommodation and assimilating into the local community once asylum seekers leave the Direct Provision Centre
- ✚ People living in the Direct Provision Centre are often suffering from trauma and can have mental health difficulties

Opportunities:

- ✚ Forge links with the Volunteer Centre and local groups, Active Retired, Men's Shed, Befriending, Sporting Organisations, Schools etc. to assist with integration into the community. Create a volunteer buddy system and family pen-pals.
- ✚ Foster collaboration with TFI Local Link Wexford to assist with transport issues.
- ✚ Identify volunteers with language skills. Explore the scope to have hospital liaison interpreters (e.g. Urdu).
- ✚ Organise interactive events and activities with asylum seekers and local residents e.g. cooking, crafts, sewing, woodwork etc.
- ✚ Create links with the Arts Department and Sports Active Wexford to develop projects.
- ✚ Amend the WCC Housing Form to include Direct Provision.

Dementia Working Group: Health Provision

Context:

A dementia group has been established in County Wexford to co-ordinate and integrate care supports for people with dementia. The ARC Team undertake a full assessment of older people to prevent unnecessary hospitalisations / residential care. Dementia can affect all age groups but if you are under 65 there is no support within the HSE.

Challenges:

- ✚ Address the fear and stigma of a dementia diagnosis
- ✚ There is insufficient information about dementia and promoting brain health amongst the public
- ✚ Career fatigue and career burden is a big issue
- ✚ People with dementia can have transport difficulties getting to appointments
- ✚ Access to facilities can be limited
- ✚ Funding for all
- ✚ Inter-departmental communication needs to be improved as staff are not aware of available services and duplication can occur
- ✚ A lack of referrals to the Memory Technological Unit in County Wexford due to insufficient awareness of the initiative
- ✚ There is technology that can assist people with dementia but it can be expensive to purchase and a hire service is logistically difficult
- ✚ There are trained people in dementia care but there is no database. There is also no record for tracking the number of people with dementia
- ✚ More signpost information for Gardaí who get call outs to people with dementia
- ✚ County Wexford has a disproportionately high number of people moving into the county to retire who don't have family members near by
- ✚ People with dementia are at risk of financial fraud

Opportunities:

- ✚ Information sharing on dementia and brain health in 'Town Hall' events, libraries or community centres to promote positive ageing.
- ✚ Share information on dementia and brain health through church newsletters, radio, local newspapers etc.
- ✚ Ensure there is an integrated care pathway and information sharing amongst care providers and statutory agencies.

- ✚ Expand funding and staffing supports for dementia patients.
- ✚ Expand the Community Call / WCC Helpline as it is very useful for frontline services and vulnerable people.
- ✚ Link the Memory Technological Unit (MTU) with the Volunteer Centre to assist patients accessing this service.
- ✚ Offer MTU clinics at outreach centres in the county.
- ✚ Explore links with the library to identify if equipment / technology hire can be facilitated through the library service.
- ✚ Map service provision and identify what is available.
- ✚ Establish a database of trained dementia champions.
- ✚ Train Befriending volunteers in dementia supports.
- ✚ Investigate if collaboration with Higher Education Institutions can be forged to better understand dementia.
- ✚ Establish and encourage GPs to recommend social prescriptions.
- ✚ Develop more day services and health clubs.
- ✚ Support adaptive housing and assisted living initiatives.
- ✚ Put in place a process for HSE and/or WCC for dealing with dementia related or neglect concerns raised by Gardaí or others in the community.

Traveller Community

Context:

Older Travellers have very strong extended family ties, good neighbours and are well respected. They like shopping locally, value the friendly community and enjoy visiting holy wells, graveyards, beaches, playgrounds and parks. Opportunities for younger family members are not good, particularly in relation to accessing employment and the transition from Primary School to Secondary School which can present challenges. However, younger people often live close to their extended family so they can greatly assist the older generation. There is a strong reliance on younger family members who assist with online services or the completion of forms etc. The Traveller Health Workers are very helpful for the Traveller community. Older Travellers prefer face to face or telephone communication. The life expectancy of Travellers is considerably lower than the average in Ireland.

Challenges:

- ✚ Literacy issues
- ✚ Typically don't use online facilities and services
- ✚ Difficulty with banking and many older people don't have a bank card or account

- ✚ The rapid transition to online services during the Covid-19 pandemic created considerable difficulties for older Travellers
- ✚ Poor quality housing and grounds on halting sites
- ✚ Housing maintenance can be delayed and there is a greater requirement to complete more works yourself. The WCC housing booklet cannot be read by some older Travellers
- ✚ Rubbish issues
- ✚ A lack of respect from some tradesmen
- ✚ Cars speeding
- ✚ Accessibility issues in the town for older people
- ✚ Isolation and loneliness, particularly during the pandemic
- ✚ Difficulty to find employment if identified as a Traveller

Opportunities:

- ✚ Offer literacy courses for older adults.
- ✚ Provide supports to the Traveller community to assist with form filling and online services.
- ✚ Information events to discuss the housing maintenance booklet and how to liaise with WCC on housing repairs. Ideally appoint a WCC Traveller Housing Liaison Officer.
- ✚ Assessment of halting sites and establish resident's associations to co-ordinate improvements.
- ✚ Explore opportunities to assist with housing repairs through schemes such as the 'Little Jobs' initiative.
- ✚ Bring a Traveller group on the WCC walkability audits.
- ✚ Foster closer links between the Traveller community and TFI Local Link Wexford; Men's Shed; Sports Active Wexford etc.
- ✚ Establish arts, physical activity and cultural initiatives with the Traveller community in areas such as story-telling, sewing, flower arranging, sports / games, bingo, allotments etc.
- ✚ Explore initiatives to record the Traveller language so it's not lost, for example Gammon or Cant.

Mobility / Accessibility

Context:

There are three types of disability: congenital; acquired; and infirm associated with ageing. Older people can have a combination of these types of disabilities.

There was 22,650 people with a disability in County Wexford in 2016

(15.1%) of the total population – the second highest in the state and much higher than the national average of 13.5%.

Challenges:

- ✚ How to ensure that those with disabilities are given the opportunity to Participate, Engage and get Involved in decision-making processes?
- ✚ How to ensure that those with a disability are not adversely disadvantaged in society?

Opportunities:

- ✚ Explore the opportunity to nominate a person with a disability onto the Older People's Council.
- ✚ Promote best practice case studies or exemplar's on accessibility.
- ✚ Compile a leaflet on accessible walking trails with tarmac in the county that includes accessible parking, toilets and refreshments.

LGBTQIA+

Context:

Throughout the pandemic older people faced many difficulties, whether shielding at home or unable to see family while in care homes. Such a sense of isolation and loneliness has been exacerbated for all those in the LGBTQIA++ community and even more so for the older members of this community.

There are also different dynamics and experiences at play within the LGBTQIA++ community based on age and grouping. For example, lesbian women are often not as isolated. The language and terminology can be difficult and it is important to get it right.

Challenges:

- ✚ The LGBTQIA+ community are more likely to experience mental health difficulties.
- ✚ The LGBTQIA+ community can feel uncomfortable in some situations for example team sports, community groups etc.
- ✚ Often less support from family and friends.
- ✚ Older members of the LGBTQIA+ community feel there is a lack of trust and understanding?

Opportunities:

- ✚ Explore the opportunity to nominate a 'Diversity Position' on the Older People's Council
- ✚ Annual awareness training to give people a better understanding of this community and their needs. This could be linked to Pride
- ✚ Host a LGBTQIA++ community exhibition as part of a positive ageing event. This could then be rotated around the libraries and other public events. It could also be filmed as a webinar.
- ✚ Form a new walking / hiking club for all ages of this community. Launch this at an event with high profile sports people.

Older People in Nursing Homes

Context:

In County Wexford there is good capacity in nursing homes and there is a mix of public and private nursing homes. Approximately 5% of older people need a nursing home. The Covid-19 pandemic had a major impact on residents of nursing homes as the links to the wider community were largely severed. However, new supports were created with the library and South East Radio (free bingo cards) that were very welcomed.

Challenges:

- ✚ Ensure planning for new nursing homes are in areas of real need and there is a connectivity with the local community. The location of a nursing home is very important. Ensuring compliance with building regulations can result in delays and additional expense.
- ✚ During the Covid-19 pandemic the challenge has been how to stay part of the community
- ✚ When day trips are allowed there is a need to have parking close to amenities and public toilets which are wheelchair accessible. Footpaths also need to be tarmacked
- ✚ Some regular visitors to nursing homes cannot drive so connectivity to public transport links is essential
- ✚ Some residents could have avoided needing nursing home care if they had received better supports when they had lived in their own home
- ✚ Shortage of accessible taxis in County Wexford
- ✚ There are a good range of tablets and technology to support zoom calls to family / friends which works very well but broadband can be an issue

Opportunities:

- ✚ Ensure there is accessible parking in towns, with public toilets and good quality footpaths and benches
- ✚ Support initiatives that foster links between the nursing homes and their community e.g. arts, religious services, music, etc
- ✚ Forge links with the Volunteer Centre so that volunteers can come into the nursing homes to chat to residents on a one-to-one basis. Activities include painting nails, reading the newspaper, playing music, singing, feeding the birds, setting up zoom calls etc
- ✚ Support initiatives with secondary school transition years
- ✚ Continue the library book service for residents which was established during the Covid-19 pandemic which worked really well
- ✚ Explore if a parking disc for the nursing homes could be given to facilitate parking for medical appointments
- ✚ Forge closer collaboration with TFI Local Link Wexford to support visitors using public transport to see residents in nursing homes – more information on timetables etc.
- ✚ Explore opportunities to develop daycare and sheltered housing on nursing home sites.
- ✚ Investigate the possibility of those residents able to attend daycare centres doing so, allowing them to see their friends.

4.5 Summary

The findings from this extensive public consultation process have been instrumental in informing the recommendations developed in this Age Friendly Strategy. The research reveals that for many older people, growing old in County Wexford can be a very positive experience.

However, the findings also illustrate that for some older people the experience can be much more challenging and isolating. This is particularly true for some of the more vulnerable groups such as the Traveller community; refugees; asylum seekers; people living alone; the LGBTQIA+ community; and those with disabilities or who have long-term illnesses. Figure 39 below summarises some of the key positive and negative experiences for people as they grow old in Wexford.

The recommendations outlined in this section of the strategy will directly address the needs of older people in Wexford across all of the themes identified by the World Health Organisation as part of its Age Friendly Cities and Communities programme.

Theme 1:

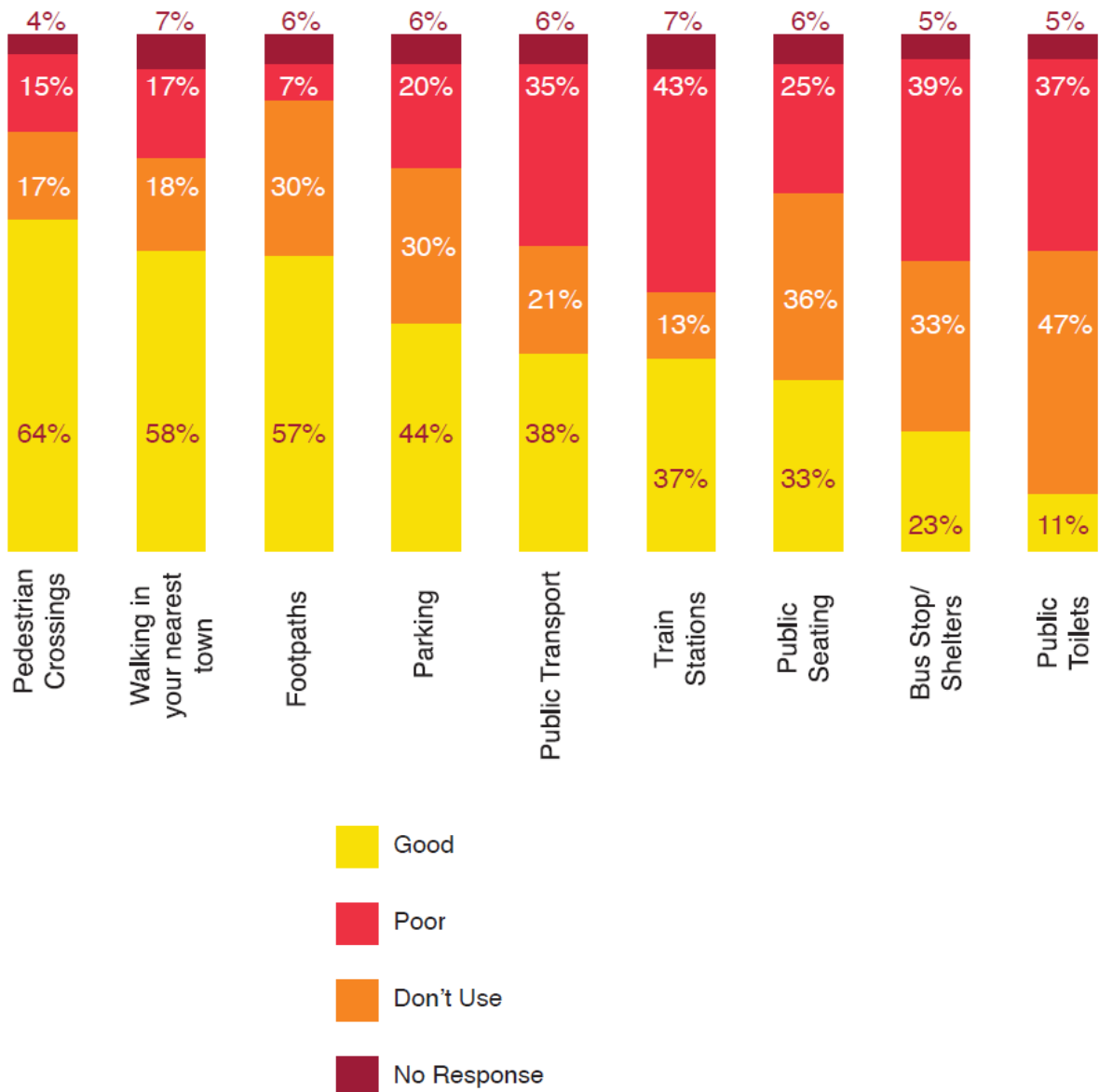
Outdoor Spaces & Buildings

Goal:

To make outdoor spaces accessible and safe for older people, thereby creating walkable communities and age friendly spaces. This enables people to stay active and to participate fully in their wider community.

The survey findings gave a clear indication of the outdoor facilities needing improvement, with public toilets, bus shelters, seating and walking on public roads being the most important.

Recommendations

Objective: Improve the accessibility of our Towns (Wexford, Enniscorthy, Gorey, New Ross, Bunclody, Rosslare Harbour, Courtown)

- ✚ Complete walkability audits in towns and Wexford Hospital (1 per year).
- ✚ Designate 1 day per week in each town as Age Friendly. Provide toilets, parking, shopping discounts, public transport, library and banking support.
- ✚ Provide and promote public toilet facilities in each town linked to existing facilities where possible.
- ✚ Create Age Friendly parking spaces in each town close to the main services and also at Wexford hospital, beaches and parks.
- ✚ Provide more Age Friendly public seating and bus stop shelters.
- ✚ Create more local parks and off-road walking tracks / cycle paths.

Objective: Improve the accessibility of our Villages (Rural Communities)

The shop, post office, pub, bank, church, community centre and national school are often at the '*Heart of the rural community*' – there is a fear around losing these facilities.

- ✚ Develop outdoor gardens / parks / walking tracks and walking trails for older people to socialise (ideally with a sheltered covered area). Prioritise communities where there are currently no outdoor amenities available.
- ✚ Provide more public seating.
- ✚ Explore opportunities to diversify the range of facilities / services offered by local shops / post office / community centres.
- ✚ Publicise the availability of public toilets in rural communities linked to existing facilities.
- ✚ Promote disabled wheelchair facilities where available.
- ✚ Create dedicated and segregated cycling / pedestrian infrastructure to connect rural communities to the towns and other villages.
- ✚ Develop initiatives to create footfall in the rural communities, thereby sustaining local facilities and services.

Theme 2: Transportation

Goal:

Provide safe, accessible and reliable public transport

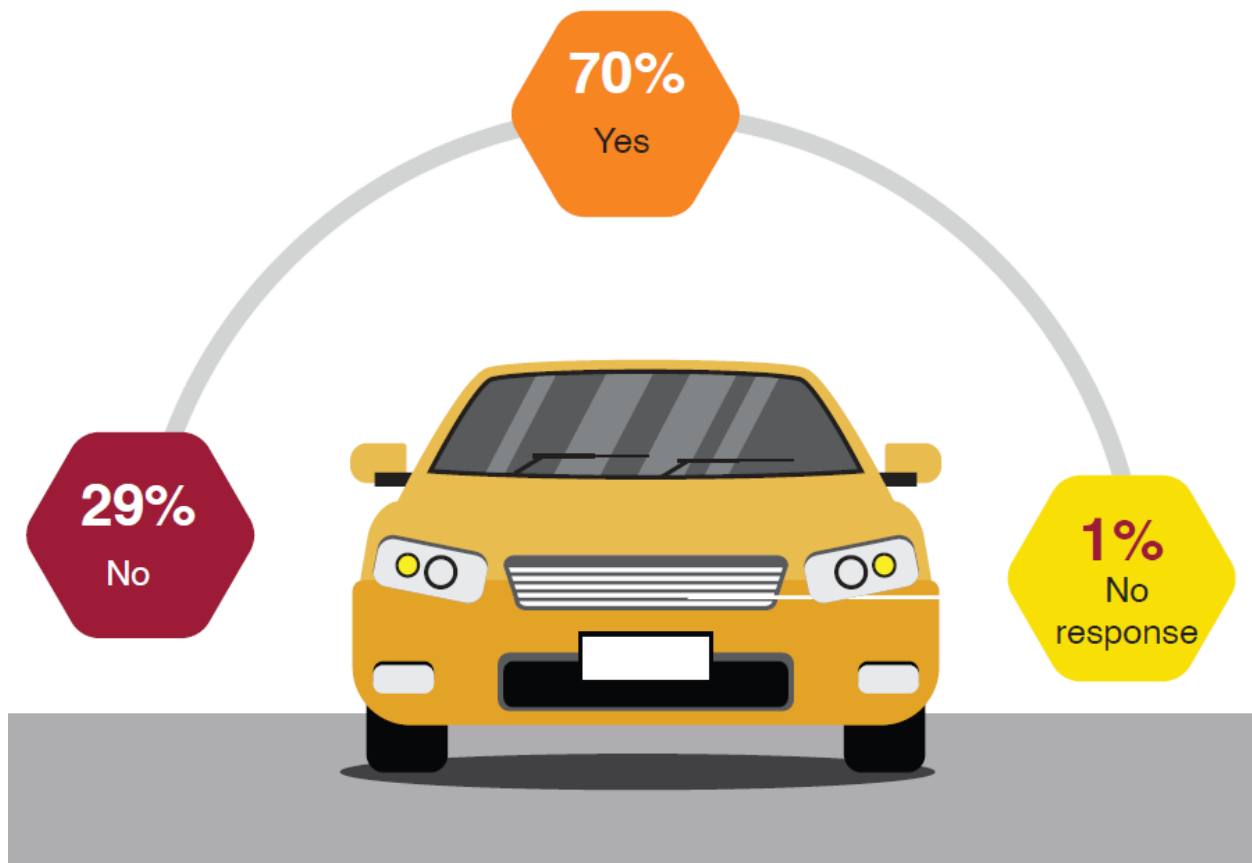
Develop active travel for older people.

Ensure people are informed about available transport options.

The public consultation process gave a clear indication of the transport needs of older people and what would be most beneficial to them.

Arising from the considerable number of older people that can't use a car, this demonstrates the need to ensure that people can access services and facilities through using public transport or other types of transport initiatives.

Recommendations

Objective: Improve people’s access to medical appointments

- ✚ Establish a county wide car volunteer scheme (prioritising people attending medical appointments.)

Objective: Further expand the public transport network

- ✚ Continue to expand the TFI Local Link Wexford service and the public transport infrastructure to best meet the needs of older people in the county. This is to be undertaken in collaboration with local communities who are best placed to identify local needs.

Objective: Invest in safe walking and cycling infrastructure

- ✚ Ambitiously develop segregated cycling infrastructure in the county so that it can be seen as a safe and valid transport choice for older people wanting to engage in activities / services outside their home.

Objective: Establish a network of Community Champions to promote public transport and active travel options within their locality

- ✚ Explore opportunities to create a network of Community Champions throughout the county who can offer local and one to one advice on public transport and their timetables. These Champions could also assist in promoting public transport options in newsletters, notice boards and on social media. This could possibly be supported by social employment schemes.

Theme 3: Housing

Goal:

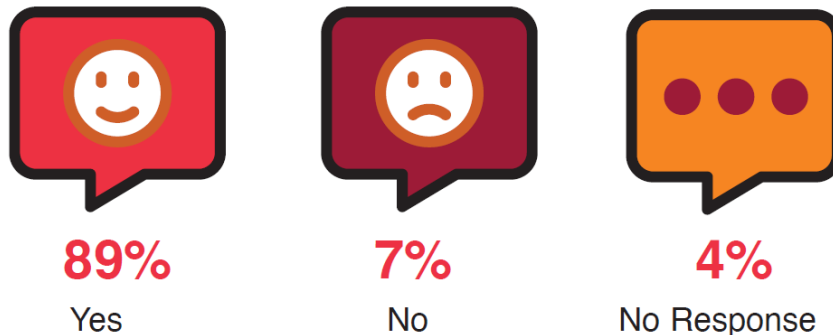
Facilitate older people to live in their own homes for as long as possible through providing supports.

Provide a range of housing options to suit different needs.

Support family members being able to live nearby.

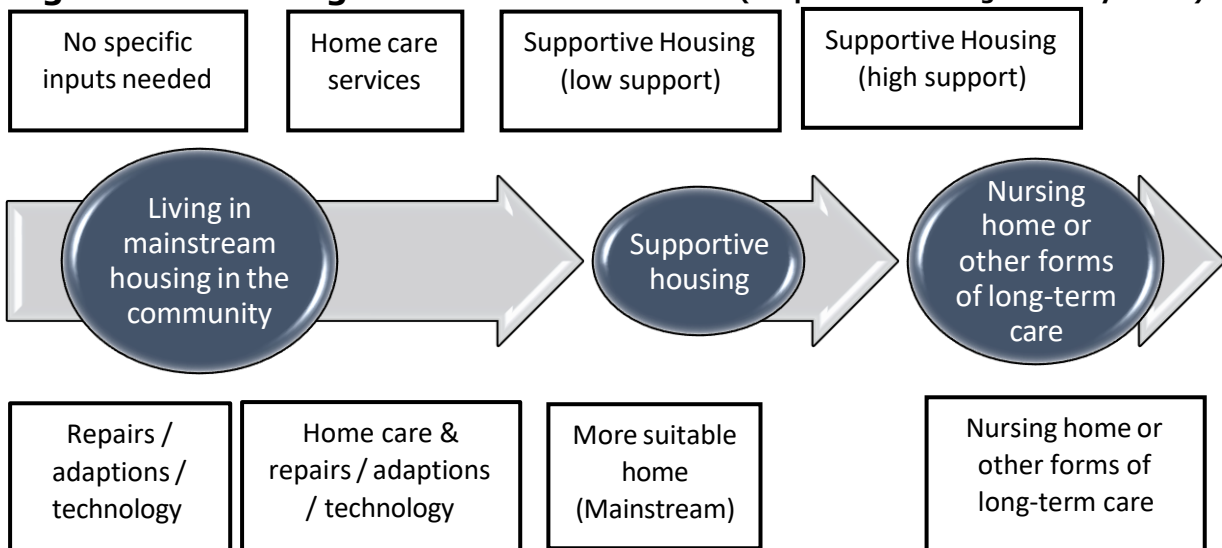
The public consultation process gave a clear indication of the housing needs of older people and what would be most beneficial to them. In particular, there was a strong message that older people want to live in their own homes for as long as possible.

Recommendations

Objective: Provide supports to enable people to live in their own homes where possible

- ✚ Improve the range of agency supports available to people living in their own homes. This includes:
 - WCC to provide one to one support to assist older people apply for home adaption or mobility aid grants.
 - Skill up Community Champions to advise on home adaption grants, personal alarms, meals on wheels, daycare centres and adaptative technologies.
 - Expand the Wexford Local Development - Little Jobs Service.
 - Explore SMART Communities and innovative home care solutions.
 - Forge partnerships to promote adaptive technologies.
 - Promote and support older people to undertake home energy audits and energy retrofit works.
 - Planning polices to support extended family networks living in close proximity to each other.

Objective: Provide a range of supportive housing options

- ✚ Identify locations which are suited for new sheltered housing developments for older people.

Objective: Support links between nursing homes and their community

- ✚ Ensure planning for new nursing homes are in areas of real need and that there is a connectivity with the local community. The location of a nursing home is very important as some visitors can't drive so public transport links are essential.
- ✚ Support and encourage partnerships with the Church, secondary schools, musicians, artists, South East Radio and members of the community to maintain links between the nursing home residents and their local area.

Goal:

Figure 47. Peoples' involvement in the following activities.

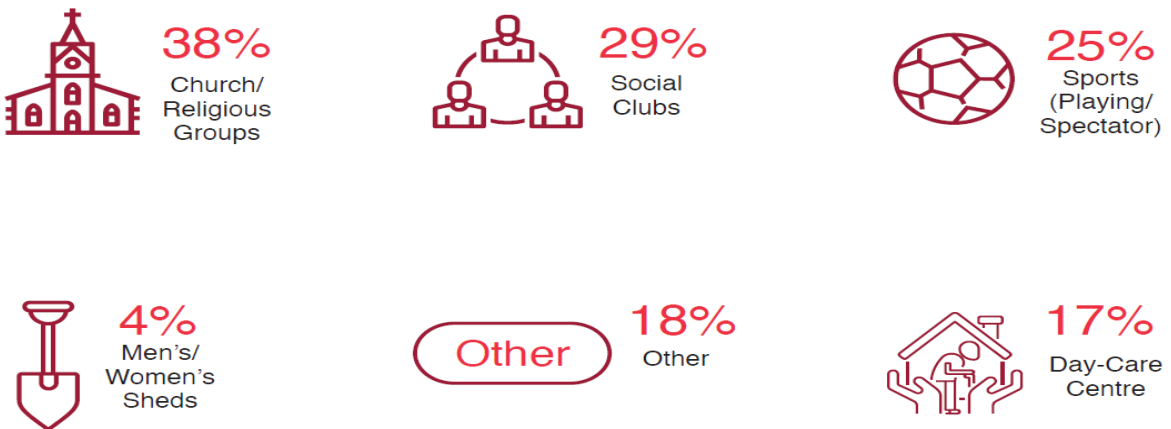
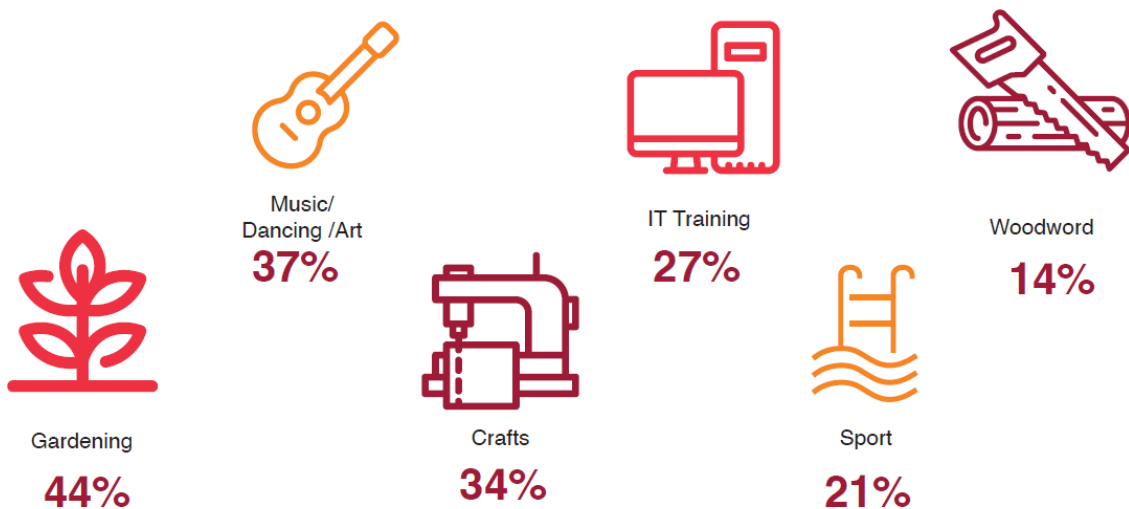


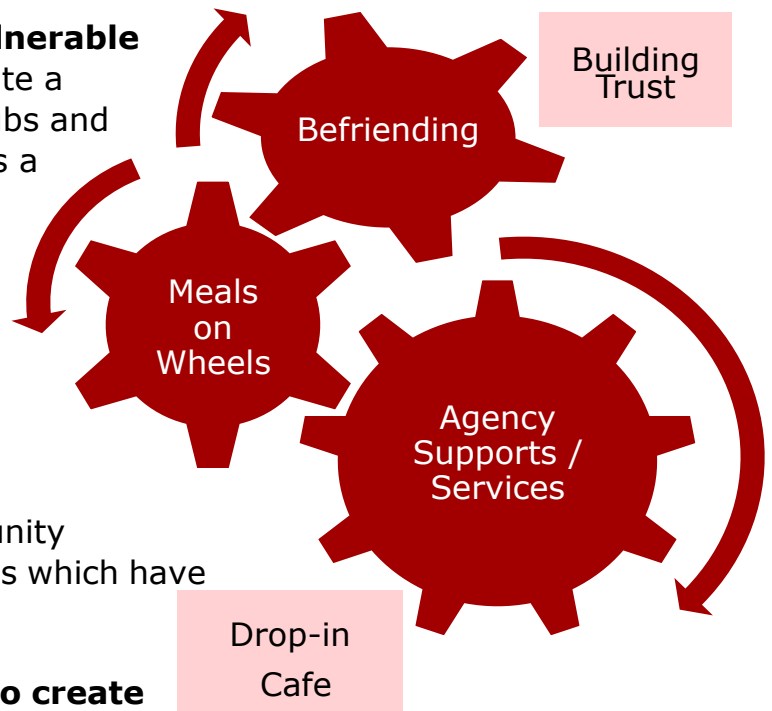
Figure 48. Are you interested in activities with young people?

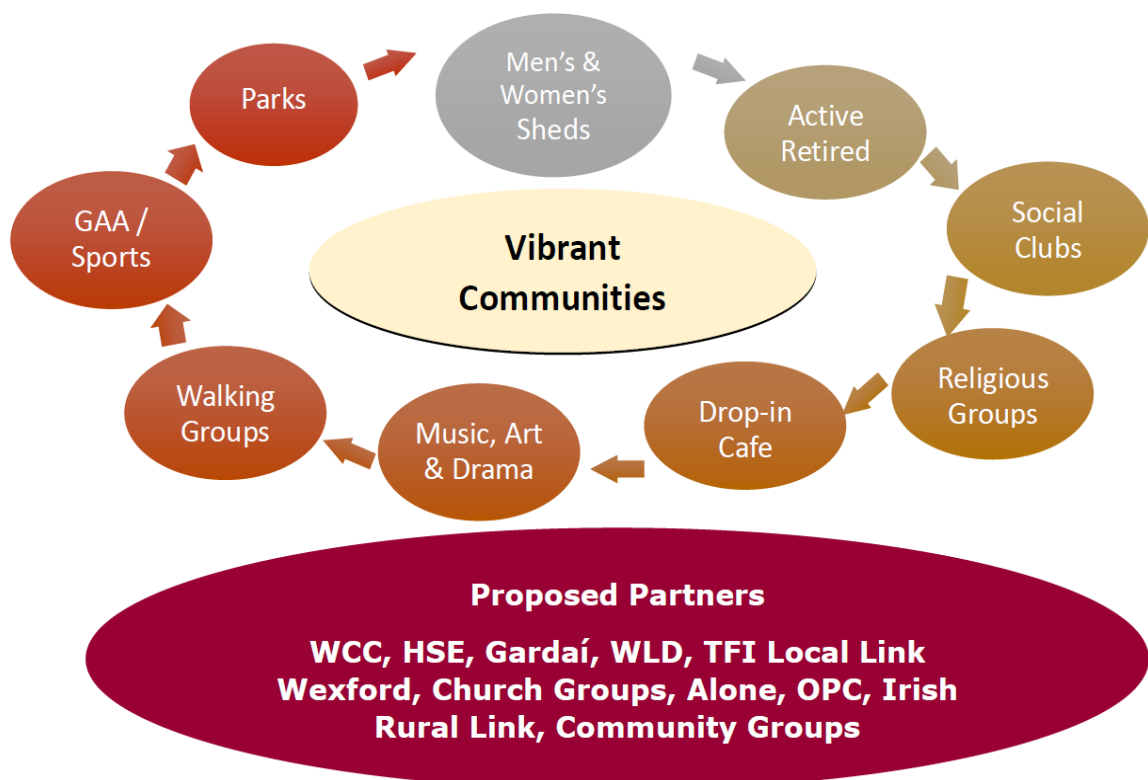
Objective: Actively support vulnerable

- ✚ **older people** Map and collate a database of facilities and clubs and identify areas where there is a deficit.
- ✚ Provide county wide coverage: daycare centres, meals on wheels, community café's and befriending services. Collaborate with relevant agencies.
- ✚ Build the capacity of community leaders in geographical areas which have limited social activities.



Objective: Support initiatives to create vibrant communities

- ✚ Create a network of Community Champions that support older people.
- ✚ Support the development and continuation of a wide range of activities including community café's which are promoted by newsletters, notice boards and online.
- ✚ Foster the establishment of intergenerational activities.



Theme 5:

Respect and Social Inclusion

Goal:

Ensure older people feel valued and can be actively involved in their community.

Allow the voice of older people to be heard in all policies affecting them, particularly those most vulnerable.

Promote positive ageing across all sectors of society.

The consultation process identified that many older people have very positive experiences of growing old in Wexford. However, not all people are so fortunate as illustrated in the table below under 'Negative Experience'.

Recommendations

Objective: Develop initiatives to ensure the voice of older people are heard

- ✚ Establish a strategic Interdepartmental Team within WCC to embed the principles of age friendly and to link to the Age Friendly Alliance.
- ✚ Extend the pilot 'Age Friendly Business Programme' to all towns.
- ✚ Establish a network of Age Friendly Community Champions that can hear the voices of older people and share this with the Age Friendly Programme Manager.
- ✚ Nominate people representing vulnerable groups onto the Older People's Council.
- ✚ Design specific Age Friendly support programmes for vulnerable target groups as outlined below:

Objective: Actively support Asylum Seekers / New Communities

- Forge links with the Volunteer Centre and local groups, Active Retired, Men's Shed, Befriending, Sporting Organisations, Schools etc to assist with integration into the community. Create a volunteer buddy system and family pen-pals.
- Foster collaboration with TFI Local Link Wexford to assist with transport.
- Identify volunteers with language skills. Explore the scope to have hospital liaison interpreters (e.g. Urdu).
- Organise interactive events and activities with asylum seekers and local residents e.g. cooking, crafts, sewing, woodwork etc.
- Develop projects with the Arts Department and Sports Active Wexford.
- Amend the WCC Housing Form to include Direct Provision.

Objective: Actively support the Traveller Community

- Extend the range of literacy courses for older adults in collaboration with FDYS, WLD and WWETB.
- Provide additional supports to the Traveller community to assist with form filling and online services.
- Information events to discuss the housing maintenance booklet and how to liaise with WCC on housing repairs. Publicise the appointment of the WCC Traveller Housing Liaison Officer.
- Assessment of halting sites and establish resident's associations to co-ordinate improvements.
- Explore opportunities to assist with housing repairs through schemes such as the 'Little Jobs' initiative.
- Bring a Traveller group on the WCC walkability audits.
- Foster closer links between the Traveller community and TFI Local Link Wexford; Men's Shed; Sports Active Wexford etc.

- Establish arts, leisure activities and cultural initiatives with the Traveller community in areas such as story-telling, sewing, flower arranging, sports / games, bingo, allotments etc.
- Explore initiatives to record the Traveller language so it's not lost, for example Gammon or Cant.

Objective: Actively support people living with dementia

- Information sharing on dementia and brain health in 'Town Hall' events, libraries or community centres to promote positive ageing.
- Share information on dementia and brain health through church newsletters, radio, local newspapers etc.
- Ensure there is an integrated care pathway and information sharing amongst care providers and statutory agencies.
- Expand funding and staffing supports for dementia patients.
- Expand the Community Call / WCC Helpline as it is very useful for frontline services and vulnerable people.
- Link the Memory Technological Unit (MTU) with the Volunteer Centre to assist patients accessing this service.
- Offer MTU clinics at outreach centres in the county.
- Explore links with the library to identify if equipment / technology hire can be facilitated through the library service.
- Map service provision and identify what is available.
- Establish a database of trained dementia champions.
- Develop a system of supports between the HSE/WCC/Gardaí.
- Train Befriending volunteers in dementia supports.
- Investigate if collaboration with Higher Education Institutions can be forged to better understand dementia.
- Establish and encourage GPs to recommend social prescriptions.
- Develop more day services and health clubs. This could be undertaken in collaboration with daycare centres who could deliver specific activities and offer support, advice and sign posting to carers / families of those living with dementia.
- Support adaptive housing and assisted living initiatives.

Objective: Actively support residents of Nursing Homes

- Ensure there is accessible parking in towns, with public toilets and good quality footpaths and benches.
- Support initiatives that foster links between the nursing homes and their community e.g. arts, religious services, music, etc.
- Forge links with the Volunteer Centre so that volunteers can come into the nursing homes to chat to residents on a one-to-one basis. Activities include painting nails, reading the newspaper, playing music, singing, feeding the birds, setting up zoom calls etc.

- Support initiatives with the secondary school transition year.
- Continue the library book service for residents which was established during the Covid-19 pandemic and worked very well.
- Explore if a parking disc for the nursing homes could be given to facilitate parking for medical appointments.
- Forge closer collaboration with TFI Local Link Wexford to support visitors using public transport to see residents in nursing homes – more information on timetables etc.
- Explore opportunities to develop daycare and sheltered housing on nursing home sites.

Objective: Actively support people with accessibility / disabilities

- Promote best practice case studies or exemplar's on accessibility.
- Compile a leaflet on accessible walking trails (tarmac surface) in the county which includes accessible parking, toilets and refreshments.

Objective: Actively support people in the LGBTQIA++ community

- Arrange annual awareness training so that people / organisations have a better understanding of the LGBTQIA++ community and their needs. This could be linked to Pride in June each year.
- Host a LGBTQIA++ community exhibition as part of a positive ageing event. This could then be rotated around the libraries and other public events. It could also be filmed as a webinar.
- Form a new walking / hiking club for all ages of this community. Launch this at an event with high profile sports people.

Objective: Actively support people living alone or who are isolated

- Promote and expand the befriending initiative to all communities in Wexford.
- Utilise the Community Champions network to reach vulnerable individuals.
- Strengthen collaboration between agencies who interact with vulnerable people to ensure older people receive the supports they require.
- Support the ambition to have a Men's Shed in every village / town.
- Revitalise the GAA Social Committee and continue the GAA supports to vulnerable people, that was so effective during Covid-19.

Theme 6:

Civic Participation and Employment

Goal:

Increase employment opportunities for older people.

Encourage positive volunteering experiences.

Continue to hear the voice of older people and ensure they can participate fully in their community.

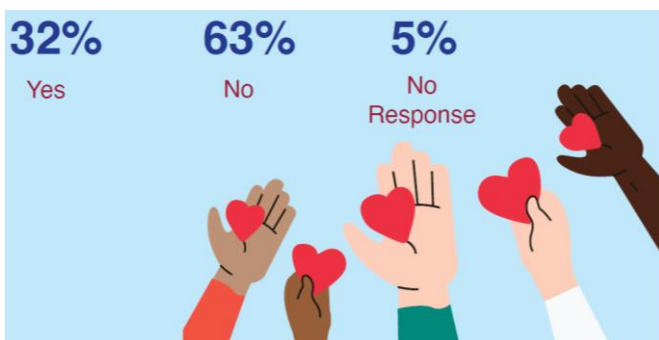
Wexford’s first Age Friendly Strategy was published in 2017 and this recommended that an Older People’s Council was formed. As a result, 18 members are now actively representing older people across the county and they have been instrumental in guiding this research and the formulation of this strategic plan: 2022-2026. In addition, the Wexford Volunteer Centre was launched in May 2021 and this is an invaluable new service that aims to enhance the quality of volunteering in the county.

“Essentially, it's about matching volunteers with organisations and providing support for all parties going forward. We'd aim to work with everyone from Tidy Towns committees to the local Women's Refuge and even those staging festivals etc across the county in a bid to help them to find suitable and willing volunteers. A lot of the time people don't even realise that their organisation can avail of such supports.”

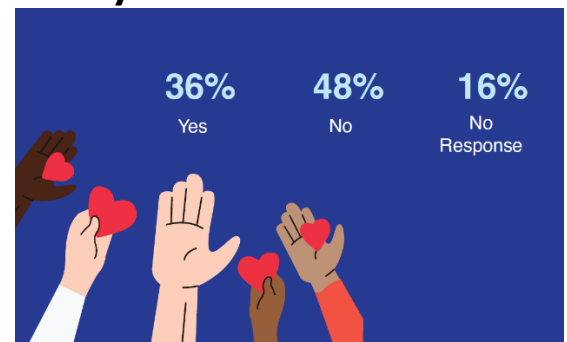

Recommendations

Objective: Increase employment opportunities for older people

- ✚ Utilise the Age Friendly Business Programme to support positive ageing in the workforce.
- ✚ Support vulnerable groups and their access to the workplace.

Objective: Encourage positive volunteering experiences

- ✚ Explore opportunities to utilise the 1,000+ database of volunteers to assist with Age-Friendly initiatives identified in the strategy.
- ✚ Examine the viability of developing a volunteer car scheme for medical appointments based on the existing cancer / HSE initiative. Access to medical appointments is a huge issue for older people and there is no dedicated service in place to address this.
- ✚ Investigate the potential for linking volunteers with vulnerable older people such as those living in the Direct Provision Centre, people living alone, or residents in Nursing Homes etc. This could be undertaken in collaboration with Alone who could provide volunteer training.
- ✚ Examine the scope to create a volunteer 'Community Champion' initiative as outlined in earlier recommendations.
- ✚ Explore the interest in working with volunteers to assist with literacy and digital supports for older people.
- ✚ Identify volunteers who have specific skills such as IT, music, art, gardening, other languages etc.

Objective: Expand the Older People's Council

- ✚ Expand the membership of the Older People's Council to include representatives from vulnerable and marginalised groups as outlined in earlier recommendations.

Objective: Promote positive ageing across all sectors of society

- ✚ Appoint Age Friendly Ambassadors to positively and proactively promote the lives of older people.
- ✚ Develop a range of inter-generational activities so that young and old people can learn from each other.

Theme 7:

Communication and Information

Goal:

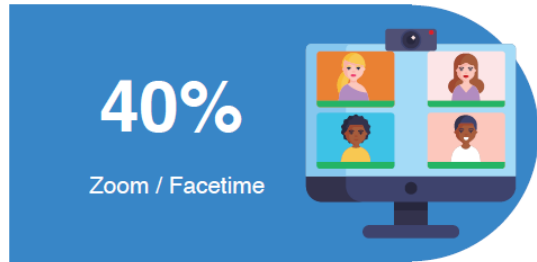
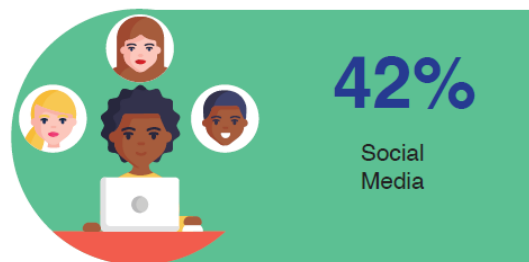
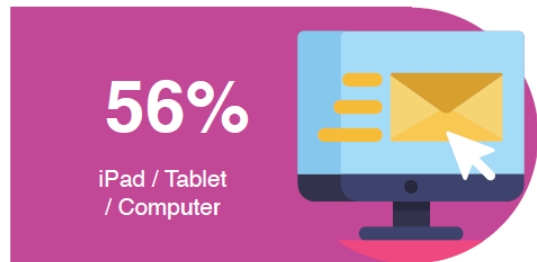
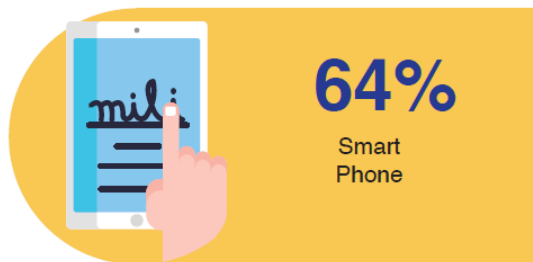
Ensure everyone is informed of services and facilities available locally and nationally.

Support older people to access services, goods and information digitally.

Assist vulnerable groups engage with all sectors of society as required.

The survey findings clearly illustrate where older people get information from with friends / family, radio and the local newspaper being the most important sources. The findings also revealed that approximately two thirds of older people use a smart phone or other technology such as iPads and tablets. Over 40% use social media and zoom / facetime to communicate with others.

However, the results also illustrated that 32% would like IT training and our consultation findings showed that this should ideally be undertaken on a one-to-one basis in the community.

In addition, the focus group sessions revealed that vulnerable groups need particular assistance with accessing services as many have difficulty accessing them online. Supports are required in literacy, language skills, financial procedures and digital literacy.

Recommendations

Objective: Ensure everyone is informed of available services and facilities

- ✚ Establish a Community Champion network to disseminate information at a local level through newsletters, community / Church notice board, social media or by word of mouth.
- ✚ Support the implementation of the Befriending Service countywide.
- ✚ Utilise existing services such as the meals on wheels, daycare centres, libraries and mobile libraries, TFI Local Link Wexford and church groups to regularly distribute information.
- ✚ Host monthly radio interviews publicising services for older people.
- ✚ Explore the potential to create a weekly newspaper column featuring older people's needs.
- ✚ Support the development of community cafes and informal social clubs so older people can regularly share information.

Objective: Support the digital access of services, goods and information

- ✚ Provide bespoke IT training for older people in collaboration with the library and WWETB.
- ✚ Expand the transition year initiative with students and older people to deliver IT training on a one-to-one basis.

Objective: Assist vulnerable groups engage with all sectors of society

- ✚ Explore upskilling volunteers to assist with literacy and digital supports for older people.
- ✚ Identify volunteers who have other languages that can assist with translation services for refugees / new communities where English is not their first language.
- ✚ Provide a dedicated Age Friendly 'Customer Care' staff member in WCC to assist with enquiries and embed this across all WCC Sections.
- ✚ Deliver a digital ambassador scheme through the library service.

Theme 8:

Community Support and Health Services

Goal:

Ensure older people can access and afford the health care services required.

Utilise new assistive technologies and telehealth initiatives.

Promote healthy and active lifestyles to improve the health status of older people.

Accessing health care was identified as an issue during the consultation process. This included transport issues to attend hospital appointments, particularly if they were out of county; parking difficulties at hospitals if the patient has limited mobility; obtaining doctor's appointments in a timely manner; and accessing health care through the public system.

These issues are accentuated for vulnerable groups that possibly don't have access to a car, have limited mobility, have no private health insurance, live alone, have no family members nearby, are a non-Irish national or are from a minority ethnic group. The survey findings illustrated that 17% of older people need mobility aids to get around.

The survey results also explored people's experience of accessing health services and the results are illustrated below.

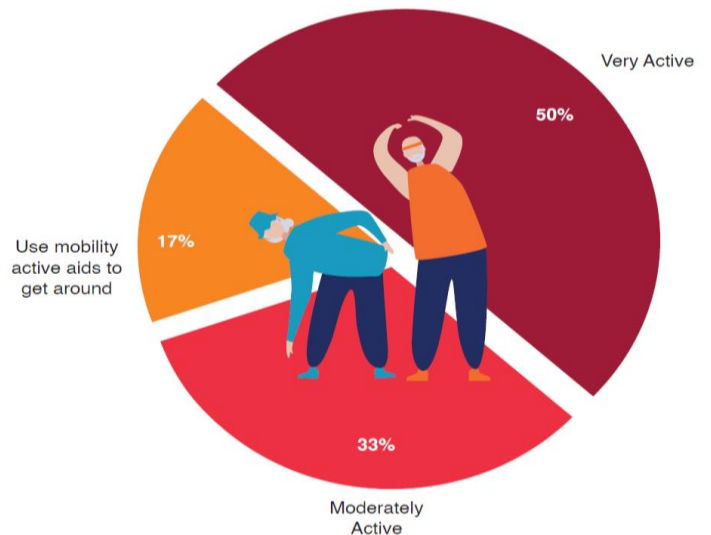


Figure 52. Experience of accessing the following?



Recommendations

Objective: Enhance access to health care services

- ✚ Examine the viability of developing a volunteer car scheme for medical appointments based on the existing cancer / HSE initiative in collaboration with the Volunteer Centre as outlined in an earlier recommendation.
- ✚ Improve parking at hospitals to facilitate people with accessibility issues – undertake walkability audits.
- ✚ Support the social prescriptions initiative to combat mental health issues and isolation / loneliness.
- ✚ Operate outreach health facilities in rural areas e.g. physiotherapy, chiropody etc.
- ✚ Greater access to the public health nurse or operate community-based health centres.
- ✚ A change of names on prescriptions can be confusing for older people, may use a generic name instead of a brand name that people are familiar with so ideally include both drug names and ensure the instructions are in a large font size.

Objective: Promote assistive technologies and telehealth

- ✚ Promote assistive technologies to health professions and the public.
- ✚ Promote the national 'Age Friendly Homes' website profiling assistive technology.
- ✚ Forge partnerships and collaboration with carers and other health professionals to support older people in their use of assistive technology. This includes training and on-going support.
- ✚ Record a webinar series on the technologies and widely circulate.
- ✚ Deliver the telehealth initiative based on findings from Phase 1.

Objective: Promote active living and healthy lifestyles

- ✚ Extend links between vulnerable groups and Sports Active Wexford to promote active living and social interaction.
- ✚ Explore the potential to develop walking trail groups linked to the Wexford Walking Trail (WWT) network.
- ✚ Include Age Friendly recreation initiatives in funding proposals.

Theme 9: Safety and Security

Goal:

Ensure older people feel safe and secure in their homes and community.

Many people living in County Wexford thought they have a high quality of life and feel safe in their homes and within their wider community.

However, older people do feel unsafe when they are walking or cycling on the public roads where there are no footpaths, which is quite common in rural areas.

Figure 53. Survey Extracts: How do you find the following?

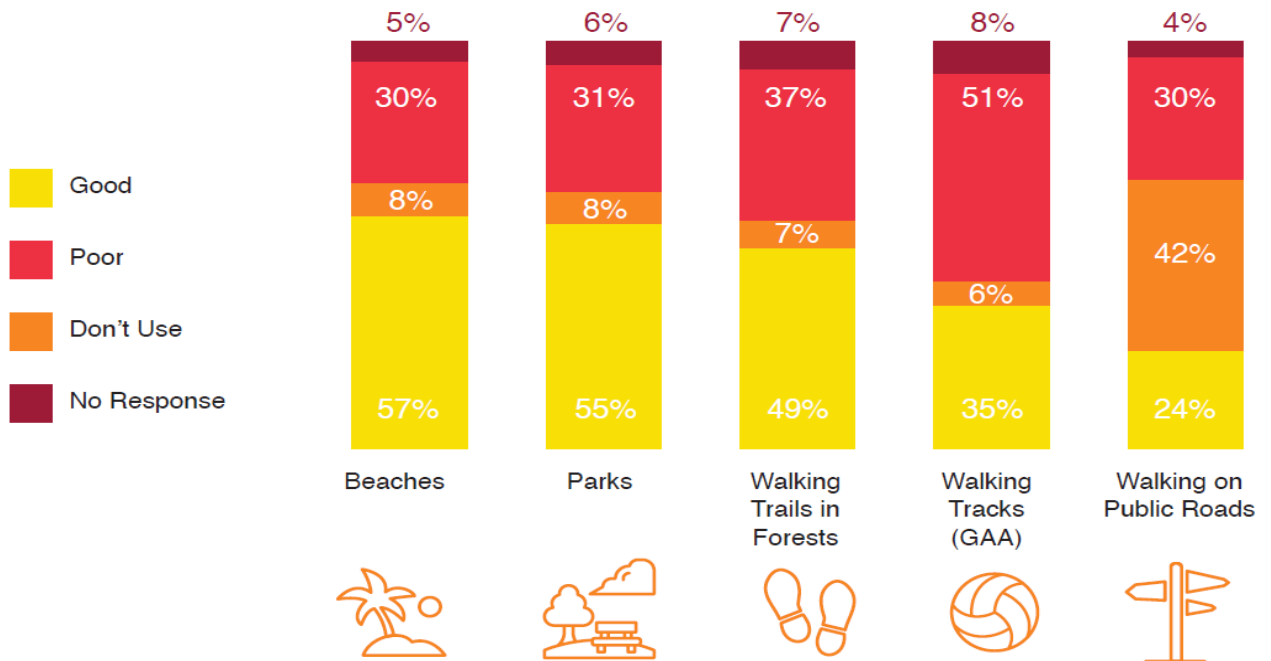
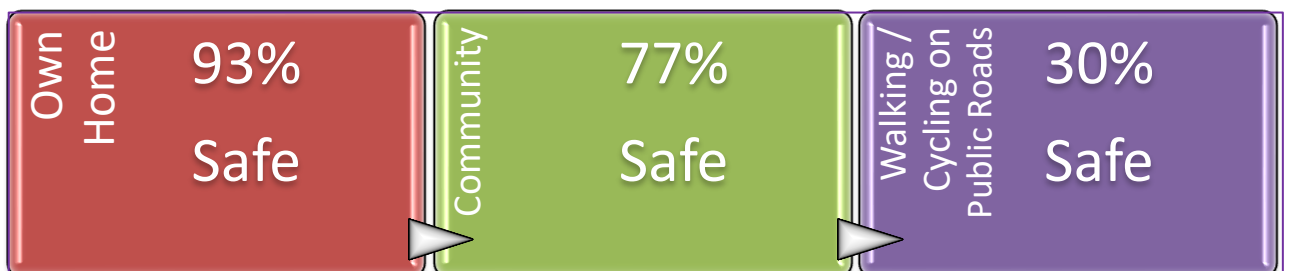


Figure 54. Survey Extracts: Do you feel safe in the following?



Recommendations

Objective: Ensure older people feel safe and secure in their homes

- ✚ Publicise home security / panic alarm services.
- ✚ Older people are vulnerable to cyber security attacks so provide training and awareness on digital technologies.

Objective: Ensure older people feel safe and secure in their community

- ✚ Improve footpaths so they are safer for people with reduced accessibility.
- ✚ Improve road safety for pedestrians and cyclists. Create designated cycleways, reduce speed limits and install signage.
- ✚ Provide greater Gardaí presence in the community where possible.
- ✚ Publicise the CCTV facilities in the towns so people feel safer.
- ✚ Address youth boredom to stop people hanging around on the streets.
- ✚ Reduce the fear of crime and crimes against older people. (e.g. Awareness and crime prevention of Elder Abuse, use of Bogus caller cards, home security etc.)
- ✚ Increase Garda engagement and accessibility with older people (e.g. Garda Clinics, Neighbourhood Watch, Community Alert Schemes, meetings with older person groups etc.)
- ✚ Support community safety initiatives that assist older people (e.g. implement the older person's register, senior alert alarms from Pobal, incorporate initiatives learned from the Covid-19 pandemic.
- ✚ Utilise community partnerships to respond to the ongoing needs and expectations of older people.

5.2 Summary

This section has identified a wide range of recommendations and objectives that should be implemented across the nine age friendly themes, subject to available funding and resources.

It is envisaged that these initiatives will become embedded into the work programmes of a wide range of government agencies and voluntary groups who can then actively collaborate to ensure the optimum outcome for older people.

It is also likely that over the course of the five-year period these recommendations will need to be reviewed and potentially revised based on evolving situations in society.

Section 6 will now outline a detailed Action Plan for the Age Friendly Strategy which has been prepared in consultation with the Alliance partners.

Action Plan

6.1 Action Plan

To deliver on the strategic recommendations outlined in section 5, it is essential to have a clear and concise 5-year action plan. This is a living strategy and will be continuously revised based on emerging needs and issues. In addition, it will be consistent with the existing and proposed LECP.

This strategic plan will continue to be monitored and adjusted, based on the emerging public health situation and the consequences of this on the lives of older people.

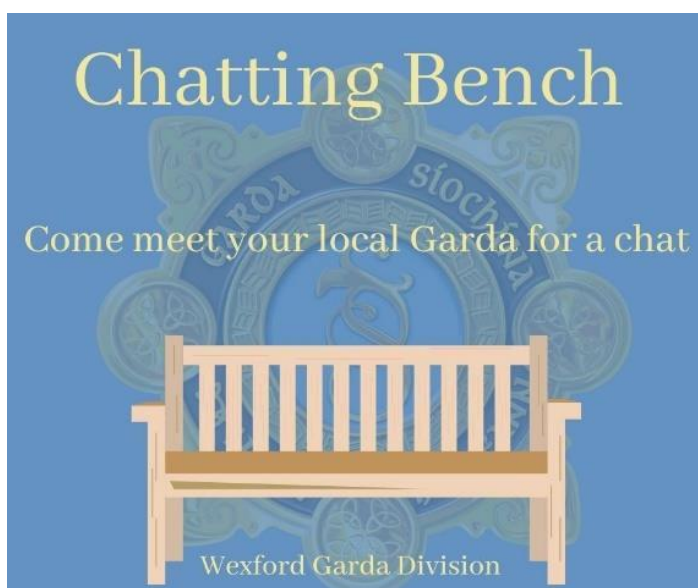

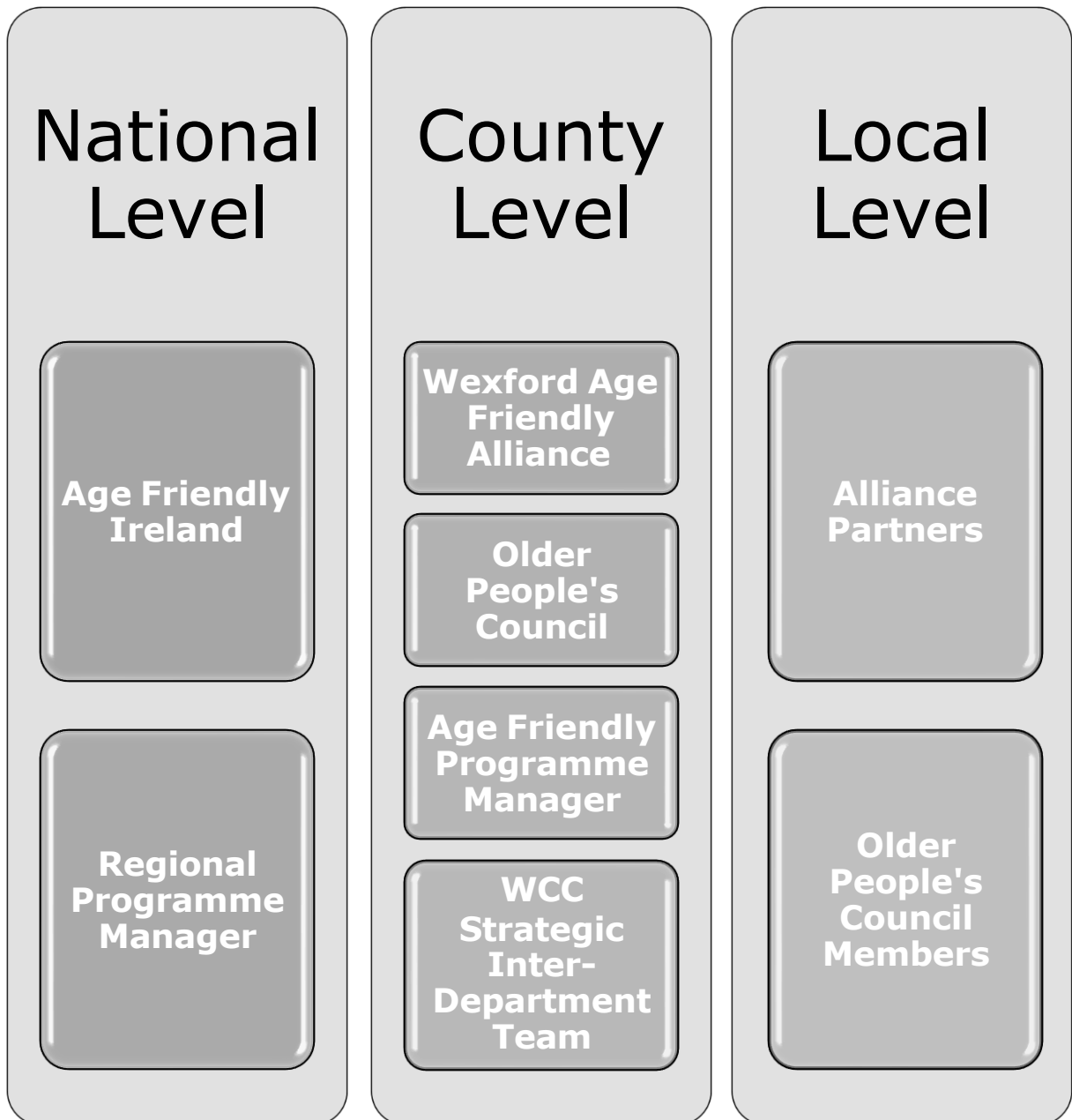
Figure 61. Chatting Bench

7.3 Monitoring, Evaluation and Review

The Alliance members will oversee the implementation of the Strategy Plan: 2022-2026.

- ✚ An annual action plan will be developed and monitored at the quarterly Alliance meetings.
- ✚ Progress reports will be produced by each lead partner for Alliance meetings.
- ✚ The Older People's Council will annually review the Action Plan and evaluate its delivery. The results will be widely publicised to ensure older people are aware of new initiatives and supports.
- ✚ The WCC Strategic Interdepartment Team will be formed to implement key projects based on emerging funding opportunities.
- ✚ An annual review will be undertaken with Community Champions to evaluate the effectiveness of actions delivered on the ground.
- ✚ Wexford will link with the Regional and National Age Friendly office to implement key strategic projects according to National policy and best practice.
- ✚ The Age Friendly Programme Manager will attend National & Regional network meetings and attend relevant training as required.

7.4 Funding and Resources

National and local funding resources will be sought where appropriate to implement the actions identified in this Strategy.

WCC also has a dedicated Age Friendly Programme Manager to support the delivery of initiatives to improve the quality of life for older people. This is undertaken in collaboration with the Older People's Council and the Age Friendly Alliance Members.

In addition, the Wexford Age Friendly Programme Manager is supported by the Regional Programme Manager and the National Age Friendly Shared Service Team which is affiliated to the World Health Organisation's Age Friendly Cities and Communities Network.

Appendix 4 Review of Age Friendly Strategy

Theme 1: Outdoor Spaces and Buildings

- Implementation of Age-Friendly walkability audits in Enniscorthy Town.
- Age Friendly Town designated in Enniscorthy.
- Age Friendly Parking pilot in Enniscorthy and County Hall.
- Age Friendly Business Training with Enniscorthy Chamber of Commerce.
- Adaption to some of the Wexford Walking Trails in the county so that they are universally accessible. These are now linked to the Wexford County Council (WCC) website and actively promoted in conjunction with Destination Parks.
- New access initiatives including the provision of beach wheelchairs, pool-pods and changing places.
- Geographical Information System (GIS) of public toilets created and updated for the county.
- The proposed Development Plans were disability proofed to ensure ease of access for all.
- Physical infrastructure improvements undertaken in villages and towns across the county. This has been achieved through the Town and Village Renewal Programme and a range of other grants.
- Issued '*Access for all Guidance Booklet*' for retailers developed by Access Section and made available at Chamber events.
- Access for all gardens and parks competition held.
- Toilets and Changing Places installed in popular locations such as the Irish National Heritage Park and Min Ryan Park.
- Upgrade of public toilets including accessibility toilets for Duncannon beach.

Theme 2: Transportation

- Significant expansion of rural transport services from TFI Local Link Wexford including evening / night-time services.
- All TFI Local Link Wexford services are now fully accessible.
- All timetables are available on the website, facebook and over the telephone.
- Installation of bus shelters in villages and towns throughout the county.

Theme 3: Housing

- New sheltered housing units completed.
- Age Friendly Housing and Public Realm training for WCC technical staff in Housing and Planning and District Engineers.
- WCC has designed and funded fully accessible social housing.

- Organised training for community and Older People's Council in the Fair Deal Scheme.

Theme 4: Social Participation

- A range of activities and sports for older people organised by Sports Active Wexford.
- Implementation of Community Leadership training programmes and courses for older people in Information Technology (IT) and crafts by the Waterford and Wexford Education and Training Board (WWETB).

Theme 5: Respect and Social Inclusion

- Sporting events organised with the Direct Provision Centre in Rosslare Harbour.
- Inter-generational projects organised in IT with transition year students and older people. In addition, a Postcard Pen-pal project was organised.
- Establishment of befriending support service on a pilot basis
- Establishment of 'Cultural Companions' for people on their own who wish to attend art and cultural events as a group.
- Many art and cultural projects and initiatives held, including storytelling, music for people living with dementia, etc.

Theme 6: Civic Participation and Employment

- Establishment of the Older People's Council so that the voice of older people could be heard and they are directly involved in the decision-making process.
- Held Older People Council meetings at a District level.
- Establishment of a Volunteer Centre for the county.
- Completed training in Age Friendly Business Training including the employment of older people.

Theme 7: Communication and Information

- Up-grade of the WCC website to make it more accessible and user-friendly through the implementation of new assistive technology called 'Recite Me'.
- Publicity of older people's services over the last five years through radio and newspaper articles. They have also been publicised via the Public Participation Network (PPN) and local newsletters.
- Age Friendly Libraries and Digital Ambassadors in all libraries. This includes the installation of Tovertafel (*Magic Tables*) and ongoing investment in new technology that supports older people.
- New 'Home Book Delivery' service implemented by the libraries for older people in response to the Covid-19 pandemic.

Theme 8: Community Support and Health Services

- Completion of a needs analysis of the Meals on Wheels Service and mapping of service provision.
- Implementation of county wide coverage of the Meals on Wheels Service.
- Completion of mapping of daycare centre provision in the county.
- HSE Understand Together & National Dementia Office Inclusive Design training for WCC technical staff.
- Working as part of the Wexford Dementia Working Group to produce an information leaflet which signposts the services and supports that are available in the county.
- Delivery of a range of support services for older people during the Covid-19 pandemic.
- Telehealth pilot project with partners including the HSE, Waterford Institute of Technology (WIT) and Tunstall Emergency Response.
- Provision of tablets for nursing home residents.
- Bringing music to nursing homes with the Covid Care concerts.

Theme 9: Safety and Security

- Increased Gardaí presence in the community, particularly during the covid pandemic.
- The Gardaí have completed a register of older people for the purpose of increased Garda engagement and accessibility with older people.
- The Gardaí making themselves available to talk to older people on the '*Chatting Benches*' around the county.
- The Gardai held events in the community on safety and security.
- Gardai are focusing on dementia and aiming to raise awareness and understanding about this issue and have joined the Dementia Alliance.

Actions to take forward into the Age Friendly Strategy 2022-2026

The Action Plan in the Age Friendly Strategy 2017-2021 was reviewed. It was agreed that the following actions have not been fully completed but are still relevant and so need to be brought forward into this Strategic Plan.

Theme 1: Outdoor Spaces and Buildings

- Age Friendly Programme Manager to hold regular meetings with Municipal District Engineers to raise their awareness of the Age Friendly Programme and to ensure works comply with Age Friendly standards.
- Significant investment has been given to outdoor infrastructure but the provision of toilets needs to be considered further in the new programme.
- Vacant / derelict buildings to be continually addressed in the new programme.

Theme 2: Transportation

- Transport access to medical appointments within the county and nationally needs to be addressed further in the new Strategy. Complete research to undertake if models of best practice exist which can be adopted within County Wexford. Liaise with Waterford Hospital and Dublin Hospitals and the transport providers to identify solutions.
- Form a working group at local and/or national level to work on this issue with partners to include Age Friendly Ireland (AFI), WCC, HSE, TFI Local Link Wexford/Bus Eireann and Volunteer Centres.

Theme 3: Housing

- Further promotion of the housing modification grant required and implement actions not completed in the last Age Friendly strategy.
- Establish a Customer Service Unit within WCC that will provide a dedicated support to assist older people with queries and complete grant forms such as the housing modification grant.
- Explore opportunities to expand the '*Little Jobs Scheme*' and promote it further. Pilot a new scheme potentially linked to the Volunteer Centre.
- Explore opportunities for Wexford to be a national pilot for installing innovative new housing technology in social housing schemes.
- Explore opportunities for new sheltered housing units linked to nursing home sites or a stand-alone initiative.
- Explore opportunities to create more housing options for older people.

Theme 4: Social Participation

- Create a database of older people's groups in the county and identify gaps and opportunities for partnership and collaboration.

- Invest in activities in community facilities to improve access to resources and services.

Theme 5: Respect and Social Inclusion

- Organise gatherings linked to social dancing and include information and advice at these events.
- Host Older People Council meetings at a District level linked to advice and training in collaboration with Alliance members.

Theme 6: Civic Participation

- Partner with the Local Enterprise Office (LEO) and the Chamber of Commerce to explore opportunities for employing older people.

Theme 7: Communication and Information

- Formalise the arrangement of having regular older people communication slots on the radio and in the local newspaper.
- Work with the Citizens Information Centres and the local newspaper to improve communication on services / facilities for older people.
- Extend the local drop in service to Community / Family Resource Centres and other community facilities.
- Create a dedicated WCC telephone line for older people to assist them to access council services.

Theme 8: Community Support and Health Services

- Mapping of sheltered housing provision in the county.
- Promote the Fair Deal Scheme as it has new guidelines.
- Establish a Thematic Group to review current support providers for attending medical appointments.

Theme 9: Safety and Security

- Continue to collaborate with the Gardaí to support people living with dementia or who are deemed vulnerable older people.

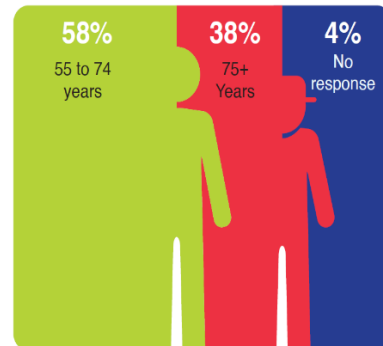

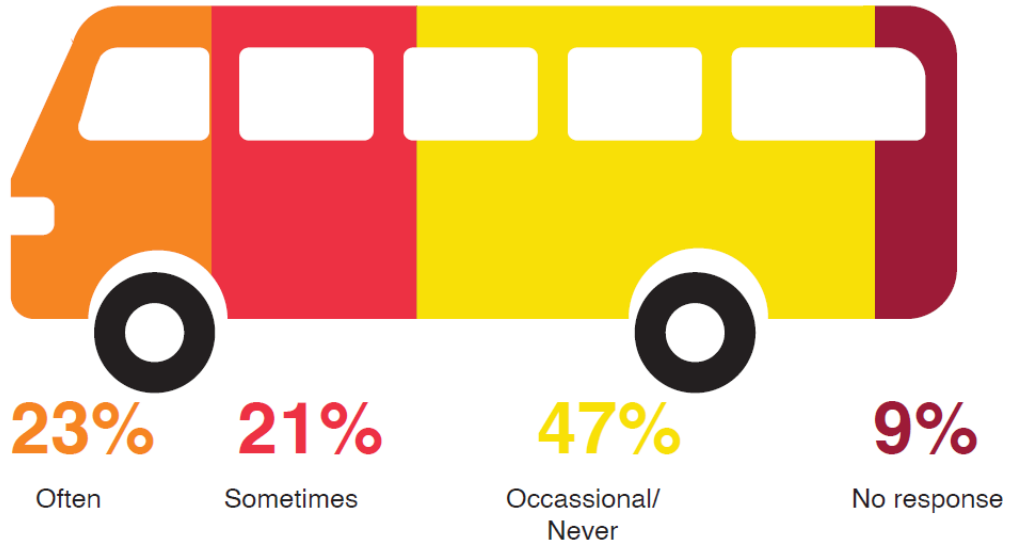

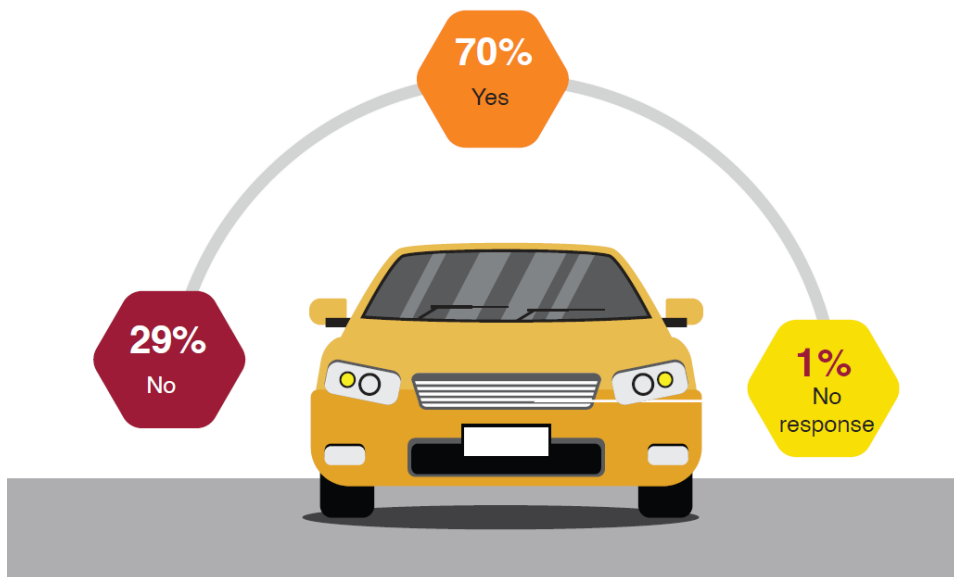

Do you rely on family / friends to access services / facilities?



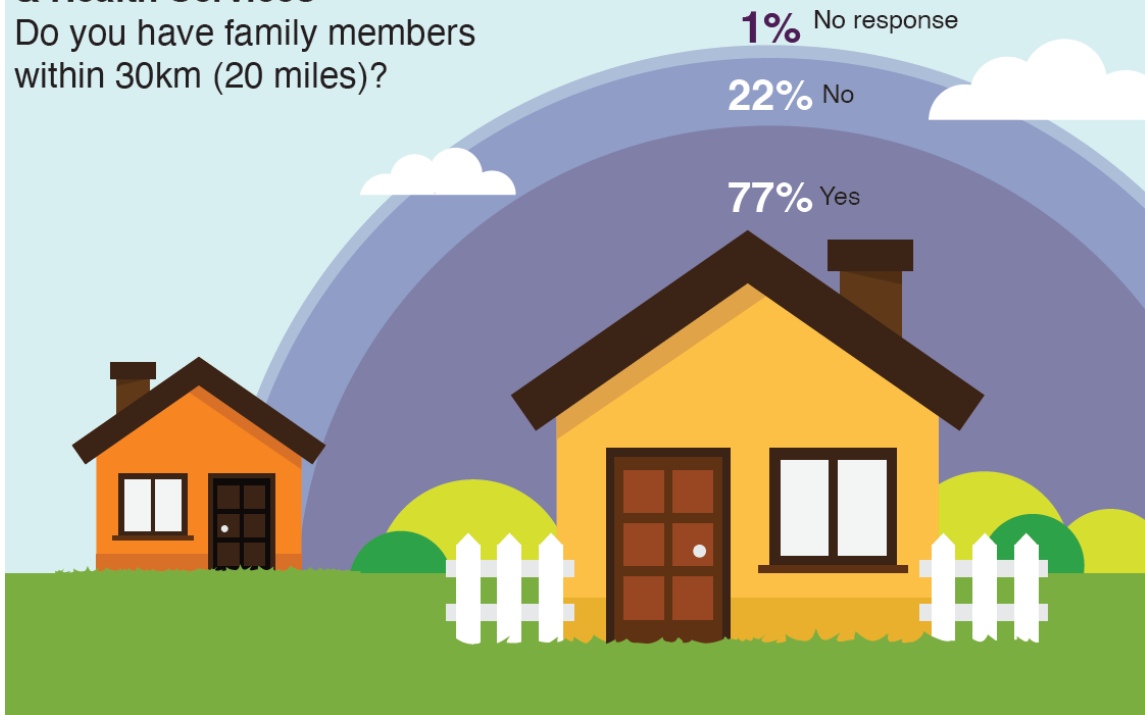

Do you drive and have access to a car?



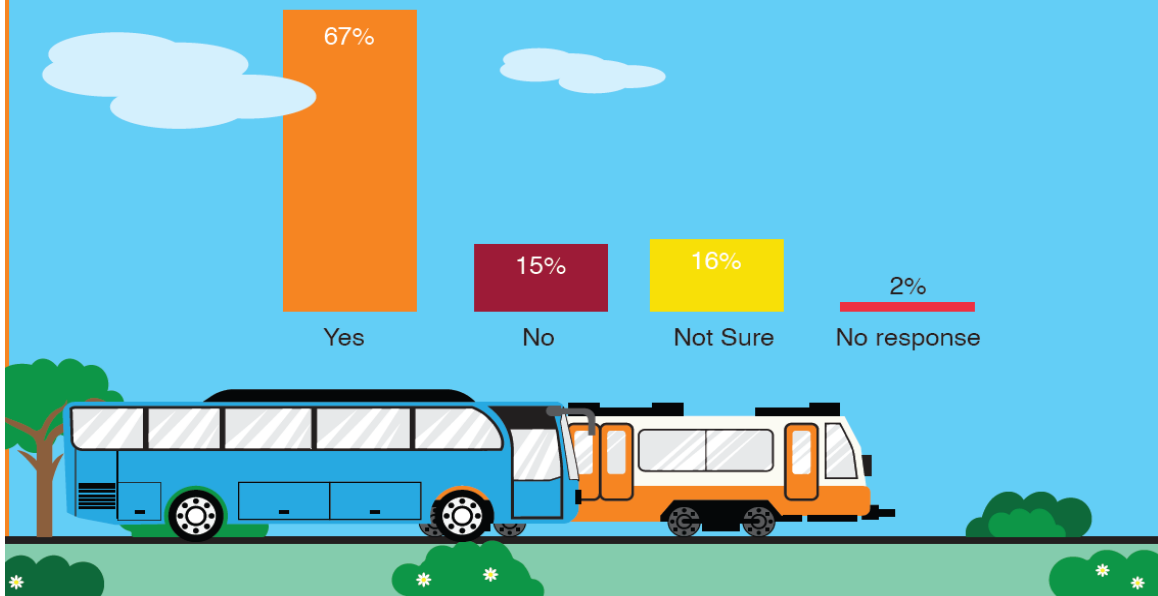

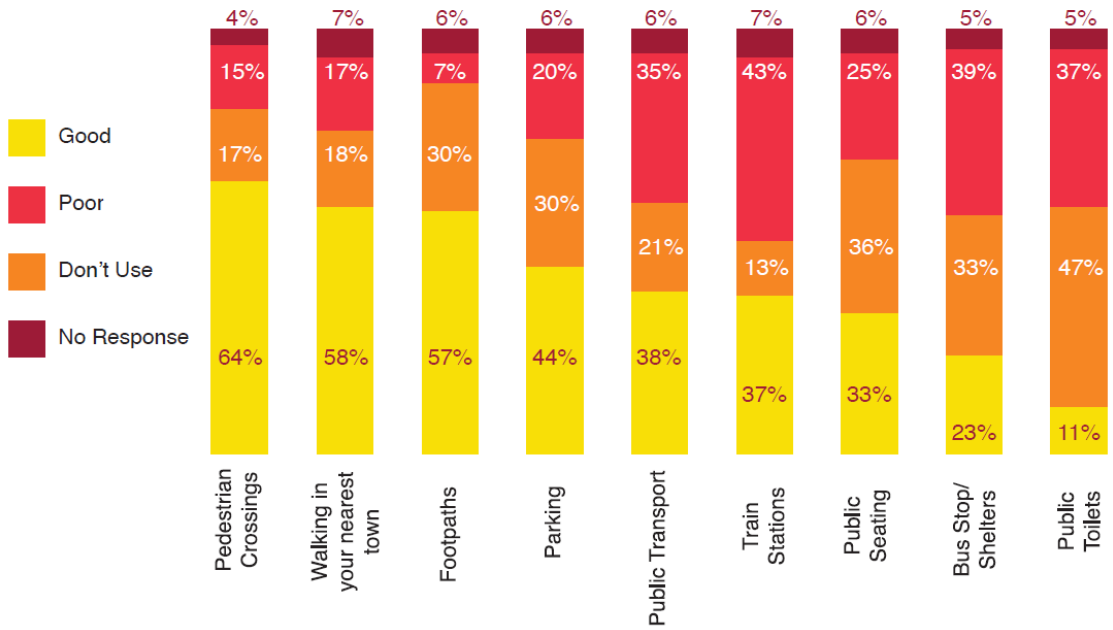

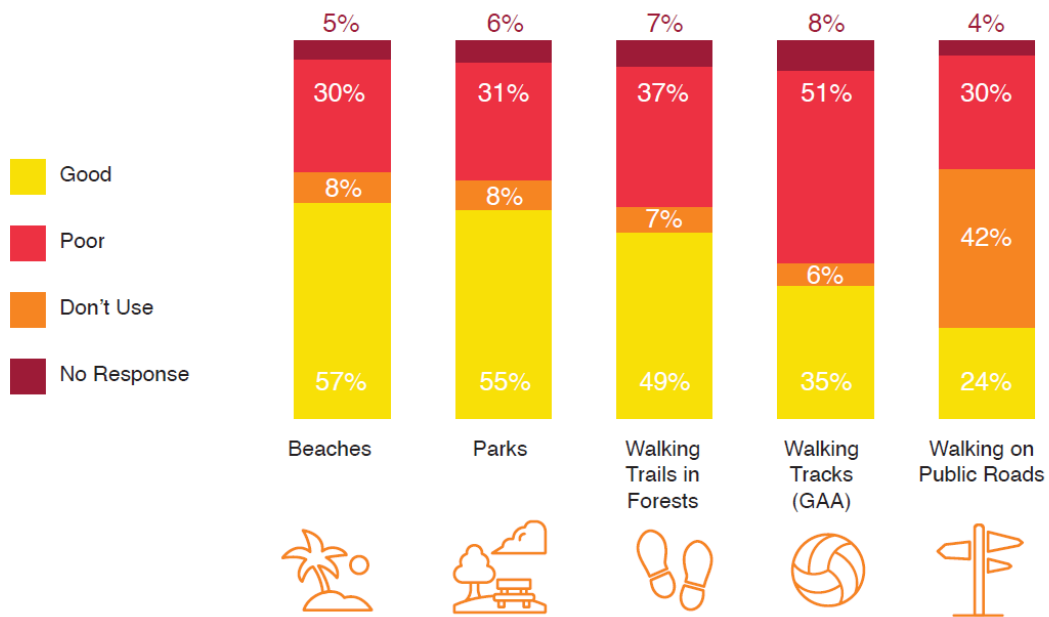

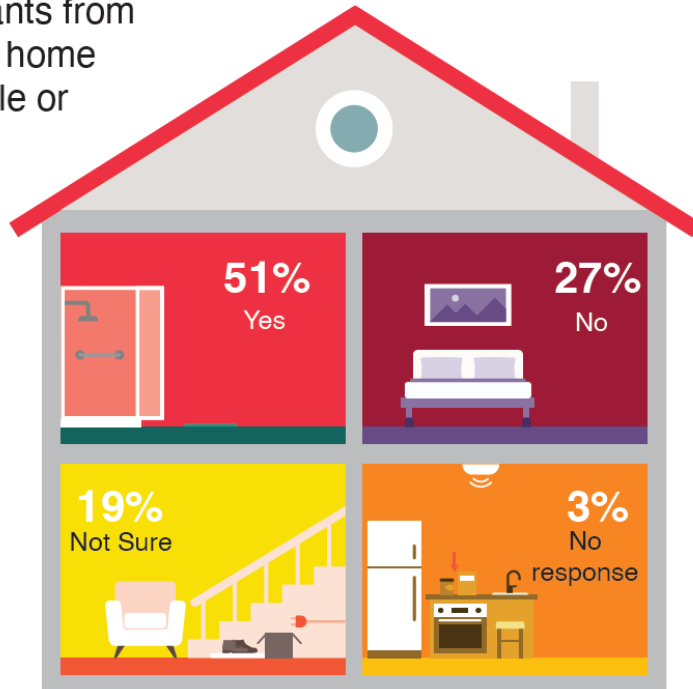

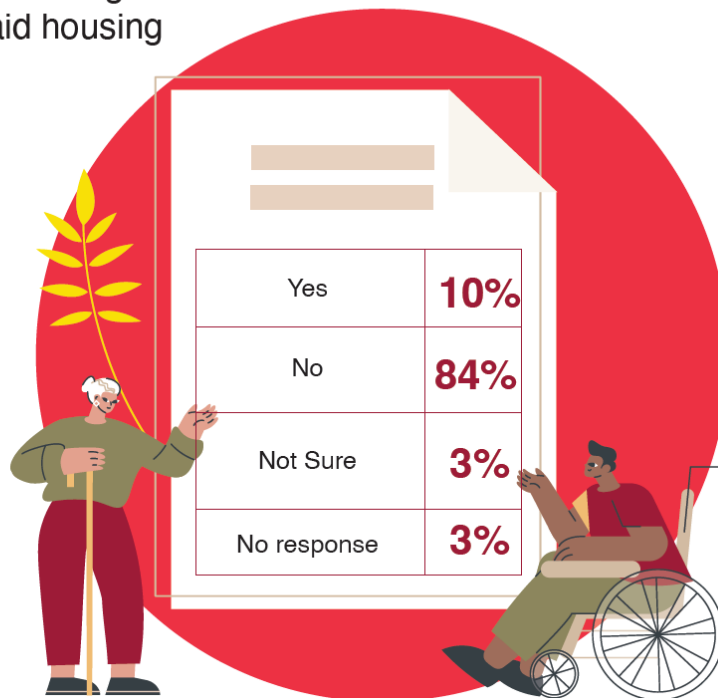

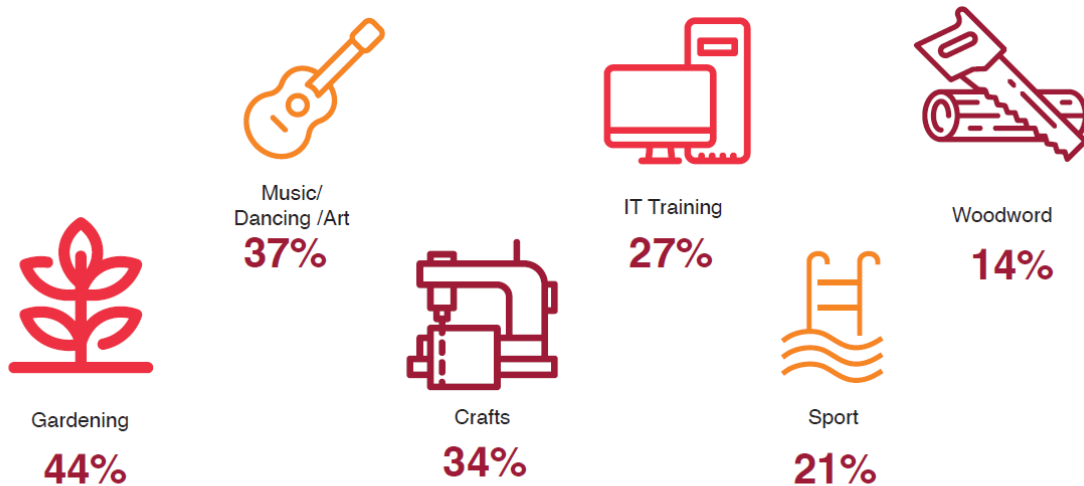

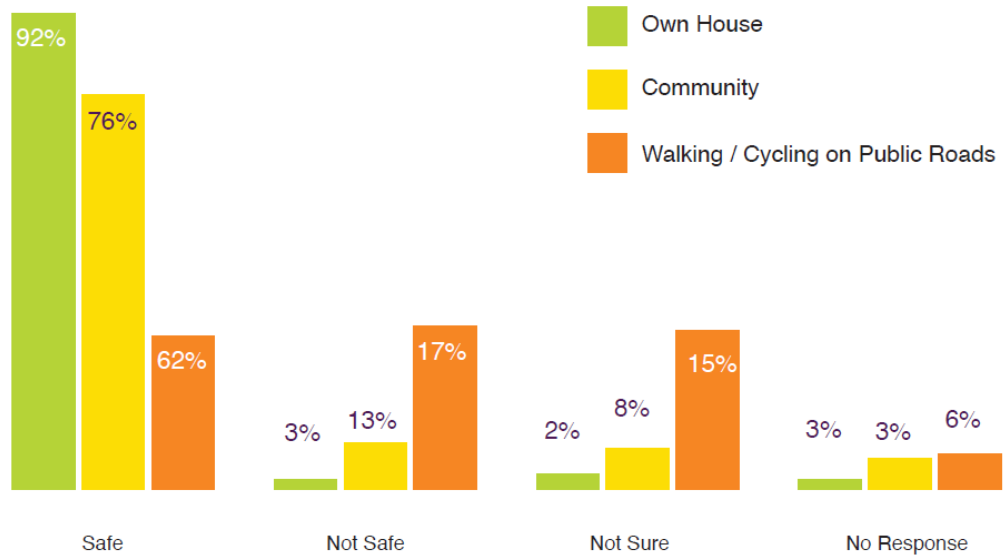

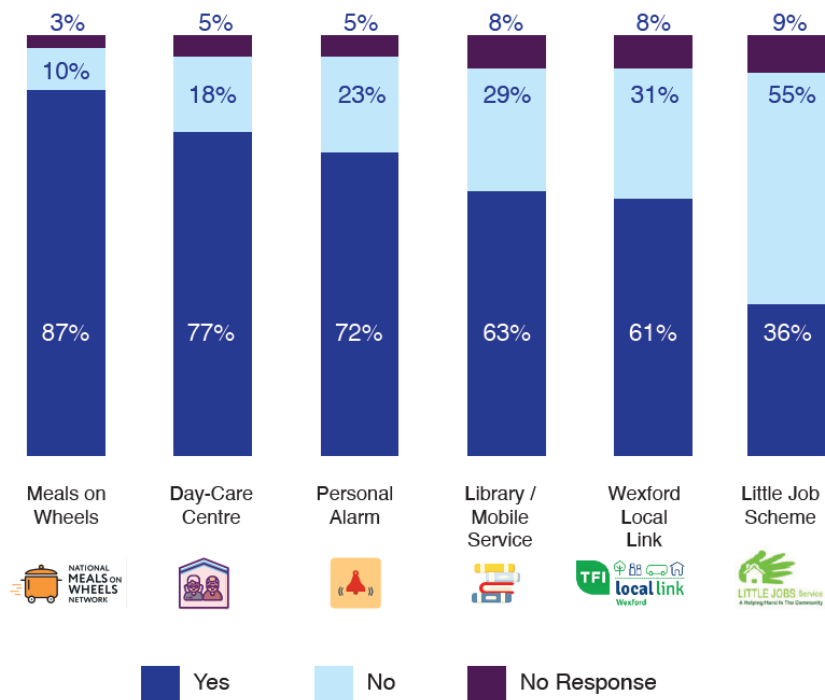
