#### 17. Notices of Motion

## 17.1 Cllr. Tom Forde

"We note with concern the rising number of needles being discarded and drug paraphernalia waste in Wexford from intravenous drug use and we ask for the strategic installation of needle and drug waste bins.

We also ask that Wexford County Council seek information from the HSE and explore the possibility of a Needle & Syringe Programme as a health promotion intervention grounded in the harm reduction philosophy."

### 17.2 Cllr. Barbara-Anne Murphy

"I call on Wexford County Council to clean, repair or replace dirty and damaged road signs, as appropriate, throughout the county over the coming months. Many road signs are so dirty, faded or damaged that it is almost impossible to read them."

#### 17.3 Cllr. Aoife Rose O'Brien

"This Council calls on the Department of Finance to introduce a shared risk model or subsidy to support homeowners of thatched roof cottages; noting the growing crisis thatched homeowners are facing due to increased premiums, a lack of insurers providing cover for these properties and subsequent issues which act as a barrier for these homeowners to sell their properties."

#### 17.4 Cllr. Leonard Kelly

"This council resolves that the Chief Executive write to the Department of Housing to request increased and multi-annual funding for the local authority Energy Efficiency Retrofitting Programme, in order to more effectively reach national climate targets and deliver much-needed regeneration to social housing in the area."

### 17.5 Cllr. Pip Breen & Cllr. Donal Kenny

"With winter approaching we would like to call for an urgent review of the Ash die back situation on our Public roads. The older and bigger trees are now being affected and pose a serious risk to road users power lines and telecommunications networks we call on Co Councils, Departments of Transport, Agriculture and Environment to coordinate a plan to deal with this crisis unfolding on our roads."

### 17.6 Clir. Ger Carthy

"Cllr Ger Carthy calls on Wexford Co Council/ TII to carry out an urgent traffic flow review. This is to include the Wexford town ring roads Drinagh-Whitford-New Ross roundabout and similar data obtained from the Newtown Road."

## 17.7 Cllr. Barbara-Anne Murphy

"I call on Wexford County Council to survey all street lighting and clean those that need cleaning; repair those in need of repair and remove branches and other growth that is blocking the light to the areas below. This is especially needed as the more energy efficient lighting does not illuminate as widely as the older lights."

## 17.8 Cllr. Robbie Staples

"In recognising the critical role that rural areas and villages play in the social, cultural, and economic life of County Wexford, and the need to ensure equitable access to safe, connected infrastructure for residents and visitors alike.

Wexford County Council calls on the National Transport Authority (NTA) to commit to allocating a minimum of 20% of all funding received from the National Transport Authority (NTA) for active travel and public realm works directly to rural areas and villages."

## 17.9 Cllr. Leonard Kelly

"That Wexford County Council request the Executive to carry out a feasibility study into the establishment of a major family-friendly summer music/cultural festival in Wexford Town.

The study should explore the potential to:

- Attract both national and international audiences.
- Build on the legacy and goodwill created by the hosting of Fleadh Cheoil in 2024 and 2025.
- Appeal to a different demographic than the existing festivals held in Wexford, thereby broadening the town's cultural and tourism offering.
- · Assess venues, infrastructure, economic benefits, and funding opportunities."

#### 17.10 Cllr. Aoife Rose O'Brien

"We, The Rosslare Municipal District, call on Wexford County Council to provide a fair share of housing developments, committing to increase the supply allocated for the RMD; noting the shortfall received to date compared to other districts"
