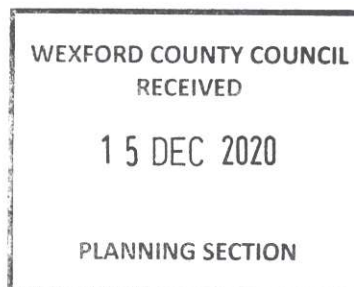

Application to the Environmental Protection Agency for an Industrial Emissions Licence**

Dear Sir / Madam,

Notice is hereby given in accordance with the EPA Act 1992 as amended, that Glanbia Ireland DAC, Rocklands, Wexford and Nutricia Infant Nutrition Ltd, Rocklands, Wexford, intends to apply to the Environmental Protection Agency (EPA) for an industrial emissions licence for the WWTP installation located at Maudlintown, Rocklands, Wexford (National Grid Reference E305923, N120353).

The class of activity of the Industrial Emissions Directive to be carried out at this jointly owned facility is:

Class 13.6: Independently operated treatment of waste water (to which the Urban Waste Water Treatment Regulation 2001 do not apply) and discharged by an installation to which Part IV applies.

An Environmental Impact Assessment Report relating to this activity, which has been submitted to Wexford County Council will be submitted to the Agency as part of this application.

The environmental impact assessment report submitted to the Agency in accordance with section 83(2A)(d) of the Act of 1992, any information provided to the Agency under paragraph (e) or (f)(ii)(II) of Section 83(2A) of the Act of 1992, any opinion issued by the Agency under section 83(2A)(de) of the Act of 1992 on the scope of the environmental impact assessment, and any further information, including reports and advice, relating to the environmental impact assessment as may be furnished to the Agency in the course of the Agency's consideration of the application, shall each be made available on the Agency's website and at the headquarters of the Agency.

Submissions may be made in writing to the Agency in relation to the likely effects on the environment of the proposed activity within the period specified by the Agency on its website under
