## **Summary of Main Issues and Chief Executive's Response**

### **Submission WXF-C3-156**


Larry Dunne (WXF-C3-156) states that the addition of certain post boxes to the RPS is a good initiative but the Planning Authority should also consider adding other small objects of interest e.g. roadside milestones, feeding troughs, wells, churn stands, The Heap of Crosses in Ballygrangans, Kilmore. Mr. Dunne states that a public campaign to invite submissions of local features of interest should be considered. He also notes that many fine structures throughout the County are falling into decay and that more financial incentives are needed to conserve such structures.



### **Submission WXF-C3-156 – Chief Executive's Response**



It is not feasible to protect all post boxes and features of interest. These are important elements that add to the cultural heritage of county Wexford but adding to the list of protected structures would add an additional consent process e.g. leaving a new cross at Ballygrangans would require consent from the planning authority. It is important that such features and community practices are highlighted but this may be an appropriate a role for the Heritage Plan for the County which will be undertaken as an objective of the plan (HT01). It is recommended that such structures are not added to the Record of Protected Structures.


