HOUSING

Housing Strategy & Services

Under the Housing for All Programme 2022 to 2026, Wexford County Council must build a minimum of 1,159 new housing units within the programme timeframe. The status of overall programme delivery, which includes new built and leasing, is contained in the diagram below. (1,190 below includes leasing)

It is the Council's intention to continue to deliver new housing, above the target provided under the programme, where demand exists and Department funding is available. The following tables outline the current delivery pipelines and status on projects. For LA Direct Build information, please refer to the Capital Development section of the Chief Executives Report.

Turnkey Delivery - The Housing Section periodically seek Expressions of Interest for the provision of social housing units via Turnkey Acquisition. The next Expression of Interest will run from 14th January to 26th February inclusive. All calls are seeking targeted delivery of smaller unit types (1 & 2 beds) in areas of need identified in the Housing Delivery Action Plan (HDAP). In addition, the process also seeks proposals for purchase of land in areas of need. All proposals received by Wexford County Council under the turnkey process are assessed by an Internal Assessment Committee.

Energy Efficiency Retrofitting Programme 2026 is the sixth year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets and number of properties delivered and funded to date, under this programme.

HOMELESS SERVICES AND SUPPORT UNIT (HSSU)

The figures below represent the total number of calls to the HSSU - it is not reflective of the number of individuals/families as quite often the same client may make multiple calls to the HSSU.

There were 1442 calls to the HSSU up to 31st December 2025, breakdown of same:-

1049 (73%)	Provided with advice and support in relation to housing and homeless prevention
155 (11%)	Supported with temporary, short, medium and long-term accommodation and tenancy sustainment support through Place Finder and Social Care Workers
222 (15%)	Calls were ineligible at the time for housing/homeless services. HSSU advised and assisted the caller on regularization of their housing situation.
16 (1%)	Calls received where it was not possible to complete a full assessment.

AFFORDABLE HOUSING



December 05th - Minister for Housing, Local Government and Heritage, James Browne TD, officially launched the fourth new affordable housing project in County Wexford in 2025.



Minister Browne, who was accompanied by the Cathaoirleach of Wexford County Council, Cllr. Joe O'Sullivan joined the Cathaoirleach of the Enniscorthy Municipal District, Cllr. Barbara Ann Murphy,

Elected Members of Enniscorthy Municipal District, Chief Executive of Wexford County Council, Eddie Taaffe, senior housing officials from Wexford County Council and representatives of the Anthony Neville Homes Team at the programme launch.

This new phase of homes, delivered by Anthony Neville Homes in partnership with Wexford County Council will provide 16 much-needed homes in Enniscorthy.

This phase of the development launched includes 12 two-bed houses, 3 three bed houses and 1 four-bed unit. The 16 homes will be made available to eligible buyers through the Local Authority Affordable Purchase Scheme, which is managed by Wexford County Council. Applications will be accepted via an online portal which will go live on Wednesday 21st January 2026 at 12pm.

Cathaoirleach of Enniscorthy Municipal District, Cllr. Barbara Ann Murphy joined the elected members from the Enniscorthy Municipal District, to launch the affordable housing information event in advance of the upcoming application portal launch in January.

The event was an opportunity for applicants to learn about the affordable housing scheme and the application process.

Expression of Interests for Building Contractors and Housing Developers - for the delivery of affordable housing in County Wexford.

This call is targeted at advance purchase opportunities for a minimum of 10 dwellings in any one scheme. Please note that Part V of the Planning and Development Act 2000 as amended applies.

Please submit a completed Expression of Interest Application Form as soon as possible **but no later than Wednesday 18th February 2026 at 4.00pm.**

Applications for Cnoc na Greine may be made from 12pm on 21.01.2026

Eligible applicants will be prioritised based on Wexford County Council's Scheme of Priority.

The purchasers will enter an affordable dwelling purchase arrangement with Wexford County Council under this arrangement the Council will take a percentage equity share in the dwelling equal to the difference between the market value of the dwelling and the purchase price, expressed as a percentage of the market value of the dwelling.

The Council may not seek realisation of its affordable dwelling equity for a 40-year period (other than for breach of the agreement). However, the purchaser may choose to redeem or buy out the affordable dwelling equity at any time by means of one or a series of payments to the Council.

In relation to 30% of the dwellings as per Wexford County Council's scheme of priority, the time of application will be one of the criteria on which eligible applications will be prioritised under the Council's Scheme of Priority. This means that eligible applications received first will be given priority.



Choice Based Letting - 204 properties were advertised on the Choice Based Letting website from 01/01/2025 to 31/12/25. As multiple properties were available in some cases, a total of 299 properties were available for allocation. Number of Views & Expressions of Interest are as per table below:-



ECONOMIC DEVELOPMENT



The Invest Wexford brand was established by WCC to promote County Wexford as a competitive and attractive destination for both foreign direct investment (FDI) and domestic enterprise leveraging its strategic connectivity, cost competitiveness, local support eco system and exceptional quality of life. Following a recent e-tender process, O'Connell Marketing has been appointed as the successful tenderer for the provision of services for digital review and development of a marketing strategy for Invest Wexford. The aim is to reposition Invest Wexford's marketing tools having regard to the new requirements of the business eco system with a key focus on digitalisation.

The project is to be delivered in two phases: (1) a review and refresh of the brand's digital assets and channels, followed by (2) the development and implementation of a sustainable, results-driven digital communications strategy.

LOCAL ENTERPRISE OFFICE

In 2025, Local Enterprise Office Wexford strengthened its role as a key driver of enterprise development in the county. The year demonstrated how sustained investment, targeted capability-building and strong stakeholder engagement have created a high-performing and increasingly competitive entrepreneurial environment in County Wexford.



The year opened with strong national representation as five Wexford creative enterprises featured at Showcase in the RDS following intensive preparation supported by LEO. This early momentum was reinforced in March with €1.76 million Enterprise Ireland funding allocation, an increase of €183,500 reflecting growing demand for digitalisation, energy efficiency and management development supports. The introduction of the Market Explorer Grant further enhanced opportunities for first-time exporters entering new international markets.

Local Enterprise Week highlighted the depth and diversity of Wexford's business ecosystem, with 11 strategically focused events addressing start-ups, scaling, digital transformation, sustainability and women in enterprise. Collaboration continued throughout April with an SME roundtable event, bringing 40 local companies into structured engagement with LEO and industry experts.

Wexford gained national visibility in May as Mór Taste represented the county at the National Enterprise Awards, showcasing the county's growing strength in food innovation. LEO Wexford reinforced its commitment to early-stage enterprise through its sponsorship at the County Wexford Business Awards. Sectoral development remained strong throughout the year, with three companies progressing through the SuperValu Food Academy and significant national exposure generated at the National Ploughing Championships. Food producers achieved outstanding success at Blas na hÉireann, securing 31 awards showing a clear return on long-term investment in product quality, innovation and capability.

Capability-building continued at scale, with the Management Development Programme, Export Accelerator Programme and specialist Retail Masterclasses supporting business leadership, export planning and strategic growth. This was further enhanced by the launch of Tap Retail supporting 14 retailers in Enniscorthy to enhance their digital presence. A new partnership with SETU under the TU Rise Programme brought targeted business clinics to rural enterprises in Rosslare Harbour Community Enterprise hub, ensuring balanced regional access to high-impact supports. National Women's Enterprise Day further strengthened networks among more than 100 female entrepreneurs.

Looking over the past eleven years, the impact is clear and data-driven. Employment in LEO-supported companies has increased from 1,070 in 2014 to 1,945 in 2024 an 82% rise. More than 1,550 net new jobs were created during this period, with positive net job creation recorded every year. The results of the employment survey for 2025 will be announced in the end of January 2025. Client numbers grew from 170 to over 230, reflecting a larger, more stable, and more resilient enterprise ecosystem.




Progress of the 2027 Year of the Normans Project


The County Norman Forum Steering group chaired by An Cathaoirleach, Cllr. Joe Sullivan met on Monday 15th December to review progress. The Tourism Officer gave a presentation on the new branding and marketing collateral and details of potential projects that have been submitted from the 5 districts. It was agreed that details of these projects will be shared with Anne-Cécile, International Relations Officer to look at potential collaboration opportunities as the project lead must be based in Normandy. A successful joint submission was made in June 2025 between Wexford County Council and Visit Wexford in partnership with Le Cotentin to host a vibrant interactive showcase at the Norman Food and Crafts Fair. The project is titled “The Village of Guillaume” which will take place in the Village of Barfleur Le Cotentin in July 2027. The next funding call for submission of projects closes on the 31st January 2026.

The funding call is open to stakeholders from France, the United Kingdom, the Channel Islands, Ireland, Southern Italy, Sicily, Norway, Denmark and Flanders to contribute projects towards shaping the programme for this landmark commemorative year.

Planning applications received 1st January to 31st December 2025





Forward Planning

Housing Growth Requirements

The National Planning Framework – First Revision, which issued in April 2025, identified a need to provide 50,000 housing units per annum in the state. The Minister for Housing, Local Government and Heritage subsequently issued Section 28 Guidelines to implement this target. The Guidelines identify Housing Growth Requirements (HGR) for each County. County Wexford has been allocated the fifth highest percentage increase nationally under the new HGR with an increase from 1,072 units to 1,622 units per annum for the period 2025-2034. The Guidelines also allow for additional flexibility in terms of headroom/additional provision, increasing from 25% to 50% over required zoning.

Local Authorities are required to review the Core Strategy in their existing County Development Plan (CDP) and, if necessary, amend it to accommodate the revised housing targets. Local Authorities must also review the quantum of land zoned for residential purposes within their functional area and determine whether there is adequate zoned land available to serve the revised targets. Where it is found that there is not adequate land zoned, local authorities are required to vary their plans to address this.

Work is well advanced and the Chief Executive will submit a report to the Members outlining his recommendations on the method by which it is intended to implement the revised housing targets. This will take the form of a series of variations to the CDP to increase the supply of zoned land. The first variation to the CDP will deal with the revisions required to the Core Strategy and land use zoning and objectives for Enniscorthy Town and New Ross Town.

Workshops were held with the Members of Enniscorthy and New Ross Municipal Districts on the 16th and 17th of December respectively. It is anticipated that the variation will go to the Members at the end of January 2026 and for public consultation in early February 2026.







Projects funded under Measures 1,2 and 3 of the 2024 TCF Suite of Supports are now complete and funding drawn down from the DRCDG.

Under Measure 1 we have Town Teams established in Castlebridge, Taghmon and Bunclody with meetings scheduled for 2026. We anticipate further roll out of TCF initiatives with these Town Teams in 2026.

Under Measure 2 we have a Town Centre First Plan in Place for Courtown/Riverchapel and we continue to meet as a Town Team and we will continue to seek funding streams throughout 2026 that will enable us to make this ambitious plan a reality.

Under Measure 3 works are now complete on these project development measures for the St Michaels Theatre New Ross restoration project and Bridgetown water based facility.

We had meetings in December for the New Ross and Enniscorthy TCF Teams with meetings Planned for Wexford TCF Team in January.

Further announcements on Town Centre First are expected Nationally in early 2026.





“Christmas Movie Night” in all IPAS Centres



Mental Health Services Working Group

The Mental Health Services Working Group met on four occasions last year. The Group's Terms of Reference have been agreed, and work has commenced on publicising the group and assessing the service needs for the County. The aims of this working group are to highlight the need for a 24/7 mental health crisis centre in Co Wexford, identify gaps in service provision, strengthen the voice of the County representatives of the Regional Health Forum and promote mental health services supports.

Local Sports Plan & County Outdoor Recreation Plan

Work on these plans will be undertaken concurrently. Sector 3 Solutions Ltd has been appointed as consultants to write both plans. Preparatory work has begun in compiling the systems mapping for the consultants to inform the consultation process and draft of the two plans. The plans are due to be delivered in Q2 of this year.

Pop-up Surveys

The Community Safety Coordinator completed the final Pop-up Survey of 2025 on community safety issues on the 9th Dec at the Men's Shed County Network meeting in Enniscorthy. This totals 8 Pop-up surveys completed in 2025 throughout County Wexford. 318 people participated and 91% stated they felt safe in the community where they lived. Results of all surveys will be published in Feb 2026 when work on the website is completed.

Wexford LCSP Steering Group

The Wex LCSP Steering Group had its final meeting on the 10th Dec and agreed a draft Communications Strategy and draft online Consultation Questionnaire for the 3-year Community Safety Plan. This will be presented to the members at the next meeting of the Partnership on the 29th Jan 2026 for consideration and approval.

Pilot Projects

Pilot Projects continued with the establishment of Community Intervention Teams to deal with issues of anti-social behaviour in estates in Enniscorthy and Wexford. This involved the Community Safety Coordinator bringing together An Garda Siochána, Ferns Diocesan Youth Service, WCC Housing Officers, Wexford Local Development, Slaintecare, Residents, and other stakeholders to agree a collaborative approach in tackling this complex problem.

Safe Play Areas

The Community Safety Coordinator also worked closely with WCC Housing Department, the Slaintecare Coordinator, the Wexford Traveller Interagency Group (TIG), and residents in coordinating and completing two safe play areas for members of the Travelling Community in Marsh Meadows New Ross, and Drumgoold, Enniscorthy. These projects were funded from the Dormant Account Fund.

The Partnership will continue with its work on other projects whilst developing the 3-year Community Safety Plan for County Wexford in 2026.



AGE FRIENDLY

End of Year Updates:

- In December, the Final Meetings for the Older Person Council and Age Friendly Alliance were held. Dates were agreed for meetings to be held in 2026.
- The Older Person Council raised the issue about access to Banks for the elderly in the December meeting. Members requested that a letter be sent out to the Regional Managers of each of the Banks operating in Wexford to raise this issue. This request was actioned.
- It was agreed to place an Age Friendly Memorial bench in Pierce Park. Wexford Borough Council also purchased an Age Friendly seat to be installed in that district.

WEXFORD PPN

PPN Representatives Workshop

Wexford PPN held a very successful PPN Representatives Workshop in The Riverside Park Hotel, Enniscorthy. The workshop was part of our Capacity Building Programme.

The aim of the workshop was to help Reps understand their roles and how they can effectively engage and contribute to the various County Council and non-County Council Committees they sit on e.g. Local Community Development Committee (LCDC), Strategic Policy Committees (SPC's), Town Centre First Committees, Local Community Safety Partnership (LCSP).

It was also a great opportunity for our representatives to meet up and share knowledge and experiences. Training was delivered by Jamie Moore.



Wexford Sláintecare Healthy Communities Programme (SHCP)

Georgia Southern Visit:

On 11 December, the SHCP Local Development Officer met with representatives from the Institute for Health Logistics & Analytics as part of a Georgia Southern visit. The programme included site visits to SHCP-supported initiatives, including Parable Gardens, where SHCP funds an education project enabling young people to engage with nature and green therapy.

HILG In-Person Planning and Review Session:

Healthy Ireland Local Government's National Office hosted an in-person Planning and Review Session for all SHCP Local Development Officers and Healthy County Representatives in Whites Hotel, Wexford in December. The session reviewed programme progress for 2025 and supported strategic planning for 2026.



Traveller Wellbeing Through Creativity – Programme Launch:

SHCP Local Development Officer attended the online launch of the Traveller Wellbeing Through Creativity Programme in December. This national initiative supports creative approaches to health and wellbeing within Traveller Primary Healthcare Projects and Traveller organisations and is being embedded within the HSE. The programme is delivered in partnership with the HSE, The Arts Council, Creative Ireland and Healthy Ireland. Applications are now open.



Opera For All – Review Meeting:

A review meeting was held on 5 December with Wexford County Council's Community and Arts Sections and Wexford Festival Opera to assess the success of the 2025 'Opera For All' initiative. The programme successfully engaged local communities and disadvantaged groups through outreach workshops and access to Wexford Festival Opera performances. Planning for 'Opera For All' 2026 was also discussed.

UCD One Health Conference:

The SHCP Local Development Officer attended the UCD One Health Centre Annual Conference on 9 December at O'Reilly Hall, UCD. The conference brought together national and international leaders across public health, policy, academia, agriculture and environmental sectors, providing a valuable opportunity to engage with emerging One Health research and policy developments.

Enniscorthy Municipal District Presentation:

On 16 December, the SHCP Local Development Officer presented to the Enniscorthy Municipal District Meeting, outlining programme progress in the district during 2025 and proposed plans for 2026.

ENVIRONMENT

COASTAL MATTERS

Seaview Coastal Protection project is in its final stage with beach access to commence shortly. Precast concrete segments for the beach access are now half complete.

Fethard Harbour New Slipway and Beach Access - The Department of Environment, Climate and Communications is in the process of finalising a decision on this project. The revised Natura Impact Statement (NIS) is being reviewed by the Foreshore license section.

Kilpatrick temporary beach access completed in April. Meeting with NPWS took place on 3rd November 2025. AA Screening Report, Hydraulic & Survey reports are ongoing.

Killmannock Drainage works: Hedge cutting, surveys have been carried out, Wayleave application is being progressed to access drainage works area.

Ballyhack & Passage East Car Ferry Infrastructure: AYESA consultant has been appointed and kick off meeting took place on 10th December.

Ballyconniger & Clone bridges now removed.

Rosslare CRFRS: Ongoing, 2nd Public Participation Day likely to be Q1 2026.

Cahore North Beach Rock Armour Enhancement: Preliminary drawing and ecology reports being prepared, Public Information evening took place in Ballygarrett GAA club. Works due to be carried out Q1 – Q2 2026.

DAFM Funding - We were allocated a total of €690,000 for Pier & Harbour projects by the Department of Agriculture, Food & Marine for projects in Duncannon, Slade & Courtown Harbours. 75% is funded by the Department, 25% co-funded by WCC.

Application almost complete rechecking possibility of any initial planning circa 2002/ 2003 with Municipal office. Reviewing files received in Early December around marina planning prior to finalizing application.

Marine Usage License (MUL) application for the Barrow pre dredging surveys. No definitive timeline from MARA. No further update.

Explosive bye laws all responses now received from Dept of Defence, KK COCO and AN GS. No issues to report and all submitted along with the responses to public consultation to Dept of Justice in December. Dept of Justice plan to come for a site visit 1st or 2nd week of Jan to confirm no changes since the initial site visits were conducted two years ago.

Hydrographic Services contract closed on Dec 12th, and decision submitted to procurement on December 17th. Contract to be awarded shortly.

Low Smoke Fuel Areas - The 5 stations in Bunclody, New Ross, Wexford, Enniscorthy & Gorey have now had their monitors updated to measure air quality and noise levels. A new station has been installed in Bunclody and is fully operational. The 18 low-cost sensors installed in Enniscorthy monitoring PM10 & PM2.5 have been removed to be calibrated. The TownAir Project to monitor gases NOx, SO2, CO has now been completed. This will be compared with 2016 levels taking during the SAFFIRE project. The project team will give an update once the work has been completed. There has been 15 inspections of premises / forecourts / shops who are all selling compliant product.

Air -Volatile Organic Compounds (VOC's)

DECO Paints: Auto-Refinishers Q4 Website Compliance Register will be updated in December. Site inspections are ongoing, 8 re-Certified since September. 3 Sites identified for enforcement in Q4 report that they have ceased operating, WCC will continue to monitor status. 1 un-registered site to be inspected in December.

Dry Cleaners: 5 Dry-Cleaners currently registered, 5 of whom are Certified. 2 non-registered premises identified 1 has been Inspected and is now undertaking assessment for certification. 1 to be inspected in December.

Petrol Stations - PVE emissions: Stage 1 testing & compliance: 9 Inspections since September; 2 Stations have ceased trading. 5 re-certified. 2 Stations awaiting final assessment reports. Q4 Register will be updated in December.

Agriculture - Wexford County Council continue to undertake a significant number of farm inspections under the National Agricultural Inspection Programme. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 are served upon farms where major non compliances are observed and are open to cross reporting to DAFM.

Under the National Agricultural Inspection Programme, Wexford County Council carried out a total of 167 farm inspections in 2024 and the target has risen to 271 inspections in 2025 concentrating in areas where water quality was most at risk of not meeting its objectives under the WFD. A total of 245 of these 271 initial GAP inspections have been carried out to date. A team of 4 Assistant Scientists take on this role lead by the Agricultural Scientist in the Environment Section. A total of 379 farm inspections have taken place altogether up to the end of October under GAP regulations, Sludge use in Agriculture, complaints made by the public, initial and follow up. The team continue to work in Aughboy, Mangan, Boro, Owenduff, Heathpark & Begerin catchments for 2025.

A total of 110 Agricultural related Planning Permission Applications have been assessed in 2025 highlighting the continued investment in Wexford Agriculture and maintaining compliance with Good Agricultural Practice Regulations.



CLIMATE ACTION

WCC is behind on our glide path for Thermal and Transport emissions. If HVO is not used for our fleet, in a significant way, Wexford County Council will not meet our CO2 target of 51% reduction by 2030. Currently we are above CO2 emissions from the baseline years of 2016-2018, so we now require over 51% reduction by 2030. The Machinery Yard now is obtaining HVO rates from Inver.

1. Two SMEs who attended the Energy Information Event in Gorey have progressed to SEAI audits and Energy efficiency grants through the Local Enterprise office.
2. Approx 30 people attended the Energy information Event in Courtown. This event was for both Businesses and homeowners and was organized as a result of the Gorey event.
3. The Climate Action team in conjunction with Jacinta Barrins course provider have produced a short video clip to promote the Over 55s Climate Course in the new year.
4. Eco Driving for drivers of WCC fleet vehicles is well underway. The drivers identified for training have completed the Module 1 theory training and a number of drivers have also completed Module 2 Practical training. 5. Staffing costs associated with the Climate Action Team were successfully recouped from the DCEE in December 2025.
6. Wexford County Council announced a circa €1.6m (gross) energy retrofit of the Apex Leisure Centre in New Ross. This ambitious retrofit project funded through the Sustainable Energy Authority of Ireland (SEAI) Pathfinder Programme grant, match funded by Wexford County Council, aims to decarbonise the leisure centres heating systems, improve the buildings overall energy efficiency while reducing its operational running costs. The primary objective of the SEAI Pathfinder Programme is to contribute towards Wexford County Council's ambitious 2030 Carbon Emissions and Energy Efficiency Targets as set out in the Wexford County Council Climate Action Plan.
7. The Climate Team in conjunction with the Energy Officer and Environmental Awareness Officer highlighted and promoted the Christmas Energy Shutdown and posted a quiz on the Climate & Energy Intranet page on the energy savings from the 2024 shutdown which amounted to over 10,000 savings in kWh and 2.6 tonnes of CO2 eq. The CAT sponsored the prizes for the quiz.
8. Staff from all sections are inputting into the Climate tracker with details on the progress on their actions for 2025. The information in the tracker will be used for various reporting requirements.
9. The Climate Action Southeast Sub-region Operational Committee meeting was held on 9th December. Notice was given by CARO of a number of reporting requirements on the LACAP and KPIs coming up in Q1 2026 including
 - Climate Action KPI 2025 data collection
 - CAP Implementation Report 2025
 - LACAP KPI Return Data – 2025
10. SPC November meeting showed good interest in the Georgia Southern University possible research project on real-time out of season water quality testing for a pilot area.

11. The Environment Awareness Officer Cliona Connolly presented at the December CASG meeting on the sustainability of the Fleadh and gave a comprehensive overview on other sustainable and circular projects and initiatives underway and completed.
12. Wexford Sustainable Energy Community won an award at an SEAI event. The Climate Action Team were involved with this group in running some of their events in 2023/2024.
13. The Climate Connected Web Tool was Launched in Galway on Monday 8 December 2025. ClimateConnected.ie provides an accessible, user-friendly web tool that guides people through their home energy use, transport habits, shopping patterns, diet and waste management—helping users identify their biggest emission sources and explore realistic pathways to reduce them, both as individuals and as part of community action. WCC contributed to the DZ element of the project with information on projects in Enniscorthy DZ.

COMMUNITY CLIMATE ACTION PROGRAMME (CCAP)

The application window for Phase 2 of the CCAP closed on Tuesday 16th December. Wexford County Council has been allocated a further €669,000 under Phase 2 for not-for-profit organisations to undertake Climate Action projects.

The CCCAP Phase 1 projects are progressing well with 8 of the 16 Phase 1 projects fully completed.

Biodiversity

The actions developed in the making of the Wexford Draft Biodiversity Action Plan have been screened for Appropriate Assessment and Strategic Environmental Assessment. The outcome of the screening process has determined that the actions set out in the draft plan are not likely to have significant negative effects on the environment and, therefore, that Strategic Environmental Assessment (SEA) is not required. Similarly, no impacts are considered likely as a result of the draft actions on the conservation objectives or overall integrity of Natura 2000 sites (European Protected Sites) due to the scale and nature of the works, lack of connectivity or distance to any Natura 2000 sites. It is therefore considered that Stage 2 Appropriate Assessment is also not required. The draft plan will now be translated into Irish and prepared to go on public display in February 2026 for a period of six weeks.

Local Biodiversity Action funding amounting to €96,000 has been announced from the Department of Housing, Local Government and Heritage. This fund is available for the Council's Biodiversity officer to apply for to cover County wide projects such as the Wetlands Survey of Wexford (phase 4), Swift surveys of the County, Invasive species surveys and control, biodiversity events and awareness raising and the Return to Nature and Hare's Corner projects which support faith communities, landowners and community groups to implement actions for enhanced biodiversity on their lands.

The Hare's Corner, an innovative biodiversity initiative coordinated by Burrenbeo Trust, in conjunction with Wexford's Biodiversity Office, is being rolled out this coming year to landowners in County Wexford. Inspired by the term 'The Hare's Corner' - an old farming expression for an awkward section of a field which wasn't intensively farmed and so was 'left to nature' - the aim of this project is to help create habitats that have proven benefits to biodiversity, climate-action as well as to the wellbeing of participants.

The Hare's Corner project offers landowners (private landowners, farmers, schools/community groups) easy to apply for supports to carry out simple but impactful actions for biodiversity such as creation of a wildlife pond, native mini-woodland, heritage mini-orchard, wildlife hedge, or bespoke 'plan for nature'. This support is offered in the form of materials (native trees and heritage apple trees), micro-funding (e.g. machinery costs for pond digging), and specialist advice and guidance. LIBRARIES, ARCHIVES AND ARTS

Library Development Plan – Public Consultation

As part of the preparation of a new Library Development Plan 2026-2030, public consultation sessions continued in Wexford Libraries branches throughout December. Members of the public shared their thoughts on the services they would like the library service to provide over the next five years. An in-person staff planning day was also held in December. Public surveys for adults and for teenagers will be available online and in hardcopy in early January.

READING AND LITERACY: RIGHT TO READ AT YOUR LIBRARY

Family Time at Your Library - is a fun reading initiative that takes place during December in libraries throughout the country. The events are aimed at supporting a family-focused approach to reading with children, as part of the national Right to Read programme and to increase awareness of the benefits of reading and promote reading as a fun, recreational activity for children. The whole family are also introduced to collections of children's books, e-books and e-audio books.

This year Wexford Library Service branches held a variety of events including:

Moo Music Workshop: an interactive workshop where 0-4 year olds sing, dance, play and learn.

Flossie McFluff Saves Christmas: Illustrator Audrey Dowling read from Flossie McFluffs' latest adventure and taught the participants how to draw the characters from the book.

There were also storytimes, craft sessions and Mrs Claus visits in all Wexford Libraries branches throughout December.

Fabulous Festive Storytime with Helena the Storyteller: - Professional storyteller Helena treated the young school starters to a festive storytime in New Ross and Gorey Libraries.

Little Irish Folklore Friends: - Junior Infants from Scoil Mhuire, Coolcotts visited Wexford Library for a storytime and craft with author Niamh Donnellan.

Ireland Reads Day - this is an initiative of the Government of Ireland to celebrate the joy of reading. It is funded by Healthy Ireland and supported by public libraries and other organisations that promote reading, literacy and the arts. Ireland Reads Day 2026 will be on Saturday 28th February 2026.

A Very Austen Quarter-Millennium - To celebrate Jane Austen's 250th Birthday Enniscorthy Library held a creative morning where adult participants got to enjoy a selection of colouring sheets, made their own bookmark, and worked on their own craft and needlework projects.

Wexford Local Development

The Elevate Programme continued over two days each week in December in Enniscorthy Library. This programme focuses on creative writing with the Elevate book club participants, the programme is sponsored by Wexford Local Development to promote & support educational achievement in County Wexford and facilitated by local author Caroline Busher.

Book Buddies Inclusive Book Club continues in Gorey Library.

Schools - Wexford Libraries branches continue to liaise with local schools and Early Learning Centres and cater for weekly class visits for story-times, general book borrowing, and library activities. They also continue to provide Outreach visits in their local areas.

Christmas Carols - New Ross and Gorey Libraries held carol services during the month provided by local groups of Ukrainian performers and the Gorey Choral Group.

Art Exhibition - Paintings by local artists Maeve Holmes, Deirdre O'Keeffe, Marianne Kenny, Trudi Doyle and John Kehoe were added to the ArtBank exhibition in Bunclody Library.

LEARNING AND INFORMATION

Age Friendly - Wexford Library held Age Action one-to-one IT training sessions while New Ross Library held Age Friendly Digital Literacy classes run by WWETB. Gorey Library hosted a Christmas themed "Happy To Chat" coffee morning and a retro Movie Matinee.

Library eResources Clinics - Wexford and Enniscorthy Libraries held staff led clinics during December demonstrating the range of online resources available to library members.

Volunteering Information Session - John Bird, the development and placement officer with the Wexford Volunteer Centre, held information sessions in Enniscorthy & Wexford Libraries for members of the public who were interested in volunteering in their communities.

Skills for Life - Digital support classes continued in Wexford Libraries branches in December led by a WWETB tutor. Alan Maher of Maher Consulting delivered a talk in Gorey Library on the basic legal and regulatory requirements for starting and operating a small business.

HERITAGE AND LOCAL HISTORY

Norman Influence in North Wexford - Gorey Library held a talk with the Wexford Normandy Cultural Association during December. The speakers were Barry Lacey and David McIlreavy. Seventeen local studies enquiries were responded to, together with a total of thirteen genealogy enquiries completed in Wexford Library in December. Two updates were made to the Wexford Great War Dead website.

Book Launch - Wexford Library held two book launches during the month.

Enchanted to A Stone: The de Lacy Family of Oulart in the Revolutionary Period by Brian Ó Cléirigh
Irish Merchant Ships and Shipowners by Terry Conlan, launched by Capt. Sean Boyce.

ENVIRONMENT AND CLIMATE ACTION

Wexford Science Café - Wexford Library held a panel discussion during December about Solar Farms on the Rise. ESB Renewables, Sean Moroney and Feargal Desmond, took the audience through the issues of larger-scale solar energy facilities and plans for the Wexford Solar Hub, based on four linked farms. On 20th January the Café will hold a session for school-leavers and their parents and teachers, in which they will discuss possible paths to careers in science and technology.

Christmas Jumper Swap - For the month of December Wexford Library offered the public a way to reuse and recycle by inviting them to donate or swap their Christmas jumpers.

Upcycled Christmas Wreath Workshop - An evening of upcycling took place in Enniscorthy Library where participants spent the evening transforming pre-loved denim into a seasonal, sustainable wreath.

ARCHIVES

Collections management - In addition to 32 research enquiries via email, telephone and post, four researchers visited the Archive during December. Research topics included the formative years of Wexford Festival Opera for a dissertation (1951-55); research on the Moulton surname in Co. Wexford; information on Hugh McGuire who was Mayor of Wexford for three successive years, 1892-94.

Acquisition - The Archive actively acquires primary school archives from primary schools across County Wexford to safeguard same for their significant value as historical and genealogical resources. Extant registers and roll books (1897-1970s) for Rathgarogue National School, New Ross were deposited in the Archive in late December.

Outreach - Following the launch of Brian Ó Cléirigh's book, Enchanted to a stone, in Oulart Community Centre on 3 December, the Archivist presented an Oulart-related artefact that displayed on the evening – a ceremonial silver trowel from the county archive collection that had been used by Fr Patrick Kenny, PP in the laying of the foundation stone of a monument in Oulart village in 1898 to the memory of the heroes of 1798.

Small Arts Festival and Fáilte Ireland Festival Open Call 2026

Wexford County Council Arts Office has announced two strands to the Festival Grant Scheme for the Small Arts Festival grant and the Failte Ireland Small Festival Grant to take place in 2026. Deadline for receipt of applications for both was 1st December 2025 . This scheme is supporting 24 festivals across the county with grants ranging from €1,500 - €3,000 in 2026.

Artist in the Community Artist Panel Open call for 2026 – 2027

Wexford County Council Arts' Office held an open call seeking professional artists across all art forms to be on a panel for the design and facilitation of Art Projects with communities throughout County Wexford in 2026 through the Artist in the Community Scheme. Thirty five artists were selected following this call.

Tyrone Guthrie Centre Bursary 2026 - Wexford County Council Arts' Office is offering two bursaries in 2026 for artists who are resident in County Wexford at the Tyrone Guthrie Centre. The Tyrone Guthrie Centre is a dedicated residential workplace for artists in County Monaghan. Each Bursary will cover full board and lodgings for a one-week residency plus a €300 stipend. This opportunity opened in December 2025 and the closing date is 27th January 2026.

Drama League of Ireland Bursary 2026 - Wexford Arts Office are offering two scholarships in 2026 for the Drama League of Ireland Residential Summer School which takes place at the University of Limerick, Saturday August 1st – Saturday August 8th 2026. The scholarship, valued at €695, will cover the cost of a residential place at the Summer School and includes tuition, accommodation and meals. This opportunity opened in December 2025 and the closing date is 27th January 2026.

Irish Writers Centre National Mentoring Programme 2026 - Wexford County Council Arts' Office is offering two places for the Irish Writers Centre's National Mentoring Programme (NMP). This programme offers two Wexford writers the opportunity to receive sustained creative and professional support from an established Irish writer of their choosing. This opportunity closed on 31 December.

Artlinks Bursary Award 2026 - Wexford County Council Arts' Office announced the Professional and Emerging ArtLinks Bursary Awards 2026, it opened for applications in December. These Awards are designed to support artists to develop their practice by providing them with the time and resources to think, research, reflect and critically engage with their art. Wexford Arts Office partners with Carlow, Kilkenny and Waterford local authorities on this award.

Cowhouse Parenting Residency Programme 2026 - Wexford County Council Arts' Office in partnership with Cow House Studios is pleased to offer a two-week residency designed specifically for parenting artists. The Parenting Artist Residency makes it possible for awarded artists to dedicate time to their work by offering childcare and supports during the residency. The deadline has passed.

SETU 3rd Year Exhibition – Westgate Heritage Centre - Wexford County Council Arts' Office hosted the 3rd Year SETU students for their weeklong exhibition 'Hidden Sides' at Westgate Heritage Centre in December.

County Wexford Youth Film Project's (Cwyfp) Youth Film Festival 2025 in New Ross - Funded by Wexford County Council Arts' Office, CWYFP is facilitated by filmmaker Therese Dalton and based in St. Michael's Theatre. It offers young people (ages 13-20) free hands-on training in filmmaking.

CWYFP hosted their annual Youth Film Festival in New Ross in December. There was a full house and the Festival's guest speaker was Conor Flannery who has worked on major film productions including 'Wednesday' and 'Gladiator II'. There were five short films and one musical film shown on the night as well as a youth panel discussion.

Creative Places Enniscorthy (CPE) - CPE is a 3-year Arts Council funded initiative in partnership with Wexford Arts Centre, Wexford County Council Arts' Office and Enniscorthy Municipal District seeking to embed creativity into Enniscorthy.

'Connections' with artist Vanya Lambrecht Ward / community leader Billy Murphy - This event took place in The Presentation Arts Centre in December and 40 people attended. Continuing the artist main meeting connections, this was a conversation around socially engaged Arts Practice for artists and community in Enniscorthy.

Voices in Harmony Christmas Concert - The Enniscorthy male choir held their Christmas concert at Templeshannon Community Centre. There were 25 members of the choir performing and 180 people attended.

Music Generation (MG) - An ongoing partnership between Wexford County Council, WWETB and Music Generation supporting performance music education countywide for young people in 25 schools and a variety of youth work contexts.



Christmas Concerts - Each of the primary schools on Music Generation's programme had a Christmas performance, supported by the musician educators who are based in their schools. The Scoil Mhuire Coolcotts 6th class band with musician educators Louise Malone and Jenna Larsen played music and sang carols in Tesco.

Bunclody Music Hub Christmas Busk - As Music Generation Wexford had received great support from the local community in Bunclody, the group of young people performed Christmas songs in Bunclody Town Square.

Small Things Like These Community Documentary Film Screening - In 2023, Small Things Like These was shot in New Ross. In 2025, the Culture Team of Wexford County Council, supported through the Creative Ireland programme preserved the memory of the making of the film adaptation of Small Things Like These. This film features stories and accounts of local people who were involved in the production. The Culture Team with New Ross Municipal district hosted a screening of this documentary in December. It was opened by Cllr John O'Dwyer, Cathaoirleach of New Ross Municipal District.

Connecting Creatively - Courtown and Riverchapel - Creative Ireland Wexford Culture Team Projects

2026 with Gorey/Kilmuckridge Municipal District Artist Call Out - The Creative Ireland Creative Communities Programme and the Gorey/Kilmuckridge Municipal District in collaboration with the Courtown/Riverchapel Town First Team, invite proposals from socially engaged artists and creatives to address this mindset of connection between the Courtown and Riverchapel communities. Running from February-October 2026, the community art project will build on already established links between the two villages, working with a range of local community groups including the Town First Team. The project will support the consolidation of the town centres, helping the communities to find ways to meaningfully connect through creative activity. Taking a community-focused approach, the project will celebrate relationships, togetherness and reimagine the identities of the once separated villages as one.


Artist In Residence Sought for Eadan's Glen Housing Estate, Ferns - The Creative Ireland Programme and the Housing Department at Wexford County Council in collaboration with the Enniscorthy Municipal District now invites proposals from collaborative and socially engaged artists to complete a residency at Eadan's Glen, Ferns between February and October 2026. The residency will support the development of the Residents' Association and build upon the sense of community already established there.

Community Building and Placemaking through Heritage in Killanne - The Creative Ireland programme and the Heritage Office at Wexford County Council, in collaboration with the New Ross Municipal District and the Killanne Development Group, sought applications from collaborative, socially engaged artists for a project that explores and celebrates community and heritage in Killanne. Working with residents of Killanne, the project will take a collaborative approach to creativity, that values experiences of and personal connections to the heritage of the community.





FINANCE

Annual Financial Statement 2025

Work will be commencing on the preparation of the 2025 Accounts shortly once all transactions for 2025 have been updated to the financial management system. The preparation of the annual accounts will take a number of months to complete but it is expected that the Council will meet the submission deadline of the end of March.

Audit Committee/Audit

Following their meeting with the Local Government Auditor in December the Audit Committee will prepare their annual reports in respect of 2024, in accordance with Section 60 of the Local Government Reform Act 2014, for consideration by the Council. It is expected that the report will be included on the agenda for the February Meeting of the Council.

Cash Flow/Overdraft - Ministerial Sanction is in place for borrowing by way of overdraft in the amount of €15m to 31st December 2026.

Auto-Enrolment - Auto-enrolment is a new national retirement savings system for employees that was introduced on 1 January 2026. The National Automatic Enrolment Retirement Savings Authority (NAERSA) is the state body established in Ireland to administer the new “My Future Fund” auto-enrolment pension scheme.

They will automatically enrol workers into “My Future Fund”, ensuring that employees who are not actively paying into a qualifying pension, through payroll, will begin saving for their future. At the start, employees will put 1.5% of their gross pay into their “My Future Fund” account, this will be matched by their employer and the State will add another 0.5%. These rates will increase incrementally over the first ten years of the scheme, building up to a retirement savings pot when employees reach 66.

There are specific criteria for auto-enrolment into “My Future Fund” and an employee is auto-enrolled if the employee:-

- Is aged between 23 and 60
- Does not pay into an existing pension through payroll
- Earns €20,000 or more in a year across all employments or more than €5,000 in a 13-week period

Employees can voluntarily opt-in provided they meet certain criteria, e.g. aged between 18-22 and 61-66, earn less than €20,000 p.a., pay PRSI Class A or J.

It has also been confirmed that the only PRSI Class exemptions will be Class S, Class M, Class A8 and Class A9.

The Department of Social Protection has confirmed that as Councillors are subject to Class S PRSI, they are excluded from the initial stage and will not be auto-enrolled in the new system.


