



# HOUSING

#### Housing Strategy & Services

Under the Housing for All Programme 2022 to 2026, Wexford County Council must deliver a minimum of 1,159 new housing units within the programme timeframe. The status of overall programme delivery is contained in the diagram below.



It is the Councils intention to continue to deliver new housing, above the target provided under the programme, where demand exists and Department funding is available.

The tables below outline the current delivery pipelines and status on projects. For LA Direct Build information, please refer to the Capital Development section of the Chief Executives Report.

#### **Turnkey Delivery**

The Housing Section periodically seek Expressions of Interest for the provision of social housing units via Turnkey Acquisition. The most recent Expression of Interest closed on the 28th November 2024. All calls are seeking targeted delivery of smaller unit types (1 & 2 beds) in areas of need identified in the Housing Delivery Action Plan (HDAP). In addition, the process also seeks proposals for purchase of land in areas of need. All proposals received by Wexford County Council under the turnkey process are assessed by an Internal Assessment Committee.

#### **Energy Efficiency Retrofitting Programme**

Energy Efficiency Retrofit Programme 2024 is the fourth year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets set by the Department for Wexford to date.

Housing Maintenance Section completed energy upgrades to 146 properties in 2023. Completing the balance of our 2021 to 2023 targets in 2023. The value of the grant funded works for 2023 was €3.99 million.

The 2024 allocation has been received from the department with an approval given for a target of 116 units: 126 of which have been completed.

#### **AFFORDABLE HOUSING**



#### Affordable Housing Information Event – November 27th, Gorey Civic Offices

There was standing room only for patrons who attended a public information event in Gorey Civic Square in relation to the pilot affordable housing scheme currently under development in Ramsfort Park, Gorey Co. Wexford.



Cathaoirleach of WCC, Cllr. Pip Breen joined the Chairman of the Gorey/Kilmuckridge district, Cllr. Oliver Walsh, Senator Malcolm Byrne with elected members from the district, to launch the information event.

A total of 20 affordable housing units are to be delivered in the Radharc Na Beannóige scheme, which is the first housing scheme to include affordable housing in County Wexford under the Government's 'Housing for All' policy. The development which is being constructed by Mythen Construction in partnership with Wexford County Council, will provide new homes for sale via Wexford County Council's 'local authority affordable purchase' scheme.

Speaking at the event, Cathaoirleach of Wexford Council, stated, 'It's great to see so many of you joining us here this evening, Wexford County Council is actively working on developing an affordable housing programme for county Wexford and we hope tonight's event helps you in your housing journey'.

The housing information event was an opportunity for applicants to learn about the affordable housing scheme, the application process and for interested applicants to speak to staff members from approved mortgage teams who were available on the day.

The scheme is due to be advertised for applications early in the new year, with the delivery of the units scheduled for 2025. For further information, please contact affordablehousing@wexfordcoco.ie




# ECONOMIC DEVELOPMENT

#### **Trinity Wharf**

Wexford County Council presented the Trinity Wharf project in the national media on Wednesday November 13th as part of our strategy to seek expressions of interest from potential investors for the delivery of this first-class transformational project, which will impact at a regional level.

The project went live on e-tenders and in the Irish Times commercial property section to coincide with the launch by Wexford County Council of an Expression of Interest / Preliminary Market Consultation process (in line with Article 40 of the 2014/24/EU Directive) seeking engagement and feedback from investors and developers to unlock the delivery of this flagship project.



It is envisaged that in Q1 2025, following analysis of relevant feedback and insights gathered through this process, Wexford County Council will proceed to run one or more procurement competitions in line with the Public Sector Directive 2014/24/EU.

#### WATERFORD/WEXFORD ESTUARY

Wexford, Waterford, Kilkenny and Tipperary Local Authorities together with Fáilte Ireland have formed a working group to identify and harness the opportunities for economic development and resources of Waterford Estuary.

The key objective is to develop a 10-year strategy to guide the future sustainable and economic development of the Estuary in an integrated manner. The strategy will focus on delivering maximum social and economic benefits to the communities of the Estuary, while safeguarding the valuable landscape, heritage and environmental interests. Currently the regional group are working with SETU on a scoping document.

#### TOURISM

#### Wexford County Council Delegation Visit to Caen, Normandie, France

The first European Summit of the "Norman People of Europe" took place on the 30th and 31st October 2024 to discuss the Millenium of William the Conqueror. This is the first step in establishing a regional approach to commemorative events starting in 2027. From an Irish perspective, a working group has now been established led by Michael MacDonagh, Chief Archaeologist, Department of Housing, Local Government and Heritage to progress plans commencing in 2027.

On the invitation of the President of the Normandy Region, the Wexford delegation attending included Councillor John Fleming, the Deputy Chief Executive, the New Ross District Manager, and County Tourism Development Officer. Other representatives from Ireland consisted of Deputy Irish Ambassador to France, Archaeologist at National Monuments Service in DHLGH, Head of National Monuments at OPW, Head of Collections at Irish Museum of Modern Art, CEO of National Library of Ireland, Director of Collections at National Museum of Ireland, Programme Manager at Royal Irish Academy, Professor of Medieval History at Trinity College Dublin together with representatives from Longford and Dublin City Councils and members of the Wexford Normandy Cultural Association.

# The European Forum was held at the historic Abbaye aux Dames in Caen and included representatives from France, Southern Italy and Sicily, Scandinavia, United Kingdom and the Channel Islands.



The Official opening plenary session included speeches from the President of Normandy, Herve Morin, Senator and Chair of the Normandy Regions Culture, Tourism and Heritage Commission, Catherine Morin-Desailly, Head of the World Heritage Mission & Director General at the French Ministry of Culture, Bruno Favel.

## **TOURISM** cont'd

Following the official opening of the Forum some "Breakout Sessions" began to work on ideas and themes that were presented by the facilitation team. These "Breakout Sessions" also took place on day two of the Forum. The facilitation team presented the findings from the workshops over the two days and at the Official Closing Plenary Session, slides of the work were shown to delegates. Closing speeches followed, along with a press conference




#### LOCAL ENTERPRISE OFFICE

#### **10 YEARS OF LEO**

In 2014, the Local Government Act empowered Local Authorities to take on an enhanced role in economic development and following the dissolution of County & City Enterprise Boards, 31 Local Enterprise Offices were established around the country. On Monday, December 9th, Wexford County Council will host a festive celebration for entrepreneurs and business owners. partners, stakeholders and the broader Wexford community to mark a decade of the Local Enterprise Office supporting Wexford businesses.

Clients of the LEO will showcase their food and craft offerings in a festive market which will also feature products developed by secondary students participating in the Student Enterprise programme.



Since its inception, the LEO has emerged as a vital partner for entrepreneurs and established businesses alike through providing a comprehensive range of services, including business advice, training, mentoring, and financial support.

#### LEO WEXFORD 10 YEAR PERFORMANCE

LEO Wexford client companies performed exceptionally well with regard to the number of jobs created over the past 10 years, created a total of 2895 gross jobs in the county since 2014, the nett number of jobs created is 1,392.

The average number of jobs created by LEO Wexford every year since 2014 is 290 per year gross (139 per year nett), the 2nd highest number of new jobs across the National LEO Network in 2023.


# LOCAL ENTERPRISE OFFICE cont'd

Key sectors driving employment numbers in Wexford LEO supported businesses (as a % of net jobs) include Food 70%, Engineering 12%, Manufacturing 8%, Life Science/MedTech 4% and Green 2%. 2023 was the fourth year running that LEO Wexford has been in the top 3 for job creation in the country. The employment survey for 2024 has been completed and results will be published in January 2025. The number of grant aided clients in the LEO portfolio has grown by 38% to 234 in the past 10 years and number of Jobs in LEO grant aided clients has grown by 83% since 2014 to 1,954

# K330 Financial Grant packages with a total value of €6,577,283 were approved in 10 years (2014-2024)

Operational efficiency, digitalisation and sustainability of SMEs are key priorities in the White Paper on Enterprise 2022 and reiterated in LEO Policy Statement 2024-2030. As part of the Service Level Agreement with Enterprise Ireland, LEO Wexford are tasked with delivering consultant led support services under the Lean for Business, Green for Business and Digital for Business programmes. The Local Enterprise Office is currently undertaking a tendering process (via E-tenders) to establish a framework of consultants to deliver these programmes from 2025-2029.

These programmes are available to both new and existing businesses and are designed to match small business owners/ managers with experienced, insightful business consultants that can provide them with practical and strategic advice and guidance in relation to specific challenges their business needs to overcome. The consultant will contribute independent, informed observation and advice to aid decision making.

Consultancy will be provided free of charge to local businesses and grant aid is available to assist businesses to implement recommendations under the Energy Efficiency Scheme and the Grow Digital Voucher.

#### **Training and Mentoring Supports**


An important function of the Local Enterprise Office is to foster a culture of entrepreneurship in the county and to provide training and mentoring programmes to help entrepreneurs to take the necessary steps to either start their own business or to upskill and build capacity. Since 2014, the Student Enterprise Programme has been successfully delivered to over 12,540 Student attending 19 schools across the county, providing them with hands on experience in setting up and running a business. Over the decade, the LEO has delivered over 1000 training programme to 13,553 individual participants. The LEO has helped entrepreneurs at the outset of their business journey with 1258 participating in Start Your Own Business courses, in addition to supporting over 1600 established business owner /managers to develop the skills to grow and scale their business through participation on the LEOs flagship Management Development Programme.

Almost 2,000 individual mentoring session have been delivered to Wexford based businesses to assist them to deal with challenges and opportunities since 2014.



#### **Forward Planning**

#### South Coast-Designated Maritime Area Plan

The South Coast-Designated Maritime Area Plan was made by the Minister for the Environment, Climate and Communications on 24 October 2024. It is Ireland's first forward spatial plan for offshore renewable energy (ORE). Wexford County Council made a comprehensive submission to the plan which contributed to the finalised version of the plan.

The plan identifies four Maritime Areas within which proposed future ORE projects may be located. It provides a suite of supportive policies including policies for the development of ports and associated infrastructure and the protection of fisheries and the environment and the support of local communities.

The adoption of this first plan for ORE in the South-East offers great opportunities for the development of Rosslare Europort and Kilmore Quay and for associated development and services elsewhere in the County.

#### **County Development Plan Monitoring**



The Annual Core Strategy Monitoring Report was completed and provides details on new dwelling completions and planning permissions granted for residential and commercial development during Year 2 of the Plan, as well as the aggregate figures for Year 1 and Year 2 to show the progress towards achieving the Core Strategy allocations.

During the first two years of the plan a total of 2,202 new dwellings were completed (34.2% of the Core Strategy allocation for the six-year plan period) and 2,336 dwellings were granted planning permission (36.3% towards the Core Strategy allocation for the six-year plan period).

#### Forward Planning cont'd

#### **County Development Plan Monitoring**

An additional 70,177sq.m. of commercial floorspace (office, industrial, retail, warehousing/logistics and hospitality) was granted planning permission since the adoption of the plan.


Work is ongoing on the Chief Executive's Report on the achievement of the objectives of the Plan. The Plan contains over 1,200 objectives covering the Council's key programmes, activities and projects, and monitoring ensures that these objectives are being met as set out.

#### Wexford Town Local Area Plan

Work on the Wexford Town Local Area Plan continues. The LAP team are progressing the development of the overall spatial planning framework for the town. A key component of the framework is the Urban Design Strategy, and the consultants Loci are progressing well with this urban design work. With regard to the Town Centre First Regeneration Strategy, another workshop was held with the Town Team on the 29th October 2024. This workshop focused on identifying the strengths, challenges, opportunities and threats relating to the town centre. Loci are reviewing the workshop outputs which will be used to inform the development of the strategy. The consultants working on the Rainwater Management Plan and the Green Blue Infrastructure strategy are currently reviewing and incorporating the feedback from the LAP team





#### MAJOR NATIONAL ROADS PROJECTS

#### N11/N25 Oilgate to Rosslare Harbour

The Project is in Phase 3 – Design and Environmental Evaluation.

Real Estate Consultancy Service tenders have received TII's approval and the appointment of the preferred tenderer is progressing.

Project design is advancing, with additional tasks addressing Service Area requirements and Active Travel provisions.

Consultations with larnród Éireann regarding the railway protection structure at the River Slaney Bridge crossing are ongoing.

Consultation with directly affected landowners regarding the scheme commenced during the reporting period. The PLO will discuss the current work-in-progress alignment design with the landowners.

Preparation of Environmental, Planning, Design and other reports are ongoing.

The progress report submitted to the European Climate, Infrastructure, and Environment Executive Agency (CINEA) has been approved. A change to the project scope is currently being prepared and is scheduled for submission to CINEA by the end of January 2025.

#### N25 Rosslare Europort Access Road

The Project is in Phase 5 – Enabling and Procurement.

Coordination with OPW/Irish Rail in relation to the OPW/Irish Rail temporary works and N25 Rosslare Europort Access Road is ongoing.

Technical Advisors are progressing through the Phase 5 (Enablement & Procurement) deliverables.

Archaeological Services (Stage 1 - 4) tender documents are completed and publication of the Tender is pending.

Technical Certificates for the three structures within the scheme have been approved by TII.

The Irish Rail Technical and Safety Approvals Process is ongoing for the proposed railway overbridge within the scheme. A Hazard Workshop for the proposed railway overbridge is scheduled for early December.

#### NATIONAL ROAD PAVEMENT SCHEMES

#### **SAFETY SCHEMES**

**N25 Tagoat** - Tenders have been invited from consultants for the design phase. This is being assessed and approval to award a contract for design works will be forwarded to TII in December.

**N80 Clohamon** - A traffic video survey at the junction will be carried out within the next 2 weeks.

**N30 Leeches Bend – West of Clonroche** - The Feasibility and Options report has been approved by TII. The preliminary design report and tender documents are being finalised by Tramore House Regional Design Office. We expect to to invite tenders before the end of the year subject to approval of the preliminary design report by TII.

**N25 Larkins Cross** - The draft Feasibility and Options report is being reviewed by Wexford County Council in preparation for submission to TII for approval, to form the basis for scheme funding. The preliminary design report will then be prepared to inform a consent application.

#### **2024 PAVEMENT SCHEMES**

<u>HD28 N25 Blackhorse to Ballykelly Pavement Scheme</u> – (Estimated Total Scheme Cost is €1,000,000). This scheme was completed in November.

#### 2025 PAVEMENT SCHEMES

<u>N25 Ballygillane to Ashfield Cross Roundabout Phase 2 Pavement Scheme</u> - TII approved the award of the contract in October.

A Letter of Intent was issued to the contractor on the 21st. October.

Works will commence in Q1 2025 following budget allocations.

#### **REGIONAL AND LOCAL ROADS**

Wexford's allocation for 2024 is €23,437,550. This allocation includes €2,000,000 for Severe Weather damage.

#### **Community Involvement Schemes**

A grant of €502,650 was received to complete 8 road sections this year. All roads complete

#### **Severe Weather - Flood Damaged Bridges**

Temporary Bailey Bridges are in place at Chapel and Cullenstown Little in the New Ross District. The contractor is appointed and scheduled to commence replacement of both temporary structures with permanent bridges. Commencement of the reinstatements is planned for January, starting with Chapel, Adamstown.

#### **Specific Improvement Grants**

A grant of €1,005,000 was received for the Owenduff river embankment stabilisation (R733 Wellingtonbridge) and to complete payments for the works on the Deeps Bridge. Works are substantially complete on the Deeps bridge, with resurfacing due for April 2025. Owenduff works will be completed in Q4 24.

Grange Beach Works coastal protection works are progressing well. The works sustained some damage during Storm Bert and will be addressed as part of the works contract. The reopening will be at the end of January 2025.

Local Improvement Schemes - All lanes under the 2024 Scheme are completed.

#### **ACTIVE TRAVEL UPDATE**

**Newtown Road – Phase 1** - The contract is substantially complete with final account determination being finalised by the NTA.

**Newtown Road Phases Two and Three (Part of the Pathfinder Project) -** Detailed design for Phases 2 & 3 is nearing completion and will be tendered in early 2025.

Beechlawn/Clonard Cycle Scheme (Part of the Pathfinder Project) - to progress to Part 8 in 2025.

#### **Roxborough Cycle Scheme (Part of the Pathfinder Project)**

The Scheme is at the final stages of Phase 3 design and will proceed to the Part 8 process in Q4 2024.

Oaklands to Kents Cross Cycle Scheme (New Ross) - will progress to Part 8 process in Q1 2025.

**Hospital Junction -** intention to proceed to Part 8 this year. Letter of comfort received from HSE in order to allow us to proceed to Part 8.

**Old Dublin Road, Enniscorthy** - A scheme feasibility report in 2 phases has been issued to the NTA in the event that supplementary funding becomes available in addition to the agreed multi-annual programme for active travel.

#### Gorey to Courtown Footpath

- Phase 1 to Ballymoney Junction is substantially complete, with the exception of planting and fencing.
- Phase 2 Ballinatray Bridge is at final design stage for the possible provision of a signalised shuttle system to accommodate pedestrians and cyclists traversing the bridge.
- Phase 3 Courtown side of Ballinatray Bridge is at preliminary design stage.

#### Implementation of the new 60km/h Default Speed Limits

The implementation of the new 60km/h default speed limits on all L-class (county) roads in the county will now be effective from the 7th of February 2025, by direction of the Department of Transport.

The installation of new poles and signs is underway in the necessary locations in preparation of the effective date. The default speed limit sign RUS 041A will be used extensively.

#### **ROAD SAFETY**

#### Just 1 Life

Our joint road safety event in association with Wexford Rotary Club, Just 1 Life, commences on the 11th of December 2024.

Over 2,300 TY / 5th year pupils will attend during the 2024 / 2025 school year at 5 events to be held in the National Opera House. Presentations include An Garda Siochana Roads Policing Unit, Wexford Fire Service, National Ambulance Service, Mental Health Wexford and the HSE.

#### **PUBLIC LIGHTING**

**LED Upgrade (National Roads)** - The LED lantern replacement on Scurlocksbush, Templescoby and Milehouse roundabouts were completed in November.

**LED Upgrade (Non-National Roads)** - Works commenced on the final phase of Led lanterns replacement works in October. Lantern replacements on the R700 (Old N30) New Ross from Kents Cross Roundabout to Irishtown .

There will be a delay in replacing the remainder of this section of the R700 due to safety issues with the old cabling along the route.

It is intended to have public lighting fully upgraded to LED by the end of 2025.

**Public Lighting Development Fund** - Due to energy savings from the Led upgrade programme we are continuing to complete "infill" lighting programmes across all municipal districts.



## **CAPITAL PROJECTS - Projects at Planning Stages**

#### **Enniscorthy Town Centre & Tourism Project:**

Preliminary design work on the Enniscorthy Castle Quarter project is ongoing and it is intended to present a concept design proposal at the December EMD meeting.

#### Forth Mountain Activity Park – Phase 2 - Activity Centre Building

Advance site clearance works have commenced on the boathouse site. Subject to survey and finalisation of the design, it is planned to tender out the boathouse project in two discrete works packages in January 2025.

#### John Street Grainstore, New Ross

Environmental assessments for the public realm area to the rear of the grainstore building are ongoing to inform an application for development consent to An Bord Pleanála. This application will be made in Q1 2025.

WEXFORDIA - Irish National Heritage Park (INHP), Hook Lighthouse and New Ross Tourism Projects

**Irish National Heritage Park: INHP -** It is planned to submit a planning application for the project to An Bord Pleanála in Q3 2025.

**Hook Lighthouse -** It is planned to submit a planning application for the project to An Bord Pleanála in Q4 2025.

**New Ross Tourism Project -** It is planned to make a submission for development consent via the Part 8 process in Q2 2025.

Esmonde Street, Gorey - The tender process for the works will commence in December 2024.

**Wexford Town to Rosslare Greenway -** It is planned to confirm a preferred route corridor for Wexford Town to Rosslare Strand and Rosslare Strand to Rosslare Harbour in Q1 2025.

**Courtown Coastal Protection & Beach Nourishment Scheme -** It is planned to submit an application to An Bord Pleanála for development consent in 2025, subject to advance approval of a Marine Area Consent by the Marine Area Regulatory Authority.

**Enniscorthy Sports Hub** - A tender competition to procure a works contractor for the Sports Hub has been concluded. It is expected to make an appointment for a works contractor in December.

Ferndale Gymnasium, Wexford - The works are ongoing with completion expected in Q3 2025.

**Curracloe Water Sports Activity Facility** - The main works contract has been awarded to Kilcaven Property Developments. Works commenced on site in mid-October 2024, with completion expected in Q2 2025.

**Adoration Convent Wexford -** A tender competition to appoint a works contractor was advertised in November, with works planned to commence in Q1 2025.

## **CAPITAL PROJECTS - Projects at Planning Stages cont'd**

**St Waleran's Link Road -** Appointment of the consultant to undertake preliminary design, Environmental Impact Assessment and submission to ABP for approval is expected in December.

**Ballynagee Link Road -** Assessment of tenders for the appointment of a main consultant are complete and appointment is imminent.

#### **Gorey Market House**

The tender for the appointment of a consulting team to undertake detailed design, procurement and construction supervision services has been advertised, with tenders due for submission in January.

**Enniscorthy Technology Park Phase 2** - Assessment of tenders for the appointment of a main consultant are complete and appointment is imminent. Appointment is anticipated in December.

**Enniscorthy Technology Park – IDA Advance Factory Building -** Tenders have been received and assessment is complete for an architect-led design team to prepare a planning application for a proposed advance factory building in Enniscorthy Technology Park. Appointment is anticipated in December.

### **PROJECTS UNDER CONSTRUCTION**

**South East Greenway -** Work on Phase 2, a 5.5 km section from Ferrybank to Curraghmore is due for completion in December 2024. Some further works will be required prior to opening this stretch of greenway in Q1 2025. Fehily Timoney and Company are advancing designs for Lot 4 and all other lots for the completion of the greenway. It is targeted to commence works on Lot 4 in Q3 2025.

**Trinity Wharf** - The next works contract is due to commence in Q3 2025, which will comprise new sea wall, bulk filling site services and surface works.

**New Ross Emigrants' Park -** The Emigrant park was the winner of the LAMA best urban planning award 2024 and Best Municipal District Initiative Award 2024.

**Mechanics Institute, Wexford -** We are now scoping up the required works to prepare the building for community use. It is planned to have the building ready for occupancy by Q4 2025.

**Murphy Floods Redevelopment -** John Tinnelly & Sons were appointed as works contractor in September 2024. Works were completed on site in mid-October.

Plans are currently being developed for an interim car park and public realm.

## **COMMUNITY - LOCAL SPORTS PLANS**

On 21st November, at Sport Ireland Campus, the "Local Sports Plan Templates" were launched at an event attended by the LCDC Chief Officer and Sports Active Coordinator. Each Local Authority is now asked to develop a Local Sports Plan to increase participation locally, in a manner consistent with the vision and objectives set down in the National Sports Policy and taking appropriate account of any existing plans.

To do this, each Local Authority is asked to work with the Local Sports Partnership, with partners on the Local Community Development Committees (LCDC), CYPSC, with clubs, schools, leisure facility providers, community groups and other stakeholders. A locally led, nationally supported approach will be a key feature of the local sports plans. Some level of funding is being made available by Sport Ireland to assist Local Authorities in this task. In Wexford County Council, this new plan will be led by the Community Section and consultation will commence in early 2025.



### **PRIDE OF PLACE**

The IPB Pride of Place 2024 in association with Co-Operation Ireland Gala Awards Ceremony was held in the Hillgrove Hotel in Co. Monaghan on Saturday 2nd November. The entries for Wexford were The Rocks Community Area and Fethard on Sea. The Rocks Community Area won the Urban Neighbourhood Category while Fethard on Sea were also successful and won runner-up in the population 1000-2000 Category. These awards acknowledge the achievements and invaluable work undertaken by the volunteers and those involved in local community development.





### SICAP 2024-2028

Wexford County Council facilitated a SICAP support workshop on the 10th October, 2024, on behalf of Pobal. LCDC representatives and Programme Implementers from 4 Local Authority areas attended, and any remaining issues in the understanding and interpretation of SICAP 2024-2028 Programme Requirements were addressed.

**Duncannon Harbour** – A contractor will be appointed to carry out site investigations to determine the cause of the structural cracks in the pier and consider a suitable solution for the repairs.

#### **Beaches**

• Grange Beach Cliff Stabilisation works started in Oct 2024. The beach access is temporarily closed until the works are completed late 2024 / early 2025.

#### Coast

- Seaview Coastal Protection and Beach Access, Kilmore: total funding of €1.6m is now approved by OPW. Contractor is now on site.

**Water Sampling** - In 2024 a total of 340 river water samples will be taken from 76 sampling sites on 36 rivers by WCC staff. 7 surveillance sites will be sampled in 2024 with analysis of all samples carried out by the EPA lab in Kilkenny.

**Section 4 Discharge Licences:** - Currently, there are 88 active discharge licences with scheduled biannual, quarterly and bimonthly monitoring returns assessed for compliance on receipt by Environmental Technical Staff and actively pursued to address any ongoing issues arising from exceedances in chemical/microbiological and flow parameters as laid down in the discharge licence for the site. There are currently 8 Discharge Licence applications under assessment and review.

**Air Quality: -** WCC enforces air quality requirements for 3 specific types of facilities, which must be registered with WCC – vehicle refinishers, dry cleaners and petrol stations. These certificates must be renewed every 3 years. On-going enforcement action is carried out to ensure sites remain certified.

Low Smoke Fuel Areas - The 4 stations in New Ross, Wexford, Enniscorthy & Gorey have now had their monitors updated to measure air quality and noise levels. There are also 6 low cost sensors installed in Enniscorthy monitoring PM10 & PM2.5 only. UoG & UCC have started a programme called Openair to monitor gases NOx, SO2, CO continuously, particle numbers 10 nm to 10 microns, as well as black carbon and organic aerosol, ions ammonium, chloride, sulfate and nitrate, all in real-time, as well as collecting 24hr filter samples of PM2.5. The filter samples will be analysed for metals and toxicity. These will be compared with 2016 levels taking during the SAFFIRE project. They will be monitoring the weather also.

**Noise and NAP 2019-2023** - Two complaints of persistent noise pollution are currently under investigation.

**Agriculture** - WCC continues to undertake a significant number of farm inspections in accordance with the WFD. WCC engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 were served upon farms where major non compliances are observed and cross reported to DAFM.

A total of 48 Agricultural related Planning Permission Applications have been assessed in 2024 to date. 10 of these applications related to further information been submitted on behalf of the applicant.

## PLANNING

The Environment Section makes an assessment and recommendations on planning applications relating to the environmental aspects of the application and the main issues regarding the impact of planning on the environment which have arisen in recent years are as follows:

- 1) Density of housing.
- 2) Applications for extensions and upgrades of existing houses on sites where the soil is unsuitable f or discharge of wastewater via a domestic wastewater treatment system.
- 3) Applications for detached granny flats and other detached ancillary accommodation.

**Landfills** - Holmestown Landfill remains temporarily closed. Environmental monitoring and maintenance of infrastructure continues at both Killurin and Holmestown in accordance with the conditions of our waste licences.

The Household Recycling Centre at Holmestown continues to provide recycling services to members of the public as well as a disposal service for other waste streams such as residual waste, bulky waste, segregated food waste, garden waste and waste paint.


## Climate Action Plan (CAP)

#### DZ

Following on from the four Decarbonizing Zone (DZ) workshops held in September and October, the Climate Action Team focused their resources on a proposed workplan for the Enniscorthy DZ. The Baseline Emission Inventory for the Enniscorthy DZ outlines that the transport Sector accounts for 35.5% of Greenhouse Gas (GHG) emissions in the DZ and the commercial sector emits 34.9% of the total GHG in the DZ. An Internal meetings was held with the main sections involved in the Transport Area in Enniscorthy and a separate internal meeting was held with the Economic Development Section. Staff from the Enniscorthy MD were present at these meetings. Proposals to progress a number of actions based on these meetings were agreed.

Other items under consideration are the promotion of the Climate Heroes App in Enniscorthy among community groups/businesses and schools over a two week period in March April 2025. The idea is to engage and mobilise differeeernt sectors into Climate Actions in the Enniscorthy Area. The app is a tool that can capture how certain actions can help reduce emissions by giving an estimated CO2 savings associated with particular choices.

The Climate Action team is also linking in with the Arts & Creative Communities officers for a number of projects both in Enniscorthy DZ and around the county with a focus on Climate awareness.

## **COMMUNITY CLIMATE ACTION PROGRAMME**



The 16 successful projects have commenced works, with four groups having already completed significant elements of their projects. The second round of the Programme is expected in 2025.

#### Sustainable Energy Communities (SEC)

Wexford SEC and the Climate Action Team continued with the awareness promotion of the SEAI's Warmer Homes Scheme, which is a fully funded home energy upgrade grant for homeowners who meet certain social welfare criteria. A drop-in information afternoon was held on 7th November in Access 2000, Green St, Wexford and was very well attended.

Enniscorthy SEC on behalf of the SEC's within Co Wexford has submitted a funding application to the "Climate Actions Work Engagement Fund". The application is seeking funding of €10,000 to enable a training of "energy champions" across all SEC's. These champions would then inform and assist members of their communities with making grant applications for home energy upgrades.

Events for children hosted in libraries included 3D Printer demonstrations, Nutty Scientist Workshops, Ecology workshops, LEGO® bricks workshops, art workshops, coding workshops, animal function talks, Intertidal Creatures through Science and Art, an exploration of fingerprinting and DNA, creative writing and a magic science show. Meanwhile adults learned about Isaac Newtown, took part in a soap making workshop and learned why soil science matters. Science communicator Niamh Shaw spoke about her Antarctic adventure, the handmade quilt made by a Gorey women's group for her trip to honour Irish female scientists and how the experience impacted her.

## ARCHIVES

#### **Collections Management**

In addition to 28 research enquiries via email, telephone and post, a total of 7 researchers visited the Archive during November. Research topics included the compilation of an inventory of the various artistes featured in the Wexford Festival Opera's photographic archive during the first 30 years of the festival (1951-81); employment records for personnel stationed at Duncannon Fort (1930s-50s); research on Dr George Hadden for a forthcoming talk; research on the townland of Boley in two rentals relating to the Colclough estate, Tintern (1834-82); coroner's reports and inquests for the 1821-25 period in County Wexford; tenants on the Boyse estate, Bannow in the late 19th century for family history research (1881-91).

#### Outreach

The launch took place in Wexford town library on 5 November of the publication **Wexford County Archive: 25 objects from the Irish Revolution, 1916-23.** Part-funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media, this flagship project grew out of a desire to have a lasting physical record in the lead up to the culmination of the Decade of Centenaries last year.

Artefacts featured in the book include extracts from Seán Sinnott's autograph book from Cork Jail, 1917; Séamus O'Brien's plate and spoon from Frongoch, 1916; Tom Doyle's prison cap, 1916; original flag from Enniscorthy 1st Battalion; Patrick Keegan's Volunteer tunic; Máire Moran's Cumann na mBan brooch; a letter written by TD Sinnott to his mother during his internment at Ballykinlar, Co. Down, 1920; a Homburg hat belonging to Liam Mellows; letters from John Creane, James Parle and Patrick Hogan on the eve of their execution in Wexford Jail, 1923.

The launch was performed by An Cathaoirleach of Wexford County Council, Cllr. Pip Breen who observed that Wexford's Decade of Centenaries commemoration programme (1912-23) 'has especially placed archival collections at the forefront of our understanding of the revolutionary decade and in providing a fresh perspective on past events for academic, local and family history research'. He congratulated author Aaron Ó Maonaigh on his thoughtful and meticulous research for the book in placing each artefact in its historical context at national and local level, and in providing a sympathetic overview of the men and women who were impacted during the period. Eighty people, many of them relatives of those who featured in the book, were in attendance.

Copies of the publication are in the process of being distributed to the history department in primary and post-primary schools across County Wexford.

#### Irish Society for Archives

The Archivist was invited to submit the first article to a new series in the Irish Society for Archives newsletter entitled 'A five-minute chat with an archivist'. This was an invaluable opportunity to showcase many of the projects undertaken by the Archive and to provide an insight into the roles and responsibilities of a local authority Archivist.

## ARTS

#### Small Arts Festival and Failte Ireland Festival Open Call 2025

Wexford County Council Arts Office is pleased to announce 2 strands to the Festival Grant Scheme for festivals taking place in County Wexford during 2025. The total fund is €50,000 and this supports on average 20 festivals across the county with grants ranging from €1,500 - €3,000

#### Arts Office and Creative Ireland Wexford Information Sessions

The aim was to promote funding opportunities via the Arts office and Creative Ireland. These include artists bursaries, artist residencies, training and networking opportunities, and opportunities for arts in community, arts in education and arts and health. These sessions took place in Wexford Arts Centre, Tomhaggard and online

#### Westgate Heritage Centre Arts Space

Management of Westgate Heritage Centre and the adjacent Computer Centre is now with the Arts Office and is being used as artist workspaces. From 1st October Wexford Arts Centre was contracted by the Arts Office to manage the day to day running of the space. Westgate Heritage Centre will be available for hire for Pop Up exhibitions and other events from the end of November. Ongoing works continue on the new Music Rehearsal Space at the back of the Heritage Centre and it will be open for bookings in December. Heritage tours continue to access the space.

#### INTERNATIONAL RESIDENCY OPPORTUNITIES

#### Lisbon 2024 & 2025 – aimed at emerging visual artists

Wexford Arts Office is partnering with Capacity Ireland and the Arts Council on a European residency opportunity for a Wexford based emerging visual artist called Breaking the Patterns. Currently there are 2 Wexford artists in Lisbon completing a 3 month residency from October-December 2024. Another artist's open call took place for a Lisbon residency to take place in Jan-March 2025. Two Wexford artists were selected.

#### **Centre Culturel Irlandais Paris (CCI)**

Wexford Arts Office is partnering with CCI Paris again in 2025 to support another funded artist residency for a Wexford based artist in Paris. Residencies of one to three months will be awarded for the period September 2025 - December 2026. This opportunity closes Tuesday 14th January 2025 at 5pm. This is open to artists across all art forms.

#### **Exhibition in County Hall- Els Dietvorst**

The exhibition continued in November in County Hall. This show was curated by Catherine Bowe and Karla Sánchez Zepeda. This final exhibition is the concluding part of a national tour of Els Dietvorst's work. ADRIFT will run concurrently at Wexford Arts Centre and Wexford County Council until Friday 29 November 2024. 23 people were taken on private tours over the course of the exhibition.

#### ISACS LIFT Residency

Wexford Arts Office was happy to support the 4th LIFT residency supported by ISACS (Irish Street Arts, Circus and Spectacle Network) and the Arts Council of Ireland with Italian artist Elisa Gallororosso, who presented her work-in-progress in the Wexford Arts Centre in November. Elisa will return to Wexford in December to utilize ISACS' hot desk and further develop her artistic research.

#### **Cow House Parenting Artist Residency Open Call**

The Arts Office with Cow House Studios are pleased to offer a two-week residency designed specifically for parenting artists. This makes it possible for awarded artists to dedicate time to their work by offering childcare and supports during the residency. The deadline is the 15th of December.

### SCREEN WEXFORD

An Arts Office and Economic Dept initiative to support the development of the film / screen industry in Wexford.

#### Remote Working in Postproduction for the Future

These workshops took place online with four sessions and over 1 day in person in Gorey School of Art and focused on the various aspects of working remotely in postproduction in film. Supported by WCC, Screen Wexford and Screen Ireland. This was designed specifically for individuals who work in special effects, film editing and sound.

#### Crew Networking Coffee Morning - Presentation Arts Centre, Enniscorthy

This was open to anyone interested in and/or currently working in video, gaming, social media, film and TV or any screen-related industries. This included writers, directors, producers, creators and crew from all departments. This event was an opportunity for local filmmakers and talent in the South East to meet and network while hearing from Screen Wexford on upcoming training, opportunities, and initiatives.

#### **CREATIVE PLACES ENNISCORTHY (CPE)**

CPE is a 3-year Arts Council funded initiative in partnership with Wexford Arts Centre, Wexford Arts Office and Enniscorthy Municipal District seeking to embed creativity into Enniscorthy.

#### **Creative Youth on a Shared Island**

A call out took place in November for all young people in Enniscorthy age 14+ for an exchange project with Fuse Arts in Derry and Freshly Ground Theatre in Tallaght and Bare Cheek Theatre Company in Enniscorthy. Workshops started in November.

#### **Recording Sessions at the Orchard Recording Studio Enniscorthy**

Creative Places Enniscorthy supported eight recording sessions to forty musicians across the Enniscorthy area in November. There will be a launch on Friday the 13th of December at the Presentation Arts Centre at 7pm.

#### Scalder? Project by Crannog Films with Creative Places Enniscorthy

Call out started from the 14th of November for locals of Enniscorthy to record a short video or audio track about what 'SCALDER' means to them and what people think about Enniscorthy. Crannog Films will have a screening night in the Templeshannon Community Centre in December. One submission will be chosen to spend a day filming with Crannog Films on one of their upcoming projects.

## CREATIVE IRELAND

#### **Good Grief**

In 2024 through the Creative Ireland Health and Wellbeing Fund, Creative Ireland teams in Waterford and Wexford developed Good Grief, a free programme to assist people who are in the second year of bereavement. The programme ran for eight weeks with 36 participants and finished with 33 participants. Most of the participants were from County Wexford. A researcher was engaged to evaluate the programme and put together a report that considers the value of it continuing in different iterations. The report is expected to be delivered in the spring of 2025.

#### **Shared Island**

As part of the Creative Ireland Wexford Shared Island project, fourteen people from Belfast, including ten students from Ulster University and Belfast School of Art, travelled to Gorey School of Art in November. They met a cohort of Wexford students, and through AI and VR collaboratively explored the interwoven effects of climate change and health. Gorey School of Art students will travel to Belfast in December to continue this conversation. The results will form the basis for a phase 2 project, that further develops meaningful Shared Island links between communities in County Wexford and Belfast.

#### Spoken Word project with Stephen James Smith


Calmast, the STEM engagement Centre in South Technological University, coordinated a project for TY students from Selskar College and Presentation School Wexford that encouraged exploration of their connections with climate change and their sense of place and belonging through the medium of spoken word. This project was undertaken in collaboration with Stephen James Smith, a Wexford Town resident who is a leading figure in Ireland's vibrant spoken word community. The workshops took place in September and October and culminated in a showcase performance at Wexford Arts Centre in November.




#### Hall for All



## THE LOCAL INTEGRATION TEAM

The LAIT held 7 clinics in the community this month.



Interagency Work - The final Community Integration Forum of 2024 took place in December. This forum continues to provide a vital platform for collaboration, focusing on the integration of individuals who have moved to Co. Wexford under Temporary Protections Orders and International Protection. The International Refugee Protection Programme welcomed its first two families to the county. Both families are settling well into their new communities, thanks to the coordinated efforts of local agencies and support networks.


A Migrant Survey Working Group convened to advance the development of a comprehensive needs assessment for individuals living under International Protection in Co. Wexford. This assessment will help identify key areas for support and inform future service provision.

Other Activities - Three initiatives have been successfully awarded funding through the Integration Team Small Grant Integration Fund. We look forward to supporting these projects and observing their positive impact over the coming months. Applications for the Migrant Strategy have been received, and we remain optimistic about progressing this important body of work in early 2025.

Training - The Team Hosted a training from NBK training (Niall 'Basil' Kennedy) on mental health & resilience which was well received by the men in the IPAS Centre in Courtown.

The LAIT hosted representatives from the UNHCR (United Nations Refugee Agency) and the Jesuit Refugee Service (JRS). These experts delivered an informative presentation for professionals, focusing on the Irish experience of International Protection. A tailored session for women residing in an IPAS Centre was held at Wexford Library, highlighting their rights and entitlements.

Ruhama delivered a two-day certified training on human trafficking, hosted by the LAIT. Thirty five participants engaged in this impactful program, which emphasised trauma-informed practices in supporting victims of trafficking. Feedback from attendees was overwhelmingly positive, underscoring the training's importance and effectiveness.

## FINANCE

## **Finance Report Q3**

The Q3 Finance Report is included on the agenda for the December meeting and the report has been circulated to members. The Q3 position is being reported at a  $\in$ 13.8k in surplus in the Revenue Account for the period to 30th September. This position assumes full recoupment of all costs incurred by the Council dealing with the costs incurred by the Council's Ukrainian response team. Also included under Division D is the ICOB and ICOB2 grant which was an unbudgeted item however it is 100% funded. The total ICOB expenditure and income included up to Q3 is  $\in$ 8.9m. The Q3 report also confirms a spend of  $\in$ 93.1m on capital development projects to the end of September, the majority of which has been incurred delivering the housing capital programme, projects in the Economic & Community Development Programme and Roads.

### **Cash Flow/Overdraft**

Ministerial Sanction remains in place for borrowing by way of overdraft in the amount of €20m to 31st December 2024. Ministerial Sanction has also now been received confirming borrowing by way of overdraft for 2024 in the amount of €15m, as approved by Members at the October meeting.

### Audit Committee/Audit

The next Audit Committee is scheduled for Wednesday 11th December and the committee will be meeting with the Local Government Auditor to discuss the 2023 Annual Financial Statement and the associated Statutory Auditors report. The annual reports from the Audit Committee prepared in accordance with Section 60 of the Local Government Reform Act 2014 are expected to be submitted to the Council early in the new year.
