QUALIFICATIONS

1. CHARACTER

Candidates shall be of good character.

2. HEALTH

Candidates shall be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

3. EDUCATION, TRAINING, EXPERIENCE, ETC.

Each candidate must, on the latest date for receipt of completed application forms:

- (a) hold at least an ordinary bachelor's degree (Level 7 in the National Framework of Qualifications) in Engineering.

OR

hold an ordinary bachelor's degree (Level 7 in the National Framework of Qualifications) **AND** a post-graduate master's degree (Level 9 in the National Framework of Qualifications) in Engineering.

OR

hold a master's degree (Level 9 in the National Framework of Qualifications) in Engineering attained after completing an integrated master's level programme of at least 4 years' duration, and which is accredited at CEng level by Engineers Ireland, or an equivalent accreditation body internationally.

- (b) have at least **five years** satisfactory relevant engineering experience;
- (c) possess a high standard of technical training and experience;
- (d) possess a high standard of administrative experience;
- (e) have a satisfactory knowledge of public service organization or the ability to acquire such knowledge.

Notes:

- (i) To ensure that Engineering has been studied to the level required by the local government sector, and in order to be fair to those who may have studied on a part-time basis, a level 7 degree will be assessed on the basis that the period of study undertaken should be equivalent to at least 180 ECTS (European Credit Transfer Accumulation System) credits.

- (ii) Candidates should note for future career progression, that at current it is policy of Wexford County Council that anyone applying for a senior Engineering post (Senior Executive Engineer, Resident Engineer, Senior Resident Engineer and Senior Engineer) will require at least an honours bachelor's degree (Level 8 in the National Framework of Qualifications) in Engineering to be eligible.

4. CITIZENSHIP:

Candidates must, by the date of any job offer, be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who is a spouse or child of an EEA or UK or Swiss citizen and has a stamp 4 visa; or
- (e) A person awarded international protection under the International Protection Act 2015 or any family member entitled to remain in the State as a result of family reunification and has a stamp 4 visa or
- (f) A non-EEA citizen who is a parent of a dependent child who is a citizen of, and resident in, an EEA member state or the UK or Switzerland and has a stamp 4 visa

THE POST

Executive Engineers are appointed to a variety of roles across the Council. The role can include responsibility for the management and successful delivery of both major and minor capital projects; responsibility for the management and effective delivery of services and responsibility for the management and supervision of staff.

Positions may arise in any area of the Council's functions which include Environment, Rural Water, Roads, Planning and Housing. The person/s appointed will work under the direction and control of the Senior Engineer or Senior Executive Engineer or other officer designated by the Chief Executive.

Environment

The Environment Section is responsible for the implementation of the national and regional Waste Management Plans that relate to Wexford and the enforcement of waste management legislation.

This includes:

- Waste Facility Permit granting and reviews at sites such as end-of-life vehicles, soil and stone.
- Environmental enforcement of illegal dumping, burning and unauthorised waste facility sites.
- Enforcing Producer Responsibility laws, which shift the financial and physical burden of product end-of-life management to manufacturers. This includes registering producers, monitoring compliance with regulations such as those for waste electrical and electronic equipment, packaging, and farm plastics.
- Control of litter and the provision and management of recycling services and facilities.

It is also responsible for investigating and resolving noise and air pollution complaints the management of public conveniences.

The section is also responsible for coastal protection which includes coastal protection works of varying scale, the management and maintenance of beaches, piers and harbours, protection and associated capital works.

Roads & Transportation

The Roads & Transportation section has the following key responsibilities:

Management of large civil engineering schemes for the construction of new roads, road and street improvement schemes.

Design of road improvement schemes, the design of village and environmental enhancement schemes and management of the Council's stock of bridges which includes inspections, major and minor refurbishment and the construction of new bridges.

Maintenance of roads and streets throughout the county together with the associated pavement and pedestrianised areas.

Advising with the transportation aspects of all major planning applications with responsibility for strategic traffic planning.

Traffic management throughout the county. Functions include traffic calming, improved pedestrian facilities, taxi rank locations, accident prevention and management of on-street parking.

Responsibility for the planning, design, installation and maintenance of all public lighting throughout the County.

The Active Travel Department based in the Roads Section and is tasked with delivering infrastructure upgrades to support safer walking and cycling in the county. Projects include:

- Safe Routes to School Programme (in collaboration with An Taisce Green Schools Green-Schools)
- Improved/segregated cycle paths.
- Improved crossings for walking and cycling.
- Upgraded/new crossings.
- Permeability measures to support improved access within and between local communities.
- Continued development of our urban space towards prioritising sustainable travel

The section also has responsibility for the Machinery Yard and Fleet Management ensuring efficient and cost-effective fleet management arrangements are in place to meet the operational needs of Wexford County Council.

Capital Projects

The Special Projects Office leads the delivery of many of Wexford County Council's large-scale capital projects, focusing on initiatives that promote economic growth, sustainable regeneration, and community development. Its work includes the development of industrial sites and business parks that act as catalysts for economic activity, as well as town centre enhancements and public realm upgrades that revitalise urban areas. The office also delivers high-value tourism projects, including visitor centres and new tourism experiences, and oversees major amenity and recreation developments such as public parks, sports facilities, and Greenway schemes. In addition, the Special Projects Office is responsible for the construction and redevelopment of public and civic buildings for cultural, heritage, and economic purposes, along with the delivery of strategic flood defence programmes that protect communities and strengthen long-term climate resilience.

Housing

The Housing Maintenance Department is responsible for the maintenance of approximately 5000 Council houses and manages major upgrade works to same, including infrastructural and energy efficiency upgrades. The section also provides general maintenance, estate management and support services.

The Housing Construction Department plays a vital role in delivering social and affordable housing under Ireland's national housing strategy, *Housing for All*.

Responsibilities include:

- Overseeing the planning, design, and construction of housing developments, ensuring compliance with building regulations and sustainability standards.

- Collaboration with stakeholders including with Design Teams, contractors, and members of the public to manage procurement, assess technical feasibility, and monitor project progress.
- Contributing to cost-effective and energy-efficient housing solutions, support modern methods of construction, and ensure that developments meet the needs of local communities while aligning with government targets and funding streams

Planning

Within Planning the building control unit ensures developments comply with the Building Regulations and Wexford County Council's Taking in Charge Policy.

PERSON PROFILE

DUTIES:

The duties of the post are to give the local authority and: -

- (a) such other local authorities or bodies for which the Chief Executive, for the purposes of the City and County Management Acts, is Chief Executive, and
- (b) to any other local authority or body with which an agreement has been made by the local authority or by any of the authorities or bodies mentioned in sub-paragraph (a) of this paragraph,

under the general direction and control of the Manager or of such other employee as the Manager may from time to time determine, such planning or ancillary services of an advisory, supervisory or executive nature as may be required by any local authority or body hereinbefore mentioned in the exercise and performance of any of its powers, functions and duties including the duty of assisting the Director of Service, or other appropriate professional employee, in the supervision of the planning or ancillary services of any of the foregoing local authorities or bodies and, when required to do so, to perform the duty of acting for the appropriate professional employee of higher rank during the absence of such employee of higher rank.

In general terms the duties may include: -

- the implementation of programmes and projects across all service areas, including in the areas detailed above;
- the supervision and contract administration of construction/operations/maintenance works;
- the implementation of projects in areas such as rural water, roads, environment, housing, building control and construction and other ancillary services;
- preparing budgets and ensuring that works are implemented within allocated budgets;
- ensuring that staff are trained and operate within the relevant skill sets;
- maintain and proactively develop a culture of Health & Safety in the workplace;
- ensuring compliance with Health & Safety legislation and regulations;
- ensuring works are implemented in compliance with all relevant legislation and regulations concerning procurement, planning, etc.;
- ensuring an efficient and effective response to all stakeholders;
- carrying out such other duties as may be assigned from time to time;
- developing and maintaining good interaction and relationships with other departments and stakeholders in delivering on projects.
- keeping detailed and accurate records of work and administrative activity.

Skills and Experience:

The ideal candidate for the position shall have:

- satisfactory Engineering Experience
- the ability to work under pressure (both independently and as part of team)
- the ability to work with multidisciplinary teams
- the ability to self-motivate to achieve good performance;
- the ability to motivate, empower, encourage and achieve maximum efficiency and value for money from the personnel and processes under their control;
- Have a good knowledge and experience of Project Management.
- experience of managing and scheduling a multiannual portfolio of projects within budget and on time;
- a track record of delivering results;
- an understanding of Local Authority services and structures in Ireland or have the ability to quickly acquire same;
- the capability of working in close consultation with key stakeholders and in seeking co-operation and consensus with a whole range of bodies and representative groups;
- experience in meeting regularly with stakeholders, providing updates, presentations and reports, taking customer feedback and ensuring any learning from same is used to enhance the operations of the organisation;
- experience in contributing to the operational and strategic planning processes and in the implementation of the agreed aims of same;
- excellent interpersonal, communication and influencing skills;
- good knowledge and awareness of statutory obligations of Health and Safety Legislation the implications for the organization and the employee, and their application in the workplace;
- experience of managing finance and budgets and ensuring value for money;
- the skills to schedule/programme the carrying out of work;
- an understanding of the role and duties of managers in safety management in the workplace;
- good general ICT skills;
- a focus on the customer and on service improvement including taking ownership and resolving issues arising;

Candidates must also:

- have the knowledge and ability to discharge the duties of the post concerned;
- be suitable on the grounds of character;
- be suitable in all other relevant respects for appointment to the post concerned; candidates, if successful, will not be appointed to the post unless they:
- agree to undertake the duties attached to the post and accept the conditions under which the duties are, or may be required to be, performed;
- are fully competent and available to undertake, and fully capable of undertaking, the duties attached to the position.

SELECTION PROCESS

Applications will only be accepted on the official Wexford County Council application form as advertised with the post.

Application forms must be typed and as fully complete as possible.

Applications will not be accepted after the specified closing date and time.

The selection process may include any or all of the following:

- The number of persons seeking admission to a competition generally exceeds that required to fill the available posts and while candidates may meet eligibility it is not practical to interview everyone. In those cases, the Local Authority may employ a shortlisting procedure. The number of candidates to be invited for interview shall be determined by the local authority. The shortlisting will be carried out by or on behalf of the Local Authority against criteria specified for the position and only on the basis of the information contained in the candidates application form;

- Completion of an online questionnaire or any other tests or exercises deemed appropriate by the Local Authority;
- A competitive preliminary and / or final interview, conducted by or on behalf of the Local Authority, this may include interviews being held remotely;
- The Local Authority may create a panel from which future temporary and permanent vacancies at the specified grade may be filled.

Any attempt by a candidate, or by any person(s) acting at the candidate's instigation, directly or indirectly, by means of written communication or otherwise to influence in the candidate's favour, any member of the staff of the County Council or person nominated by the County Council to interview or examine applicants, will automatically disqualify the candidate from the position being sought.

Wexford County Council will not be responsible for any expense a candidate may incur in attending for interview.

The Local Authority shall require a person to whom an appointment is offered to take up such appointment within a period of not more than one month and if he/she fails to take up the appointment within such period or such longer period as the Local Authority in its absolute discretion may determine, the Local Authority shall not appoint him/her.

CONDITIONS OF SERVICE

1. Tenure:

The post, whether temporary or permanent, is whole-time and pensionable.

Persons who become pensionable employees of a Local Authority who are liable to pay the Class A rate of PRSI contribution will be required in respect of their superannuation to contribute to the Local Authority at the rate of 1.5% of their pensionable remuneration plus 3.5% of net pensionable remuneration (i.e. pensionable remuneration less twice the annual rate of social insurance old age contributory pension payable at the maximum rate to a person with no adult dependent or qualified children).

All persons who become pensionable employees of a Local Authority will be required in respect of the Local Government (Spouses and Children's Contributory Pension) Scheme to contribute to the Local Authority at the rate of 1.5% of their net pensionable remuneration (i.e. pensionable remuneration less twice the annual rate of social insurance old age contributory pension payable at the maximum rate to a person with no adult dependent or qualified children) in accordance with the terms of the Scheme.

For new entrants under the *Single Public Service Pension Scheme* effective from 01/01/2013, superannuation contributions are 3.5% of net pensionable remuneration and 3% of pensionable remuneration.

2. Probation:

Where a person who is not already a permanent employee of Wexford County Council is appointed, the following provisions shall apply:-

- (a) there shall be a period after such appointment takes effect during which such person shall hold such employment on probation;
- (b) such period shall be 6 months but the Chief Executive may, at his discretion, extend such period;
- (c) such person shall cease to hold such employment at the end of the period of probation, unless during such period the Chief Executive has certified that the service of such person is satisfactory.

3. Salary:

The salary shall be fully inclusive and shall be as determined from time to time. Holders of the post shall pay to the local authority any fees or other monies (other than their inclusive salary) payable to or received by them by virtue of their employment or in respect of services which they are required by or under any enactment to perform. An allowance may also be payable in respect of travel expenses and subsistence.

Entry point to this scale will be determined in accordance with Circulars issued by the Department of Environment, Community and Local Government.

Appointees who are not existing public servants will enter at the minimum point of the scale.

4. Health:

For the purpose of satisfying the requirement as to health, it will be necessary for successful candidates, before being appointed, to undergo at their expense, a medical examination by a qualified medical practitioner to be nominated by the local authority. Defects reported as a result of this examination must be remedied before appointment. On taking up appointment, the expense of the medical examination will be refunded to the candidate.

5. Retirement / Superannuation:

Single Public Service Pension Scheme:

Effective from 1st January 2013, *The Single Public Service Scheme* applies to all first-time new entrants to the public service, as well as to former public servants returning to the public service after a break of more than 26 weeks.

All new entrants to pensionable public service employment on or after 1 January 2013 are, in general, members of the Single Scheme.

Pension Age: Minimum pension age of 66 years (rising to 67 and 68 in line with State Pension age changes). Scheme Members must retire at the age of 70 years.

New entrants to the public service appointed on or after 1st April, 2004.

Retirement Age will be determined by the terms of the Public Service Superannuation (Miscellaneous Provisions) Act, 2004. The Act introduces new retirement provisions for new entrants to the public service appointed on or after 1st April, 2004. For new entrants there is no compulsory retirement age and 65 is the earliest age at which retirement benefits can be paid.

In all other cases, 60 years is the minimum retirement age, with 70 years being the maximum retirement age.

6. Driving Licence

When required to do so holders of the office may be required to drive a motor car in the course of their duties and should therefore, hold a full driving licence for class B vehicles free from endorsement and disqualification.

7. Residence:

The holder of the post shall reside in the district in which their duties are to be performed, or within a reasonable distance thereof.

Additional Relevant Information

- An applicant who is found to be ineligible at any stage of the competition will not be further considered. Provision of inaccurate, untrue or misleading information will lead to disqualification from the competition, withdrawal of employment offer or dismissal.
- A candidate who does not attend for interview when and where required by the council, or who does not, when requested, furnish such evidence as the council requires in regard to any matter relevant to their candidature, will have no further claim to consideration.
- An invitation to attend for interview is not regarded as an admission that you possess the prescribed qualifications and/or requirements for this post. Documentary proof will be required before appointment where you claim credit for particular qualification, experience, etc.

- **General Data Protection regulation (GDPR)**

- **Former Public Service Employees**
Candidates should note that anyone who has taken part in public service early retirement schemes set out below is not eligible to take part in this competition.

Incentivised Scheme for Early Retirement (ISER):

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in the Department of Finance Circular 12/09 that retirees, under that scheme, are debarred from applying for another position in the same employment in the same sector. Therefore, such retirees may not apply for this position.

Department of Health and Children Circular (7/2010):

The Department of Health Circular 7/2010, dated 1st November 2010 introduces a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider public service or in a body wholly or mainly funded from public funds.

The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years, after which time any re-employment will require the approval of the Minister for Public Expenditure and Reform. People who availed of either of these schemes are not eligible to compete in this competition.

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduces, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the public services by any public service body (as defined by the Financial Emergency Measures in the Public Interest Act 2009-2011) for a period of 2 years from termination of the employment. Thereafter the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility) and the Minister's consent will have to be secured prior to employment by any public service body.

- **Declaration**

Applicants will be required to declare whether they have previously availed of a public service scheme of early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.
