HOUSING

Housing Strategy & Services

Under the Housing for All Programme 2022 to 2026, Wexford County Council must build a minimum of 1,159 new housing units within the programme timeframe. The status of overall programme delivery, which includes new built and leasing, is contained in the diagram below. (1218 below includes leasing)



It is the Councils intention to continue to deliver new housing, above the target provided under the programme, where demand exists and Department funding is available. The following tables outline the current delivery pipelines and status on projects. For LA Direct Build information, please refer to the Capital Development section of the Chief Executives Report.

Turnkey Delivery - The Housing Section periodically seek Expressions of Interest for the provision of social housing units via Turnkey Acquisition. The current Expression of Interest is open until the 13th November. All calls are seeking targeted delivery of smaller unit types (1 & 2 beds) in areas of need identified in the Housing Delivery Action Plan (HDAP). In addition, the process also seeks proposals for purchase of land in areas of need. All proposals received by Wexford County Council under the turnkey process are assessed by an Internal Assessment Committee.

ENERGY EFFICIENCY RETROFITTING PROGRAMME

Energy Efficiency Retrofit Programme **2025** is the **fifth** year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets & no of properties delivered and funded to date under this programme.

The range of works undertaken in the properties include external wall and attic insulation, new doors, new windows, blocking of fireplaces, low energy lighting, high efficiency boilers, and upgraded heating system and controls. All properties received a minimum of a B2 BER rating after the works were completed.

AFFORDABLE HOUSING



'Cnoc na Gréine' - Application Portal Launching January 2026



Wexford County Council, in partnership with Neville Homes are delighted to launch a new affordable housing purchase scheme for private buyers at 'Cnoc na Gréine', Enniscorthy, Co. Wexford. The development of new A rated homes will provide first-time buyers and eligible homebuyers the opportunity to buy a newly constructed home.

The new A Rated homes, a range of 2, 3 & 4-bedroom units, will see up to 16 affordable purchase properties made available for sale to eligible private purchasers at a price below the market price of the properties with funding secured under the Governments Affordable Housing Fund Programme.

Prices net of the Affordable Dwelling Contribution start from €214,000 for two bed dwellings and €240,00 for three-bed unit, with buyers able to get support through the Government's Help to Buy Scheme.

Applications must be made through Wexford County Councils Affordable Housing Portal which is scheduled to open January 2026.

Homeless Services and Support Unit (HSSU)

The figures below represent the total number of calls to the HSSU - it is not reflective of the number of individuals/families as quite often the same client may make multiple calls to the HSSU.

There were 1260 same:-	calls to the HSSU up to 30th October 2025, the following is the breakdown of
908 (72%)	Provided with advice and support in relation to housing and homeless prevention
140 (11%)	Supported with temporary, short, medium and long-term accommodation and tenancy sustainment support through Place Finder and Social Care Workers
199 (16%)	Calls were ineligible at the time for housing/homeless services. HSSU advised and assisted the caller on regularization of their housing situation.
13 (1%)	Calls received where it was not possible to complete a full assessment.

CHOICE BASED LETTING

The CBL System has had 3 system improvements based on feedback from elected representatives. Properties are now advertised individually with house specific photographs for easier identification and decision making form applicants. Secondly the system is now generating automated e-mails to advise of properties when advertised in an applicants area of choice. Thirdly, unsuccess applicants are receiving a notification e-mail that a property which they expressed an interest in has been allocated.

199 properties were available for allocation on the Choice Based Letting website from 01/01/2025 to 29/10/25.



Female Entrepreneurs in Wexford Celebrated on National Women's Enterprise Day

Over 100 women in business gathered at the Talbot Hotel Wexford on Thursday, October 16th, to celebrate National Women's Enterprise Day (NWED) 2025 — a flagship event organised by the Local Enterprise Office (LEO) Wexford aimed at inspiring, connecting, and empowering female entrepreneurs across the county.

Centred on the theme "Making It Happen," this year's event shone a spotlight on insight, growth, and visibility, celebrating the resilience, creativity and innovation of women driving enterprise across Wexford and beyond.

Hosted by presenter Shonagh Lyons, the event featured a stellar line-up of speakers, including keynote speaker Ruth Larkin founder and Managing Director of Lark Bridal Ltd, a serial industry entrepreneur behind multiple multi-million-euro businesses, and a professional consultant, trainer, executive coach and mentor focusing on foreign expansion, commercialisation, and sales and marketing strategy. Larkin's keynote speech inspired attendees to embrace strategic thinking, resilience, and confidence in scaling their businesses.



The Wexford National Women's Enterprise Day Ambassador, Sharon Ginnetty founder of Optimise Marketing, shared her entrepreneurial journey and insights into building a brand from the ground up. She was joined by Deirdre Delaney of Delaney Concrete Ltd. & Bio-Crete and, Niamh Byrne Owner of Ruby Rouge & Director of BuyerPix, for an engaging panel discussion exploring leadership, communication, and the realities of business growth.

Attendees enjoyed an inspiring morning of networking, discussion, and motivation, with opportunities to learn from the lived experiences of established business leaders who have "made it happen" in their respective industries.

SETU partner with Wexford LEO for business support clinics

South East Technological University (SETU) has partnered with the Wexford Local Enterprise Office (LEO) to deliver a series of targeted business support clinics for rural enterprises in the Rosslare area.

This collaboration aims to give local business owners direct access to one-to-one expert advice on key themes vital to the long-term competitiveness and resilience of rural SMEs — digitalisation, innovation, business succession, and sustainability.

The initiative responds to the increasing demand from Rosslare's business community for tailored, practical support in adapting to rapid technological change, planning for generational continuity, and building sustainable operations that can compete nationally and internationally.

The Business Development Clinics are designed to provide businesses with personalised, one-to-one sessions delivered by subject-matter experts drawn from both SETU and the wider LEO mentor network.

Each participating business is offered a confidential consultation to review its current position and identify actionable steps for growth.

Key Focus Areas:

- Digitalisation: How to adopt digital tools, enhance online presence, and streamline business processes.
- Innovation: Developing new products, services, and business models with expert guidance from SETU innovation specialists.
- Succession: Planning for leadership transition, governance, and inter-generational continuity.
- Sustainability: Integrating sustainable practices and exploring green opportunities to future-proof the business.

Expert advisors from both institutions — including SETU lecturers and industry specialists in digital transformation and sustainability, along with LEO-approved business mentors — are providing guidance tailored to each enterprise's needs.

Each business attending the clinics also gains follow-on access to LEO supports such as mentoring, training, and export development programmes, ensuring that the advice received can be turned into practical action.

- Strengthen Rosslare's small business network through access to expert advice and innovation resources.
- Increase local adoption of digital tools and sustainability practices.
- Support succession planning and long-term viability for family-owned rural businesses.
- Enhance export readiness, leveraging Rosslare's strategic location.

In collaboration with Visit Wexford and Tourism Ireland, a new marketing campaign is taking place from November to target Great Britain visitors.





This campaign will operate on the "KAYAK" online travel agent network.

This marketing campaign will run for three months and will have the following reach:

- 300,000 co-branded display
- 600,000 on social media
- 500,000 direct emails

This campaign will be targeted at visitors aged 35+, with a strong 55+ audience who have the time and the spending power for short breaks and cultural getaways. This target market is more than twice as likely as the average traveller to visit historic parks, go to the theatre, and enjoy food and culture — which sits perfectly with what County Wexford has to offer.

This marketing campaign aligns perfectly with the Wexford Destination Development Plan (DEDP) and the International Marketing plan. This will be a fantastic opportunity to raise County Wexford's profile in one of our key international markets, with a strong digital push, and is focused on driving real bookings.



A year-long marketing campaign has also started with "The Irish World" newspaper which is read by the Irish diaspora and people in the UK who already have a connection to Ireland.


This marketing campaign includes a permanent banner ad on digital running across the year, guaranteeing over 300,000 impressions.




There will also be regular editorial features to keep Wexford in front of our target audience all year round.

Planning applications received 27th September to the 24th October 2025




Planning applications received 1st January to 24th October 2025

Conservation Works

The Heritage Section is currently overseeing essential conservation works at Clonmines church, Killag church and Ballycogley castle. These repairs will ensure the survival of these important medieval buildings and will help build resilience in the face of climate change. The work is being funded by the National Monument's Service's Community Monuments Fund which has provided €400,959 in grant aid.







Forward Planning

Housing Growth Requirements

Following the approval of the National Planning Framework – First Revision, the Minister for Housing, Local Government and Heritage has issued new Section 28 Guidelines with regard to the implementation of the new Housing Growth Requirements. The NPF has identified the need to plan for an additional 50,000 households nationally. Wexford has been allocated the fifth highest percentage increase nationally per year under the new housing growth requirement from 2025 to 2034 which will see an increase from 1,072 units to 1,622 units per year.

In addition, additional flexibility has been allocated to planning authorities with an increase threshold from 25% on additional provision of up to 50%.

Local Authorities are required to review the Core Strategy in their existing County Development Plan and, if necessary, amend it to accommodate the revised housing targets. Local Authorities must also review zoned land in within their functional area and determine whether there is adequate zoned land available to serve the revised targets. This work will require a Variation to the Wexford County Development Plan 2022-2028. The Chief Executive will prepare and submit a report to the Members outlining his recommendations on the method by which to implement the revised Housing Growth Requirements.

The planning team are currently working on the revised Core Strategy and reviewing a number of settlements to identify appropriate lands to zone. A tiered approach to zoning is being used to identify:

- 1. lands that are serviced
- 2. land that is serviceable within the life of the plan.

This will ensure that the lands which are proposed for zoning are capable rapid activation and housing delivery.

The proposed Variation will require assessment under the Strategic Environmental Assessment, Habitats and Floods Directives.



The National Human Rights Strategy for Disabled People 2025-2030

Work is continuing developing a new programme for Wexford County Council in line with the *5 Pillars* to deliver accessible services consistent with the requirements of the Disability Act 2005, the UNCRPD, and the newly published Human Rights Strategy for Disabled People 2025-2030.

The Access Section recently facilitated a request from CCMA Rural, Community, Culture & Heritage (RCCH) Committee which was related to *Pillar 3* of the new National Strategy. The request based on correspondence from the Joint Oireachtas Committee on Disability Matters

Pillar 1: Inclusive Learning and Education

Pillar 2: Employment

Pillar 3: Independent Living and Active Participation in Society

Pillar 4: Wellbeing and Health

Pillar 5: Transport and Mobility

seeking a written submission from Local Authorities, on the subject of "Participation in Community Life for Persons with Disabilities" with a particular emphasis on leisure and sport. This correspondence demonstrated the type of data, evidence and statistical level of information which is now expected in response to Local Authorities meeting their obligations on Disability Matters.

The Access Section will endeavour to base the design of any new programme, strategy in keeping with the structure type and level of detail that the recent survey request demonstrated. It highlighted a more collaborative interdepartmental approach to recording information which extended beyond our direct services to include data from sporting and leisure facilities and activities supported by means of Wexford County Council funding.

TOWN CENTRE FIRST

Measure 2. The Courtown/Riverchapel TCF Plan is now adopted and we are looking at officially launching the Plan in the coming weeks.

A big thank you to the Courtown/Riverchapel Town Centre First Team who are a voluntary group representing business and community groups throughout Courtown/Riverchapel area and who have given of their time and energy into ensuring that this process was a success.

A pipeline of projects has been identified that can make Courtown/Riverchapel a better place to live, work, visit and do business. Measure 3. Work is ongoing with the Project development measures for these 2 €50k projects.

- 1.St Michaels Theatre, New Ross. Drawings are now complete and will be forwarded to St Michaels Theatre board (Feachtas Ealaoin) in the coming weeks. These detailed design drawings will enable Feachtas Ealaoin to go to tender for the roof replacement and enhancement works when funding allows.
- 2. Kilmore Scope/ Bridgetown hub for Water based activities/walking cycling tourism. The preliminary drawings for the water hub are complete and we had a very successful consultation evening in October where in excess of 50 people attended during the afternoon and evening. We will be delivering these drawings and community report to Kilmore Scope with a view to working with them and the wider community in delivering on this ambitious project for this community.





Measure1: Under this measure Town Teams were established in Taghmon, Castlebridge and Bunclody with investment in capacity building helping to get these teams engaged. Meetings have taken place in Sept with other Town Teams to meet in Oct/Nov.

Vacant Homes - Work is continuing on vacant homes with €439,098 paid out in Grants in the last 4 weeks and nearly €450,000 of initial approvals granted in this time period which is having a very positive impact on improving vacancy and dereliction throughout the County.

ROADS & TRANSPORTATION

MAJOR NATIONAL ROADS PROJECTS

N11/N25 Oilgate to Rosslare Harbour - The Project is in Phase 3 – Design and Environmental Evaluation.

Project design is progressing, with additional tasks underway to address Service Area requirements, Active Travel provisions, and Biodiversity considerations.

Engagement with larnród Éireann is ongoing in relation to the railway protection structure at the River Slaney bridge crossing. The preliminary design of the preferred bridge type over the River Slaney is in progress.

Updates to the traffic modelling are ongoing, along with the repeat of certain environmental surveys.

Phase 3 Targeted Archaeological Test Excavation tender process has commenced.

Preparation of the Maritime Usage License (MUL) and Maritime Area Consent (MAC) applications is ongoing.

Consultation with directly affected landowners is continuing, and the Technical Advisors are advancing design updates to address landowner concerns as far as possible.

A Real Estate Valuation of the currently proposed alignment is ongoing.

The preparation of Environmental, Planning, Design, and other supporting reports is ongoing.

N25 Rosslare Europort Access Road - The project is currently in Phase 5 – Enabling and Procurement.

The Management Group has provided additional comments to the Technical Advisors regarding the Main Construction Contract Tender Documents, specifically in relation to the due diligence review. A response from the Technical Advisors is awaited.

Technical and safety approval for Structure B1 (Railway Overbridge) has been received from larnród Éireann. The Bridge Agreement has also been received from larnród Éireann and is currently under review by Wexford County Council's legal advisor.

Negotiations between real estate valuators and landowners regarding Compulsory Purchase Order (CPO) compensation is ongoing.

Draft procurement documents for the appointment of Technical Advisors for Phases 6 and 7 have been submitted to TII for review and approval. The formal tender process is expected to commence shortly.

On-site works under the Archaeological Services (Stages I–IV) contract are expected to commence in the coming weeks.

Restoration Improvement Programme

Wexford's allocation is €12,440,500. This includes a further €372,500 funding under RI approved by the DoT in August 2025 and this was used to extend the works at Kellystown, Adamstown in New Ross MD.

97 projects have been added to our countywide programme – total of 86 projects completed to date. The remaining projects will be completed over the coming weeks.

Surface Dressing Programme

Wexford's allocation is €2,841,500. 71 projects have been added to our programme with all 71 completed.

Community Involvement Schemes - All 7 schemes completed

Local Involvement Schemes (LIS) - €619,894 funding allocated in early 2025. A further €560,298.00 was announced by DoT. Preparatory works are underway to progress all schemes.

Adoration Convent Wexford - A formal ground-breaking ceremony was held on September 30th, attended by elected members, the Adoration nuns and officials from Georgia Southern University and Wexford County Council. Works are progressing well onsite & completion is scheduled for January 2027.

Ballast Office - (A) Essential Repair Work - Award of contract is now imminent and works are expected to start in the coming weeks.

(B) Refurbishment - Initial investigations are being carried out into the potential suitability of the building for use as the Borough District of Wexford Offices.

LOCAL COMMUNITY SAFETY PARTNERSHIP

The inaugural meeting of the Wexford Local Community Safety Partnership was held on the 30th September 2025 at Wexford Council Chamber.

This is the first meeting of a safety partnership to be held in the country with welcome addresses by the Chief Executive, Minister for Justice Mr. Jim O' Callaghan, (video recording) and Chief Superintendent Derek Hughes.

The partnership comprises of 29 members representing state agencies, local authority elected members and community groups which will now work together to improve and enhance community safety in the county. Councillor Mary Farrell was elected Chairperson and Councillor Ger Carthy was elected Vice-chairperson. A Steering Group was also established to begin the work on a 3-year Local Community Safety Plan. The partnership will report to the National Office for Community Safety at the Department of Justice which supports and oversees all Local Community Safety Partnerships throughout the country.

COASTAL MATTERS

Seaview Coastal Protection project is in its final stage with beach access to commence shortly. Project should be finished at the end of the year. Precast concrete segments for the beach access are currently being placed.

Fethard Harbour New Slipway and Beach Access - The Department of Environment, Climate and Communications is in the process of finalising a decision on this project The revised Natura Impact Statement (NIS) is being reviewed by the Foreshore license section.

Kilpatrick temporary beach access completed in April, meeting with NPWS is planned for 03rd November to progress to a permanent solution.

Killmannock Drainage works: Hedge cutting, surveys have been carried out, Wayleave application is being progressed to access drainage works area.

Ballyhack & Passage East Car Ferry Infrastructure: Mini Tender sent to consultants for this works. Consultant is in the process of being appointed

Ballyconniger & Clone bridges due to be removed in October.- Next week.

Rosslare CRFRS: Ongoing, no date fixed for 2nd Public Participation Day yet, likely to be Q1 2026.

Cahore North Beach Rock Armour Enhancement: Premlinary drawing and ecology reports being prepared, with works due to be carried out Q1 – Q2 2026.

DAFM Funding - We were allocated a total of €690,000 for Pier & Harbour projects by the Department of Agriculture, Food & Marine for projects in Duncannon, Slade & Courtown Harbours. 75% is funded by the Department, 25% co-funded by WCC.

Court cases

The monitoring returns on receipt are assessed by Environmental Technical Staff and actively pursued to address any ongoing issues arising from exceedances in chemical/microbiological and flow parameters as laid down in the Discharge Licence for the site.

Low Smoke Fuel Areas - The 5 stations in Bunclody, New Ross, Wexford, Enniscorthy & Gorey have now had their monitors updated to measure air quality and noise levels. A new station has been installed in Bunclody and is fully operational. The 18 low-cost sensors installed in Enniscorthy monitoring PM10 & PM2.5 have been removed to be calibrated. The TownAir Project to monitor gases NOx, SO2, CO has now been completed. This will be compared with 2016 levels taking during the SAFFIRE project. The project team will give an update once the work has been completed.

Air -Volatile Organic Compounds (VOC's)

(Auto-Refinishers) currently there are 72 registered auto refinishers around the county. Q4 Website Register of compliant premises (Auto Refinishers) to be updated in December. Site inspections are ongoing. 1 Site identified for enforcement in Q4 has ceased operating.

Agriculture - Wexford County Council continue to undertake a significant number of farm inspections under the National Agricultural Inspection Programme. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 are served upon farms where major non compliances are observed and are open to cross reporting to DAFM.

Under the National Agricultural Inspection Programme, Wexford County Council carried out a total of 170 farm inspections in 2024 and the target has risen to 271 inspections in 2025 concentrating in areas where water quality was most at risk of not meeting its objectives under the WFD. A total of 177 of these 271 initial GAP inspections have been carried out at teh end of October 2025. A team of 4 Assistant Scientists take on this role lead by the Agricultural Scientist in the Environment Section. A total of 281 farm inspections have taken place altogether up to the end of October under GAP regulations, Sludge use in Agriculture, complaints made by the public, initial and follow up. The team continue to work in Aughboy, Mangan, Boro, Owenduff, Heathpark & Begerin catchments for 2025.

A total of 104 Agricultural related Planning Permission Applications have been assessed in 2025 highlighting the continued investment in Wexford Agriculture and maintaining compliance with Good Agricultural Practice Regulations.







CLIMATE ACTION

WCC is behind on our glide path for Thermal and Transport emissions. If HVO is not used for our fleet, in a significant way, Wexford County Council will not meet our CO2 target of 51% reduction by 2030. Currently we are above CO2 emissions from the baseline years of 2016-2018, so we now require over 51% reduction by 2030.

The Climate team organised\attended a number of events\meetings recently including

- 1. Energy Information Event for the SMEs of Gorey was held on 15th October in Loch Garman Arms by the Climate team with speakers on the night from the South East energy Agency and the Local Enterprise Office. The event provided information on grants for businesses and how to apply for an energy voucher for an audit for your business.
- 2. Over 55s Climate Course a leaflet was created to promote this FREE course which will be held in Enniscorthy in Feb May 2026.
- 3. The Climate Action Coordinator held a meeting with SETU and a follow up meeting with SETU and Georgia Southern University on possible research projects that Environment and SETU? Georgia Southern could collaborate on.
- 4. Harnessing Bioeconomy Solutions for Climate Adaptation Event in Teagasc Grange with a tour of an Anaerobic Digester plant.
- 5. Progressed the EV onboarding project with meetings with the Fleet Manager and more meetings arranged with EV Providers.

COMMUNITY CLIMATE ACTION PROGRAMME (CCAP)

Wexford County Council has been allocated a further €669,000 under Phase 2 of the programme. The application window for Phase 2 opened on 21st October and will remain open for eight weeks until 5pm on Tuesday 16th December. Any not-for-profit organisation that is interested in Phase 2 of CCAP are encouraged to contact the CCCO for further information and to discuss their proposed project.

The CCCAP Phase I successful projects are progressing well with several stages completed, six of which have been fully completed.

Biodiversity

- Following on from the actions being adopted by the SPC, they are currently being incorporated into the Local Biodiversity Action Plan 2026 –2031. The plan is currently being drafted.
- Local Biodiversity Action Funding claims are currently being processed.
- A Rare Plant Mapviewer is being created, with a view to increasing staff awareness on the sensitivity of ground disturbance in certain areas.

Gorey Library held an interactive talk with personal trainer and Pre/Postnatal Fitness Specialist Stephanie O'Louglin. She shared practical, realistic strategies to improve strength, energy, and overall wellbeing.

SCIENCE

New Ross Library hosted Oliver McCabe, renowned nutritional therapist, author and TV chef. He shared ways on how to nourish the gut, boost energy levels and improve mental clarity incorporating foods into everyday meals.

A Life in Science with Dogs and other Animals

Wexford Town Library's' Science Cafe continued this month hosting a conversation with zoologist Kay Nolan, on understanding the molecular basis of animal development and evolution, which can contribute to better knowledge of the physiology of disease in humans.

LOCAL HISTORY

A total number of 39 local studies enquiries were responded to, together with a total of 26 genealogy enquiries completed in Wexford Town Library in October.

The disbanded Royal Irish Constabulary and forced migration 1922–1931

Wexford Town Library held a talk examining the process of disbandment and its immediate consequences, it focused particularly on men disbanded from Co. Wexford.

Revisiting a Bronze Age Burial Landscape

North Wexford Historical Society held their monthly talk in Gorey Library.

National Children's Book Festival 2025

Wexford Library Services, in association with Libraries Ireland, have been successfully hosting Children's Book Festival each October for many years. It continues to be the central focus for library services to children at this time of year and runs a successful programme of events for schools and families throughout the county.

This year Wexford Libraries' branches welcomed visits and workshops from well known Irish authors and illustrators as well as an online event.

CHILDREN'S SERVICES

Schools

Wexford Libraries' branches continue to liaise with local schools and Early Learning Centres and cater for weekly class visits for story-times, general book borrowing, and library activities. Outreach visits continue regularly also.

COMMEMORATION 2025

1925 County Wexford Local Elections

Enniscorthy Library hosted Historian in Residence Paul Byrne as he spoke about the County Wexford Local Elections in 1925, the first local election in the new Irish Free State.

Local Studies

Wexford Libraries uploaded their third collection to the Digital Repository of Ireland: Memories of 1916 - County Wexford Oral History Project. 14 oral recordings are included in this collection.

ARCHIVES

Collections management

In addition to 38 research enquiries via email, telephone and post, a total of five researchers visited the Archive during October. Research topics included an examination of local authority minutes and reports in relation to naval mines across County Wexford during and following the second world war (1939-47); family history research through undigitized minute books of New Ross workhouse (1882-95); research on the Rose of Castile opera performed in Wexford in 1951; viewing of a surviving window from the former Nuzum's Hotel, Enniscorthy by American descendants.

Acquisition

The archives of the Irish Countrywomen's Association are an important source for highlighting how instrumental the organisation continues to be in improving the lives of rural women. The Archive holds archival material for several ICA guilds across the county including the two earliest minute books for Bree guild where the ICA was founded in 1910 by Anita Lett. Archival material from Duncannon ICA guild was deposited in the Archive in late October comprising minute books, accounts, and photos from 1953 to 2024.

The Archive acquired an important 17th century letter which was written by Onesiphorous Phaire, owner of an ironworks near Enniscorthy whose father Robert had been granted substantial land in counties Cork and Wexford under the Cromwellian settlement. The letter, dated 5 June 1689, to his brother in Co. Cork provides an invaluable insight into the concerns that southern Irish Protestants faced at the time. Predating the 1798 rebellion by 109 years, the survival of family correspondence from the 17th century is relatively rare and this acquisition is even more significant as a result.

ARTS

Sidelong Glances: An Oblique Look at the Sea

The Arts Office of Wexford County Council, in partnership with Wexford Arts Centre, opened the group exhibition Sidelong Glances: An Oblique Look at the Sea. The exhibition features work from Irish Museum of Modern Art's (IMMA) National Collection and invited Irish and international artists, Orla Barry, Herman Braun-Vega, Gary Coyle, Ann Hamilton, Ailbhe Ní Bhriain, Kathy Prendergast, and Marisa Rappard. The exhibition was opened on the 13th of October by Christina Kennedy, Senior Curator, Head of Collections, IMMA and finishes on the 21st November 2025.

Wex-Arts Exhibition – Rooted Utopias: Our Future at Play at Westgate Heritage Centre

Group exhibition featuring work by Paul Carter, Denise Kehoe, Jo Kimmins, Mairead Holohan, Aiseling Noone, Seamus O'Brien, Liam O'Rourke, and Marika Sheridan and was curated by Karla Sánchez Zepeda, a local art historian and curator. The Exhibition opened on the 14^{th of} October and closed on the 1st November 2025.

Small Arts Festival and Failte Ireland Festival Open Call 2026

Wexford County Council Arts Office have announced two strands to the Festival Grant Scheme for Small Arts Festival grant and the Failte Ireland Small Festival Grant to take place in 2026. Deadline for receipt of applications for both is Monday the 1st December 2025 at 4.00pm. This scheme supports on average 20 festivals across the county with grants ranging from €1,500 - €3,000.

Artist in the Community Artist Panel Open call for 2026 – 2027

Wexford County Council Arts Office has announced an open call seeking professional artists across all art forms to design and facilitate Art Projects with communities throughout County Wexford in 2026 through the Artist in the Community Scheme. This opened on the 3rd October 2025 and the deadline for applications is 14th November 2025 at 5pm.

Guided Art Collection Tour at County Hall

The Arts office hosted an art collection tour for the public guided by local visual artist Oonagh Latchford on the 22nd October at 2pm. 15 people attended the tour.

Artist in the Community – Traditional Song Project at Grantstown Priory and artist Aileen Lambert

Wexford Arts office visited Grantstown Priory on 14th October for the conclusion of Artist in the Community Scheme project 'Traditional Song Project' between Grantstown Priory and artist Aileen Lambert. There was singing, dancing and storytelling, all from staff and clients of the centre - they have spent 5 weeks with Aileen learning new songs, which was finished off with a performance.

Creative Places Enniscorthy (CPE)

CPE is a 3-year Arts Council funded initiative in partnership with Wexford Arts Centre, Wexford Arts Office and Enniscorthy Municipal district seeking to embed creativity into Enniscorthy.

Enniscorthy Circus Club

This youth-led contemporary circus project began in October will bring together young members of the diverse communities that make up Enniscorthy, who may not otherwise connect to learn dance and circus skills over eight weeks with Doulab Circus and Dance.

Threshold Spaces

Is an Enniscorthy Environmental Art Project forged from the outcomes of a Research and Development project 2024; Unity in Diversity – Enniscorthy Land Art Project. The artist works with the Ukrainian woman's group looking at boundaries, domains and the threshold space are in the context of community life with artist Mayumi Nakabayashi.

Voices in Harmony

Enniscorthy male choir started a 10-week song writing project in October led by musician Paul O'Reilly. This will conclude with a performance in Enniscorthy.

Music Generation (MG)

Ongoing partnership between Wexford County council, WWETB and Music Generation supporting performance music education countywide for young people in 25 schools and a variety of youth work contexts.

Programmes in October

Bunclody Music Hub with ninety-seven young musicians, Selskar Sounds Music Hub with thirty five young musicians, Macky Music Early Years Music Programme and the Primary Schools Programme with musician educators working in 22 Primary Schools across Wexford County started the new academic year in the first week of October.

Opening of the Opera Festival and Fireworks

On 17 October Music Generation Wexford enabled twenty-eight 5th and 6th class students from Scoil Mhuire Coolcotts (partners on Music Generation Wexford's primary school music programme) to perform from the stage on Wexford's quayside at the opening of the Wexford Festival Opera, prior to the annual fireworks display.

Back to the Festival

In conjunction with Wexford Festival Opera 2025, Music Generation Wexford is producing Back to the Festival On the 23rd & 25th October, Aileen Donohoe, leads a performance devised to engage and provoke groups of young people to perform during the festival.

SCREEN WEXFORD

An Arts Office, Economic Department initiative to support the development of the film / screen industry in Wexford.

Crew Networking

Took Place this quarter at Presentation Arts Centre in Enniscorthy 24th October where local film crew get together and hear about opportunities and news in the film industry, 15 people attended.

The Picture House- Wexford Film Society 'One Last Show in Taghmon'

Screen Wexford attended the launch of The Picture House- Wexford Film Society where a local short film was premiered - 'One Last Show in Taghmon' on October 14th in the Art Centre. This film was supported in kind by Screen Wexford and Wexford County Council.

Professional Film Development Bursary

This bursary closes on the 30th October for local filmmakers to avail of a €500 bursary towards the cost of Script to Editing film costs.

CREATIVE IRELAND

Rural Connections

Creative Ireland Wexford has invested in 5 rural community venues (one from each Municipal District) including Colclough Memorial Hall, Saltmills, Marshalstown Community Hall, The Bank Rosslare, Castlebridge Community Hall, and Ballyfad Community Hall. Artist-led workshops continued throughout October to understand how these venues can be further animated through creativity and improve their function locally. A sharing session will take place on the 19th November at Castlebridge Community Hall with some seed funding awarded to each venue to take ideas forward.

Bunclody Placemaking Project

The Creative Ireland Programme supported a creative placemaking consultation for Bunclody, led by placemaking experts Studio Myco. The people of Bunclody have an opportunity to share their thoughts and visions for future developments in the town. A report with ideas coming directly from the consultations will be available for future funding applications. The final workshop/consultation session for the Bunclody Placemaking Project took place on the 23rd October with Transition Years attending FCJ Bunclody. Syudio Myco will present findings at an exhibition at St. Aidan's Hall in Bunclody on Thursday 27th November 6.00-8.00 pm.

Enchanted Ecologies, Redmond Park, Wexford

The Enchanted Ecologies project led by artist Mayumi Nakabayashi offered users of Redmond Park new ways to connect with the park through the biodiversity and natural materials found there. Mayumi delivered 14 workshops in the park throughout the year, with the final two happening in October 2025. A small bowl made of clay found only in the Enniscorthy district was made as part of this project, and it was set into an old tree stump by the Men's Shed who are resident in Redmond Park, to collect rainwater that can be used by birds and wildlife.



Good Grief Phase 2

Phase 2 of the Good Grief project began in October 2025, with workshops coinciding with the Grief's Current Shape exhibition in Garter Lane, Waterford. Ore workshops will be held in November and December at the Storyteller's House in Oulart, Wexford, and the Presentation Arts Centre, Enniscorthy.

Audit

Cash Flow/Overdraft
