**Section 75 of Roads Act 1993  
Temporary Closing of Roads**

Notice is hereby given that Wexford County Council intends to close the road listed hereunder to vehicular traffic from 08.30 to 18.00 on Sunday 13 October 2019, to facilitate refurbishment works to the electricity supply network.

**Road Closure** R744-1 Templeshannon, Enniscorthy from the Hendrick Tyre Centre to the Pharmacy

**Alternative Route** From Hendrick Tyre Centre to Clonhasten to Drumgold to Templeshannon to the Pharmacy via the R744, L6057, L6056, L2040, and the L2500.

Alternative routes will be signposted. Local access will be facilitated.

Any person wishing to object to the closing of these roads should lodge the objection, in writing, to the County Secretary, County Hall, Wexford, before 12.00 noon on Monday, 16 September, 2019.

Temporary Closing of Roads**

Wexford County Council has decided to close the roads listed hereunder to vehicular traffic from Monday 16 September 2019 to Friday 29 November 2019, between 08.00 and 18.00 each day, to facilitate the installation of water mains.

**Road Closure:** L5135-3 From Ballyandrew Cross Roads, Ballyandrew to its junction with the L5136 (Road towards Kiltomas Cross Roads).

**Alternative Route:** From Ballyandrew Cross Roads to Boolnadrum Bridge to Bull Ring Cross Roads to Kiltomas Cross roads to Ballyandrew via the L5138, L1017, L1014 and the L5136.

**Road Closure:** L5135-2 Ballyandrew, Tinnashrule and Askinamoe from its junction with the L5136 (Road towards Kiltomas Cross Roads) to its Junction with the L5137 (Road towards the townland of Moneydurtlow).

**Alternative Route:** From Ballyandrew to Tinnashrule to Kiltomas Cross Roads to Newtown to Ferns Upper to Askinamoe via L5136, L1014 and the L5135.

Alternative routes will be signposted. Local access will be facilitated. It is anticipated that the roads will re-open to traffic at weekends and evenings.
