Section 75 of Roads Act 1993 **Temporary Closing of Roads**

Wexford County Council has decided to close the road listed hereunder to vehicular traffic for two one week periods between 10 December 2018 and 10 March 2019, to facilitate road surfacing on the Mountelliott Roundabout.

Road Closure:

Craywell Road (R700) from its junction with the N30 to its junction with College Road (L8504).

Alternative Routes:

Northbound - From John Street to College Road to Mountgarrett Road to Ring Road to Mountelliott via L8504, L8039 and N30.

Southbound - From Mountelliott to Irishtown to Haughton Place to Mary Street Upper to Mary Street to North Street to John Street via N30. L4502, L4501 and R700.

During the December to March period the road will only be closed for a total of two weeks, i.e. two non-consecutive weeks. Because the surfacing work is weather-dependent it is not possible at this stage to state when the closures will take place, only that they will occur within the December to March window. Local residents will be informed by letter drop a few days in advance of the closures.

Alternative routes will be signposted. Local access will be facilitated.
