**Section 75 of Roads Act 1993
Temporary Closing of Roads**

Wexford County Council has decided to close the roads in New Ross Town listed hereunder to vehicular traffic from 15.00 to 19.00 on Saturday, 16 November 2019, to facilitate the Christmas Parade and the switching on of the Christmas lights Ceremony.

Road Closure: Quay Street, North Street, Lower Mary Street and South Street North (R700-2, L4501-1 and L4500-3).

Alternative Route: From The Quay to Oaklands Roundabout to Kent's Cross to Irishtown to Mountelliott via N25 and N30

Alternative routes will be signposted. Local and pedestrian access will be facilitated.

**Wexford, Waterford and Wicklow partner
with Welsh authorities to boost Tourism**

The Celtic Routes project seeks to transform less well known areas of Wales - Carmarthenshire County Council, Pembrokeshire Coast National Park and Ceredigion County Council, Wicklow, Wexford and Waterford through the development of links between areas. The aim is to increase the visitor appeal of these areas by offering a number of immersive, compelling and authentic Celtic experiences that will slow visitors down and change these less-know areas from transit zones to visitor destinations in their own right, thereby increasing the time visitors spend in these regions and boosting the economy of the local areas.

Learning Journeys – Invitation

In order to support and encourage participation by tourism operators in the Celtic Routes project and to encourage the development of business connections across the Irish sea, the Celtic Routes Partnership has established a 'Learning Journeys' scheme. The scheme provides an opportunity for businesses working within the tourism and cultural heritage sectors to visit similar businesses in the Ireland/Wales area where they will have opportunity to learn and share best practice, foster mutual learning and to forge and strengthen networks. The principle of Learning Journeys is that learning is shared.

Applicants seeking to access Learning Journey support must be able to clearly demonstrate a desire and ability to use the learning to improve their business and promote the Celtic Routes. A maximum 36 learning journeys (up to 18 from Ireland and up to 18 from Wales) will be supported by the Celtic Routes project.

Courtown North Beach and Marina Feasibility Study**

Wexford County Council has recently completed a study to determine the feasibility of reinstating a wide sandy beach to the north of the existing harbour at Courtown, constructing suitable coastal defences to retain the beach and an option of developing a new harbour. We will host a public information session on the feasibility study as follows:
