

## Roads

### Road Works Speed Limit Order, No.1 of 2019 on the N25 and L8056-6 at Pigotts or Tanyard, Arnestown and Ballymacar.

Notice is hereby given that Wexford County Council, in exercise of the powers under Section 10 of the Road Traffic Act, 2004, in the interests of road safety and to facilitate the construction of the N25 PPP New Ross By Pass; has made an Order entitled Road Works Speed Limit Order No.1 of 2019 relating to the N25 and the L8056-6 in the townlands of Pigotts or Tanyard, Arnestown and Ballymacar to apply a road works speed limit of

60km/h at the locations specified hereunder:

- On part of the N25 from a point 530.00 metres in a Westerly direction from its intersection with the L40072-1 to a point 915.00 metres in an Easterly direction from its intersection with the L8056-6.
- On part of the L8056-6 from its intersection with the N25 to a point 300.00 metres in a South Easterly direction from its intersection with the N25.
