Notice of intention to extinguish a Public Right-of-Way at the following location:

Chapel Lane Enniscorthy Wexford

Notice is hereby given that Wexford County Council / Enniscorthy Municipal District Council propose to extinguish the public right-of-way at the above location.

The right-of-way to be extinguished refers to a distance of approximately 130 metres of laneway, which extends in a northerly direction between Drumgoold Villas Enniscorthy and Marfield Estate Enniscorthy.

The lane is bounded at the northern extremity by the Local Road L6173-1 and at the southern end by Local Road L2039-1 as indicated on a map which may be inspected at the offices of Wexford County Council, County Hall, Carricklawn, Wexford & the Enniscorthy Municipal District Office, Court Street, Enniscorthy, County Wexford during normal office hours 9.00 a.m. to 5.00 p.m., Monday to Friday excluding Bank Holidays until 18th December 2019.

Any representation or objection to the proposal may be made in writing addressed to the undersigned at Wexford County Council, County Hall, Carricklawn, Wexford not later than 5.00 p.m. on 14th January 2020.

It should be noted that any person making such representation or objection may make a request in writing to state their case at an oral hearing conducted by a person appointed by the Local Authority for that purpose.

Wexford County Council has decided to close the road listed hereunder to vehicular traffic from Wednesday 4 December 2019 to Friday 20 December 2019, to facilitate the installation of a water main.

Road Closure: L5080-1 at Ballyminaunhill, from its junction with the L5079 at Barnadown Upper to its junction with the R741 at Coolnahinch.

Alternative Route: From Barnadown Upper to Clogh to Gorey to Paul Funge Boulevard to The Avenue to Ballyminaun to Barnadown Upper via the L5079, R772, L1038, R741 and the L5078.

Alternative routes will be signposted.

Local access will be facilitated.
