**Section 75 of Roads Act 1993  
Temporary Closing of Roads**

Notice is hereby given that Wexford County Council intends to close the road listed hereunder to vehicular traffic for a one week period between 4 February 2019 and 29 March 2019, to facilitate road surfacing on the Mountelliott Roundabout.

**Road Closure:** National Primary Road N30 at Irishtown/Mountelliott, New Ross.

**Alternative Routes:** **For National Road traffic**  
From Irishtown to Kent's Cross to Ballinaboola to Carrickbyrne to Adamstown to Ballymackesy junction via N30, N25, R735, and N30.

**For Local Road traffic**  
From Mountelliott to Corcorans Cross to Old Ross to Ballinaboola to New Ross via N30, L4003, L4008, L4010, N25 and N30

During the February to March period the road will only be closed for a total of one full week. Because the surfacing work is weather-dependent it is not possible at this stage to state when the closure will take place, only that it will occur within the February to March window.

Local residents will be informed by letter drop a few days in advance of the closure. Alternative routes will be signposted. Local access will be facilitated.

Temporary Closing of Roads**

**Road Closures:** L3027-2, L30271-1/2, and L7039-1/2 at Shelmaliere Commons (ed Forth & ed Carrick), Forth Commons (ed Rathaspick & ed Carrick) and at Bargy Commons
