# **Expressions of Sympathy:**

The Council observed a minute's silence.

## **Confirmation of Minutes:**

On the proposal of Councillor L. Allen, seconded by Councillor P. Byrne, the Council approved the minutes of the County Council meeting held on 10<sup>th</sup> December, 2007.

## **Matters Arising from Minutes:**

Cllr. J. Dwyer asked for the minutes to be amended under the item – "Expressions of Sympathy" to read

- the families of the recent victims of drug dealers.

## **Anti Social Behaviour:**

The Chairman welcomed Superintendent John Roche and Inspector Pat McDonald to the meeting.

Superintendent Roche advised the meeting that the priorities of the Policing Plan were:

Crime Prevention and Deduction, Road Safety, Public Order, Community Engagement.

### **Crime Prevention & Deduction:**

The Superintendent advised that there was

- 47% crime deduction rate in 2007
- 4% reduction in all headline crime
- 15% reduction in Burglaries
- 7% reduction in theft from unoccupied premises
- 8% increase in theft from shops
- 44% reduction in theft from persons

#### **Public Order:**

The Superintendent advised that:

- Public Order was a problem mainly at weekends
- There were 1495 incidents reported in 2007 (an increase of 287)

- There were 1200 incidents of criminal damage in 2007.
- He was deploying high visibility patrols outside night clubs at weekends.

## **Drugs:**

The Superintendent advised that:

- there were 370 seizures under Section 3 of the Drugs Act (possession for immediate use)
- there were 76 seizures under Section 15 of the Drugs Act (possession for sale or supply)
- there was a dedicated Drugs Unit in place.
- He had applied for a sniffer dog for the region.

## **Road Safety:**

The Superintendent advised that:

- There was 5 Sergeants and 32 Gardai attached to the Traffic Corps.
- They were targeting Drug/Drink Driving and Speeding.
- There were 19 fatalities a reduction of 15, 11 of these fatalities were single vehicle incidents.
- There were 990 incidents of drug/drink driving detected.
- There was a total of 12,900 tickets issued for various offences.

# **Community Engagement:**

The Superintendent advised that there was a full time Community Garda Unit currently staffed by 4 Gardai and would be extended by the assignment of 2 further Gardai.

In response to questions by the Members, the Superintendent advised that:

- All complaints to the Gardai are logged but it was necessary for the complainant to disclose their name and address and not all complainants were willing to do this.
- He had made an application for additional manpower to provide a full time station in Castlebridge.
- ASBO's referred to persistent and reckless behaviour once off incidents would not qualify.
- Burglaries of houses was a concern.

- There was a call forwarding facility in Bunclody Garda Station.
- It was policy not to take Gardai from the smaller stations.
- Part of New Ross was in the Waterford district but that would be addressed as part of the reorganisation of the areas.
- There were 1,500 Hackney licensed in the area but there was a problem accessing one at night in rural areas.
- A third Garda was approved for Ferns and the recently retired Garda was in the process of being replaced.
- The drug unit was a district unit and the officer in Gorey worked with the Arklow unit.
- It was planned to increase the community Gardai force.
- The new Wexford Garda Station would have facilities for the safe custody of prisoners and proper interview facilities.
- Joint Policing Committee was comprised of various sectors of the community who would fuel information into the Policing Plan.
- Drugs were very difficult to detect.
- With the Traffic Corps Patrols, there was practically a 24 hour Garda presence available.
- The Rosslare customs sniffer dog had been used on occasions.

The Chairman thanked Superintendent Roche and Inspector McDonald who then left the meeting.

## **Local Drugs Task Force:**

The Chairman welcomed Cllr Davy Hynes, Tommy Redmond and Sean Kelly to the meeting.

The representatives of the Task Force outlined the problems being caused by substance misuse and the requirement for additional resources particularly in the following areas:

Education
Treatment Centres,
Detox Centres
Methadone Clinics
Detection of dealers

The Members of the Council complimented the members of the Task Force on their dedication and outlined some of the problems being experienced in the Community. On the proposal of Cllr. D. MacPartlin the Council resolved to request the Minister for Justice to provide additional resources to the Gardai to assist in the detection of drug dealers and also to provide resources to assist with adequate treatment facilities.

The members of the Task Force then left the Meeting.

# **Wexford Harbour and Slobs Special Protection Area**:

Mr. A. Doyle, Deputy County Manager advised that he had requested Mr. Lorcan Scott, National Parks and Wildlife Service to attend the meeting to explain the designation to the Members.

Mr. Scott advised the meeting that the designation was proposed under EU legislation – EU Birds Directive (79/409/EEC) and would not change any of the operations currently present in the harbour, in particular any operation licensed by another Authority like Mussel Dredging, which was licensed by The Department of the Marine.

Mr Scott further advised that the list of operations requiring consent of the Minister in the proposed area were to protect wild life and were generally operations, which would alter, damage, destroy or interfere with the integrity of the area. Those who had a legal interest in the area could only make objections to the proposal and the objections must be on scientific grounds.

The Members of the Council expressed their concerns that as the proposed area stretched from Wexford Harbour to Enniscorthy it would effect any developments along that coastline in particular:

- The Trinity Wharf Development
- Mussel Dredging, which was listed as an operation requiring consent
- Leisure activities of Wexford Boat Club also listed
- The Car Park at Ferrybank
- The provision of another River Crossing at Wexford
- Works to relieve flooding in Enniscorthy
- The future of the Council's land at Edermine.

The Chairman thanked Mr. Scott for his attendance. Mr. Scott then left the Meeting.

Following discussion it was proposed by Cllr F. Kehoe that this Council while acknowledging the need for the protection of Wildlife call on the Minister for Environment, Heritage and Local Government to reject the proposed designation as advertised and to review the matter in consultation with Wexford County Council, Wexford Borough Council and Enniscorthy Town Council.

## **Notice of Motions:**

## Motion in the name of Cllr. John Dwyer:

"That this Council notes the increase in agency employment throughout the economy. We are aware that many workers from home and abroad are offered agency employment when they are seeking direct and permanent employment.

We understand trade unions have raised concerns that many of these workers are retained on minimum conditions and in some cases are not receiving all their entitlements.

Agency employment should not be used as an unnecessary substitute for direct employment or as a mechanism for avoidance of or undermining of fair pay and conditions.

Noting that legislation will come before the Oireachtas on the issue of Agency Employment, this Council believes and will recommend to the minister that the principle of equal treatment should be included in any such legislation on this issue".

## Water, Environment & Emergency Services:

### **Nitrates Directive:**

Mr. N. McGuigan, Director of Service, advised the members that the Council was obliged to carry out farm inspections and report any irregularities to the Department of Agriculture and that the first priority was to inspect the Council's drinking water abstractions followed by the rivers for pollution.

It was proposed by Cllr. D. MacPartlin and seconded by Cllr. P. Codd that the Council request the Department of Agriculture to extend the Farm Waste Scheme because of the effect of the weather on the ability of farmers to comply within the current time frame.

### **Transportation:**

Mr. A. Doyle, Director of Services, advised the members:

- The flooding of one of the roundabouts on the Gorey By-Pass was due to a stream being blocked which had now been cleared
- The provision of CCTV cameras to detect persons littering at parking areas on the Gorey By-Pass was being examined
- The road works 8 years ago between Ferns and Camolin was resurfacing and was of a temporary nature, the current works being carried out are strengthening and resurfacing
- There are no specific funds available for the resurfacing of Wexford Quays. The Council would need a substantial increase in the roads discretionary grant to carry out the works.

## **Progress Reports:**

### Housing:

In response to member's questions, Mr. T. Larkin, Director of Services, advised:

- There was a difficulty resolving the issue of separated persons who still had a legal interest in a house with regard to their social housing application. Attempts were being made to deal with each application on its merits but there was a need for persons to resolve their legal issues. He would brief the SPC on the matter.
- Applications were still being accepted under the Housing Aid for the Elderly Scheme but only exceptional cases were being approved as the budget was expended.
- There were issues still outstanding in relation to the Esmonde Road, Enniscorthy. The Council had invested heavily in Chapel Lane, a playground, landscaping and planting, all of which had been subjected to vandalism. The derelict house would be demolished shortly and plans were being prepared for the development of land in Council ownership in the area.

### **Environment:**

In response to member's questions, Mr. N. McGuigan, Director of Services, advised:

- The Consultants report on the suitability of the property for the Gorey Civic Amenity Site had been received, the cost had to be negotiated with the owner and a submission for funding forwarded to the Department of Environment, Heritage and Local Government.
- All dogs were required to be under control in public places and there
  was legislation in place dealing with the muzzling of certain breeds of
  dog
- A draft proposal had been prepared in relation to St. Kieran's Pier and attempts were being made to resolve the problems with the owner
- There was a community action day planned for the Enniscorthy Area.

# Planning:

### **Budget 2008:**

The Draft Budget and County Manager's Report for 2009 had already been circulated to the Council. The County Manager outlined significant pressures impacting on the budget and main highlights for which provision was made as follows:

The draft budget has been framed in the context of a very challenging economic period. The downturn in national exchequer returns has resulted in a reduction in the allocation from the Local Government Fund of 6.13% or €1.4m. It has proven particularly difficult to present a balanced budget for the coming year. While successful efforts were made over the last number of years to keep rates increases lower than the prevailing inflation rates, it is not possible to do so this year.

In summary the following are the proposals for some of the main charge-related income areas:-

- The Rates increase proposed is 4.5%.
- It is proposed to reduce Wheelie Bin charges

240 litre bin - €399

140 litre bin - €324

80 litre bin - €224

- It is proposed to maintain the landfill charge at €110 per tonne (plus levy of €20) for one off customers.
- It is proposed to increase water and waste water charges by 3%.

Following discussion the Council considered the detailed proposals of the budget.

# Division A – Housing and Building

The members considered the provisions under services A 01 to A 11.

In response to members, Mr. T. Larkin, Director of Service, advised:

- Increased income from rents was due to increased housing stock.
- The allocation for D.P.G.'s and housing aid for the elderly will not meet the current demand and a report outlining proposals will be brought to the members early in the new year.
- Support staff for RAS had been pared down but were sufficient to meet the workload.
- The Council's traveller accommodation units were satisfactory and any reduction in the allocation would result in a deterioration of the service.

# **Division B - Road Transport and Safety**

The members considered the provisions under services B01 to B11.

In response to members questions Mr. A. Doyle, Director of Services, advised

- The provisions for grant income were estimated as the allocations from the Department were not yet notified.
- There was a provision of €100,000 for taking housing estates in charge with an income of €50,000 from local contributions.
- Tender prices for works were sought annually.
- Maintenance works on local bridges would be carried out from the general maintenance provision.
- Emergency repairs would be carried out from the general maintenance provision.
- Provision and improvement of public lighting would be funded from a capital balance. There is a sufficient amount available to do this for one year.

## **Division C – Water Services:**

The members considered the provisions under services C 01 to C 07.

In response to members questions Mr. N.McGuigan, Director of Services, advised

- Water Services for the Town Councils were now being administered by the County Council hence the contributions from other Local Authorities were omitted.
- The bulk of Public Convenience maintenance provision was the Council's own maintenance costs.

## **Division D – Development Management:**

The members considered the provisions under services D 01 to D 12.

In response to members questions Mr. E. Hore, Director of Services, advised

• There was €13,225,000 levied under the development levy scheme with €6,677,000 collected. The Planning Enforcement Section followed up on the collection but not all of the balance was due as some developments had not commenced while others were being built in stages.

# **Division E – Environmental Services:**

The members considered provisions under services E 01 to E 14.

In response to members questions, Mr. N. McGuigan, Director of Services, advised

- House insurance normally covered Fire Services costs for attendance and there was a hardship scheme in place.
- The Council had 17,000 domestic refuse customers.
- A commercial refuse collection would be considered but the Council would remain with the domestic only for the present.
- The Council was negotiating with commercial customers on landfill charges.

# <u>Division F – Recreation and Amenity:</u>

The members considered the provisions under services F 01 to F 06.

In response to members questions Mr. T. Larkin, Director of Services, advised

- Reduction in expenditure under the Arts programme would not jeopardise the overall programme
- The provision under Community Grants included long term funding of capital projects

## Division G – Agriculture, Education, Health and Welfare:

The members considered the provisions under services G 01 to G 06. There were no issues arising.

## **Division H – Miscellaneous Services:**

The members considered the provisions under services H 01 to H11.

In response to members questions, Mr. G. Mulvey, Head of Finance, advised that 1% increase in the rates yielded €157,990.

## Adoption of Budget 2009:

Cllr. D. MacPartlin proposed the members adopt the following public statement in relation to the 2009 budget

"The imposition of the increase in the rates on business premises is directly related to €1.4 million reduction in the local authority fund provided by the Government.

Because of this cut, the decision by Councillors to increase rates is inevitable in the absence of any other source of income. We acknowledge that this is an unfair imposition on the business sector at a time when many of them are encountering economic difficulty.

However Councillors are required by law to agree a budget and failure to do so will lead to their dissolution with the budgetary decisions then taken by the County Manager.

We do not believe that a dissolution of the County Council is in the best interest of the people of Co. Wexford as the ability of members to act for citizens in the difficult times ahead is of paramount importance. Accordingly, and with the greatest of reservations we have had to agree the budget proposed for 2009".

This was seconded by Cllr. P. Reck and agreed by the Council.

It was proposed by Cllr. P. Reck and seconded by Cllr. L. Allen that Wexford County Council adopt for the financial year ending 31<sup>st</sup> December the draft budget with the following amendments
