1. <u>Presentation by Valuation Office (In-Committee):</u>

On the proposal of Councillor L. O'Brien, seconded by Councillor A. Donohoe, it was agreed that Item No. 1 on the agenda would be held In-Committee to allow for open discussion on the new valuation proposals.

The Cathaoirleach welcomed the Rates Staff to the meeting.

Declan Lavelle, Head of Valuation Services, then made the attached presentation. He advised that the new Valuation Office List will be published in autumn 2019.

Following the presentation Councillors raised a number of issues and questions which were answered by Declan Lavelle. Included in these issues were:

- The timing of issue of valuations prior to the 2019 local elections
- Concerns over progressive towns being hit harder by new valuations
- The method of assessing rental values
- The speed of revaluation of properties
- The relationship between the rent and the valuation
- The effect on family owned businesses
- Construction company premises and yards and office larger than is now required

- Vacant properties
- The amount paid by multiples and large supermarkets
- Rural v urban public houses value in trading data
- Work being carried out by local valuers
- Public utilities
- Two similar businesses
- Limits on increases
- The increasing rates on nursing homes will be passed onto elderly people
- Exemptions for sports and community centers
- Preliminarily valuations on change of use
- Valuations on 6 month trading

In particular Mr. Lavelle noted that the revaluations are closely linked to the rental figures, which reflect the market rent. The experience of the Valuation Office to date is that they have only received representations from 18% of rate payers with regard to the changes in the rates. He advised that he is conscious of the Local Elections in 2019 and will feedback the Members concerns to the Commissioner.

The Cathaoirleach thanked Declan Lavelle for his presentation and he noted that it was the general view of the meeting that the 2019 date for the revaluations to go live will certainly be an issue. He also asked that Valuation Office keep in touch with the County Council regarding any further updates on the matter.

On the proposal of Cllr. L. O'Brien seconded by Cllr. M. Byrne and agreed by all the Council approved the Section 26 Fire and Emergency Operations Plan 2017-2021 as submitted to the meeting.

4. Annual Service Delivery Plan Quarter 2:

On the proposal of Cllr. M. Byrne seconded by Cllr. R. Ireton the Annual Service Delivery Plan Quarter 2 was noted by the Members. A number of issues were raised with regard to the progress to date in some areas in the Report including roads, third level education, Holmestown, the park at Killeens, the Womens Refuge, CCTV, litter and illegal dumping.

The Cathaoirleach proposed given the number of queries that Members should email in their queries for detailed answers.

11. Notices of Motion:

It was agreed that motions 11.1, 11.5 and 11.6 would be dealt with together

11.1 Cllr. D. Wadding:

"This council calls on Minister Simon Harris to acknowledge the flaws in the Herity report on foot of the tragic death of Thomas Power and to upgrade cardiac services at University Hospital Waterford providing a 24/7 service for the South East region which has a population of over half a million".

11.5 Fianna Fail Party:

"Recognising the need for the Southeast Region to have access to critical healthcare; recognising the failure of the Herity report and its rational and findings to deliver 24/7 Cardiac Care- Second Cath Lab, this Council calls on An Taoiseach and Minister Harris to instruct the HSE to proceed with the installation of this vital service with immediate effect and upon adoption, this motion is circulated to all the County/City Councils in the region".

11.6 Cllr. D. Hynes:

"This council calls on the Minister for Health to provide the people of the South East with 24/7 Cat Scan at University Hospital Waterford as the lack of the round the clock services is putting lives at risk".

The three motions were proposed by Cllr. D. Wadding, seconded by the Fianna Fail Members and Cllr. D. Hynes and agreed by all.

11.2 Cllr. D. Wadding:

"After the tragic Grenfell Towers fire disaster in London, we call for a review of fire safety standards in all council accommodation and of all new developments to ensure the highest possible fire prevention measures and materials are used".

The above motion was proposed by Cllr. D. Wadding, seconded by Cllr. A. Kelly and agreed by all.

Mr. J. Carley, Director of Services, advised that the Minister had asked for a national review to be carried out. The Director will send out copies of the Department Circulars received by the Council to the Members. He also noted that the Chief Fire Officer had commenced his own review prior to the receipt of the Circulars.

11.3 Cllr. D. Hynes:

"This Council calls on the Minister for *Housing*, Planning, Community and Local Government, to urgently look at the The Housing Assistance Payment (HAP) scheme which is replacing long-term rent supplement. On the Rent Supplement scheme, tenants were left on the housing list until such time as an offer of a social house could be made by the Council. It is now the case that applicants on HAP are not on the list any more (except in the unlikely case of a transfer). This is a discriminatory anomaly and prevents housing applicants on HAP from receiving an offer of a social house with all the advantages that accrue in security of tenure etc".

The above motion was proposed by Cllr. D. Hynes seconded by Cllr. A. Kelly and agreed by all.

At 5.15 p.m. Councillors J. Fleming and G. Carthy left the meeting.

11.4 Cllr. M. Byrne:

"Recognising the challenge of suicide in County Wexford and the need to promote positive mental health and supporting the work done by many voluntary groups in this County, that Wexford County Council resolves to continue to campaign for improved services in 2018 and to provide a fund for this purpose and for supporting voluntary groups in this sector. In order to this, the Council shall provide for a one off increase in the Local Property Tax of 1% for one year, 2018, with the specific purpose of all sums raised being used to tackle suicide and promote positive mental health in Co. Wexford."

The above motion had no seconder and therefore fell.

12. Sealing of Documents:

On the proposal of Cllr. L. O'Brien, seconded by Cllr. K. Codd Nolan the Members noted and approved the sealing of documents as submitted to the meeting.

Cllr. A. Donohoe welcomed the renewal of work on Courtown Pier.

Cllr. D. Wadding looked to reduce the numbers of bottles of water being used at Council Meetings and suggested that a water cooler would be used; it was agreed that this would be looked into by the County Secretary.

This concluded the business of the meeting.
