On the proposal of Cllr. J O'Rourke seconded by Cllr. G Carthy and agreed by all the Council resolved to adopt the above Minutes.

Matters Arising

Cllr Ger Carthy proposed that the September Council Meeting be held in person, this was seconded by Cllr Garry Laffan and was agreed by all. It was further noted that the remote facility would also still be available for those who preferred to attend virtually. The Chief Executive advised the meeting that a new Audio-Visual System was being installed in the Council Chamber to facilitate this hybrid style model going forward.

2. Local Property Tax 2022 - Local Variation Factor Decision

The Head of Finance advised the meeting that she was seeking approval for a 10% increase on the base rate for LPT in 2022 which is the same level that it has been retained at since 2018. The Chief Executive informed the members of the importance of this funding to progress the Councils Economic and Community development Programme.

Proposal: Cllr Michael Whelan proposed the increase of 10% and this was seconded by Cllr Ger Carthy.

Counter Proposal: Cllr Tom Forde proposed not to accept the 10% increase which was seconded by Cllr J Owens.

A number of Councillors spoke on the two proposals.

A vote was taken on the proposal to not increase the LPT for 2022. The voting result was as follows: 26 Against, 4 For, 1 Abstain and 3 absent at the time of the vote.

This counter proposal was defeated and the original proposal of increasing the LPT by 10% of the base year for 2022 was therefore deemed carried.

3. Draft Wexford County Council (Wexford Borough District) Traffic and Parking Bye Laws 2021

The final draft of the Wexford Borough District Traffic and Parking Bye Laws were circulated to the members for approval. On the proposal of Cllr G Laffan seconded by Cllr M Bell the Bye laws were unanimously approved.

- 4. Part XI of the Planning and Development Act, 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended).
- 4.1 LAC2102 Proposed erection of 20 No. two storey semi-detached dwellings together with all associated site works at Ramsfort Park, Gorey, Co. Wexford.

This proposal was approved by the members on the proposal of Cllr J Sullivan, seconded by Cllr M Bell.

4.2 LAC2103 – Development of a 12 Unit Residential Women's Refuge Building with associated social, communal, amenity and support spaces. A single 3 storey detached block with defined road and garden boundaries, storage, and service areas at The Rocks, Maudlintown, Wexford town.

This proposal was approved by the members on the proposal of Cllr G Lawlor, seconded by Cllr J Hegarty.

5. Briefing on the Draft County Development Plan 2021 - 2027

Mr. T Larkin, Director of Services advised the meeting that Section 2 of the Planning and Development (Amendment) Bill 2021 provides for a further period of up to one year for review off County Development Plans due to the extenuating circumstances with Covid. However, he noted that this was not yet enacted.

On the proposal of Cllr Pip Breen and seconded by Cllr J Hegarty it was agreed to proceed with the review of the Development Plan at the point.

It was further proposed by Cllr G Lawlor and seconded by Cllr M Sheehan that a meeting be held in person of the council as soon as convenient to progress this. A date of Monday 6th September was agreed for this meeting to be held "in person".

Cllr Forde noted that much of the responses to correspondence sent by the council were statements of what was already known.

10. Deferred Notices of Motion from Council Meeting 10th May 2021

10.1 Cllr. F. Ó Súilleabháin

Procurement

That Wexford County Council notes the long overrun in the completion period for some of our major projects, as well as the high overspend for some of our projects in comparison to the original projected cost.

As a solution, this council will:

(a) endeavour to insert a *Sunset-type clause* to tie developers to an agreed completion date on projects and (b) that we will insert a *Social Inclusion Contract* to ensure a higher percentage of local labour get employed and (c) that we will look at the model of *Community Wealth Building* as introduced in some local authority areas abroad. (CWB seeks to leverage existing local and regional resources to provide workers, families, and communities with greater control over their own economic development and ensure money is kept in the local economy)

As an example, in Co. Wexford this could entail the breaking down of a contract into smaller parts i.e., on Gorey Town Park project, one local company could be employed to do the soft landscaping: another the hard surface works and another the building works, playground etc.

This alternative model is more beneficial to the local economy and local businesses than the current e-tendering model which would appear to favour a single larger company.

On the proposal of Cllr T Forde and seconded by Cllr J Codd this motion was passed by the Council.

The Chief Executive did note that there may be some conditions of contract law in Irish Contract Law that may restrict this, and it was agreed that the Executive would investigate this further.

Suspension of Standing Orders

On the proposal of Cllr. G. Lawlor, seconded by Cllr. J. Hegarty and agreed by all, the Council resolved to suspend Standing Orders to allow the meeting to continue until 6.00pm.

10.2 Cllr. G. Carthy

"That we the Members of Wexford County Council request that the Minister for the Environment, Climate and Communications and Transport, Mr. Eamonn Ryan TD prioritises the planning, design and construction of the N24 Waterford to Limerick Corridor Road project within the Review of the National Development Plan. This project is critical to the development of the South East region and to the achievement of national targets on addressing regional imbalance by connecting the cities of Waterford and Limerick, the South East, South West and Mid-West Regions, Rosslare Europort, the Port of Waterford, and existing strategic transport corridors including the M7(Dublin – Limerick), M8 (Dublin-Cork) and M9 (Dublin-Carlow-Kilkenny-Waterford) motorways. It is further requested that this Notion of Motion be sent to the Minister for Finance, Mr Paschal Donoghue TD and Minister for Public Expenditure and Reform, Mr. Michael McGrath TD. "

As Cllr Carthy had left the meeting it was agreed to defer this motion to the September meeting.

10.3 Cllr. F. O Súilleabháin

"Wexford County Council should examine the *Community Wealth Building* model with a view to incorporating it into their Local Economic Community Plans (LECP).

Community Wealth Building has emerged as a powerful approach to local economic development and has been particularly successful in Preston, England, North Ayrshire, Scotland and Cleveland, United States.

The model will allow counties to leverage existing resources, such as procurement, to meet local needs while creating quality employment and promoting equity and sustainability.

This Council will initiate dialogue with local public bodies and semi-state companies in the locality regarding their potential role in the strategy.

That we will bring local businesses, enterprises, and community activists into the discussion around developing the project.

That we also engage with councils in Preston, North Ayrshire and elsewhere which have successfully developed this model."

(A number of councils have already passed this motion.)

On the proposal of Cllr F O Súilleabháin and seconded by Cllr T Forde this motion was passed by the Council.

Cllr L. Kelly left the meeting at this point.

10.4 Cllr. G. Carthy

"That this Council calls on the Government in the light of Brexit and other market influences to recognise the strategic value of the South-East Ports in Rosslare and Belview, Waterford through

- Strategic investment in the Ports, in particular through the purchase of additional land for the expansion of Rosslare Europort and the advance construction of Rosslare Europort Harbour Access Road.
- Amalgamation of the ports structure and governance to create a Tier 1 port as a combined entity.
- Designation of the combined entity as the service port for offshore renewables in The Irish and Celtic Seas. "

As Cllr Carthy had left the meeting it was agreed to defer this motion to the September meeting.

10.5 Received from Cllr John Fleming Referred from Housing SPC

"When a Councillor makes a representation on behalf of a client on the housing list, the Councillor is then to be informed/updated and included in all correspondence between the County Council and the client."

On the proposal of Cllr J Fleming and seconded by Cllr A Browne this motion was passed by the Council.

The Director of Service Ms. Carolyne Godkin noted that it would be difficult to include members on all documentation, she would commit to the member representation a client being updated once an allocation was made.

10.6 Cllr. T. Forde

"The local authority sector is obliged to bring all social housing stock up to a building energy rating of minimum B1 by 2030, as committed across a range of national and EU policies. As Wexford will struggle to achieve this ambitious target, I ask that this council write to the relevant Minister seeking sufficient funding to meet this obligation."

On the proposal of Cllr T Forde and seconded by Cllr G Lawlor this motion was passed by the Council.

10.7 Cllr. F. Ó Súilleabháin

"This council notes that a large portion of our county's secondary roads are in need of "total reconstruction".

It further notes that a recent assessment estimated that Co. Wexford needs 196 million euro in funding to bring our secondary roads up to what would be deemed a "reasonable standard."

That we now enlist the support of all 5 TDs this month in writing to the Department to ask what plans they have to properly address this crisis as a matter of urgency"

On the proposal of Cllr F O Súilleabháin and seconded by Cllr P Barden this motion was passed by the Council.

11.1"This council is calling on the HSE to give the temporary workers involved in the COVID 19 Vaccination Centre in Enniscorthy, full-time employment as a measure of appreciation to these people. Each one of these people have worked on the front line along with the doctors and nurses, often doing 12-hour shifts in order to get as many as possible of our people vaccinated in this time of national emergency and deserve nothing less."

On the proposal of Cllr D Hynes and seconded by Cllr T Forde this motion was passed by the Council.

Cllr. T. Forde

11.2 "I ask that this council seek to develop "rainbow walks" in support of Pride awareness, at different junctions/crossing points across the districts."

On the proposal of Cllr T Forde and seconded by Cllr C Byrne this motion was passed by the Council.

Cllr. D. Hynes

11.3 "This council calls on the Minister for Health to provide funding and reactivate the START Housing program which was operated jointly by the Council and Threshold. At a time when people's mental health is under pressure as never before in these unprecedented times, it is essential that people suffering from long term mental health issues be given support and accommodation as soon as possible and not be handed a HAP form and asked to fend for themselves."

On the proposal of Cllr D Hynes and seconded by Cllr G Lawlor this motion was passed by the Council.
