1. Confirmation of Minutes:

1.1 County Council Meeting 12th December, 2022

On the proposal of Cllr. G. Laffan, seconded by Cllr. A. Connick, the Council resolved to confirm the Minutes of the County Council Meeting on 12th December, 2022.

2.1.1 Matters Arising

Cllr. G. Carthy advised that there is a chronic shortage of bed capacity, resulting in serious delays in Wexford General Hospital. He called on the Wexford Members of the Regional Health Forum to seek an emergency open floor meeting of the Regional Health Forum to discuss the issues. Cllr. G. Carthy proposed that the Council write to the Minister for Finance requesting that he use the emergency legislative provisions introduced for Covid to provide emergency funding for the provision of 96 additional beds, and to consult the Attorney General in relation to same. This was seconded by Cllr. J. Owens.

- 2. Part XI of the Planning & Development Act, 2000 (as amended) and Part 8 of the Planning & Development Regulations, 2001 (as amended):
 - 2.1 LAC2211 Public realm space and utilise heritage building for multi-purpose use at Brennan's Lane and The Shambles, Mary Street, New Ross, Co. Wexford.

Having considered the report of the Chief Executive, on the proposal of Cllr. M. Sheehan, seconded by Cllr. M. Whelan, the Council resolved to approve the Part 8 for the public realm space and utilise heritage building for multi-purpose use at Brennan's Lane and The Shambles, Mary Street, New Ross in accordance with the terms of LAC2211, as circulated.

3. Section 183 of the Local Government Act 2001:

3.1 Intention to dispose of a portion of a former public road which now serves Clearstream Technologies, Enniscorthy, to Clearstream Technologies Ltd, Moyne Upper, Enniscorthy, Co. Wexford.

On the proposal of Cllr. J. O'Rourke, seconded by Cllr. K.C. Nolan, the Council resolved to approve the disposal of a portion of a former public road which now serves Clearstream Technologies, Enniscorthy, to Clearstream Technologies Ltd, Moyne Upper, Enniscorthy, Co. Wexford in accordance with the terms of the Section 183, as circulated.

4. Delegation to Travel to New York for St. Patrick's Day

Mr. E. Hore advised that it is proposed to send a delegation of two Members and one official to New York to participate in various engagements for St. Patrick's Day, on foot of an invitation from the New York County Wexford Association.

On the proposal of Cllr. M. Sheehan, seconded by Cllr. L. Kelly, the Council resolved to approve the New York delegation.

5. Invitation to New Ross Municipal District for Delegation to Travel to Hartford

Cllr. M. Sheehan, Chair of New Ross Municipal District advised that it is proposed to send a delegation of two Members and two officials to Hartford, Connecticut in light of the strong bond of the sister city relationship between Hartford and New Ross. The delegation will participate in various engagements for St. Patrick's Day, on foot of an invitation from the Central Connecticut Celtic Cultural Committee.

On the proposal of Cllr. M. Sheehan, seconded by Cllr. J. Fleming, the Council resolved to approve the Hartford delegation.

Cllr. C. Byrne requested that for all future proposed trips abroad, details of the number of people travelling and the length of stay should be provided to the Members. This was agreed by the Executive.
