2.1.1 Matters Arising

Cllr. G. Carthy sought an update in relation to rail connectivity for Rosslare. Ms. L. Hore advised that there is an all-island strategic rail review ongoing at present. Ms. L. Hore indicated that the Economic Development & Enterprise SPC has written to the Minister seeking an update.

2. Part XI of the Planning & Development Act, 2000 (as amended) and Part 8 of the Planning & Development Regulations, 2001 (as amended):

2.1 LAC2210 - Install a replacement stairs to access the cliff top walk at Arthurstown Pier

Having considered the report of the Chief Executive, on the proposal of Cllr. M. Whelan, seconded by Cllr. M. Bell, the Council resolved to approve the Part 8 for the installation of a

replacement stairs to access the cliff top walk at Arthurstown Pier in accordance with the terms of LAC2210, as circulated.

Ms. L. Hore outlined the reasons why the CPG recommended sending a strong delegation headed by the Cathaoirleach and the Chair of each Municipal District to Savannah in 2023 and sought the approval of the Council.

In relation to the response received from Minister O'Brien's Office (7.5 above), Cllr. T. Forde expressed his dissatisfaction that there is no room for discretion when assessing income over a 52-week period for social housing eligibility. Cllr. T. Forde is supportive of Cllr. M. Sheehan's previous motion which sought "to permit Local Authorities the ability to disregard the Annual Average (52 Week) Income rule to accept applications for Social supports in cases that present evidence of exceptional incidents of hardship and/or extenuating medical conditions". Cllr. T. Forde proposed that Wexford County Council write to the Minister expressing dissatisfaction with the current assessment process and this proposal was seconded by Cllr. G. Lawlor.

Response of the Executive:

If passed an invitation will be extended to the Russian Ambassador.

The motion was proposed by Cllr. J. Moore and seconded by Cllr. F. Ó'Súilleabháin.

Cllr. J. Moore spoke in favour of his motion highlighting that Ireland has led the way in peacekeeping and the intention of the invite is to highlight the impact on those who had to flee Ukraine. Cllr.'s T. Forde, D. Hynes and F. Ó'Súilleabháin spoke in favour of the motion.

Whilst acknowledging the well-intended spirit of the motion, Cllr.'s L. Kelly, M. Whelan, P. Breen, J. Codd, B.A. Murphy and G. Lawlor spoke against the motion.

The Cathaoirleach advised that there would be a roll call vote at Cllr. L. Kelly's request. The outcome was the motion fell with 5 in favour and 20 against. The voting was as follows:
