Wexford in accordance with the terms of LAC2213, as circulated.

On the proposal of Cllr. B.A. Murphy, seconded by Cllr. M. Sheehan, the Council resolved to adopt the Fire and Emergency Operations Plan 2022 to 2027.

Cllr. B.A. Murphy requested figures for the number of staff the Fire Service is down. Ms. C. Godkin agreed to provide information.

5. Wexford County Council Traveller Accommodation Programme 2019-2024, Mid-Term Review

Ms. C. Godkin outlined the requirement to undertake a mid-term review of the Traveller Accommodation Programme. Ms. C. Godkin advised that the review proposes an increase from 100 units in the original programme to 126 in the revised programme. The mid-term review has been approved by the Housing SPC.

On the proposal of Cllr. A. Connick, seconded by Cllr. W. Kavanagh, the Council resolved to adopt the revised Traveller Accommodation Programme 2019 – 2024.

6. Active Travel Study Tour – 21st May, 2023–24th May, 2023

Mr. E. Hore outlined the detail of a proposed Active Travel Study Tour to the Netherlands, funded by the NTA. The purpose of the tour is to learn from the best of Dutch cycling in terms of expertise, technology and infrastructure.

There was an extensive discussion on active travel with a number of Members expressing their dissatisfaction with the funding allocated to Enniscorthy and Gorey Kilmuckridge Municipal Districts.

Cllr. M. Whelan requested that the Executive share the list of active travel projects submitted to the Department for approval, and those approved for funding.

On the proposal of Cllr. P. Breen, seconded by Cllr. G. Laffan, the Council resolved to approve the Active Travel Study Tour.

13.1 Cllr. M. Sheehan & Cllr. P. Breen

"That this Council reaffirms our support for the Greyhound industry locally and welcomes the continued funding from the Government to uphold and maintain the standards, employment and recognises the economic benefit and return on investment. Furthermore, we call on our Oireachtas members to support the Industry and notes the opposition by three of them to ensure the passage of funding and jeopardising the future of the sport. "

Response of the Executive:

If passed, this Motion will be forwarded to the Minister for Agriculture, Food and the Marine, for consideration.

Cllr. G. Lawlor proposed the following amendment which was seconded by Cllr. L. Kelly.

"That this Council believes that the funding model under section 12 of the Horse and Greyhound Racing Act 2011 is in urgent need of review and replacement, and calls on the Minister for Agriculture, Food and the Marine to carry out such a full and independent review of the fund, including in particular with recommendations on:

- How best to support these sectors, those involved in it, and rural communities,
- Measures needed to ensure the highest standards of animal welfare are implemented and complied with,
- How the rights of workers in the sector can be improved and an employment regulation order introduced to set minimum rates of pay and conditions,
- Whether and how funding for these sectors and other sports should be aligned."

The Cathaoirleach advised that there would be a roll call vote on the amendment to the motion. The outcome was the motion fell with 9 in favour and 16 against. The voting was as follows:

On the proposal of Cllr. L. McDonald, seconded by Cllr. C. Byrne and agreed by all, the Council agreed to suspend Standing Orders to allow the meeting to continue past 5.30pm.

13.2 Cllr. T. Forde and Cllr. L. Kelly

"We call on the Department of Education and Minister Norma Foley to provide a clear commitment and timeframe for a new, and necessary, school building for Wexford Educate

Together National School. We ask that the Department begin to engage meaningfully with the school leaders throughout all stages of the project where they have failed to do so to date"

Response of the Executive:

If passed, this Motion will be forwarded to the Minister for Education, for consideration.

The motion was proposed by Cllr. L. Kelly, seconded by Cllr. G. Lawlor and carried.

13.3 Motion passed at Climate Change, Biodiversity and Environment SPC 17.11.2022

"Requesting a Special Meeting of the Full Council on the whole issue of coastal erosion, flooding and rising sea levels as most districts have a problem in this regard with land being lost or flooding problems."

Response of the Executive:

If passed, the Executive will liaise with the Climate Change, Biodiversity and Environment SPC and the Environment Department to facilitate a special meeting, as outlined.

The motion was proposed by Cllr. M. Farrell, seconded by Cllr. J. Moore and carried.

13.4 Cllr. J. Fleming

"I am calling on Wexford county council to implement the following policy, when Wexford county council purchase turn key developments or lease from an approved housing body that at least 15% of the properties have disability (wheel chair accessible) bathrooms on the ground floor ."

Response of the Executive:

Wexford County Council has included the following priority in our Strategic Plan for Housing Persons with Disabilities 2021-2026, County Wexford Housing and Disability Steering Group:

"Local Authority Turnkey acquisitions have increasingly become a method of social housing delivery in recent years. Where Wexford County Council acquires an entire development, 20% of units are required to be adaptable in line with the County Development Plan. Where only a percentage of units are being acquired the Local Authority should seek to acquire adaptable units where possible (subject to unit size and cost). There should also be an increased awareness relayed to developers around the need for adaptable units".

Policy objective 9 of the Housing Strategy in the Wexford County Development Plan 2022 – 2028 states "To promote Universal Design and Lifetime Housing standards in new homes built in the County in accordance with best practice. Significant developments of new homes shall ensure that a minimum of 20% of dwellings are suitable to accommodate or are adaptable to provide accommodation for people with disabilities. Developers will be

required to show an accessible route to the residential units from the boundary of the property. Proximity and access to local services must also be considered relative to the units which are accessible".

Wexford County Council has to be cognisant of the current housing demand and the available supply of turnkey properties when assessing proposals. The Housing Department also works closely with AHB's, many of whom specialise in the delivery of accommodation for people with disabilities.

The motion was proposed by Cllr. J. Fleming, seconded by Cllr. M. Whelan and carried.

13.5 Cllr. J. Hegarty

"Wexford County Council has previously expressed its full support for the Healthy County Committees "Not around us" campaign to discourage smoking or vaping in any outdoor area used by children and young people. In support of the next phase of the "Not around us" campaign, I propose that any event organised by, funded by, supported by or on Wexford County Council property which engages children or young people would be designated a "Not around us" supporting event and would display the "Not around us" logo and signage in promotion of the event and at the event itself. his requirement will then be included in any event support or funding agreements, as standard. Soft copy graphics will be included on WCC website and the signage and banners available for events through WCC MD offices. "

Response of the Executive:

The Executive believes that this motion is a natural progression from the following motion which was passed in November 2021:

"Wexford County Council commits to include all Council playgrounds, parks, beaches and areas designed for children and young people as part of the initial phase of the Healthy County Committee "Not around us" campaign. This will establish a series of places and spaces all over County Wexford where children and young people can enjoy themselves in a smoke and vape free environment".

Currently there are 32 playgrounds, 5 libraries and 8 beaches with Not Around Us signage, in addition to the Community sign ups. The Community Department will work with the Healthy County Committee and other relevant stakeholders to embed this practice within the organisation.

This motion fell as the proposer wasn't present to move the motion.

13.6 Cllr. T. Forde and F. O Súilleabháin

"This council welcomes the tax free Accommodation Recognition Payment (ARP) of €800 per month to persons who provide a property used to accommodate refugees from

Ukraine. We ask that such initiative be extended/implemented in an effort to accommodate all homeless people in Ireland. "

Response of the Executive:

If passed, this Motion will be forwarded to the Minister for Housing, for consideration.

The motion was proposed by Cllr. F. O Súilleabháin, seconded by Cllr. J. Codd and carried.

13.7 On behalf of all Councillors in the New Ross District

"In light of the ongoing housing crisis, I call on the Minister for Housing to amend the Social Housing Allocation Regulations 2011 to increase the suspension period from 12 to 24 months for applicants who refuse an offer of a new property on unreasonable grounds.

Refusals on certified medical grounds or on the basis of a report from An Garda Síochana are not deemed to be unreasonable."

Response of the Executive:

If passed, this Motion will be forwarded to the Minister for Housing, for consideration.

The motion was proposed by Cllr. A. Connick, seconded by Cllr. M. Sheehan and carried.

13.8 Cllr. M. Sheehan

"This this Council calls the Government to amend the Oil emergency contingency and transfer of renewable transport fuels 2023 bill to ensure that any future measures or actions taken by the Minister for the Environment to direct essential fuel and oil supplies in times of a declared Crisis or Emergency is subject to robust committee oversight and approval of the Oireachtas. "

Response of the Executive:

If passed, this Motion will be forwarded to the Minister for the Environment, Climate and Communications and Minister for Transport, for consideration.

The motion was proposed by Cllr. M. Sheehan, seconded by Cllr. P. Breen and carried.
