1. Presentation to the Council - Comhairle na nÓg

The Cathaoirleach welcomed Paula Kelly, Co-ordinator of Comhairle na nÓg and a delegation from Comhairle na nÓg comprising Conor Brennan, Amy White and Matthew Colgan.

The delegation made a presentation to the Council on the subjects of self-harm and suicide prevention as it impacts on young people. They had examined and taken action on a number of themes associated with these issues.

Among the actions they had done was the distribution of posters, brochures and other information, a social media campaign and a setting up of Teentalk, an out of hours counselling service run through the FDYS. They noted that the counselling service required funding in order to continue.

The presentation was well received by the Council and the Members complimented Comhairle na nÓg on the work they had done and congratulated them for their confidence in making their presentation to the Council.

The delegation thanked the Council for their positive feedback.

Ms. A. Byrne, SEO, Community Section noted the positive partnership the Council enjoys with the FDYS and advised that Comhairle na nÓg should submit a formal letter to Wexford County Council concerning funding and other supports.

2. Presentation to the Council - Centre of excellence in high performance buildings

Mr. T. Larkin, Director of Services advised that the full presentation had been circulated to the Members of the Council and that he would give a synopsis of the main points contained in the presentation.

The Director advised that Enniscorthy has been designated a UN Centre of Excellence on Nearly Zero Energy Building. (NZEB). Under the UN programme there is a network of Centres of Excellence which are a model of best practice with regards to energy saving.

Mr. Larkin advised that Wexford County Council was ahead of its counterparts across the globe when it came to provision of NZEB social housing. Effectively the techniques used in building and heating of local authority social housing are leading to a large reduction in the costs of heating for local authority tenants.

The County Council is collaborating with the WWETB to train people in the techniques required to achieve these improvements in the building and heating of houses. Funding in setting up the Centre of Excellence will be provided by Wexford County Council initially with applications for funding from Climate Action Fund to follow.

The Members congratulated the Chief Executive and Director of Services for this initiative and highlighted the improvements in the cost of home heating, health improvements, fuel poverty and problems such as dampness and mould. The opportunity for workers in the building trades to upskill at the Centre of Excellence was also highlighted.

Following this discussion, on the proposal of Cllr. B.A. Murphy, seconded by Cllr. L. Kelly and agreed by all that the Council would support the Centre of Excellence in working to achieve high performance buildings.

10 Extension of Courtown Local Area Plan

Mr. T. Larkin then advised the meeting of the process required to extend the Courtown Local Area Plan, which has the support of the Gorey Municipal District.

On the proposal of Cllr. A. Donohoe, seconded by Cllr. Cllr. F. Ó Súilleabháin, and agreed by all, a request was made to the Chief Executive to furnish a report, prepared pursuant to Section 19(1)(e)(ii) of the Planning & Development Act 2000 (as amended), on the appropriateness of extending the duration of Courtown and Riverchapel Local Area Plan 2015.

The Chief Executive's Report on the Extension of the duration of the Courtown and Riverchapel Local Area Plan 2015 had been circulated to the members in anticipation of this request.

The Chief Executive's Report was then considered by the Council. On the proposal of Cllr. P. Breen, seconded by Cllr. J. Sullivan and agreed by all, it was agreed to defer the sending of notices under Section 20(3)(a)(ii) of the Planning & Development Act 2000 (as amended) by a period of 5 years, thereby extending the duration of the Courtown and Riverchapel Local Area Plan 2015.

11 2019 Q4 Annual Service Delivery Plan

Mr. E. Taaffe, Director of Services then presented the 2019 Q4 Annual Service Delivery Plan, which had been previously circulated to members. He advised the meeting that any questions in relation to the Plan should be emailed to his office.

18 Notices of Motion

18.1 Cllr. Jim Moore

"As part of Wexford County Council's campaign to tackle litter and waste dumping I propose the Council, through its Environment and Arts departments, develop a series of short films. These can be made available to our schools and cinemas, etc to urge people to act responsibly when dealing with litter and waste disposal".

The above motion was proposed by Cllr. Jim Moore seconded by Cllr. L. Kelly and agreed by all.

Cllr. D. Hynes left the meeting at 5.15pm.

18.2 Cllr. Tom Forde

"That this council write to Minister for Agriculture, Food and Marine, Michael Creed, expressing dissatisfaction with the recent EU fishing agreement which has failed to safeguard fishing into the future."

"This Council asks that our government do everything in its power to push for an effective ban of super trawlers from Irish waters and, while they do operate in these wagers, to implement relentless monitoring of their fishing activities."

As Cllr. Tom Forde had left the meeting it was agreed to defer his motion to the February 2020 meeting.

18.3 Cllr. Jim Moore

"Request Wexford County Council, through its Environment section, to immediately investigate the use of smart technology as part of its campaign to reduce the number of damaged and stolen lifebuoys. New technology will offer low cost, low power systems with alarms in managing this essential lifesaving equipment."

The above motion was proposed by Cllr. Jim Moore seconded by Cllr. M. Farrell and agreed by all.

18.4 Cllr. Tom Forde

"This council calls for a complete reform of the Direct Provision system and recognises that this system is inhumane and that people in this system lack access to basic necessities such as cooking, movement, and social requirements.

We also ask that the Department of Justice closely liaise with Wexford County Council with regard to any form of direct provision or overflow facility in the county so that the local population can have an accurate information and understanding of what this entails."

As Cllr. Tom Forde had left the meeting it was agreed to defer his motion to the February 2020 meeting.

19. Any other Business

Cllr. L. Kelly raised the issue of broadcasting of Council meetings. Mr. E. Taaffe, Director of Services advised that he had submitted a Report to the Protocol Committee for consideration earlier in the day.

The cost of the system would be €20,000 per annum on a 5 year contract. It would also be necessary to amend standing orders and do an impact assessment regarding GDPR. He further advised there was no revenue provision in the budget and the matter could be reviewed at Budget 2021.

Cllr. A. Donohoe advised that experience of other local authorities was that only 10 - 12 people watched the meeting live.

The Cathaoirleach advised that he intended to write to Care Doc to give presentation at a meeting of County Council in March or April 2020 with regard to the provision of health services over the Christmas period.

The Cathaoirleach then wished all the Members of the Council who will be candidates in the forthcoming General Election the best of luck.
