1. Presentations to the Council – Social Innovation Fund Ireland – John Evoy Wexford Local Enterprise Office (LEO)

Social Innovation Fund Ireland – John Evoy

Ms. E. Hore, Head of Enterprise introduced John Evoy, Social Innovation Fund Ireland who made a presentation to the members. The presentation which had been previously circulated briefed the members on the role of the Social Innovation Fund and the types of projects which they support.

Mr. E. Taaffe, Director of Services notified the meeting that the Council had received approval for €9m in respect of Wexford Flood Defence Scheme. He also noted that the Enniscorthy Flood Scheme is awaiting Ministerial approval and is expected to start in the summer.

The new road bridge near St. Senan's is expected to begin at end of 2020 or early in 2021.

18. Deferred Notices of Motion

18.1. Cllr. T. Forde

"This council calls for a complete reform of the Direct Provision system and recognises that this system is inhumane and that people in this system lack access to basic necessities such as cooking, movement, and social requirements.

We also ask that the Department of Justice closely liaise with Wexford County Council with regard to any form of direct provision or overflow facility in the county so that the local population can have an accurate information and understanding of what this entails."

The above motion was proposed by Cllr. T. Forde seconded by Cllr. L. Kelly and agreed by all.

19. Notices of Motion

19.1 Cllr. L. Kelly

"I would like to request that Wexford CoCo map all current defibrillator units in operation in Co Wexford and create a public awareness campaign on a district level around the locations of same. As part of this mapping exercise I would request that other key areas are identified where defibrillator could be installed."

The above motion was proposed by Cllr. L. Kelly seconded by Cllr. G. Lawlor. A number of members raised issues with regard to the mapping of the defibrillator units and the responsibility for advertising the locations of the units.

The Chief Executive advised that he would check if there was a practical way of dealing with this motion and report back to the Council.

19.2 Cllr. D. Hynes

"That this council calls on the government to insure that whatever pension age is finally agreed on ie 65-67 years of age , that it applies to everyone including members of the government and

ministers. To end the scandal of ex ministers receiving pensions at 50 +! And also that these gold plated pensions be done away with also".

The above motion was proposed by Cllr. D. Hynes and seconded by Cllr. T. Forde. Following a show of hands the motion was defeated.

19.3 Cllr. J. Moore

'Wexford County Council requests the Department of Housing to introduce regulations, as a matter of urgency, whereby the Department or its agents, ie Private Residence Tenancy Board, implement robust controls on Private Landlords and their Tenants who reside in local authority estates. These regulations are required to counter anti-social behaviour when it is identified in their properties.'

The above motion was proposed by Cllr. J. Moore seconded by Cllr. F. Staples and agreed by all.

20 Any Other Business

Carolyne Godkin, A/Director of Services advised the meeting that a series of bye laws (see below) are being prepared for the Council and will come before the Council over the next number of months.

- Consumption of Intoxicating liquor in public places Bye-Laws
- Revision to Harbours and Piers Bye-Laws
- Revision to Open Burial Grounds Bye-Laws

She also advised that there would be a community event in the Riverside Hotel on the 12th March, 2020.

Cllr. A. Connick noted that the new bridge in New Ross had been closed due to an orange weather warning and asked who had the authority to close the bridge. Mr. E. Hore, Director of Services advised that he had written to TII and a protocol is now being put in place with regard to the closing of the bridge.

A speed Limit amendment in New Ross has been passed by New Ross Municipal District and will come before the full Council at the March, 2020 meeting.

The Chief Executive then advised the Council that the motions passed by the Council are not automatically implemented. They must be lawful, must have resources and finance available.

The County Secretary notified the members that he is the Returning Officer for the Senate Elections and that members will receive their voting papers on 16th March, 2020 and that the poll will close at 11am on 30th March, 2020.

He advised the members that the vote must be made in the presence of the Returning Officer and that the ballot paper should not be filled in in advance.

This concluded the business of the meeting.
