1.Economic Development & Planning:

LOCAL ENTERPRISE OFFICE

Training: A key support for SME's by the LEO is the provision of training to ensure that business owners are competitive and can respond to new markets and improve productivity. A new training prospectus with over 80 training programmes will be launched in February 2020 at the Social Innovation Day. A key theme for 2020 will be to support enterprise "Beyond Brexit" ".

In line with a move towards a paperless strategy, the number of printed brochures will reduce by 87% on 2019 with an advertising strategy aimed at directing people to our website/online booking.

Contract Business Advisor: This initiative aims to support companies to maximise opportunities and minimise risks particularly in relation to advice, information and supports beyond brexit. The tender deadline for Contract Business Advisor support to client companies closed on 10th January 2020. Following assessment of the tenders, we aim provide advisors to work with our clients on an intensive basis from February to the end of October. Specific areas of work will include the following;

- 1. Brexit Challenges / Exports / New Markets
- 2. Financial Analysis
- 3. Business Planning / Growth Plans
- 4. Increase Productivity / LEAN

Wexford Launch of National Social Innovation Fund: Social Innovation Fund Ireland (SIFI) will be launching a call for funding applications in January at a National in Dublin. John Evoy, Social Enterprise Development Manager at SIFI will co-host a showcase event on social enterprise and the new funding opportunities for enterprise in Wexford on Monday 10th February at a Social Innovation event in County Hall.

Green for Business Breakfast seminar: As part of the economic strategy to position Wexford as a leader in sustainability the LEO is hosting a breakfast seminar, entitled 'Green for Business', on Tuesday January 28th 8am – 9.30am in Ferrycarrig Hotel in conjunction with 3CEA. The initiative is funded by Enterprise Ireland under the successful regional funding application to support collaboration and clusters.

The aim of the event is to raise green awareness among SME's and give tips on how to 'green' their business. Information will also be given on potential funding sources/grants available. The event is open to all SME's and is free of charge, however booking is essential at Eventbrite.ie

Showcase: Showcase – Ireland's International Creative Expo returns to the RDS, Dublin from Sunday, 19th to Wednesday 22nd January 2020.

This on-trend annual trade fair enables 450 of Ireland's top designers and manufacturers to present their very latest work to over 5,000 retail buyers from Ireland and 20 countries, including the UK, USA, Mainland Europe and the Far East.

The Local Enterprise Showcase, which will once again fully occupy the balcony of the Main Hall at the RDS, will feature unique products from emerging Irish businesses supported by their Local Enterprise Offices. LEO Wexford has 3 companies exhibiting in the Showcase: Jumbleink; Wild Herb Elixirs; Grainne Kenny Design.

ECONOMIC

Centre of Excellence in High Performance Buildings A key strategy for Wexford County Council's economic programme is to promote Wexford as a champion of excellence in high performance buildings, both new and retrofit. WCC is working in partnership with the WWETB who are delivering the first accredited training courses with Mosart to upskill the construction centre for employment in delivery of more energy efficient buildings with an NZEB training centre established in 2018 at Enniscorthy.

In addition to supporting job creation as a key component of the climate action plan, Wexford County Council is working towards the development of a centre of excellence to lead on energy efficiency and innovation in this sector, supporting the delivery of sustainable quality homes, addressing fuel poverty and promoting quality indoor health. The members will consider the proposals on the initiative at their January meeting.

Invest Wexford In partnership with working with Enniscorthy Municipal District the department supported a business networking event in Enniscorthy over the Christmas break with Invest Wexford. The aim of the initiative was to bring business leaders and the diaspora together to work towards a shared vison for Enniscorthy to support job creation and investment.



Business In The Community

Coláiste Abbáin

The Economic Development Section are continuing The Business In The Community programme with Transition Year Students, in Coláiste Abbáin Adamstown in 2019/2020. The first session of this programme was held in Coláiste Abbáin on 4th December which was an introductory session to inform students about the services provided by Wexford County Council and to give an insight into the range of careers across the departments.

The next session is scheduled for Wednesday 15th January where feedback will be given on cv's provided by the Transition Year students and also advice on interview preparation.

Media: The well known chef - Neven Maguire was in Wexford in October 2019 to film his Irish Seafood Trails programme. The television series is dedicated to seafood in various locations around Ireland which includes County Wexford and is an opportunity to highlight the quality produce from our coastal county. The episode which features Wexford is the 5th episode in the series and is scheduled to be broadcast on the 5th Feb, 8.30pm on RTE One

<u>BUCANIER</u> (Building Clusters and Networks in Innovation Enterprise and Research)

50 participants now recruited, they have been assigned mentors to complete six half day mentor sessions. 2 new companies recruited in December.

3 Irish participants attended a Sowing the Seed of Success Conference in Carmarthen in November. Two Irish Companies showcased at Gifted as part of the Blas na hEireann Taste the Island area.

BUCANIER has two cross boarder events planned for January and February:

- A workshop will be held on the 15th of January which will be attended by 52 participants for Ireland and Wales
- A Supplier to Buyer Event in Pembrokeshire on the 5th of February, we are taking 10 Irish companies across.





FORWARD PLANNING

Regional Spatial and Economic Strategy: The Regional Spatial and Economic Strategy (RSES) for the Southern Region was adopted on the 29th of November 2019. The Forward Planning Section, supported by our Regional Assembly Members and the Planning SPC, made detailed submissions throughout the process. The resultant strategy now contains many policies and objectives which will support and set the framework for the future spatial, social and economic development of County Wexford. The RSES takes effect on the 31st of January 2020.



Wexford County Development Plan 2020-2026: The preparation of the Wexford County Development Plan was paused by Statutory Instrument pending the adoption of the Regional Spatial and Economic Strategy for the Southern Region. Wexford County Council must recommence the preparation of the County Development Plan within 13 weeks of the effective date of the Strategy (31st January 2020). It is anticipated that the pre-draft plan will be submitted to the Members in Q2 of 2020.



National Marine Planning Framework: The National Marine Planning Framework (NMFP) -Consultation Draft has been published by the Department of Housing, Planning and Local Government. It is Ireland's first marine planning framework and it applies to a broad range of activities including aquaculture, offshore renewable energy, shipping, ports and harbours, sea fisheries and tourism. It is an important document as it will set development consent the framework for development in the whole marine area. Submissions on the NMPF must be made before the 28th Feb 2020. The Department intend to hold a consultation event in Wexford and details will follow.

Biodiversity and Natural Heritage

In-house Actions: Starting in January 2020 a two week controlled trial of new biodegradable cleaning products will take place. Wexford County Council are on the road to eliminating most, if not all, bleach and chemical cleaners in its office in 2020.

Natural Wexford: A Natural Wexford sign has been installed at Camaross to inform visitors of the Camaross Pingos, an internationally important geological fossil. A stock proof fence was erected around one of the larger Pingos at Camaross to protect it from damage.

Work has commenced on a Natural Wexford Sign for Forth Mountain. The sign will inform visitors to the area, including those visiting the newly re-established 'Three Rocks Trail' of the importance of the natural heritage on Forth Mountain. Scoping is being carried out to decide on the next locations for Natural Wexford signs.

Derelict Sites, Dangerous Structures and Vacant Sites at 31st December, 2019

Derelict Sites Project – From Vacant to Valued: The Senior Executive Officer in Planning, Tom Banville, has pulled together a project team from Planning, Housing and Property to specifically target Derelict Sites in the County. The project titled 'From Vacant to Valued' has a great capacity to have a positive impact on the built environment of County Wexford. There are currently 53 sites on the Derelict Sites Register for the county.

These sites are sores on our landscape. From Vacant to Valued will target 25 derelict or vacant properties, 5 within each Municipal District, and work to return them to valued use as social housing or for community use.

The ideal site profile is:

- 1. An urban site
- 2. A site serviced for Water and Waste
- 3. A site with additional land for housing units.

To date the Project Team has meet on 3 occasions and has identified 10 properties to date throughout the county, (Gorey and Kilmuckridge -4, New Ross -3, Enniscorthy 3) with the potential for return to social housing, for potential community use or return to the private market following CPO. The project team will meet on a monthly basis to progress these targets for development under schemes such as the Buy and Renew Scheme.

The SEO has attended Municipal District Meetings in Gorey and Kilmuckridge, Enniscorthy and New Ross to present the project to the members and agree target sites for inclusion on the project. The SEO is due to attend the District meetings in Wexford and Rosslare in January 2020.

Built Heritage Investment Scheme and Histortic Structures fund 2019: The Final Reports were submitted to the Department of Culture, Heritage and the Gaeltacht for the Built Heritage Investment Scheme 2019 and the Historic Structures Fund 2019.

The table below summaries the fund allocated for 2019:

A total of \notin 79,000 was paid to 11 projects under the Built Heritage Investment Scheme. Matching funding by the owners of the structures amounted to \notin 117,639.40 with an estimated 408 employment days required to complete these projects. The total expenditure for projects under the scheme was \notin 196,639.40.

The Projects ranged in diversity from thatching cottages, repairing a unique boundary wall of a local church, to restoring the wheel of a nineteenth-century corn mill wheel.

Historic Structures Fund 2019:

Structure: Pugin Chapel, St. Peter's College, Summerhill, Wexford. Allocation: €32,000

Approved works: Essential repair works were required to the windows of the Pugin Chapel in St. Peter's College. They were at the risk of structural failure. The leaded glass windows were removed and the window openings were boarded up. The windows were surveyed and templates were made. Off-site work included the measuring and surveying of each panel, dismantling the leaded glass, washing the old glass for re-use, cutting the drawn sheet restoration glass and leading the panels.

Disability Access: Disability Access Certificates (DACs): The number of DAC Applications validated up to and including up to and including 31/12/2019 totals 71 Total Refused 3. Total Granted 55. Awaiting F.I 8. Under Assessment 5.

2. Special Projects:

Min Ryan Park, Wexford: Works are progressing well, with all earthworks now substantially complete, access road well advanced and key features such as playground area, entrance works and circulation pathways at various stages of construction. The park is expected to open to the public in early 2020.

Trinity Wharf: The application for development approval was submitted to An Bord Pleanála on 15/02/2019. WCC has responded to a request for further information issued by An Bord Pleanála in late July 2019.

The related application for foreshore consent was submitted to Department of Housing, Planning and Local Government on 01/03/2019 and the public consultation process for this application is now completed.

Grant aid of €2.028m has been secured for the scheme under the Urban Regeneration Development Fund (URDF) to date.

Crescent Quay: Works at Crescent Quay are substantially completed.

Ballast Office: Essential repair works are required to the Ballast Office to prevent it from falling into disrepair. An appointment for design services was completed in April and investigative, structural surveys and inspections have been completed. Works are planned to commence in Q2 2020.

Templeshannon Regeneration, Enniscorthy: The preliminary designs, environmental studies and planning documents for the proposed pedestrian bridge have commenced and are expected to be completed by April 2020.

WCC presented revised options for the street and public realm works to the Members of the Enniscorthy MDC in December 2019. Following consultation with the members, a revised plan for these works will now be prepared for public consultation as part of a further planning process in Q1 2020.

Enniscorthy Technology Park, Killagoley: Works are now substantially complete on Phase 1 of the Technology Park.

Gorey Market House: Following discussion at their July monthly meeting, the members of Gorey-Kilmuckridge Municipal District have requested that the development of the 2012 Public Realm plan for the Market House be suspended and that the Council re-examine options for the development and operation of a multi-functional performance venue at the site as proposed in the Public Consultation Process of 2018.

Market soundings have indicated that there may be interest from the private sector to fund the design and construction of a multi event performance venue and WCC will issue a Call for Expressions of Interest seeking proposals for same in January 2020.

Wexford Arts Centre: An appointment for design services was completed in April and investigative and building surveys and inspections are substantially completed. The preliminary design is complete and the Part VIII process commenced on the 8th October 2019. The period for submissions closed on 05/11/2019. A report on submissions will be prepared and presented to the Council in January 2020. Works are planned to commence on site in Q2 2020.

John Street Building Regeneration Project: The Council has received initial RRDF funding in the value of circa. €0.328m towards the acquisition and redevelopment of

the old grain stores at John Street, New Ross. It is planned to convert these buildings into a high quality enterprise hub. Architects have been appointed for the project and the Part VIII process is due to commence in Q1 2020 with construction planned to be completed by Q2 2021.

High Hill, New Ross: Detailed design and tender documents are progressing and works are expected to commence in Q2 2020. An application for RRDF funding approval for this project as part of the expansion of the New Ross tourism experience was successful.

Carrigfoyle Activity Centre: Works have commenced on Phase 1 (access road, car park, trails and services) and is programmed to be completed by Q3 2020.

An RRDF application for funding for the scheme was submitted in August 2019 seeking support for the scheme. This application was not successful.

Enniscorthy Tourism Project: Alan Sherwood & Associates has been appointed to prepare the feasibility study and an application to Failte Ireland for Capital Investment funding.

The project was presented to the Enniscorthy Municipal District at its January 2019 meeting. The propositions options report is currently being finalised.

An application for funding for the project was submitted to Failte Ireland's Pathways to Growth programme in July 2019.

Kilmore Quay Link Road: Part 8 approval was obtained in February 2019. Detailed designs and tender documents have been completed and tenders for construction works have been received and are being assessed. Works on site are planned to commence in Q1 2020.

An RRDF application for funding for the scheme was submitted in August 2019 seeking support for the scheme, but was unsuccessful.

Gorey Town Park: Niall Barry & Co. Ltd was appointed for the construction of the redevelopment works at Gorey Town Park in March 2019. Works commenced on site in May and are due to be completed by April 2020.

WEXFORDIA – INHP, Hook Lighthouse and New Ross Tourism Projects

WCC has secured RRDF funding for the development of a cluster of tourism projects within the county.

Design services are currently being procured for the development of the INHP and the Hook Lighthouse to shovel ready status including securing the required environmental, planning and other consents.

Procurement for detailed design for the New Ross Tourism Experience will commence in Q1 2020.

Wexford Flood Relief Scheme: Funding of €9m has been approved by the OPW for the Wexford Flood Relief scheme based on the initial findings of the South Eastern CFRAM report. The OPW have identified a need for further analysis of wave levels in the scheme area so that wave overtopping can be addressed as part of the scheme. Funding for the wave level study will be provided by the OPW the Brief for services for this study will be advertised in December 2019. The project brief for the Flood Relief Main Project is currently being drafted.

Enniscorthy Flood Defence Scheme: Work is complete on the public exhibition report and is currently being reviewed by OPW before submission to Department of

Public Expenditure and Reform. Work on detailed design and tender documents for the new Slaney Road Bridge are approaching completion.

GREENWAYS:

Rosslare Europort to Waterford City Greenway.

Draft feasibility, route options and environmental screening documents have been completed. Public information events were held in Wellingtonbridge & Rosslare Strand in May 2019. The preparation of the EIAR & NATURA Impact reports for the proposed development is substantially completed.

A presentation to the Rosslare MDC was made in Dec 2019 where the proposals for the 1 way system in the village of Rosslare to facilitate the greenway were detailed. The proposals were endorsed by the MDC. The members also requested that section of the greenway from Rosslare Harbour to Rosslare be reviewed and it was agreed proposed route would be walked by members in January 2020.

An application for funding, submitted to the Department of Transport, Tourism and Sport on 28/11/2018 was not successful.

New Ross to Waterford Greenway / South East Greenway:

Section 85 and funding agreements have been signed by Wexford County Council, Kilkenny County Council & Waterford City & County Council to enable Wexford County Council to act as the lead authority for this project. Detailed design is currently underway and it is planned to tender for a Works contractor in April 2020. Site investigation and vegetation clearance works commenced in December 2019. Grant aid funding of €8.0m for the project was awarded from DTTAS on 21/06/2019.

Curracloe to Wexford Greenway:

Permission for the development was refused by the Board in a decision issued on 17/10/2018 citing, in particular, concerns in relation to the potential impact of the development on the Raven Point Nature Reserve Special Area of Conservation and Wexford Harbour and Slobs Special Protection Area.

The Council has reviewed the ABP decision and met with the NPWS to review issues raised in the Planners report with a view to identifying alternative routes for the project. This will be the subject of further discussions with the NPWS.

Wexford to Rosslare Greenway

WCC has undertaken a preliminary study to examine the potential for developing a greenway from Wexford town to Rosslare. Further route options assessment, studies and consultation are required to determine the feasibility of delivering this greenway prior to committing to preparing an application for planning consent.

COMMUNITY

INTERREG – Celtic Routes: The Discover Your Celtic Routes (The Celtic Routes) project aims to encourage visitors to explore new areas of South East Ireland and West Wales en route to their final tourist destination. The objective is to increase the visitor appeal of the targeted areas, including through the development of new trails linking local culture, heritage and the natural environment. The Celtic Routes project will run until December 2020.

The project was launched in the Riverside Park Hotel, Enniscorthy on the 6th of December, 2019, and was attended by representatives from the three Irish local authorities along with the Welsh Councils as well as TDs, Councillors, Business, Tourism and other representatives.

Funding of €1.9m for the Celtic Routes project is provided under the European Territorial Co-Operation Programme – known as Interreg or the Ireland/Wales Fund. This funding will not be affected by Brexit.

A promotional / marketing campaign started in earnest in December 2019 and albeit it will not be visible in Ireland – it will be promoted extensively in Irelands main tourism markets.



Pride of Place awards: Craanford was honoured at the all-Ireland 2019 IPB Pride of Place awards held in Kilkenny on Saturday 30th November, 2019. The village, including Monaseed and Hollyford, took top spot in the 300-1000 population category.

Garda Youth Awards 2020 launched: The 2020 Garda Youth Awards were launched in County Hall on Monday 9th December. The awards acknowledge the young people who by their presence make their communities and society in general, a better place in which to live. The awards will be hosted by Wexford County Council in conjunction with An Garda Síochána on the 27th of February, 2020.





Traveller Interagency Group The TIG continues to (TIG): implement actions to address the needs identified in the Traveller Needs Analysis report. А specially commissioned Traveller led information leaflet was finalised in November to promote the work of TIG and encourage greater engagement with the TIG among the Traveller community, through PPN representation.

2017 Town and Village Renewal Scheme: The long awaited playground construction at Bridgetown was completed on the 19th December 2019, with the playground formally handed over to the Council. A formal launch will be planned for early in January 2020.

Healthy Ireland: The Addendum to the HIF Round 3 Grant Agreement approved at the LCDC meeting on the 11th December 2019. This provides for funding of €246,050 to fund 6 HIF actions including a joint action across 5 LCDCs, a Community Mental Health Fund Action (CMHF) and Small Grants Scheme, A Community Engagement action, and the employment of a Healthy Ireland Coordinator for County Wexford. The actions include the Regional Implementation of agreed policy priority programmes (Joint LCDC action), Sports active – Swim for All (National Schools) Programme, Active Fellas, YOUth – Five ways to wellbeing, Roma Community Mental Health and Physical Health Project, Make the Moove: Farmers matter, and

the CMHF action: the Traveller Men's Health Project and Traveller Women's Self-Care Community Hubs.

Age Friendly - Positive Ageing Seminar: As part of a Regional Healthy Ireland action, the HSE South East Community Healthcare organised a one day Positive Ageing seminar in partnership with the Local Community Development Committees (LCDC's) of Carlow, Kilkennv. Tipperary, Waterford and Wexford and the Age Friendly County Programmes to share and showcase the valuable work happening across the region.



This was a great opportunity for the sharing of good practice in relation to Positive Ageing initiatives and to allow networking and information sharing with services. Wexford's presentation was given by Brian Toomey, PPN and LCDC member, on a pilot Dementia Training project that took place in Bunclody. Wexford was very well represented at the event with many members of the Older People's Council and Age Friendly Alliance attending.



Age Friendly Launch: Representatives of the country's 31 local authorities were presented with by World charters Health Organisation (WHO) Senior Health Advisor on Ageing, Alanna Officer and An Taoiseach, Leo Varadkar TD at a ceremony at Slane Castle, Co Meath on 16th December. Wexford was represented at the event by Wexford County Council's Chief Executive Tom Enright, Cathaoirleach

Michael Sheehan, Age Friendly Programme Manager Ann Marie Laffan and Older People's Council Vice-Chairperson Betty Breen.

The WHO gave recognition to the implementation of age-friendly policies and practices by all the local authorities under the Age Friendly Ireland Programme. This included measures such as housing developments, libraries, car parking and improved customer services and communication aimed at older people. The WHO's Alanna Officer, says it means "Ireland is committed to becoming a good place in which to grow old".

Local Community Development Committee (LCDC) Meeting: An LCDC meeting was held on 11th December and included updates on SICAP, Healthy Ireland and the Local Economic and Community Plan.

Local Action Group (LAG) Meeting: A LAG meeting was held on 11th December and LEADER Expressions of Interest on Walking Trails/Tracks, Biodiversity, Water Resources and Youth Facilities with grant aid totalling €1,237,876.53 were presented. Of the projects presented 47 were eligible and 10 were partially eligible.

LEADER grant funding totalling € 1,483,621.29 was approved at the meeting under the Rural Tourism, Enterprise, Development of Renewable Energy, Basic Services Targeted at Hard to Reach Communities and Rural Youth subthemes.

LEADER: There were 9 claims received for Article 48 pre-payment check and 7 claims were checked with 6 returned with minor queries to the implementing partner, Wexford Local Development. 4 claims were processed and are moved through the process. There were four claims totalling €33,823.54 paid out to fund projects.

Wexford Public Participation Network (PPN)

In late November Wexford PPN held District Meetings in all five districts. Issues and queries raised at these meetings have been compiled and issued to PPN Representatives and staff to action for members.

Following the approval of **Our Vision for Community Wellbeing** at the November membership meetings Wexford PPN formally launched the Vision at an event in County Hall on 16th December.

Wexford PPN's Vision for Community Wellbeing is an all-encompassing vision that the member groups of Wexford PPN have for County Wexford, which was developed over a six month period through a range of member consultations. The bottom-up vision development process with member groups ensures the vision is the mandate for Wexford PPN Representatives as they represent Wexford PPN membership on decision making bodies across the county.

Wexford PPN was delighted to have Dr Sean Healy of Social Justice Ireland launch the Vision. Dr Healy was the Chair of the Working Group on Citizen Engagement with Local Government in 2013, which resulted in the formation of Public Participation Network's.



The launch event also offered the opportunity to recognise the achievements of some Wexford PPN members who were recently supported to complete an Introduction to Community Development through An Cosán Virtual Community College (VCC) - a blended learning model of online and offline learning. On the evening Maria Flanagan from An Cosán VCC and Noel Stacey of Wexford PPN presented participants with certificates of achievement.

Work continued on the Wexford PPN 2020 Work plan and Budget. We will meet with Wexford County Council in early January to re-sign the Memorandum of Understanding for 2020.

LIBRARIES, ARTS & ARCHIVES

Archive- Digitisation: In an effort to enhance access but also to showcase more of its holdings to potential users, Wexford County Archive undertakes an annual digitisation programme. Three collections were digitised during December 2019 – scrapbooks relating to Bunclody Farmers' Co-operative Society Ltd. (1959-76); floor

plans of the Convent of Perpetual Adoration, Bride Street, Wexford (1966); and a volume of County Wexford Grand Jury presentments (1817-23). Each collection was scanned to a high resolution file in TIFF format for preservation purposes, and in PDF format for online access.

Family Time at your Library: Family events and activities took place in all libraries during the month of **December** to support the involvement of the whole family in children's reading. Family Time at your Library activities were provided to engage family members in the enjoyment of reading and sharing stories. A total of 522 children and adults attended 15 Family Time events in all libraries in the County.

Sensory Library Funding: The Department of Rural and Community Development has announced funding of up to €20,000 per authority for the provision of the provision of sensory facilities and equipment in public libraries that can help individuals with sensory impairments, special educational needs and other learning differences, and those on the Autism spectrum. The Department funding will be matched by local authorities to provide sensory library rooms, sensory play equipment and toys, assistive technologies, autism friendly signage, books and social stories. It is expected that the new services will be available in the libraries in mid-2020.

Digital literacy with Microbits and Virtual Reality at your Library: A training programme for library staff on the use of BBC micro-bits and virtual reality in libraries took place in Autumn 2019. Family workshops on coding and BBC microbits were then delivered by library staff in Wexford Library in December. The plan in 2020 is to run Microbit afterschool and weekend programmes making 17 Microbit sets available for public use in each branch library.

Virtual reality headsets are also available in all libraries and will enhance the visit of school groups to the library from Spring 2020.

Men's Shed Countywide Folklore Project: A project facilitated by artist and folklorist Michael Fortune and funded by Wexford County Council and the Dormant Accounts fund was showcased on 15th December in Wexford Library. The Folklore on Film Training Programme introduced participants who are members of Men's Sheds in County Wexford to the process of collecting folklore on film and to the resources of their local library. This project is funded through the Dormant Account Funds via the Department of Rural and Community Development.

Cursed Murphy's Podcast: Wexford Library hosted a podcast by local artist Peter Murphy on the 17 December in front of a live audience. The podcast which was supported by the Arts Department of Wexford County Council was recorded for airing in early 2020. The podcast featured guests actress, singer, director Maria Doyle Kennedy and poet Annemarie Ní Churreáin. 30 attended.

Heritage: A new book entitled Sailing Ships of Wexford 1840's - 1940's : A Century of Sail in County Wexford by Brian Cleare and Jack O'Leary's was launched in Wexford Library on 12th December. This book looks back at the time when ships sailed out of Wexford bound for the North America and the Black Sea as well as crisscrossing the Irish Sea. The publication was supported by Wexford County Council.

ARTS

Artlinks: Artlinks offers professional development support for emerging and professional artists in the South East Region with Wexford, Carlow, Kilkenny and Waterford art offices. Closing date for applications is 22^{nd} January, 2020. Total fund for Wexford is $\in 25,000$ making Artlinks is an extremely competitive award in Wexford with average grants of $\in 1,000 - \in 3,000$. Another element of Artlinks this year is a collaborative award the deadline for this is 30^{th} March, 2020.

Small Arts Festival and Experimental Events Grant Scheme 2020: Open call from the Arts office took place in November 2019. Closing date is Monday 13th January, 2020. This grant scheme aims to promote and support a diverse range of small arts festivals and experimental events. The focus is on festivals/events of high artistic quality that are innovative and have a strong emphasis on public engagement. We also welcome applications promoting cross disciplinary artistic collaborations and experimentation. The total award fund is $\in 22,000$ with an average of 12 festival/ events awarded per year with grants between $\in 1,000 - \in 3,000$ max.

Cow House Studios New Parenting Artists Residency Programme: is a new annual residency to support parenting artists and their families, funded by Wexford County Council Arts Department in partnership with the Cow House Studios in Rathnure, Co. Wexford. Currently there are no residencies facilitating parenting artists in Ireland. Following the success of a pilot scheme in 2018 a clear need locally and nationally was identified amongst parenting artists. 39 applications were received and an independent panel selected two artists in December 2019 for this new 4 week residency to commence in February 2020.

Creative Hub, exhibitions: Artist Anne Martin Walsh opened an exhibition in the Creative Hub in December and this will run until 17th January after this time artist Michelle Colfer will exhibit until the end of February 2020.

Information Clinics: The Arts Officer Liz Burns will hold a series of information clinics during January to discuss funding and other opportunities through the Arts Office. These clinics will be of particular interest to artists, community groups, festivals and schools. Four free information clinics will be held Gorey, Enniscorthy, Wexford and New Ross. The first will be held in Gorey on 13th January at 2.00pm in Gorey Library for further details of this and the other sessions go to https://www.wexfordcoco.ie/arts-and-culture/.

On the 20th and 21st November the second workshop on Fire Safety in Homes and Flats was run by Wexford County Fire Authority in Portlaoise on behalf of the NDFEM.

4. Transportation, Water Services:

WATER SERVICES

A. Irish Water – Asset Delivery

Irish Water Capital Schemes

Enniscorthy Network Upgrade

Surveying work are continuing in the Enniscorthy area to enable a hydraulic model of the sewer network to be completed. Once the model is complete, design works on areas requiring rehabilitation / upgrade will commence.

IW Asset Management: Enniscorthy and Sow Regional Water S.S.

New water intake and pumping station at Clonhasten.

Planning permission was granted in September 2019. Tender documents are being compiled by the Consultant with additional requirements from Irish Rail to be incorporated. New infrastructure expected to be operational in 2022.

Wexford Drainage Area Plan

This project will produce a complete drainage model of the Wexford Town foul drainage system.

A full detailed hydraulic model will be produced identifying all pipelines and infrastructure and deficiencies in the network. Nicholas O'Dwyers have been appointed as Consultants by IW. Drainage infrastructure survey works have commenced in Wexford Town and Castlebridge. Survey works originally due to be completed in December 2019, but manhole and other surveys deferred by Irish Water from August 2019 to restart in Wexford in January 2020.

IW Asset Delivery: Fethard-on-Sea Sewerage Scheme

The preliminary design for the project is now complete and can be issued to the appointed Consultant / Contrator for design & build. Discussions with land owners are due to commence shortly. We will be in a position to issue a construction schedule shortly which will indicate a start & completion time scale.

IW Asset Delivery: Gorey Regional Water Supply – South Wellfield

The Gorey RWSS will be upgraded and a new 8 MI/day WTP and 7,500m³ reservoir provided at Ballyminaun. Planning permission was granted by WCC to upgrade the borehole sites and build a new water treatment plant at Ballyminaun. The hydrogeological investigations show that remedial works will be required to most of the boreholes. The CPO is completed as objections were withdrawn before scheduled oral hearing. The contract has been awarded to Glan Agua with works expected to start on site in October/November 2019. Plant expected to be operational in early 2022. Construction began October 2019 at New Treatment plant and storage site in Ballyminaun. Pipe installation works to commence early December 2019

IW Asset Delivery: Untreated Agglomeration Study (UTAS)

Arthurstown, Ballyhack and Duncannon:

The project has been tendered and a preferred contractor has been selected. An application for planning permission has been granted by Wexford County Council. It is envisaged that construction will commence in early 2020 with the new plant operational by 2021.

Kilmore Quay:

The scheme design is complete and ready to tender. Land acquisition is now finalised and a planning application was lodged in December 2019. It is expected to commence construction in 2020 with the plant operational by the end of 2021.

IW Asset Delivery: Wexford Town Watermain Rehab and Gas Network

A significant de scope of works by Gas Networks Ireland was issued in September which will affect the quantity of both gas mains to be installed and water mains to be rehabilitated under this contract. We are currently assessing the impact of this de scope to establish what works will be done and what may get delivered under alternative Irish water funding.

Direct Labour Pipe Laying Crew

The crew has commenced a Water Main Rehabilitation Project in Askinamoe Ferns, approximately 1km long. The crew will focus primarily on the find and fix scheme for 2020 to reduce leakage and unaccounted for water.

Ferns Upgrade – Capital Investment Plan

This project has successfully passed into Phase 2 Gates 2-3 detailed design which has commenced.

IW Asset Management: Murntown Pumping Station - operational 14th February 2019

- Contractor defects liability period in operation until May 2020.
- Installation of SCADA telemetry to begin on site February 2020.
- Decommissioning works at Redwood Park WWTP will take place during Q1 2020.

DPI Scheme: Somer's Way Pumping Station and Rising Main, Ballycullane

- Contractor in place for rising main, formal contract pending agreement of insurances.
- Road opening licence application submitted.
- MEICA works (pumps and associated equipment) for conversion of WWTP to a pumping station quotations returned, on hold pending rising main works.
- Associated civils works quotations returned, on hold pending rising main works.
- New 3-phase electrical supply agreed with ESB, currently pricing associated civil works.

IW Asset Management: Fairgreen Pumping Station and Rising Main, Ballycullane

- Invest to save application for conversion to pumping station with rising main to Ballycullane WWTP main plant now approved by Irish Water.
- Design of Civil and MEICA works underway.

IW Asset Management: Trinity Street Wastewater Pumping Station

- Various HSQE works in foul sump being priced.
- Generator Switch-gear replacement has been added to the Irish Water Generator Ready Programme for 2020, and temporary control measure in place in the interim.

IW Asset Management: Sinnottstown Lane Wastewater Pumping Station

• New pump and control panel were installed by Contractor in December, bringing the larger rising main into service increasing capacity at this station. Works to be completed on site in Q1 2020.

IW Asset Management: Telemetry Upgrades (WW)

- SCADA upgrades (IP radio) for Rosslare Strand and Enniscorthy network WW pumping stations were completed in December.
- Additional telemetry signals at Trinity St WWPS, Ballymurn WWTP, Distillery Road WWPS, and Rosslare Strand WWTP approved by Irish Water, and contractor preparing programme of works, with some completed in December 2019 and remainder to be done in Q1 2020.

IW Asset Management: Kilmallock & Taylorstown WTW (new pumps, automated treatment, replacement of chlorine gas etc)

Project is at final account stage. The upgrade works have enabled automated water treatment at both plants. Following the upgrade works Kilmallock has removed from the EPA's Remedial Action List.

IW Asset Management: Disinfection and pH Control Programme

Disinfection works at Chestnut Grove, Woodview Drive, Raheen, Edermine, Monagear, Davidstown, Ballinellard, Boolavogue Camolin, Terrerath, Clonroche, Ballyhogue, Bree, Kilmuckridge Coolgreaney, Camolin, Castledockrell, Ballindaggin, Vineagar Hill, Newtown, Killagooley and Carrigbyrne commissioned but require process proving.

Works partially complete at Creagh.

IW Asset Planning: Treated Water Storage

Additional reservoir storage to bring schemes up to the required 24 hours of storage of treated water has been approved for Camolin,Kiltealy and Kilmallock. Currently at site selection phase. Site investigation works to commence at 2 sites, Camolin and Kilmallock in December 2019.

Water Network Program

Coffey Water (CNL) are appointed as regional contractor for the Water Network Programme for the South East. To date works have been carried out in Enniscorthy in Bellefield and St Aidan's. Reinstatement works are currently underway for sites that have commenced. Additional works will continue on these sites in 2020. Works in Gorey at McCurtain St are complete, permanent road reinstatement will be carried out in 2020. Other sites in Enniscorthy, Taghmon and throughout County Wexford are at design stage with construction not expected until 2020. This WNP project will continue through 2020 with works to start on additional sites.

GMC Sierra are continuing to work on the WNP contract in Wexford town. New watermains have been installed in Bernadette Place, St Aidans Villas, Wygram, Bishopswater, Corish Park and Clifford Terrace to date. New connections for the properties at this locations will be provided by Irish Water's contractor subject to consent and agreement with the householders. Works are progressing at design, consent and construction stages at additional locations in Wexford town to provide new connections and remove shared services: St Ibars Villas, St Enda's Terrace, Hill St, Mannix Place, St John's Avenue, Barrack St, Fishers Row, Francis St, Glena Terrace, Grogan's Rd, Carrigeen St, High St, Mary St, John St, Michael St, Kevin Barry St, Swan View, Rowe St Lower, Trinity St, The Faythe, Casa Rio.

Capital Maintenance Budget

CM is operating on a rolling budget since 2017. Current approved spend from IW is 2,795,971. Total commitments to end of July was $\in 2,724,314$. Capital maintenance funding is on hold for the remainder of the year except for emergency replacements.

WATER CONSERVATION

Water Conservation:

- Countywide consumption for November was on average 39.6 MLD, a reduction of 1.1 MLD since October 2019.
- New IW Leakage Management software, supplied by Crowder, is now live for Wexford County. Water Services staff are currently undergoing software training.
- Acoustic logger trial in Enniscorthy Low Level DMA is ongoing with HWM and EMR Solutions.

Leak Detection and Repair:

- 43nr leaks were detected and repaired in November 2019.
- Leak detection is currently concentrated in the South Regional area.

Water Network Programme with Coffey Northumberland/GMC:

- Gorey:
 - Reinstatement works on Grattan Terrace is to be completed by Coffey Northumberland.
- New Ross:
 - Charlton Hill has outstanding reinstatement works to be completed by DLC.
- Wexford:
 - GMC have completed BYS and mains rehab works in Wexford town in Bernadette place, Clifford St, Bishopswater and Wygram.
- Enniscorthy:
 - Private side lead replacement works in Bellfield Road still outstanding, due to be completed in 2020.

Find and Fix Scheme:

 DMA's have been selected for intensive leak detection works under the Find and Fix scheme, including Enniscorthy - Low Level, Enniscorthy -7", Gorey - Fairy Lane, Gorey - Pollshone sth, Wexford - Rathaspeck, New Ross - Town Centre and South Regional -Duncannon/Arthurstown.

Pressure Management:

• Water Network Program pressure management works of new PRV's, chambers and kiosks will commence in Wexford, Enniscorthy, Gorey and New Ross areas.

SCADA-Telemetry:

- Works to the SCADA system are ongoing.
- Disinfection program works being uploaded as available.

Global Information System:

• Corrections to system are continuously being surveyed and digitised on the Arc GIS.

NATIONAL ROAD MAJOR SCHEMES

M11 Gorey to Enniscorthy PPP Scheme

M11, N80 Link and N30

The M11, N80 Link and N30 are now open to traffic. Works in relation to fencing, landscaping drainage and general housekeeping will continue until contract completion.

Side Roads

Any outstanding works in relation to side roads will involve the installation of Traffic Management on a temporary basis to enable the works to be carried out safely.

R772 (Underpass on old N11 - Enniscorthy to Oilgate Road)

Works Completed

Liaison Office

Wexford County Council is continuing to liaise with the public in relation to the scheme.

COUNTY WEXFORD'S NATIONAL ROADS SCHEMES:

N25 New Ross By-Pass:

Progress Update January 2020

The project is now very close to completion and remains on course to open at the end of January 2020. There are a number of factors that may influence the actual opening date, including the seasonally variable weather and the significant arrangements that need to be implemented for the opening of such a major road and bridge project including the Stage 3 Safety Audit. The project will be endeavouring to announce the opening date as soon as possible.

A significant amount of finishing work was completed in the weeks before Christmas, and a relatively small amount of works remain to be closed out. Once the project has sufficiently developed to allow the road to open to traffic, the opening date will be decided by Transport Infrastructure Ireland in consultation with Wexford County Council and other project stakeholders. Arrangements for an opening ceremony for the project are also being progressed in consultation with TII.

A contract has been awarded to Highway Safety Developments Ltd from Knocktopher for the upgrade of signage along the existing sections of public road network that will be bypassed. Upon opening of the bypass signage on the bypassed sections of existing national primary roads will be changed to reflect their new status as regional roads.



2019 Pavement Schemes

The following schemes were either awarded or commenced in 2019 and will be completed in 2020.

N30 Clonroche from Ballymackessy to Tomfarney.

This scheme commenced on September 30th. 2019 and will be completed by the end of February 2020.

Pavement Repairs N25 Ring Road Wexford, N25 Orristown Junction Killinick

This scheme was tendered in October 2019. A contractor was appointed in November 2019. This scheme will be commenced in the first quarter of 2020.

2020 Transport Infrastructure Ireland (TII) Allocation:

The 2020 TII road improvement allocation has been received from TII. The following schemes will be carried out in 2020;

- N30 Mountelliot Pavement Scheme
- N11 Kileen to Newtown Phase 2 Pavement Scheme
- N25 New Ross Roundabout to Clonard Great Pavement Scheme
- N11 Ferns Pavement Scheme

N30 Mountelliot Pavement Scheme

This scheme runs from the newly constructed Mountelliot roundabout to the R731 Ballyanne junction in New Ross.

Contract documents are substantially completed and it is hoped to tender this scheme by the end of January.

N11 Kileen to Newtown Phase 2 Pavement Scheme

This scheme runs from the Ferrycarrig Bridge to the Maldron roundabout on the N11. Works are progressing on the tender documents. This scheme should be tendered in the first quarter of the year.

N25 New Ross Roundabout to Clonard Great Pavement Scheme

This scheme runs from the Maldron roundabout to the Whitford roundabout. Survey works will commence in February.

It is expected to tender this scheme in the second quarter of the year.

N11 Ferns Pavement Scheme

Preliminary archaeology investigations were carried out in 2019. Further archaeological investigations are required to be carried out in advance of the pavement scheme going ahead.

The timing of the pavement scheme will become clearer once the archaeological investigations have been completed.

Winter Maintenance

The 2019/2020 winter maintenance programme commenced on Monday 14th. October 2019. There have 23 no. call outs up to Thursday 2nd. January 2020.

Public Lighting LED Upgrade (Non National Roads)

Over 7,000 lanterns have been upgraded to Led since the beginning of 2016. It is hoped to upgrade the remaining 5,700 lanterns on non-national roads and housing estates in 2020.

TII Energy Efficiency Schemes

TII have funded the upgrade of public lanterns on national roads over the last 4 years. The locations upgraded to date are listed below,

- N25 Drinagh Roundabout
- N25 Maldron Roundabout

TII has not indicated how many schemes it intends to fund in 2020 but we would expect to have the 8 locations funded over the next 2 to 3 years.

REGIONAL AND LOCAL ROADS

Resurfacing/Strengthening

The strengthening programme commenced in the Enniscorthy District on 13 February.

Roads completed (clause 804) in the last month were: Coolcul Big to Coolateggart and Killowen; (both in New Ross District).

Surface Dressing Works

The surface dressing programme commenced in the Enniscorthy District on 10 June. The county's surface dressing programme of 100km was completed on the 6 September.

Community Involvement Schemes

Preparing roads for Community Involvement Schemes.

Local Improvement Schemes

Local Improvement Schemes completed in the last month were: Marshalstown; (Enniscorthy District). Preparing roads for Local Improvement Schemes in all Districts.

General Maintenance

Drainage, patching and road surface repair works ongoing in all Districts.

5. Finance:

Audit Committee

The Audit Committee is expected to meet with the Local Government Auditor to discuss the 2018 Accounts and associated audit. The committee will then proceed to prepare their report for the Council on the Audit Committee activity during 2019, their views following consideration of the Audited Financial Statement for 2018 and associated audit report together with a note on their proposed programme of work for 2020. It is expected that the report will be submitted to the Council for consideration after the next Audit Committee which is scheduled for March 2020.

Annual Financial Statement 2019

Work will be commencing on the preparation of the 2019 Accounts shortly once all transactions for 2019 have been updated to the financial management system. This work will take a number of months but it is expected that the Council will meet the submission deadline of the end of March.

Capital Programme 2020 – 2022

Work has commenced on the preparation of the next 3 Year Capital Programme and it is planned to have this ready for consideration of members in the first quarter of 2020.

Cash Flow/Overdraft

The Council continues to operate in overdraft, Ministerial Sanction is in place for borrowing by way of overdraft in the amount of €13m for the period to the 31st December, 2020.
