Note 1 - Conferences Fees are paid directly to conference organisers and not to members

Note 2 - Conferences at Home will relate to Conferences held within the state of Ireland.

Note 3 - Training is provided for members by AILG and LAMA

Note 4 - Conferences Abroad will include Twinning and Conferences held outside the state of Ireland, including Northern Ireland. These figures also include a refund of flight costs received in 2022 in relation to cancelled flights for Cllrs. G. Lawlor and M. Bell. Cllr. L. Kelly was booked to go to Savannah USA in March 2022 as part of the Council Delegation to Savannah, Georgia, USA but did not travel. The Council is in the process of recovering a refund of the cost of his flight from the Travel Agent/Airline concerned.

Note 5 - Members expenses is an allowance to reimburse members for costs incurred in the performance of their duties as Councillors. The travel and subsistence elements of the allowance are calculated by reference to the distance from each Councillor's home to Council Headquarters and is calculated on an annual basis and paid in monthly instalments. The amount for miscellaneous expenses is paid on a vouched basis to a maximum set by legislation. The allowance carries an attendance requirement, with full allowance paid for 80-100% attendance, and reduced pro-rate where attendance is less than 80%.

Note 6 - Representational Payments are in effect a "salary" type payment to Members. Amounts are set by legislation and are shown in "gross" terms, before deduction of PAYE, PRSI and other statutory deductions
