On the proposal of Cllr. D. Hynes, seconded by Cllr. B.A. Murphy, the Council resolved to confirm the Minutes of the Special Meeting of Wexford County Council (Climate Change, Coastal Erosion, Coastal Flooding & Rising Sea Levels) on 11th April, 2023.

2. 3 Year Capital Programme 2023 – 2025

Ms. A. O'Neill, Head of Finance presented the proposed 3-year Capital Programme for the Council's consideration. The Programme outlined 199 capital projects at various stages together with estimated costs and proposed sources of funding.

The Programme was prepared on the basis of a realistic and prudent assessment of the position regarding each project and on the basis of the information available at the time and having regard to the measures proposed to fund the Programme.

The Members considered the Programme and raised a number of points for clarification which were responded to by Ms. A. O'Neill and the Management Team, including the following:

- Is land cost included in the funding of playground at Templeshannon?
- Spend of c€220m on housing welcomed.
- Concern over cost of 3 housing units at the Bullawn, New Ross.
- Query in relation to cost of Carrigfoyle & Curracloe activity centres.
- Request for breakdown of cost for Gorey town park.
- Villages in New Ross prioritised for improved wastewater facilities?
- Investment in Kilmore Quay business hub welcomed.
- Concern over cost of feasibility study for New Ross port.
- Is New Ross library being extended?
- Request to explore greenway to White Mountain rather than St. Mullins.
- Update on progress of lighting at Min Ryan skate park.
- Request for increased spending on housing land.
- Plan for Mechanics Institute and Ballast Office.
- Possibility of fast tracking N11/N25 works.

12.3 Cllr. Barbara-Anne Murphy

"That Wexford County Council use 'The Street' in Co. Hall to facilitate Pre Planning Clinics for people hoping to apply for planning permission for one off houses on a quarterly basis. This measure would help to alleviate the pressure on pre planning and allow people to move on with their lives."

Executive Response:

The use of an open clinic was considered at a recent SPC which discussed the problems relating to delays in the preplanning system. It was agreed that such a proposal would have limited benefit as only the basic generic advice could be given (this information is available from the County Development Plan and could be provided by the applicants' architect or planning agent).

The Planning Department had previously held information events but those attending wanted advice on their projects and had to be processed for individual meetings. At present the preplanning requests are reviewed by the planner and, in many cases, site visits are carried out to advise on the setting and design of developments. Each preplanning request is also validated to comply with Section 247 of the Planning and

Development Act 2000 (as amended), mapped and recorded on the Planning APAS system. This would be incredibly difficult in an open meeting.

The Planning Section will continue to assist the planning agents in advising their clients and work has been carried out on this through the agent advice days and email updates. General advice can also be given by calling the Planning Department Customer Unit (053 9196101) and the Planner on Call will seek to provide assistance.

To the end of last month (28-4-23) the Planning Staff have completed 136 preplanning meetings and are continuing to clear the back log despite increasing workloads and additional duties.

Ms. L. Hore corrected the record and advised that the SPC hasn't discussed open preplanning meetings, as incorrectly outlined in the Executive response to the motion.

After some discussion on the motion, Ms. L. Hore agreed to implement the proposal as outlined on a trial basis.

The motion was proposed by Cllr. B.A. Murphy, seconded by Cllr. A. Bolger and carried.

12.4 Cllr. Tom Forde

"We request that Housing Minister Darragh O Brien allow local authorities to work with landlords to lease suitable properties on a long term basis. Under the Housing for All strategy that was announced by the Government at the end of 2021, the Leasing Scheme has ceased and WCC can no longer accept new proposals for this scheme. We ask that this scheme be reinstated to support a housing solution for many that are in need and to avoid some of these properties becoming or staying vacant."

Executive Response:

If passed, this Motion will be forwarded to the Minister for Housing, for consideration.
