1. Presentations

On the proposal of Cllr. M. Sheehan, seconded by Cllr. M. Whelan, standing orders were suspended to allow the presentations to be taken as the first agenda item.

1.1 Wexford Walking Trails

The Cathaoirleach welcomed Peter O'Connor, Wexford Walking Trails, Ann Murphy, Wexford Walking Trails, and Rory O'Mahony, Wexford County Council.

Peter O'Connor gave a presentation on Wexford Walking Trails outlining:

- What Wexford Walking Trails is.
- Trail design and marketing.
- Trail infrastructure.
- Benefits of walking trails.
- Sustainability of the network.

Peter O'Connor responded to a wide range of queries from the Elected Members regarding the following:

- Timeline for work at Kelly's wood and Arthurstown.
- Are there restrictions on height above sea level that trails can be developed for insurance reasons?
- Can the Rocks walking trail be included on the brochure?
- More investment in urban walking trails is needed.
- Timeline for commencement of work on walking trails in Enniscorthy.
- Request for increased advertising of trails.
- Timeline for works on Edenvale to Castlebridge walking loop.
- Request that the trail on Vinegar Hill be kept cut back for accessibility.
- What are Wexford Walking Trails administrative costs?
- Request that greenway from Wexford Town to Curracloe be considered.
- What are the plans for new trails for the next 3 to 5 years?
- If trail crosses private land, how long does it take to get permission?

Mr. T. Enright thanked Peter O'Connor and Ann Murphy for all their work on Wexford Walking Trails.

- The need for a close working relationship with the Gardaí to tackle the very small minority who will engage in anti-social behaviour.

On the proposal of Cllr. J. O'Rourke, seconded by Cllr. B.A. Murphy, the Council resolved to adopt the Wexford County Council (Enniscorthy Municipal District) Traffic & Car Parking Bye Laws, 2023.

6. Draft Wexford County Council Climate Action Plan (2024 – 2029) – Approval for public consultation on 10th October

On the proposal of Cllr. M. Whelan, seconded by Cllr. P. Breen, the Council resolved to put the Draft Wexford County Council Climate Action Plan (2024 – 2029) out to public consultation.

7. Savannah Delegation 2024

Ms. L. Hore outlined the reasons why the CPG recommended sending a strong delegation headed by the Cathaoirleach and the Chair of each Municipal District to Savannah in 2024 and sought the approval of the Council.

On the proposal of Cllr. P. Breen, seconded by Cllr. J. O'Rourke, the Council resolved to approve the Savannah delegation.

8. Invite from Fishguard - Goodwick Council to attend memorial service 11th November, 2023 - For Approval

Mr. M. Drea outlined the detail of an invitation received from Deputy Mayor Cllr. William Shaw to attend a memorial service on board the ferry to remember those who lost their lives on the SS St. Patrick sunk on Friday 13th June 1941. That fateful day some 12 passengers and 17 crew lost their lives, and it was a mixture of both Welsh and Irish. The service will take place this year on Saturday 11th November. Stena are covering the cost of the travel.

On the proposal of Cllr. J. O'Rourke, seconded by Cllr. M. Farrell, the Council resolved to approve a delegation to attend the memorial service.

The meeting adjourned for a comfort break and at this point.

- Query as to who is responsible for the signs promoting veganism on the Rosslare Road.
- Congratulations to the housing staff for securing emergency accommodation in Enniscorthy.

- Can Council prioritise filling of Greenway Development Officer post?
- Under URDF Call 3, can priority be given to first time buyers when properties are put up for sale?

- Can a reserve list also be submitted to the Department for the Town & Village Scheme in case additional funding is available?

14. Notices of Motion

14.1 Cllr. T. Forde & Cllr. D. Hynes

"This council acknowledges the need for good landlords in the rental market but also commits to take appropriate action against landlords who fail in their legal duty to provide tenants with a property that provides a safe and healthy environment for tenants to live in. This council notes that in 2022 the council did not issue any Prohibition Notices or initiate any legal proceedings and will ensure that in future swift action is taken to issue Prohibition Notices and initiate legal proceedings for landlords who breach the minimum standards regulations and who fail to comply with an Improvement Notice".

Executive Response:

In accordance with the Housing (Miscellaneous Provisions) Act, 1992 as amended, it shall be the duty of the Landlord to ensure that the property complies with the requirements of the Housing (Standards for Rented Houses) Regulations 2019.

Wexford County Council have carried out 818 private rented inspections from the 01/01/2023 to 30/09/2023, of which, 12% have been deemed compliant with the Housing

(Standards for Rented Houses) Regulations 2019. Approximately 700 Improvement Letters and 85 Reminder Letters have been issued in 2023.

Experience from the inspection process to date would indicate that the majority of properties were in reasonable condition, with the most common breaches being Fire Blanket, Smoke Alarms, Mechanical Extractor Fans, Wall and Window Vents, Carbon Monoxide Alarms and Windows Restrictors.

Wexford County Council strives to achieve compliance through resolution and meaningful engagement with landlords, however, is committed to commencing Enforcement proceedings, in cases where landlords have continuously failed to comply with the Regulations.

Wexford County Council acknowledges that it has not issued any Prohibition Notices or initiate any legal proceeding in 2022, however, enforcement proceedings nationally were very low, with only 1,746 Improvement Notices and 170 Prohibition Notices issued following 49,308 inspections.

Wexford County Council commits to take the appropriate action against landlords who fail to comply with the Regulations and has identified a number of properties which will be escalated to enforcement proceedings imminently.

"This Council calls on the Minister for Transport to help fund much needed development at Waterford Airport in the 2024 budget"

The motion was proposed by Cllr. M. Whelan, seconded by Cllr. A. Conncik and carried.

14.3 Cllr. F. 'Ó Súilleabháin

"Wexford County Council warmly welcomes plans by Tara Film Studios to commence construction in this county next Spring. We acknowledge that this will see employment opportunities for local people, and we commit this council to work closely with WWETB, SETU, Gorey School of Art, as well as groups such as Screen Ireland and the Irish Film and Television Network this year, and over the coming years, to help develop apprenticeships, training programmes and academic courses in film production and any related areas."

Executive Response:

Wexford County Council is fully committed to film production within the County. Screen Wexford is the film office for Wexford County Council and delivers a comprehensive support service for all levels of production within the County. Their role is to assist in making content a seamless and simple experience.

Screen Wexford foster talent in Film, TV, Animation and video production and help kickstart or progress careers. Screen Wexford's focus includes sharing the abundance of fabulous locations offered by the county, along with facilitating local, national and international productions. They are heavily invested in the growth and development of our local crew base through the design and delivery of a range of world-class training programmes.

14.4 Cllr. L. McDonald & Cllr. B.A. Murphy

"That this council supports the calls from the Judiciary, The Law Reform Commission and most recently highlighted by former state pathologist Dr Marie Cassidy in her documentary "Dr Marie Cassidys casebook, the femicide cases "for the fundamental and immediate reform of the defence of provocation (which is used as a defence in a 1/4 of murder trials in this jurisdiction) in order to bring Ireland in line with all other common law jurisdictions."

"That this council calls upon the government departments of Agriculture and Transport in conjunction with our local authorities and utility companies to urgently devise a scheme to address the pressing issue of rotting and diseased trees on our roadsides to include a replacement programme to support replacing the depleted hedgerows which will result from same." Drea advised that in his capacity as Meetings Administrator he made the decision to redirect the motion as it was seeking to amend the housing allocation policy, which had been approved by the Housing SPC earlier this year. Mr. Drea confirmed that standing order 16. (a) provides that "If any Notice of Motion of which notice has been duly given relates to a matter normally dealt with by a Municipal District or any other Committee, or comes within the terms of reference of any Committee or Committees, it shall be referred to such Committee or Committees as the Meetings Administrator may determine."
