Mr. Eamonn Hore, Director of Services provided a detailed summary report on this incident to the Council which outlined the nature and cause of the incident, including dates, status of the Council's investigations into the matter, contact with Irish Water, HSE and EPA.

Mr. Hore advised that the Council's investigations were continuing but it was clear that the main cause of the poor water quality was attributed to the power failure which impacted on the chlorine dosing system.

Mr. Hore further outlined the extensive testing that has been carried out throughout the system in Gorey town and the improvement works that have taken place to date.

## 11. Deferred Notices of Motion from Council Meeting 10th May 2021

# 11.1 Cllr. G. Carthy

"That we the Members of Wexford County Council request that the Minister for the Environment, Climate and Communications and Transport, Mr. Eamonn Ryan TD prioritises the planning, design and construction of the N24 Waterford to Limerick Corridor Road project within the Review of the National Development Plan. This project is critical to the development of the South East region and to the achievement of national targets on addressing regional imbalance by connecting the cities of Waterford and Limerick, the South East, South West and Mid-West Regions, Rosslare Europort, the Port of Waterford, and existing strategic transport corridors including the M7(Dublin – Limerick), M8 (Dublin- Cork) and M9 (Dublin-Carlow-Kilkenny-Waterford) motorways.

It is further requested that this Notion of Motion be sent to the Minister for Finance, Mr Paschal Donoghue TD and Minister for Public Expenditure and Reform, Mr. Michael McGrath TD".

The Motion was proposed by Cllr. G. Carthy, seconded by Cllr. M. Sheehan and approved by the Council.

#### 11.2 Cllr. G. Carthy

"That this Council calls on the Government in the light of Brexit and other market influences to recognise the strategic value of the South-East Ports in Rosslare and Belview, Waterford through:

- Strategic investment in the Ports, in particular through the purchase of additional land for the expansion of Rosslare Europort and the advance construction of Rosslare Europort Harbour Access Road.
- Amalgamation of the ports structure and governance to create a Tier 1 port as a combined entity.
- Designation of the combined entity as the service port for offshore renewables in The Irish and Celtic Seas.

The Motion was proposed by Cllr. G. Carthy, seconded by Cllr. M. Sheehan and approved by the Council.

#### 12. Notices of Motion

#### 12.1 Cllr. J. O'Rourke

"I write to ask in light of the inability of new community operated playgrounds and those whose policies may have lapsed to get insurance cover and increased burden of individual costs on existing community operated playgrounds I call on Wexford County Council to take all these playgrounds in under the councils policy."

Cllr. O'Rourke asked that the Motion be withdrawn, and this was agreed.

#### 12.2 Cllr. M. Whelan

"I call on this council to support the call from the I.F.A. to extend the deadline date on registration of rights of way and easement for at least 2 years from the 30th November 2021. And to send the bill to the law reform commission to look at the structure as it stands".

The Motion was proposed by Cllr. Whelan.

Following discussion, it was agreed to amend the Motion by deleting the phrase "for at least 2 years" and to replace it with the phrase "for at least 4 years".

The amended Motion was proposed by Cllr. M. Whelan, seconded by Cllr. C. Byrne and agreed by all.

#### 12.3 Cllr. K. Codd Nolan & Cllr. C. Byrne

"In view of the inability of Community Groups to access reasonable Insurance on both new projects and renewal of existing policies on play-grounds or Community Parks that are not in the ownership of a Local Authority we propose that Wexford County Council immediately write to Minister Sean Fleming T.D. Minister of State for Dept of Finance with responsibility for Insurance, requesting that he urgently examine the area of Leisure Insurance in Ireland and bring forward an immediate solution to enable Community groups acquire reasonable insurance to cover these very important facilities."

The Motion was proposed by Cllr. K. Codd Nolan, seconded by Cllr. C. Byrne and agreed by all.

It was agreed that the feasibility of extending the Council's public liability insurance policy to cover these community playgrounds would be examined. It was further agreed that on receipt of the Minister's reply to the Motion, the matter would be brought before the Council for further consideration,

## 12.4 Cllrs. D. Hynes, T. Forde,

"In the interest of local democracy, this Council calls for an urgent review of local authorities protocol regarding executive making decisions that disregard elected members, for instance in the area of GDPR where this council's heavy-handed approach is leading to serious concerns on the part of members. In view of the fact that it would seem that executive functions are superseding reserve functions, we move that the Chief Executive take immediate action to ensure fair play, and to avoid a breakdown in the relationship between the Executive and the Elected Members. In the interest of those who are elected to represent the people of Wexford"

The Motion was proposed by Cllr. Hynes and seconded by Cllr. Forde,.

Many members contributed to the ensuing debate. Concerns identified included delayed response to telephone calls, lack of information flow between staff and the Members, and in some cases perceived poor quality of responses provided to the Members queries.

The Deputy Chief Executive and County Secretary expressed their disappointment to learn of the Members concerns and undertook to address the issues raised.

It was also agreed to convene a meeting of the Members Portal Working Group to consider the concerns identified in relation to the Portal and to report to the Council with proposals to resolve those concerns.

#### 12.5 Cllr. M. Whelan

That this council calls on our six Oireachtas members to bring the case for the provision of adequate funding for research into Motor Neuron disease.

The Motion was proposed by Cllr. M. Whelan, seconded by Cllr. L. McDonald and agreed by all.

As the Council had now sat for one hour and fifty-five minutes, the Cathaoirleach declared the meeting closed, with the remaining items deferred to the next meeting of the Council

## 12.6 Cllr. Leonard Kelly,

"I am calling on Wexford County Council, working with each municipal district to carry out a complete road safety audit on all estates that are taken in charge by Wexford County Council, with particular emphasis on the condition of existing speed ramps (and assessment of need for new ramp) and the erection of signage (Slow Down, Children at Play, etc.) as appropriate.

I have received many representations relating to reckless behaviour of some drivers within residential areas. The safety of residents and their children should not be dependent on makeshift signage or on discretionary funds being spent by individual councillors for things like speed ramps. Any and all safety upgrades need to be costed, budgeted and planned to give clarify to local residents.

We should not be found wanting in this regard."
