8. Deferred Notices of Motion from Council Meeting 10th May 2021

8.1 Cllr. F. Ó Súilleabháin

Procurement

That Wexford County Council notes the long overrun in the completion period for some of our major projects, as well as the high overspend for some of our projects in comparison to the original projected cost.

As a solution, this Council will:

- (a) endeavour to insert a Sunset-type clause to tie developers to an agreed completion date on projects and
- (b) that we will insert a Social Inclusion Contract to ensure a higher percentage of local labour get employed and (c) that we will look at the model of Community Wealth Building as introduced in some local authority areas abroad. (CWB seeks to leverage existing local and regional resources to

provide workers, families and communities with greater control over their own economic development and ensure money is kept in the local economy)

As an example, in Co.Wexford this could entail the breaking down of a contract into smaller parts i.e. on Gorey Town Park project, one local company could be employed to do the soft landscaping; another the hard surface works and another the building works, playground etc.

This alternative model is more beneficial to the local economy and local businesses than the current e-tendering model which would appear to favour a single larger company.

The Motion was proposed by Cllr. F. Ó Súilleabháin and seconded by Cllr. J. Codd.

Following discussion, it was agreed to defer this Motion to the July meeting of the Council for further consideration

8.2 Cllr. T. Forde

"We also call on the minister of agriculture to intervene in the current impasse that Wexford scallop fishers are facing due to the British Brexit ruling banning them from landing their catch at any British Port."

The Motion was proposed by Cllr. T. Forde, seconded by Cllr. J. Codd and agreed unanimously.

8.3 Cllr. J. Moore

'Wexford County Council calls on the Minister for Housing, Local Government and Heritage to facilitate a meeting with the Council and the National Coastal Management Strategy Steering Group to highlight the immediate concerns of Wexford County Council and secure the responses required to address the coastal erosion issues in Wexford.'

The Motion was proposed by Cllr. J. Moore, seconded by Cllr. M. Farrell and agreed unanimously.

8.4 Cllr. G. Carthy, Cathaoirleach

"That we the Members of Wexford County Council request that the Minister for the Environment, Climate and Communications and Transport, Mr. Eamonn Ryan TD prioritises the planning, design and construction of the N24 Waterford to Limerick Corridor road project within the Review of the National Development Plan.

This project is critical to the development of the South East region and to the achievement of national targets on addressing regional imbalance by connecting the cities of Waterford and Limerick, the South East, South West and Mid West Regions, Rosslare Europort, the Port of Waterford and existing strategic transport corridors including the M7(Dublin – Limerick), M8 (Dublin- Cork) and M9 (Dublin-Carlow-Kilkenny-Waterford) motorways.

It is further requested that this Notion of Motion be sent to the Minister for Finance, Mr Paschal Donoghue TD and Minister for Public Expenditure and Reform, Mr. Michael McGrath TD. "

At the request of the Cathaoirleach, this Motion was deferred to the July meeting of the Council.

8.5 Cllr. F. O Suilleabhain

"Wexford County Council should examine the Community Wealth Building model with a view to incorporating it into their Local Economic Community Plans (LECP).

Community Wealth Building has emerged as a powerful approach to local economic development and has been particularly successful in Preston, England, North Ayrshire, Scotland and Cleveland, United States.

The model will allow counties to leverage existing resources, such as procurement, to meet local needs while creating quality employment and promoting equity and sustainability.

This Council will initiate dialogue with local public bodies and semi-state companies in the locality regarding their potential role in the strategy.

That we will bring local businesses, enterprises and community activists into the discussion around developing the project.

That we also engage with councils in Preston, North Ayrshire and elsewhere which have successfully developed this model."

(A number of councils have already passed this motion.)

The Motion was proposed by Cllr. F. Ó Súilleabháin and seconded by Cllr. J. Codd.

Following discussion, it was agreed to defer this Motion to the July meeting of the Council for further consideration

8.6 Cllr. M. Bell

"I ask this Council to write to the Department of Health, Minister Stephen Donnelly, to help victims of domestic, sexual and gender -based violence access to free psychological support & counselling, noting that this is a free service for perpetrators while in prison."

The Motion was proposed by Cllr. M. Bell, seconded by Cllr. G. Lawlor and agreed unanimously.

8.7 Cllr. M. Sheehan

"Welcoming the agreement between the DPER and the DSPEA to resolve the longstanding issue of the CE Supervisors Pension entitlement, this Council calls for the speedy implementation of the agreement in full and to ask the Minister for Social Protection, Heather Humphreys to consider extending participant's last year of their Community Employment Schemes by a further year in recognition of the lost time, training and contributions to the community due to Covid 19".

The Motion was proposed by Cllr. M. Sheehan, seconded by C. Byrne and agreed unanimously.

8.8 Cllr. G. Carthy, Cathaoirleach

"That this Council calls on the Government in the light of Brexit and other market influences to recognise the strategic value of the South-East Ports in Rosslare and Belview, Waterford through Strategic investment in the Ports, in particular through the purchase of additional land for the expansion of Rosslare Europort and the advance construction of Rosslare Europort Harbour Access Road, Amalgamation of the ports structure and governance to create a Tier 1 port as a combined entity, Designation of the combined entity as the service port for off-shore renewables in The Irish and Celtic Seas. "

At the request of the Cathaoirleach, this Motion was deferred to the July meeting of the Council.

8.9 Cllr. T. Forde

"That Members receive an update at every monthly meeting of this council on the status of each motion that is passed by this council until the content of the motion has been followed through or reached its endpoint."

The Motion was proposed by Cllr. M. Forde and seconded by L. Kelly.

The County Secretary pointed out that while most Motions are relatively straightforward to bring into effect, more complex Motions require detailed consideration by the Executive before being carried out, and of course the outcome of that consideration process should be advised to the Members in due course
