1. Confirmation of Minutes:

On the proposal of Cllr. P. Breen, seconded by Cllr. J. Moore and agreed unanimously the Council resolved to adopt each of the above Minutes.

Matters Arising:

It was agreed that the Council would obtain legal advice to clarify if the Council's Standing Orders could be used to set the criteria under which remote meetings of the Council could be held, or under which an individual member could attend remotely.

In response to a query from Cllr. Hegarty, Mr. T. Larkin DoS agreed to bring the matter of fees for Taking in Charge Certificates before the next available relevant SPC.

Ms. C. Godkin A/DoS advised that following a notice of Motion to the November Meeting of the Council, the Council is agreeable to support the National Ambulance Community Responder Scheme and will advance this project in the coming months.

Cllr. M Sheehan reminded Ms. Godkin of his recent request for a breakdown of the 2021 Budget provision of €300,000 towards costs at Ozanam House.

Cllr. C. Byrne raised the issue of Council's slipway charges. In response, the CE advised that these charges have been set under the 2021 Schedule of Charges. He reminded the Members that these charges were very were modest and the associated income was reflected in the excellent range of amenities available at the locations in question.

Cllr. Sheehan asked that consideration be given to a mortgage scheme for fire-fighting personnel that recognises the fluctuations in their incomes.

2. Part XI of the Planning and Development Act, 2000 (as amended) and Part 8, of the Planning and Development Regulations, 2001 (as amended):

2.1 LAC2004 – Development of a Public Realm Improvement Scheme at Esmonde Street, Gorey, Co. Wexford

On the proposal of Cllr. J. Sullivan seconded by Cllr. P. Breen the Council resolved that the proposed development should be carried out in accordance with the Report of the Chief Executive as circulated.

3. Wexford County Council Harbour & Pier Bye-Laws 2020

On the proposal of Cllr. J. Sullivan, seconded by Cllr. D. Kenny the Council resolved to adopt and make the *Wexford County Council Harbour & Pier Bye-Laws 2020* in accordance with Section 199 and Section 200 of the Local Government Act 2001 (as amended).

At this point, Cllr. Kenny made his apologies to the Cathaoirleach and left the meeting

13. Notices of Motion

13.1 Cllr. L. Kelly

"Requesting that Wexford County Council write to the Ministers for Justice, Finance and Public Expenditure to make provisions where drug and drug trafficking monies confiscated under the Proceeds of Crime Legislation be redirected from central coffers back into local addiction services, youth organisations, and community initiatives to combat the effect of addiction on our communities, and that the necessary legislation is changed as a matter of urgency to allow this vital funding support to happen".

Proposed by Cllr. L. Kelly, seconded by Cllr. T. Forde and agreed.

13.2 Cllr. T. Forde

"I ask that Wexford County Council write to the Minister for Housing, Local Government and Heritage, Darragh O Brien, and ask that the local authorities allocation for disability adaption works be increased to match the need of our demand. In the very least we ask that funding be reinstated to the previous level before it was reduced by 16% on 2019 levels to €481,053.

This council is mindful that reductions to these funds has and is preventing many vulnerable people from living with dignity and with the basic necessities required for a comfortable standard of living."

Proposed by Cllr. T. Forde, seconded by Cllr. J. Codd and agreed.

13.3 Cllr. M. Sheehan

"That this Council calls on the Department of Education and the Higher Education Institutions/ Bodies to offer a rebate scheme to third level students who are charged full rate for on-campus accommodation but are afforded limited access due to Covid restrictions for the Academic Year 2020/2021. Upon passage, this motion is circulated to all Local Authorities.

Proposed by Cllr. M. Sheehan, seconded by Cllr. A. Bolger and agreed.

13.4 Cllr. F. Ó Súilleabháin & Cllr. T. Forde

"This Council notes the centenary of the passing by the British Parliament at Westminster of the Government of Ireland Act in December 1920, the Act which provided for the Partition of Ireland. We recall the deep injustices, divisions and conflict caused by this Act. We reiterate our support for the Good Friday Agreement and the political process arising from it, including the revoking of the Government of Ireland Act. We reaffirm our support for the self-determination of the people of Ireland as expressed in Article 3.1 of Bunreacht na hÉireann and for the bringing about of a United Ireland "by peaceful means with the consent of a majority of the people, democratically expressed, in both jurisdictions".

Accordingly we call on both the Irish and British governments to fully implement the Good Friday Agreement and all their obligations with regard to the rights of citizens; we call on the British government to agree to set a date for the Irish Unity referendum as provided in the Agreement; we call on the Irish government to work for this outcome.

We stand ready as a Council to work with all statutory bodies and with civic society to plan and prepare for the referendum on Irish Unity and for a positive outcome to the referendum."

Proposed by Cllr. F. Ó Súilleabháin and seconded by Cllr. J. Codd.

The following amendment to the Motion was proposed by Cllr. M. Sheehan and seconded by Cllr. P. Breen, being the amendment of Paragraph 2 of the Motion as follows:

Accordingly we call on both the Irish and British governments to fully implement the Good Friday Agreement and all their obligations with regard to the rights of citizens; we call on the British government to agree to set a date for the Irish Unity referendum as provided in the Agreement <u>when circumstances permit</u>. We call on the Irish government to work for this outcome.

13.5 Cllr. L. Kelly

"In the Program for Government a commitment to an allocation of 10% of the total transport capital budget for cycling projects and an allocation of 10% of the total capital budget for pedestrian infrastructure was made. The commitment to cycling and pedestrian projects is set at 20% of the 2020 capital budget (€360 million) per year for the lifetime of the Government.

In order to place Co. Wexford front and centre of securing our share of this funding, I propose that Wexford county council prioritise the development and adoption of a

high-quality cycling policy and that the department of Transport are approached by the Council to have Wexford, New Ross, Enniscorthy and Gorey included under the remit of the NTA from where the expertise of the newly created cycle design office can be sought.

As part of this I propose that Wexford County Council carries out a full assessment of our roads network and develops cycle network plans paying particular attention to the development and renewal of walking and cycling strategies for urban settings (for travel to education, work and for recreation), which will be implemented with the help of a suitably qualified Cycling Officer with clear powers and role."

Proposed by Cllr. Kelly, seconded by Cllr. L. McDonald and agreed.

In agreeing the Motion, the Members asked that rural villages and towns in County Wexford would also be considered for similar investment.

13.6 Cllr. M. Sheehan & Cllr. P. Breen

"That this Council backs the Government support for the Greyhound and Horse Industry and calls on the Minister to ensure continued support and funding on a multi-annual basis.

Proposed by Cllr. Sheehan, seconded by Cllr. P. Breen and agreed

The Cathaoirleach and Chief Executive thanked the elected members and staff of the Council for their excellent work throughout the year and wished everybody a Safe and a Happy Christmas.
