The use of violence or threat of violence or intimidation towards staff. Intimidating behaviour. Harassment of staff or fellow customers



Duine den fhoireann nó duine eile den phobal a taifeadadh gan cead. Ar mhaithe le cearta príobháideacha, ní ghlactar le taifeadadh fíis nó fuaime nó pictiúr a tógadh gan cead scríofa sonrach, agus ní ghlactar le postáil mhíchuí dó sin thuas luaite ar aon ardán meán nó meán sóisialta

In the interest of privacy rights, the recording of staff and/or customers using video and/or audio recordings or taking photographs without specific written authorisation and the inappropriate posting of same on any media platform.



Postáil trácht do-ghlactha nó ábhar maslach ar aon ardán meán (lena n-áirítear na meáin shóisialta) faoi fhoireann na Comhairle i ndáil lena ról le Comhairle Contae Loch Garman

The posting of unacceptable comments or offensive material on any media platform (including social media) about staff of the Council in relation to their role with Wexford County Council.



Iompar a chuireann as do dhaoine nó atá contúirteach agus a chuireann isteach ar úsáid agus taitneamh áise do dhaoine eile nó ar chumas na Comhairle a seirbhísí a sholáthar don phobal

Behaviour that is disruptive or dangerous and interferes with the use and enjoyment of a facility by others or the capacity of the Council to deliver its services to the public.

Customers who breach the code of conduct may be subject to a range of sanctions depending on the severity and nature of the behaviour.
