I refer to your request received in this office, under the Freedom of Information Act (2014) for records held by this FOI body.

The request sought:-

"Under the FOI Act 2014, I am seeking the following:

- a copy of all invoices/receipts associated with St Patrick's Day travel for the local authority in 2025.
- a record of who travelled.
- a table/spreadsheet/record of all costs if possible.
- the itinerary for the trip.
- an information note on the trip if you or your communications department wish to provide one. I would prefer to receive this information electronically, ideally in its original electronic format."

The Decision Makers in this case, were Michael Drea, County Secretary, Billy Byrne, Senior Staff Officer, Economic Development & Alan Fitzhenry, New Ross Municipal District Manager. The decision has been made to grant your request.

The schedule of records and records are now available to view at FOI Responses | Wexford County Council (wexfordcoco.ie).

Section 37 Personal Information

Section 37 of the FOI Act 2014 states:-

"(1)...a head shall refuse to grant an FOI request, if in the opinion of the head, access to the record concerned would involve the disclosure of personal information (including personal information relating to a deceased individual)."

The records withheld under this section contain personal information of other individuals who are identifiable from the records. We do not have the consent of these third parties to release their personal information and in the circumstances, I do not believe it is appropriate for me to seek their consent. It is therefore my decision that these documents are exempt from release



Schedule of Records

A detailed Schedule of Records is attached to the records; this shows the details of the records that were considered to fall under the scope of your request, and it details the decision in relation to each record. The decision can be to grant, part grant or refuse and this is detailed in the Schedule. Where it is decided to part grant or refuse a document the exemption sections that are relied upon are quoted.

Right of Appeal

If you are unhappy with this decision, you may appeal it. In the event that you wish to make such an appeal, you can do so by writing to the Freedom of Information Unit, Wexford County Council, Carricklawn, Wexford or by email to foi@wexfordcoco.ie.

Your appeal should include a fee of €30 which can be made payable to Wexford County Council. You should make your appeal within 4 weeks from the date of this notification, where a day is defined as a working day excluding weekends and public holidays. However, the making of a late appeal is permitted in appropriate circumstances. The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this body.

If you are unhappy with the response you receive to your internal review request, you have a right to appeal to the Office of the Information Commissioner. This appeal must be made within 6 months of the date of the internal review decision and may be made by writing to:-








Leas-Cathaoirleach presentation to Liam Murphy.







APPENDIX I New York Mayor Eric Adams' St. Patrick's Day Address

Mayor Eric Adams: Thank you so much. It is such a pleasure to be here and I keep trying to tell the announcer over and over again, it is O'Adams, O'Adams. You know, happy St. Patrick's Day. When you think of March 17, 1862, when the first parade took place here in New York, it has grown into the largest parade in our country.

This is really the Emerald Isle of America right here in New York City. Two million people will be watching, 150,000 participants here, really showing the pride and energy of the Irish people here in New York City. And when you think about it during this day, I've learned when I was in Ireland that this is just liquid sunshine.

We continue to march and enjoy the beauty of the seven shades of green right here in New York City. This is important for us because the Irish community is the bedrock of New York City. Look at our bridges, our subways, look at all of the major edifices and towers that you see. The Empire State Building, which is a symbol of our resiliency after the Great Depression.

Little over one year, that entire building was built and it still stands there to let us know what the contributions are and will continue to be from this community. You are part of our Department of Sanitation, the Police Department, the Fire Department, the teachers, all those things that make us great in the first place is right here in this room as a symbol of who we are and what we are. I'm so proud to march in this parade each year.

I look forward to being here at Gracie Mansion. You grace us with your presence and I cannot tell you enough while we watch strife all over the globe. It is going to be the spirit of the Irish people, the various immigrant groups that came here and showed that this is the greatest city on the globe in the greatest country on the globe because of our diversity. It's the mixture of all of our different ethnic groups and culture that give us the quality that we look for and we should never take that away. I love this country and I love the people who are part of it.

As a member of the New York City Police Department for 22 years, when you put on a bulletproof vest and protect the children and families of the city, you have a different love affair with them that can never go away no matter what happens and I believe, truly, when we sing our song and we state the rockets red glare of the bombs burst in the air gave proof through the night that our flag is still there, and it will always be still here because of the people that are part of this great city in this great country and that is emblematic to all that we see today. Congratulations. Thank you for your contribution. Happy St. Patrick's Day.

APPENDIX II Archbishop Eamon Martin's Homily

Archbishop Eamon Martin's homily in St Patrick's Cathedral, New York.

Saint Patrick was a pilgrim of hope and in this Jubilee year of Hope I'm honoured to be with you In New York as a pilgrim of hope and bring you greetings from Armagh, the home of Saint Patrick. Thank you, Cardinal Dolan for your kind invitation and warm welcome. Beannachtaí na Féile Pádraig oraibh go leir.

We know from his own writings that Patrick was trafficked into slavery in Ireland as a young teenager, but despite his isolation and the pain of loneliness, so far from his home and family, Patrick turned with all his heart to God, and dared to hope. Much later in his life, as a priest and bishop, he heard the "voice of the Irish" calling him and Patrick had the courage to return to the land of his captivity, this time as a missionary to spread the Good News to the people of Ireland and a message of hope and trust in the Lord. No doubt he was inspired by those words in today's Gospel reading: "Put out into deep water and lower your nets for a catch" and again, "Follow me; do not be afraid; for from now on it is men that you will be catching". When I was ordained a priest I chose for my ordination card a verse from psalm 31: "Be strong let your heart take courage, all who hope in the Lord (*Psalm 31:24*)." And I have been privileged during my years as a priest and a bishop to witness hope in the lives of many people — including people who "dare to hope" even in the most difficult of circumstances.

Friends nowadays there seem to be so many reasons to give up on hope – the terrible wars, violence and injustices that seem intractable; the shocking disregard for human dignity and vulnerable life; the almost relentless advance of climate change.

I can't imagine what it must be like to lose all hope. And yet sadly we live in a world where too many people feel overwhelmed by the pressures and worries of everyday and are tempted to despair. But as people of God we can never allow ourselves, or the world, to stop daring to hope. That phrase, to 'dare to hope' comes from chapter 3 of the Old Testament book of Lamentations:

"Yet I still dare to hope when I remember this: The faithful love of the Lord never ends! His mercies never cease. Great is His faithfulness; ... therefore, I will hope in Him!"

That's the kind of hope that kept Saint Patrick going in his captivity; that's the Hope which sustained the faith of our fathers in Ireland in spite of persecution, famine and forced displacement. That's the Hope which sustained the Irish who came here as immigrants in famine times with little more than the clothes on their backs, but

were inspired to dream, to pull themselves up, and to help build a brighter future for themselves and their families.

The Christian Hope which we celebrate during this Jubilee year is much more than human optimism. It is a Hope forged in adversity which confronts the difficulties of this life with eyes fixed on the Risen Lord.

I've been thinking today about those who built the two beautiful Cathedrals of Saint Patrick, here in New York, and back home in Armagh. Both Cathedrals were constructed in tough times largely from the pennies of the Irish, at home and in the diaspora. The two cathedrals were opened in the 1870s, just six years apart; and interestingly, both have twin spires, reaching to the skies, daring to 'hope against Hope' and pointing to our shared heavenly homeland.

Our patron Saint Patrick was indeed a pilgrim of hope who felt strengthened and protected by God in good times and bad, even when insulted and imprisoned. He tells us himself that he simply couldn't be silent about the great blessings and gifts so kindly bestowed on him in the land his captivity. He had a deep conviction that he was called to be a witness to faith, hope and love, to spread the name of God 'faithfully and without fear' — Patrick believed that the work of a missionary was a 'holy and wonderful work', something for which he was prepared to willingly give up his life.

No doubt our ancient ancestors would have spoken about Patrick in words like those of the prophet Isaiah in todays first reading:

"How beautiful upon the mountains are the feet of the messenger who announces peace, who brings good news and announces salvation". Isaiah 52:7 I've been thinking a lot about peace during my pilgrimage of hope this last few days. On Friday I travelled to Capitol Hill in Washington DC to reflect with my good friend the Church of Ireland Archbishop John McDowell about the unfinished work of peace and reconciliation in Ireland. Many of the young adults who were attending our talk had little or no memory or knowledge of the violence and conflict that had happened in the island of Ireland. I thanked God for the fact that the beautiful island of Saint Patrick is no longer making the headlines because of death and destruction on our streets.

One young man took me aside afterwards and said "Archbishop, we need to speak more than ever about peace and reconciliation and fraternity, because the world seems to be getting more fragile and fragmented. There's more talk now about rearmament among nations than about the needs of the hungry and the common good". I sensed in his words a yearning for Hope.

Yesterday when I visited the Ground Zero 9/11 memorial with a group of young people from Saint Paul's High School, Bessbrook in County Armagh. One of the

young girls asked me, "Archbishop could this happen again?" And I said, you and I must have hope in God and work and pray for peace to make sure that it never does.

Friends, as sons and daughters of Saint Patrick, somewhere deep inside all of us, the voice of God is challenging us to be pilgrims of hope in this troubled world. I pray this Saint Patrick's Day day that every one of us here will have the courage and strength: to be fearless ambassadors of Hope and charity; energetic peacemakers; compassionate carers for the sick and the lonely; faithful stewards of God's creation; generous helpers of the poor and the marginalised, and welcoming friends for those who, like Patrick and so many of our Irish ancestors, are forcibly displaced from their homeland.

Wexford Delegation strengthens economic and strategic ties in US visit to Savannah and Atlanta.

Wexford County Council has returned from a successful delegation visit to Savannah and Atlanta, Georgia which has paved the way for further significant economic, educational and cultural development opportunities for County Wexford.

Led by An Cathaoirleach, Cllr Pip Breen and comprising municipal district representatives, senior council officials and enterprise leaders, the visit built on the long-standing sister city agreement with Savannah and explored new trade and investment opportunities in Atlanta. The visit sought to deepen economic linkages, develop strategic partnerships, and promote educational and cultural exchange with key institutions and organisations in both regions.

Economic and Infrastructure Development

A highlight of the visit was the delegation's strategic engagement with the Georgia Ports Authority. Strategic discussions focused on shared infrastructure challenges and growth strategies. This knowledge sharing partnership is expected to drive innovation, knowledge exchange and infrastructure development critical to the South East Region of Ireland. Our partners Wexford Enterprise Association joined Wexford County Council at a business forum with our Tradebridge partners Savannah Economic Development Authority.



Through engagements with Enterprise Ireland, the IDA and the Consulate office and business organisations, the delegation promoted Wexford as a prime location for trade, investment, research and innovation. Further strengthening trade ties, the delegation explored opportunities to expand the Tradebridge programme, originally developed between the South East of Ireland and 16 counties in South East Georgia into the greater Atlanta region.



Educational and Cultural Exchange

The delegation were guests of honour at the Georgia Southern University, Statesboro Campus launch of the **Wexford HUB** at the Henderson Library which is a designated key location space at the university of 26,000 students building on the intake programme of students coming to Wexford which commences at the end of Spring. To date the successful relationship has seen over 300 students attending the GS International Learning Campus in Wexford. In addition, discussions took place on further developing the iconic adoration convent in Wexford which will see over €6 million investment to a new student accommodation. A new focus of the linkages with GS are the opportunities for research and innovation with SETU and its application to opportunities for both regions.



High Level Political and Civic Engagement

The delegation's presence at the Savannah St. Patrick's Day Parade, attended by over 800,000 people, showcased Wexford on an international stage with the Cathaoirleach conducting TV media interviews regarding the collaboration between our two regions.



In Atlanta, An Cathaoirleach cllr Pip Breen addressed the Georgia House of Representatives and was honoured with a proclamation from Speaker of the House, Jon Burns, reinforcing strong diplomatic ties and recognising County Wexford's contribution to international partnership and cultural diplomacy. Wexford was honoured to be the first County in Ireland to be recognised by the Georgia House of Representatives in recognition of the key achievements of the linkages with Savannah, Georgia Southern University and Tradebridge.





An Cathaoirleach Cllr. Pip Breen said "This visit has further strengthened the foundations for long term economic growth, international collaboration and shared learning. Our engagements in Georgia open exciting new doors for County Wexford in areas from port development and renewable energy to education and enterprise"

Chief Executive Eddie Taaffe commented "The relationships built during this visit will contribute directly to job creation, infrastructure advancement, educational exchange and the global promotion of Wexford as a dynamic future focused county".

Wexford County Council Delegation Report Hartford, Connecticut - 13th to 18th March 2025

In recognition of the strong bond of the Sister City relationship between Hartford and New Ross since 1995, the Central Connecticut Celtic Cultural Committee invited a delegation from New Ross Municipal District to attend the 53rd Annual Greater Hartford St. Patrick's Day Parade. The parade is a huge event each year with c.60,000 spectators lining the streets of Hartford and is always held on the Saturday before St. Patrick's Day.

The NRMD was delighted to accept the formal invitation and Councillors Pat Barden and John Fleming were nominated to attend, along with Mick Mc Cormack TRO deputising for Alan Fitzhenry District Manager NRMD.

In advance of the trip, the NRMD began requesting and setting a series of meetings in Hartford, in order to discuss economic, educational and cultural connections and how best to progress and grow the link into the future.

ITINERARY

Thursday 13th March

An early start and a full day of travel. Our group travelled from Dublin Airport to Boston and transferred on to Hartford, Connecticut.

Note: Direct flights from Dublin to Hartford with Aer Lingus re-start at the end of March, meaning better connectivity for the large population of Irish Heritage.






Friday 14th March


We were collected early and brought to Fox61 for television Interview. Fox 61 is a television station in Hartford, Connecticut serving the Hartford-New Haven market and an affiliate of the Fox Network. We did a 10 minute live broadcast with Fox 61 news teams and promoted New Ross and County Wexford and explained the sister city links between, New Ross and Hartford. This station has high viewer figures around Connecticut and has a high audience share.





Following this we met and had constructive meetings with Julio Concepcion and his colleagues from Metro Hartford Alliance. We had a good discussion with Julio and the team at Metro Hartford Alliance around regeneration of the downtown area, challenges in relation to vibrancy and footfall in the town centre and discussions about how these challenges could be overcome.





We then travelled to City Hall for a Civic Reception with the Mayor of Hartford City Council, Arunan Arulampalam along with his fellow City Councillors and Town Clerk Denise Petteys. During the reception, speeches were made along with official presentations. We had extensive discussions with the City Councillors and spoke on many issues and how the relationship between the sister cities could be strengthened.

We invited Hartford City Council to New Ross and there was a formal proposal that they should visit as a Council in the coming years. The Mayor advised that he would like to see this happen in the next few years and that it would be discussed at upcoming meetings of their Council.





In the evening, we were special guests at the St Patrick's Parade Mass, held in St Anthony's Church. We met with many members of the Irish community and enjoyed a beautiful ceremony full of music. Chairperson Liz Saunders and members of the Central Connecticut Celtic Cultural Committee (CCCCC) then invited us to a pre-parade dinner and presentations were made between the groups.

Saturday 15th March

A very busy Parade Day started with an invitation to a breakfast event hosted by Congressman John Larson. The Wexford Council delegation was warmly welcomed at the Society Rooms in Hartford and here we met with a number of influential Irish American politicians and officials and we spoke of Irish/American issues and of the links between New Ross and Hartford.


We spoke with Congressman Larson afterwards at length about Wexford and New Ross and about our sister city relationship with Hartford.





Our delegation then gathered outside the State Capitol building and formed in Division 1 of the 9 Division St. Patrick's Day Parade. A massive cultural event annually, the parade route was lined with 60,000 people who loudly celebrated and cheered us on. We marched with the New Ross banner around Bushnell Park and down Main Street, before joining CCCCC members on the parade

viewing stand to watch the other 8 Divisions of the parade pass by. An event full of colour and music, making us proud to be Irish.





We then travelled to the suburb of Glastonbury to visit the Irish American Home Society as guests of the community & the CCCC along with staff from the Irish Consulate from New York. Here we watched live traditional music and a showcase of Irish Dancing from the children of a local dance school. We met and engaged with many of the diaspora and promoted Wexford as a key holiday destination within Ireland.

Sunday 16th March

Our delegation was invited by members of Hartford GAA to meet with them and we watched a number of games with them at their club grounds. They also thanked us for Visit Wexford partial sponsorship of their scoreboard and advised that the Visit Wexford logo will be going on the scoreboard shortly.

We had a number of meetings also with members of the kennedy cup sister cities golf grouping who will be coming to New Ross in 2026 to continue the strong sporting link between the 2 sister cities. They will compete against the New Ross golfers in and around County Wexford in 2026 and bring a party of up to 20 people to take part in this biennial golfing tournament.



Monday 17th March

On our final full day in Hartford we visited New Ross Park in Hartford and also toured the city meeting with Irish diaspora and promoting New Ross and Co.Wexford. New Ross park is an urban park dedicated in 1995 to commemorate the Sister City relationship. The park hosts a skate park designed by famous American skateboarder Tony Hawk and its external walls are "Wexford Purple".

There are plans due to be presented to the City Council to add a new area to this urban park, which will celebrate important New Ross landmarks, including the Dunbrody Famine Ship.








Tuesday 18th March

LE COTENTIN DELEGATION MARCH 2025 REPORT

Wexford County Council Delegation Report Le Cotentin, France March 2025

Wexford County Council delegation was led by Cllr. Garry Laffan, Deputy Mayor of Wexford Borough Council and included Cllr Pat Kehoe and executive of Wexford County Council.

Hosted by Le Cotentin Council and Office de Tourisme du Cotentin, the aim of the delegation was to explore economic, culture and tourism opportunities between Wexford and Le Cotentin and the possibilities of building on the strategic, civic, economic, education and cultural opportunities between the two regions.

Le Cotentin

Le Cotentin consists of 129 communes and 180,000 inhabitants. It is the 4th largest conurbation in the Normandy region and the 3rd largest community in France.

It is an area of strong innovation in sectors such as agri-food, energy (off-shore wind and nuclear), shipbuilding, engineering and aquaculture. With an oceanic climate and relatively abundant rainfall in each season, the area is highly favourable to grass growth and more than half of agricultural land is grassland. Dairy products account for over 50% of revenue from sale of agricultural products.

There are approximately 10,000 people employed in the food industry in Le Cotentin, with the vast majority in the dairy industry, followed by bakery products, fish and beverages.

The port of Cherbourg is a key gateway to France and Europe, with regular ferry connections. Cherbourg town has a population of 85,000.

Itinerary March 2025

Day 1

We arrived in Cherbourg by ferry in the early afternoon and went directly into meetings. Our first meeting took place at the Cotentin Council where we were welcomed by Christèle Castelein, President of Cotentin Council and remarks were given by the head of the delegation Cllr Laffan, Deputy Mayor Wexford Borough

District, followed by presentations.



The remainder of the afternoon was spent at a number of meetings with the following stakeholders, Cotentin Council, Ports of Normandy, the Office de Tourisme du Cotentin, Brittany Ferries & Stena Line. Those in attendance included the following

Potential areas identified for initial collaboration included

- > Promotion of County Wexford on large screen in Cherbourg Port terminal to encourage tourists to spend time in County Wexford. Reciprocal?
- > Joint approach by both councils to featuring and promotion of food and beverage products from both regions on ferry routes.
- ➤ Le Cotentin in process of bringing 160 farm producers together under one label with the aim of promoting local produce. Potential to link in with Wexford Food Network for cross collaboration and promotion.

The meetings were followed by a visit to the Port Authority in Cherbourg.

In the evening a civic reception took place in Cherbourg Town Hall, which included the official delegation, Visit Wexford representatives, Ladies Football teams, Wexford hurling teams and the New Ross pipe band representatives. The evening concluded with remarks from Deputy Mayor of Cherbourg-en-Cotentin and the Councillor in charge of International Relations (Cotentin Council) where the possibility of establishing a 'twinning' relationship between County Wexford and Le Cotentin was introduced. Cllr Laffen responded on behalf of the delegation.



Following the official remarks a presentation of gifts took place



Later that evening, the delegation had an informal meeting with Michael Dodds, Managing Director of the Normandy Tourist Board and Candice Rousseau, Project Officer for Co-operation with the UK, Ireland and the Channel Islands for the Year of the Normans project to discuss plans for Year of the Normans 2027.

Day 2

Early the next morning the delegation joined reps from Visit Wexford who had a stand promoting Co Wexford as a tourism destination at the Cherbourg Market in Place de Gaulle. This promotional visit was undertaken as part of their strategic aim of attracting greater international visitor numbers to Co Wexford and increasing

dwell time in the county. The New Ross Pipe Band arrived in parade to the square and their lively performance attracted a large crowd to the Visit Wexford stand.



Straight from the Cherbourg Market, the official delegation, Visit Wexford representatives and members of the Cherbourg Community paraded, with the New Ross Pipe Band to Stade Maurice Postaire for an afternoon showcasing GAA as part of the Irish Festival of Le Cotentin.



The afternoon saw Kilmacud Crokes ladies Gaelic football team, play the French National Gaelic football team in a challenge game. This game preceded the Hurling Super 11s final between Naomh Eanna and Faythe Harriers from County Wexford.

Following the Hurling Super 11s hurling final, medals were presented to both teams



In the evening le Cotentin Council hosted a dinner for the official delegation and Visit Wexford representatives at La Maison Rouge a French Restaurant approximately a 15-minute drive from Cherbourg in the coastal area of Anse du Brick. Eimear Ryan Charleton (Second Secretary at Embassy of Ireland France) represented the Embassy of Ireland France at this dinner. Various representatives from le Cotentin were also in attendance.

Day 3

The Official Delegation started their day by attending the start point of the Cherbourg Urban Cultural Trail where over 1,000 participants set off to walk or run through the City of Cherbourg.

Following the start of the Cherbourg Urban Cultural Trail Emmanuel VASSAL, Councillor in Charge of International Relations (Cotentin Council) & Julien BOUGOND, Deputy director Office de Tourisme du Cotentin gave the Official Delegation a guided walk through the city of Cherbourg, highlighting its main historical sites and landmarks.

We departed Cherbourg City at 2.30 pm to catch our ferry from Cherbourg Port.
