The prizes are cash to fund environmental projects in your local community. The results will be announced at Wexford County Council's Environment Awards Ceremony in November. The Council's decision on all matters relating to the competition will be final. Judging of this year's competition will take place by Wexford County Council in June and July.

Judging

The following criteria will be taken into account when judging entries:

- Community effort.
- Litter management initiatives.
- Absence of graffiti, illegal dumping, abandoned cars.
- Planting initiatives e.g. flowers, shrubs, hanging baskets.
- Treatment of communal areas such as open spaces and grass margins.
- Best environment initiatives - recycling / re-use / composting / nature studies / energy conservation / water conservation / waste prevention.
- Best preservation and protection of a heritage site in sympathy with its character.
- Best access initiatives and provision and promotion of inclusive space.
