Note 1 - Conferences and Training Fees are paid directly to conference organisers and not to members

Note 2 - Conferences at Home will relate to Conferences held within the state of Ireland.

Note 3 - Training is provided for members by AILG and LAMA

Note 4 - Conferences Abroad will relate to Conferences held outside the state of Ireland and will include Northern Ireland. In 2020, a number of members were booked to attend a Twinning event in Belgium which was later cancelled due to the Covid-19 pandemic. To date, a partial refund of €377.88 has been obtained in respect of the associated flight costs. The balance of the flight costs incurred is in the process of being recovered from the Airlines concerned.

Note 5 – Members expenses is an allowance to reimburse members for costs incurred in the performance of their duties as Councillors. The travel and subsistence elements of the allowance are calculated by reference to the distance from each Councillor's home to Council Headquarters while the amount for miscellaneous expenses is set by legislation. The allowance is calculated on an annual basis and is paid in monthly instalments. The allowance carries an attendance requirement, with full allowance paid for 80-100% attendance, and reduced pro-rate where attendance is less than 80%.

Note 6 - Representational Payments and MD Allowances are in effect a "salary" type payment to Members. Amounts are set by legislation and are shown in "gross" terms, before deduction of PAYE, PRSI and other statutory deductions
