2. Section 183 of the Local Government Act 2001 :

2.1 Intention to dispose of property at 67 Upper John Street, Wexford Town.

On the proposal of Cllr. G. Carthy, seconded by Cllr. C. Walsh the Council resolved to dispose of property at 67 Upper John Street, Wexford Town in accordance with the terms set out in the S.183 Notice as circulated.

2.2 Intention to lease lands at Spawell Road, Wexford Town (to It's Good to Talk)

On the proposal of Cllr. A.R. O'Brien, seconded by Cllr. G. Laffan the Council resolved to lease lands at Spawell Road, Wexford Town to It's Good to Talk in accordance with the terms set out in the S.183 Notice as circulated.

2.3 Intention to transfer lands at Clonard Avenue, Wexford to St. Aidan's Diocesan Trust

On the proposal of Cllr. C. Walsh, seconded by Cllr. M. Sheehan the Council resolved to transfer lands at Clonard Avenue, Wexford to St. Aidan's Diocesan Trust in accordance with the terms set out in the S.183 Notice as circulated.

2.4 Intention to transfer a portion of land at Tobinstown, Ramsgrange, New Ross, Co. Wexford.

On the proposal of Cllr. M. Sheehan, seconded by Cllr. J. Fleming the Council resolved to transfer a portion of land at Tobinstown, Ramsgrange, New Ross, Co. Wexford in accordance with the terms set out in the S.183 Notice as circulated.

3. Part XI of the Planning and Development Act, 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended)

3.1 LAC2507 - Proposed 50-unit housing development and associated site works at Rosbercon, New Ross, Co Wexford.

Cllr's M. Sheehan and J. Dwyer expressed concerns in relation to the inclusion of apartments in the proposed development, sharing the view that New Ross has a poor history in relation to apartment living. Cllr. Dwyer also expressed concerns in relation to the risk of flooding and the proximity of the nearest primary school. Cllr's J. Fleming and M. Murphy spoke in favour of the development.

Mr. E. Taaffe advised that where possible the concerns of the locals have been addressed and the density on the site is because of its town centre status. Mr. Taaffe outlined that the mix of units within the development is reflective of the housing need in the area. Mr. Taaffe also clarified that all units within the development are own door, and the flood risk has been addressed by the flood scheme.

Having considered the report of the Chief Executive and the matters raised in the Chamber, on foot of a roll call vote the Council resolved to approve the Part 8 for a proposed 50-unit housing development and associated site works at Rosbercon, New Ross, Co. Wexford in accordance with the terms of LAC2507, as circulated. The result of the vote was 26 in favour, 3 against, and 2 abstained. The voting was as follows:

4. Draft Development Contribution Scheme 2026 - 2029 - For Adoption

Ms. L. Hore circulated the draft Development Contribution Scheme 2026 – 2029. Ms. Hore advised that the rates in the current Development Contribution Scheme are unchanged since 2013 and are very low relative to other local authorities. Wexford County Council is therefore constrained in funding capital programmes and is limited as to what can be achieved in the delivery of projects for the County.

The proposed draft charges were brought before the Planning and Building Control SPC at its meeting on the 1st of September 2025. Ms. Hore outlined that the proposed scheme was advertised, and the online consultation portal opened for submissions, on the 24th of September 2025, with four submissions received.

Mr. E. Taaffe advised that development contributions haven't been increased since 2013, yet the cost of providing infrastructure has increased massively. Mr. Taaffe outlined that the current levy as a percentage of the average cost of construction is 0.34% and the new draft scheme will result in a modest increase to 0.77%.

On the proposal of Cllr. M. Sheehan, seconded by Cllr. B.A. Murphy, on foot of a roll call vote the Council resolved to adopt the Development Contribution Scheme 2026-2029. The result of the vote was 29 in favour, and 1 against. The voting was as follows:

The Council noted the content of the Q3 Progress Report on the 2025 Annual Service Delivery Plan, as circulated.

6. Draft Polling Scheme 2025 - For Adoption

On the proposal of Cllr. G. Laffan, seconded by Cllr. B.A. Murphy, and agreed by all, the Council resolved to adopt the Draft Polling Scheme 2025 in accordance with Section 28 of the Electoral Act 1992, as amended, and the Electoral (Polling Schemes) Regulations 2021.

7. Chief Executive's Report

The Chief Executive and members of the Management Team responded to a wide range of queries from the Elected Members regarding the following:

- Concerns raised in relation to the Paddocks development in Coolcotts and the alleged failure of the developer to provide telecommunications ducting which may result in footpaths and roads having to be dug up.
- Frustration expressed at the length of time taken to carry out some housing repairs such as the replacement of doors.
- Request for figures on the number of successful appeals of housing decisions.
- Update sought on the group housing scheme for the families in Park.
- For those who are refused access to Ozanam House, where do they go for accommodation? Request that no-one be refused an emergency bed.

Cathaoirleach Cllr. J. Sullivan informed the Councillors that an envelope is circulating through the chamber, and all are invited to make a voluntary contribution to the Cathaoirleach's chosen charity which is St. Aidan's Services.

- Wexford County Council was commended on the Cnoc na Greine affordable housing launch.
- What is the social housing retrofitting target for 2026?
- Explanation sought as to why there are 114 transfer applicants on the housing list for Rosslare Municipal District.
- Request for a breakdown of the number of tenant-in-situ houses purchased in the Rosslare Municipal District over the past five years.
- What is the value of rent arrears above which admission to Ozanam House will be refused?
- Is there a timeline for the announcement of new social housing eligibility income thresholds nationally?
- When will affordable housing projects be rolled out to all Municipal Districts?
- When will the information night for housing services/schemes be rolled out?
- How much funding is available for taking estates in charge and which estates will be taken in charge first?

- The issue of solar farms and the protest by Gusserane residents against a proposed solar farm prior to the Council meeting was raised. Cllr. M. Murphy outlined the economic impact of his 220-acre farm which sustains his family and employees who earn a living directly from the farm, but also the many related businesses that benefit from it, together supporting a total of 115 people directly and indirectly. Cllr. Murphy said there needs to be a reassessment of the approach to solar farms, outlining his view that it makes no sense to use prime agricultural land for solar farms. Cllr's M. Sheehan, J. Fleming, P. Barden, V. Barron, L. McDonald, P. Breen, J. Dwyer, A.R. O'Brien, J. Codd, and G. Carthy expressed support for the Gusserane resident's protest.

Cllr. G. Carthy expressed the view that the Councillor's should bring forward a material contravention to curtail solar farms. Cllr. Carthy requested legal advice in relation to this matter. Cathaoirleach Cllr. J. Sullivan committed to seeking legal advice on behalf of the elected representatives.

- Update sought on the taking in charge of Pondfields and Parkfield estates.
- Request that the Council consider an economic plan for the County like the "Positioning Wexford for the Upturn" plan.
- Update sought on the three houses to be developed in Adamstown.
- Concern expressed that carbon offsets from solar farms are being taken out of the agricultural sector and being offset against businesses.
- Can Wexford's eligibility for Clár funding be reviewed?

The meeting adjourned for a comfort break at this point.

12. Notices of Motion

12.1 Cllr. AR. O'Brien

“Wexford County Council calls on the Minister for Housing, Local Government and Heritage, and the Minister for Justice, to develop and implement a clear national policy and legislative mechanism enabling local authorities to remove perpetrators of domestic violence from joint tenancies where a tenant has been found, through appropriate legal or protective processes, to have perpetrated domestic abuse against another tenant or occupant, in order to protect victims and other household members.

Further, that this policy should prioritise the safety and housing security of victims, ensuring that survivors of domestic violence are not placed at risk of homelessness or forced to leave their homes because of the abusive behaviour of another joint tenant.

This policy will also provide local authorities with explicit statutory authority to amend or sever joint tenancies in circumstances where a tenant has been found, through appropriate legal or protective processes, to have perpetrated domestic abuse against another tenant or occupant.

Wexford County Council further requests that these measures be progressed as a matter of urgency in order to strengthen protections for victims of domestic violence and to support local authorities in maintaining safe and stable social housing environments.”

This motion was proposed by Cllr. A.R. O'Brien, seconded by Cllr. M. Farrell and agreed by all.

12.2 Cllr. J. Fleming

“That Wexford County Council calls on the Minister for Rural and Community Development and the Gaeltacht to give the power to Dog Wardens to force dog and horse owners to microchip their animals and if not compliant to issue a large fine and to confiscate the animal concerned, if necessary.”

This motion was proposed by Cllr. J. Fleming, seconded by Cllr. P. Kehoe.

Cllr. G. Laffan proposed the following amendment which was accepted by Cllr. J. Fleming and agreed by all:

“That Wexford County Council calls on the Minister for Rural and Community Development and the Gaeltacht to give the power to Dog Wardens to enter private property and to force dog and horse owners to microchip their animals and if not compliant to issue a large fine and to confiscate the animal concerned, if necessary.”

12.3 Cllr. M. Sheehan

“That this Council calls for the appointment of a dedicated Minister of State with responsibility for animal welfare and pet control to oversee the overhaul of legislation, regulation and protection of animal welfare including empowering wardens to impound and punish those in breach of the recognised regulations.

Furthermore, we call on the government to engage and consult with registered dog breeders on the optimum suite of effective reforms and regulations and punishments for those found to be neglecting or abusing animals.”

This motion was proposed by Cllr. M. Sheehan, seconded by Cllr. A.R. O’Brien and agreed by all.

12.4 Cllr. AR. O’Brien

“Wexford County Council calls on the Minister for Children, Equality, Disability, Integration and Youth to ensure that Tusla is adequately staffed, fully resourced, and subject to strengthened monitoring mechanisms so that it can meet its statutory responsibilities in a timely, effective and child-centred manner.

Further, that the Minister ensure sufficient staffing levels across all Tusla service areas, including child protection, social work, family support, early intervention, and foster care in a timely manner.

Lastly, we call on the Minister to prioritise enhanced oversight and performance monitoring, ensuring that service delivery standards are maintained, cases are managed promptly, and children and families receive the support they require.”

This motion was proposed by Cllr. A.R. O’Brien, seconded by Cllr. M. Sheehan and agreed by all.
