1. Presentation by ESB Generation about €150m investment in Wexford- the Wexford hub utility solar generation project, together with a new 110kV substation at Dennistown.

Sean Moroney, Eoin Naughton and Conor Sheridan from ESB Generation gave a presentation which included an introduction to the ESB Net Zero Strategy, South-East Region; ESB Utility Scale Solar Electricity Generation; The Wexford Hub Solar Park. Mr. Moroney and colleagues answered a multitude of questions.

Mr. E. Taffee, Chief Executive welcomed the more than €148m investment in infrastructure in the county providing clean, green and renewable energy while also providing €1m in rates to the Council and the approximate €250k Community Benefit Fund.

10. Notices of Motion

10.1 Cllr. J. Fleming

"I am calling on the Minister for Transport when allocating roads funding to our County Councils annually to use a funding mechanism which takes account of previous funding allocations, the level of local investment in road maintenance from the Council's own resources, and the results of pavement condition studies as this is the fairest and most practical way."

Cllr. T. Forde proposed an amendment to the motion to seek funding based on the kilometres of road in the county.

The proposed amendment was accepted by Cllr. J. Fleming.

On the proposal of Cllr. J. Fleming, seconded by Cllr. M. Sheehan and agreed by all, the following amended motion was carried:

"I am calling on the Minister for Transport when allocating roads funding to our County Councils annually to use a funding mechanism which takes account of previous funding allocations, the level of local investment in road maintenance from the Council's own resources, the total kilometres of road in the county and the results of pavement condition studies as this is the fairest and most practical way."

10.2 Cllr. M. Sheehan

"In an effort to protect our urban centres and to increase transparency in the planning system , this Council calls on the Minister for Housing, Local Government and Heritage, James Browne TD to reform the Planning Exemption processes by amending the Planning and Exempted Development Regulations, namely Section 5 and 6 (as amended 2023) to give Planning Authorities greater flexibility to protect our retail and town centres and to introduce an input of public submissions into planning exemption requests."

The motion was proposed by Cllr. M. Sheehan, seconded by Cllr. J. O'Rourke and defeated on a show of hands.

10.3 Cllr. A.R. O'Brien

"With regard to the emergency rent supplement support for victims of domestic violence, I call on this council to write to the Minister for Social Protection requesting to include referrals from An Garda Síochána in the eligibility criteria; and that a referral from either An Garda Síochána or Tusla is satisfactory and appropriate for both individuals and families experiencing domestic violence; noting that the absence of this referral may exclude some individuals from this vital emergency support."

The motion was proposed by Cllr. A.R. O'Brien, seconded by Cllr. M. Farrell and agreed by all.

10.4 Cllr. T. Forde

"We ask that this council create a permit system, and standardised designs, that would allow businesses to apply to use signage on bollards/sandwich boards throughout the county, as long as they are not creating an obstacle for any pedestrians or road users. We also ask that the views of elected members be factored into any change of approach from the council towards such signage." Cllr. V. Barron proposed an amendment to the motion to refer to a solution being the permitting of elevated signage on business premises which was seconded by Cllr. C. Walsh.

On a show of hands, the following amended motion was carried:

"We ask that this council create a permit system, and standardised designs, that would allow businesses to apply to use signage on bollards/sandwich boards throughout the county, as long as they are not creating an obstacle for any pedestrians or road users or to consider the permitting of elevated signage on business premises as an alternative solution. We also ask that the views of elected members be factored into any change of approach from the council towards such signage."

10.5 Cllr. C. Walsh

"This Council, mindful of persistent assault on the Palestinian People by Israeli Defence Forces, calls for the immediate cancellation of the EU/Israel Trade Deal, the enactment of legislation to ban goods from Occupied Territories and the deployment of UN peacekeepers to protect and distribute humanitarian assistance. If passed, this motion is to be forwarded to the Tánaiste, and Minister for Foreign Affairs and Trade.

The motion was proposed by Cllr. C. Walsh, seconded by Cllr. L. Kelly and agreed by all.

10.6 Cllr. J. Fleming

"I am calling on the Minister for Rural and Community Development to increase the funding allocation for the Local improvement scheme and to allow a choice of either works by the applicants or payment for their percentage contribution."

The motion was proposed by Cllr. J. Fleming, seconded by Cllr. B.A. Murphy and agreed by all.

"That this Council calls on the Minister for Housing, Local Government and Heritage, James Browne TD to amend Section 12 of the Residential Tenancy Act 2004 to eliminate blanket bans on pets in tenancy agreements thereby reducing the number of pets being surrendered and abandoned. If passed, this motion is circulated to all Councils nationwide."

The motion was proposed by Cllr. M Sheehan, seconded by Cllr. T. Forde and agreed by all.

10.8 Cllr. A.R. O'Brien & Cllr. L. Kelly

"This Council is gravely concerned that the Central Bank of Ireland is regulating the Israel Bonds Issuance Programme and, thereby, facilitating the sale throughout Europe of bonds which are funding genocide in Gaza. The Central Bank is facilitating Israel to allow it to finance its war operations. This Council notes that

(1) the bonds, known as Israel Bonds, have, since 1951, raised funds for the Israeli Treasury for use across the Israeli economy including the financing of the apartheid system, the Israeli military and illegal settlements

(2) the bonds are now being advertised as war bonds and are funding the genocide in Gaza

Wexford County Council further notes that

(1) in January 2024 the International Court of Justice (ICJ) confirmed the plausibility of the charge of genocide against Israel

(2) in June 2024 the UN's International Commission of Inquiry on Palestine found that Israel's actions in Gaza "constitute the war crimes of wilful killing and mistreatment, and the crime against humanity of extermination"

(3) in July 2024 an ICJ ruling declared that Israel is committing the crime of apartheid and its entire regime of military occupation of Palestinian territories is illegal and must end immediately

(4) all institutions are under obligation under international law to prevent genocide and abuse of human rights

Wexford County Council, therefore, calls on the Central Bank of Ireland to immediately end the regulation of the Israeli Bond Issuance Programme."

The motion was proposed by Cllr. A.R. O'Brien, seconded by Cllr. L. Kelly and agreed by all.

10.9 Cllr. T. Forde

"This council calls on Fianna Fáil Minister for Housing James Browne to re-examine the income thresholds for social housing applicants and also to end the practice of including payments such as the Working Family Payment (WFP) as a means of income when applying for housing supports.

Such payments aim to give extra financial support to people on low pay, but this continuing policy is directly resulting in the exclusion of lower income families from qualifying for Social housing supports."

The motion was proposed by Cllr. T. Forde, seconded by Cllr. J. Sullivan and agreed by all.

A.O.B.

Cllr. L. Kelly welcomed plans to make the Adoration Convent gardens at Bride Street accessible to the public.

Cllr. L. McDonald sought a response from Mr. E. Hore to recent negative commentary from some quarters in relation to the 2027 Year of the Normans Commemorations.

Cllr. Pip Breen informed the chamber that it was his last meeting as Cathaoirleach. He said he enjoyed his time as Cathaoirleach and thanked fellow Members and the Management Team for their support.
