# 2.1 District Managers Report

The District Manager delivered his report.

# **Nollaig – A Traditional New Ross Christmas**

He advised the members that the district is looking forward to a traditional New Ross Christmas this year with the Chairman Cllr Pat Barden and Santy himself turning on the Christmas Lights at the launch of New Ross Christmas 2021 outside the Tholsel on the 20<sup>th</sup> November and asked everyone to support New Ross and District again this year. The Members agreed that Sophie Becker would also be asked to switch on the lights.

# **CCTV**

The New Ross Town CCTV scheme as presented to the Members was advertised on the 28<sup>th</sup> of Sept and is out for public consultation. The link was given to the Members and all were encouraged to review the plan and submit observations

## **Wexford Rally**

The Members were advised that the Wexford Rally has chosen to locate their base this year in New Ross at the albatross site which brings significant economic benefits to the Town and District and that the Wexford Rally 2021 would take place this weekend in the New Ross District. The District Manager commended Wexford Motor club for their engagement and acknowledged and thanked Cllr Anthony Connick for his role in helping maximise the opportunities from Wexford Rally 2021 in New Ross Town and District. Cllr Connick thanked the Officials and the Gardai for their assistance with the Rally.

# **Streetscape Enhancement Measure 2021.**

There was huge Interest in the Streetscape Enhancement Scheme 2021 with the Lions share coming to New Ross with 41 successful applications with a total cost of

works set at €221,553 and funding approved of €111,925. The District Manager commented that this is a massive endorsement in our Town by the traders which shows the optimism and pride that traders have for their Town and Businesses.

### **Destination Towns**

Work is continuing on the Destination Towns project. Most notable features of the programme over the last few weeks were the finishing of crests on Cook's lane and the civil works for the Arches on Brennan's Lane.

#### **Pedestrianisation**

Preliminary Meetings have taken place with the Consultants regarding the Pedestrianisation proposal and a first draft of the Feasibility study for New Ross Town was received which will have to be backed up with further vehicular traffic analysis and studies before bringing to the members in the near future.

# **NRMD Venue for Council Meetings**

St Michaels Theatre was booked out for today's meeting and as a result we have come to the Brandon House Hotel. An announcement is awaited regarding a return to normality on the 22<sup>nd</sup> of October in relation to returning to the Tholsel for the next meeting if conditions and regulations allow.

# **Playground Pearse Park**

A stare date of 18th of October has been agreed for the playground with a completion date prior to Christmas.

## **St Kearns Explosion Commemoration**

The District Manager congratulated the organisers of the St Kearns explosion Commemoration on their event over the previous weekend and the organising Committee have thanked the Council for their support with the event.

## **Monument to Commemorate World War 1**

A monument is being procured to commemorate all of those who fell in the great War from the New Ross area, for a suitable site at St Stephens Cemetery and it expected to officially unveil it by Armistice Day which is the 11<sup>th</sup> of Nov.

# **Eugene O'Neill Festival**

The District Manager invited all Members to the official opening event of the Eugene O'Neill Festival on this Friday in St Michaels Theatre New Ross. He informed them that this year's main event is being filmed and will be streamed to our friends in Danville many of whom would normally be here but because of restrictions, will enjoy the events from the US. He thanked the organising committee who have done great work in making this festival happen yet again this year and he advised the Members that the Municipal District will continue to work with the committee and WIT in

exploring the possibilities of moving this friendship from Cultural and Civic to creating sustainable enterprise links and partnerships between the 2 Towns.

# **LAMA All Ireland Community and Council Awards**

The Members were informed that New Ross Municipal District has been shortlisted for the finals of the All Ireland LAMA Community and Council Awards 2021 in the Arts and Culture Category for the Summer Sessions 2021, giving National recognition to New Ross yet again.
