1. Confirmation of Minutes:

1.1.1 Minutes of the October Meeting of the Members of the Municipal District of Enniscorthy – 21st October 2025

On the proposal of Cllr Byrne, seconded by Cllr O'Rourke, the Minutes of the October Monthly Meeting of the Members of the Municipal District of Enniscorthy held on 21st October 2025 were adopted by the Council and signed by the Cathaoirleach.

1.2 Matters Arising

- Cllr. O'Rourke wished to correct the record regarding a letter he had written to the GAA about parking at Pearse Road on match days – correspondence was not issued to Derek Kent as stated at the October meeting.
- Cllr Kehoe confirmed that he had spoken to the Secretary of Fixtures who apologised for the recent overlaps in fixtures. The various sporting organisations will be liaising with each other to allow time between matches, and this will make it easier for local residents and ease congestion.

Sandra Martin then updated the members about Phase 2 of CCAP funding – closing date for applications is 16th December 2025. Cllr Browne enquired about eligibility for groups who had already received funding in Phase 1. Ms Martin confirmed that they could apply but priority will be given to first time applicants.

2.1 Planning

The Planning reports circulated prior to the meeting were noted.

Executive planner David Wall attended on behalf of planning. He confirmed that the Draft Local Area Plan for Enniscorthy is due to be published before Christmas. A discussion took place about plans for rural villages and cluster developments with a communal septic tank. Mr Wall confirmed that there are plenty of applications for such development, but the problem is when things go wrong who is responsible and there are many developments not taken in charge as a result, which is a problem. Zoning for larger towns is a priority.

2.2 Community, Environment, Libraries & Fire Service

The Community, Environment, Libraries and Fire Service reports circulated prior to the meeting were noted and various issues discussed – in particular: -

- CCTV for dumping hotspots no update
- Prosecutions in respect of illegal dumping Executive Scientist Siobhan Murphy to revert on numbers of prosecutions for 2025.

The members were advised if they are aware of specific dumping blackspots, other than those listed for the pilot, to let the Council know.

2.2.1 Presentation by Wexford Football Alliance

Mr Tony Doyle from Wexford Football Alliance updated the meeting about the Enniscorthy Astro pitch. The Wexford Football Alliance (WFA) is a not-for-profit organisation and run by a committee founded in February 2024. The facility is very busy and is running well and the new online booking system will enhance this. There is a caretaker part paid/part voluntary. There will always be a need for staff even when the facility is automated.

The members praised the facility and raised some issues of concern, in particular: -

- Booking fees
- Priority booking for local clubs

Mr Doyle advised that the booking rates are consistent with other all-weather facilities and that any monies accrued by the WFA are channelled back into the maintenance and upkeep of the facility.

Mr Doyle advised that while it is an automated booking system there is priority for Enniscorthy Clubs, and no one can monopolise the bookings.

2.2.2 Presentation by Wexford Library Services

County Librarian Eileen Morrissey and Executive Librarian for Enniscorthy Trish Keenan gave a presentation on the range of services available through the Library Service. The members were unanimous in their praise of the service. Ms Morrisey also asked that the members encourage people to participate in the Library Survey which feeds into the Library Development Plan due to be launched in 2026. The library particularly wants to hear from people who are not accessing the service to see how they can further adapt to their needs.

2.3 Housing

The reports circulated prior to the meeting were noted. The members raised some issues, in particular:-

- Progress on the Lyre
- Developments in rural areas
- Acquisition of land

Senior Staff Officer, Caroline Creane advised that the Lyre has Stage 1 funding. Further archaeological tests are being carried out. While the land transfer is not complete this is not delaying pre-development work. It is hoped that the project will reach Stage 2 in 2026.

Cathaoirleach Cllr Murphy stressed the need be more ambitious in the district, building one or two houses in villages where people still want to live. Clarification is needed from Uisce Eireann on capacity.

Cllr Kehoe stressed the need for land acquisition rather than waiting for developers to come to the Council. Ms Creane advised that an Expression of Interest for houses and land had been advertised with a closing date of 13th November and a further one

will be advertised in early 2026. Director of Services Carolyne Godkin advised that the Council is actively looking at land purchase. The new Housing Plan has been launched, and Wexford County Council will now put their programme together based on this.

Cllr O'Rourke requested that the HDM1 form be amended so that the GP is required to provide more specific information on housing need. Roseanne Redmond to revert on this but did comment that this form is a national one.

Cathaoirleach Cllr Murphy at this juncture called for a break in the meeting to allow for tea at 10:34 am. The Meeting resumed at 10:47 am.

2.4 Municipal District Report

Enniscorthy Municipal District Parking Bye-Laws 2025

The Enniscorthy Traffic and Car Parking Bye-Laws 2025 were adopted by the Members at a meeting held on the 10th October 2025 and come into effect from 12th November 2025. Details can be found on Wexford County Council website in the following link.

National Supervalu Tidy Towns Competition

Enniscorthy Town CCTV Project

The civil works and electrical work on the Enniscorthy Town CCTV project are now complete. Educom will commence with the CCTV installation works on 17th November.

Bunclody CCTV Project

No further update. Awaiting authorisation from the Garda Commissioner.

Enniscorthy Digital Retail Village

The Enniscorthy Digital Retail Village (DRV) pilot scheme continues to progress positively. Thank you to all the retailers for their interest and enthusiasm in supporting the Digital Retail Village initiative.

Due to strong demand Wexford County Council has agreed to support an additional five businesses bringing the total number of participating businesses to 15.

Working closely with Tap Retail, the final 15 have now been selected. However, should any of the chosen businesses be unable to fulfil their commitment to the scheme we will revisit other applicants.

Wexford County Council hope to secure additional funding in early 2026 to extend participation to more businesses.

The Digital Retail Village will be up and running for the busy Christmas period. More details to follow regarding the official launch.

Creative Ireland Wexford Culture Team Project 2026

Artist in Residence at Eadan's Glen Social Housing Estate, Ferns

The Creative Ireland Programme and the Housing Section at Wexford County Council in partnership with the Enniscorthy Municipal District propose to engage an artist to complete a residency at Eadan's Glen between February and October 2026.

The residency will support the development of a Residents' Association and build upon the sense of community already established there. It is intended that this creative residency will meaningfully connect the residents of Eadan's Glen not only to each other, but also to the wider community of Ferns. The main objectives are to provide a programme of activity including workshops and events; to develop an event for Crinniú nan Óg 2026; to establish a Residents Association.

Residents have been informed of the project, and the Residency has been advertised through the relevant channels.

The members congratulated the various Tidy Towns teams on doing such great work in the district and all improving their score from the previous year. Cllr Murphy praised the work which is all voluntary and suggested that an information evening be organised for the groups early in 2026 to help them prepare for the next round.

District Manager, Claire Lawless confirmed that there has been a great response to Enniscorthy Digital Retail Village. A workshop has taken place to onboard the participants, and it is hoped that the retail village will be launched in early December.

2.5 Roads Report.

The Roads Report circulated prior to the meeting was noted.

The members praised the efforts of Neil Dempsey, Roads Engineer and his crews for their efforts during Storm Claudia the previous weekend.

Mr Dempsey responded to various queries and questions from the members as follows: -

- Works at the Duffry a new curbline has been put in and space left for planting/biodiversity
- Old Dublin Road works are finishing up for now as there is no further funding.
- N80 crash barriers and manholes hope to get funding for these in 2026.

2.6 Flood Defence Scheme Report.

Enda Waters, Engineer from Special Projects attended the meeting in place of Larry McHale. He confirmed that the Public Consultation is on Wednesday 26th November in the Riverside between 3.00 pm and 8.00 pm and he encouraged the Members and members of the public to attend.
