# 1.1 County Council Meeting 14.02.2022

On the Proposal of Cllr. M Sheehan, seconded by Cllr. A Donohue, the Minutes of the Special County Council Meeting of 14.02.2022 were adopted by the Council

# 1.2 Protocol Committee Meeting 01.11.2021

On the Proposal of Cllr. P Breen, seconded by Cllr. J Moore, the Minutes of the Protocol Meeting of 01.11.2022 were adopted by the Council.

# 2. Part XI of the Planning and Development Act, 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended):

#### 2.1 LAC 2109

Proposed development – demolition of all existing structures on the old Tesco site and protection of adjoining remaining structures; a new temporary surface carpark with provision of circa 120 standard spaces; perimeter and internal footways; new 2 m wide footway to TK Maxx side of Oyster Lane, Corten steel architectural structure with infill planting on Crescent Quay frontage; public lighting; drainage and other miscellaneous services and associated works at Crescent Quay, Wexford, Co. Wexford.

Having considered the report of the Chief Executive in relation to the proposed development, and on the proposal of Cllr. G. Laffan, seconded by Cllr. M Bell, the Council unanimously resolved that the proposed development proceed as recommended in the Chief Executive's report.

#### 2.2 LAC 2110

Proposed construction of 30 no. residential units at Wexford Street, Gorey, Co. Wexford

Having considered the report of the Chief Executive in relation to the proposed development, and on the proposal of Cllr. A. Bolger, seconded by Cllr. J. Sullivan, the Council unanimously resolved that the proposed development proceed as recommended in the Chief Executive's report.

#### 2.3 LAC 2111

Proposed development of Public Realm Works to Create New Public Open Space at The Quay, New Ross, Co. Wexford.

Having considered the report of the Chief Executive in relation to the

proposed development, and on the proposal of Cllr. M Whelan, seconded by

Cllr. M Sheehan the Council unanimously resolved that the proposed development proceed as recommended in the Chief Executive's report.

#### 3. Section 183 of the Local Government Act 2001:

3.1 Proposed intention to transfer air title of annex at the rear of 24 Lower George's Street, Wexford which overhangs the garden of the adjoining Council owned property at 1 & 2 Abbey Street, Wexford.

Having considered the statutory S. 183 Notice in respect of the proposed intention to transfer air title of annex as circulated and on the proposal of Cllr. G. Lawlor, seconded by Cllr. M. Bell, the Council unanimously resolved that the transfer of air title proceed in accordance with the terms of the Notice.

3.2 Proposed intention to lease Drumgoold Community Centre to Ferns Diocesan Youth Service Ltd.

Having considered the statutory S. 183 Notice in respect of the proposed lease as circulated and on the proposal of Cllr. A. Bolger, seconded by Cllr. C. Byrne, the Council unanimously resolved that the lease proceed in accordance with the terms of the Notice.

# 4. Wexford County Development Plan Review

4.1 Strategic Environmental Assessment and Natura Impact Report on the Draft Plan and Proposed Material Alterations to the County Development Plan.

Before the decision on proceeding to the next stage of the Development Plan was discussed two notices of motions were put to the floor as follows:

#### 4.2 Notices of Motion

4.2.1 It was proposed by Cllr J Fleming -

To amend Section 5.7 of Volume 10 Energy Strategy contained in the Draft Plan to require that Wind turbines are located a minimum of 400m from an adjoining landholding and a minimum of 6 times the tip height of the wind turbine or 900m (whichever is the greater) from a residential property.

(Relevant submission WXF- C3-164)

Reason: To minimise impacts on adjoining residences and

properties in the interests of the proper planning and

development of the area.

Following discussion on this matter and advice from the Senior

Planner, Cllr J. Fleming withdrew this Motion.

**4.2.2** It was proposed by Cllr J Fleming and seconded by Cllr C Byrne -

To not add the Farmhouse at the Mayne, Enniscorthy (RPS Reference 15702006) to the Record of Protected Structures. (Relevant submission WXF-C- 31).

Reason: The protected status of the house is not compatible with the zoning of the surrounding lands.

Following discussion on this matter and advice from the Senior Planner Cllr J. Fleming withdrew this motion.

At this point in the meeting Mr. D Houston advised the members that the specialist consultants engaged to carry out environmental assessments of the Draft Plan had completed their assessments and that these were circulated for the Members consideration in advance of the meeting.

Mr. Houston drew the Members attention to the conclusions of the assessments and stated that the proposed material alterations and the associated assessments could now proceed to the next stage and be placed on public display.

On the proposal of Cllr P Breen and seconded by Cllr Oliver Walsh the Council unanimously resolved to proceed to the next stage of the development plan process.

# 5. Extension of Duration of Gorey Local Area Plan.

In relation to the Gorey Town and Environs Local Area Plan 2017-2023, following a discussion, Cllr P Breen seconded by Cllr D Devereux requested that the Chief Executive provide a report on the acceptability or otherwise of extending the duration of that plan.

## 6.1 Consideration of submissions received on the Draft Byelaws

Ms. C Godkin, DOS referred to the Report to Wexford County Council on the 135 submissions which were received during the public consultation period for the draft WCC Draft Beach Byelaws 2022 which had been circulated to the members for their consideration

## 6.2 Making of Wexford County Council Beach Byelaws 2022

On the proposal of Cllr J Moore and seconded by Cllr M Farrell the Council resolved unanimously to make the Beach Byelaws 2022. The Council further agreed to undertake a review the 2022 Beach Byelaws within a period of 5 years of the Byelaws being made.

On the proposal of Cllr J Owens, seconded by Cllr M Farrell it was unanimously agreed to accept the invitation to the London Wexford Associations Annual Dinner Dance which would be attended by the Cathaoirleach and Municipal / Borough District Chairs.
