A window on New Ross - 179 years ago

So, how have things changed? What was the situation in New Ross 179 years ago, when the 'Reports and Plans on Proposed Boundaries of Cities and Boroughs in Ireland' (including New Ross), were ordered by The House of Commons, London, 8 June 1832.

- 1832 34 years after the 1798 rebellion.
- 1832 13 years before the building of the original Dunbrody Ship.
- John Hyacinth Talbot, MP, Repeal Association Party, elected to represent New Ross in the House of Commons.
- 1832 William Henry Bartlett, Artist and Architect publishes his iconic drawing entitled 'New Ross'.
- 1832 The Report on New Ross. Read on ...



The full report contains detailed descriptions of 33 Cities and Boroughs. The report on New Ross is reproduced here from the original publication. References are given as to when the town was created a borough, the number of burgesses, baliffs and freemen in the town. The limits of what are called the Corporation Lands are well defined, as are the extent, population and number of houses of all description. Details of the Assessment whether it be 'Borough Cess' or 'Church Rates' are also given as well as the number of rate payers and freeholders. A very detailed description of the proposed boundary and what direction it takes is given. A table shows the result of the inquiry with all the aforementioned details on it.



-NEW ROSS.

REPORT on the Borough of New Ross; with a Description of the Proposed Boundary.

NEW ROSS, otherwise Rosspontum, or Rosspont, is not, as its name might General import, a new Town, but one of considerable antiquity, and is called "New" only Description. to distinguish it from an older place, called also Ross, (now of no importance) in New Ross, an its neighbourhood. New Ross is called an ancient Borough in the Charter that ancient Town. was granted to it by James I.

It is situate on the left bank of the River Barrow, in the County of Wexford, at the distance of 86 statute miles from Dublin. The River is navigable up to the Town for Vessels of 200 tons burthen; and by means of it a considerable Export Trade in Agricultural Produce is carried on. There is a wooden Bridge over the Barrow, which connects the Town with the County of Kilkenny.

There are in the Town 1,040 Houses, of all sorts; and the Population, accord- Population. ing to the Census of 1831, is 6,284; the increase in the last 10 years being about 500. The Town is seated on the side of a steep hill, rising from the River, and its general appearance does not denote prosperity; this, however, we are told is owing to the difficulty that has existed of late years in obtaining land on leases of sufficient duration to encourage building.

2. The Town has received several Charters; one from Richard II, another Charters. from Edward VI, a third from James I, and a fourth from James II; the latter, Charternowin force however, having been annulled in the time of King William, the Charter of James I, granted by James I, in the year 1609. granted in the seventh year of his reign (1609) is the latest now in force.

As in it no mention is made of the right of returning Members to Parliament, we conceive that this right rests only on prescription. New Ross first sent Members to Parliament in the year 1374.

The persons who at present enjoy the Elective Franchise are, 24 Burgesses and No. of Electors: 14 Freemen; in all 38. The Freemen are admitted solely by special favour. Of 24 Burgesses, 14 Freemen. the 38 Electors about 20 are resident.

3. By the Charter the number of Burgesses is not limited, nor is that of the Constitution of the Freemen. The Sovereign is elected annually, and must be a Burgess; the Re-Borough. corder also must be a Burgess. There are two Bailiffs who may be either Burgesses or Freemen. The Mayor and Recorder are ex officio Magistrates of the County of Wexford; and the Sovereign on vacating that office, is a Magistrate for the Town for the ensuing year. At present the duties of the Sovereign are performed by a Deputy, though we do not see that such an officer is recognized by the Charter*. By the Charter (of James 1.) the Borough is made to extend one mile Borough contains Charter*. By the Charter (of James 1.) the Borough is made to extend the line a considerable in every direction beyond its former Limits, it therefore includes a great deal of District beyond what is at present purely an Agricultural District; but as the dwellers within this the Town District have never enjoyed the Elective Franchise, we are not called upon by our instructions to include so much of what is purely the Country within our Boundary, simply because it is within the Jurisdiction of the Sovereign, or part of the Borough by the Charter.

4. The Corporation possess Estates of some extent, but they have been leased for Estates of the long terms, at low-rents, so that their present income is said not to exceed £. 200. Corporation. per annnm.

The Charter gives to the Burgesses the power of appointing to interior offices; but no power to depute to others the duties of the superior officers.

Until very lately they also levied Tolls, which in former times produced £. 400. or £. 500. a year; but these Tolls have latterly been disputed, and are now discontinued.

Union of Parishes,

5. There are six Parishes joined in the Union of New Ross; viz. Old Ross, Clonleigh, Ballyanne, Turreraugh, Cashinstown and St. Mary, in which latter Parish the Town of New Ross is situate. The exact Boundaries of these Parishes could only be ascertained by considerable time and trouble. There is but one Parish Church for the whole Union, that of St. Mary within the Town of New Ross. The Union contains 26,000 statute acres.

6. There are no Assessments in the Town except for Church Cess; and on this the sum raised is only for the present year, £. 10, 15, 2, on 340 houses.

This sum being so trifling as scarcely to make the people care about the fairness of the Assessment, we did not feel inclined to put much confidence in it. We therefore employed persons to make a valuation under our own inspection, but we find the result little different from that of the Churchwardens.

The total number of Houses is 1,040, of which 893 are slated, and 147 thatched.

The Houses may also be divided into those having more than seven windows, which are 314, and those with less, 726.

Number of Qualified Occupiers, 246. 8. The 316 Qualifying Tenements will not however furnish an equal number of Qualified Occupiers, for we have to deduct, 1st, For unoccupied Houses; 2dly, For Houses occupied by Females; 3dly, For cases where two or more Tenements are occupied by the same person, as is the case generally with the warehouses; and, lastly, For persons disqualified by office, and if we take all these at 70, we do not reckon on the number of Qualified Voters exceeding 246.

The number of Freeholders registered for the County of Wexford in virtue of property in the Town of New Ross, is 22; of which 18 are resident Householders in the same.

Freemen with rights reserved. Of the 38 persons at present in possession of the Elective Franchise, 20 only are resident in the Town, or within seven miles; and of these latter, 12 are Householders within our limits, so that the number whose rights are to be reserved we do not reckon at more than eight.

10. We have as yet spoken only of the Town of New Ross, on the left bank of the Barrow; but there is a Village called Rossbercon on the other side of the River, that we consider to have a community of interest with the Town, such as to entitle it to be included with it.

We consider ourselves obliged to include the Suburb called Irish Town, but we Remarks on the do not go beyond the Burial Ground, because the houses there cease to be contiguous, and that Modellin beyond it is generally considered to be a separate Village. The distinction is also strongly marked by a considerable fall in the ground.

Nearly the whole of the Town of New Ross is the property of Mr. Tottenham, and we understand that the Leases held under him are generally for short periods.

The Table that we subjoin contains a summary of the information that we have Table. been able to collect.

At present it will not add above 10 or 12 to the Constituency; but being on the bank of the River it may very possibly increase. It is connected with New Ross by means of a wooden Bridge.

The following is the Boundary we propose :

FROM the point (A) on the South of the Town, at which the Lower Bally- Proposed Boundary. hack Road is met by the Southern Fence of the Garden of Belle Vue Cottage, along such Southern Fence to the Eastern extremity thereof (B); thence in a straight line, up a steep hill, to the point at which the middle Ballyhack Road is joined by a Bye-Road, which runs Eastward therefrom, and at which point there is a Gateway and one Pillar (C); thence along the said Bye-Road to the point (D) at which the same turns to the South, and which is marked by a Gateway and two Pillars; thence in a straight line, in an Easterly direction, to the Southern End of the Barn (E), which stands in a Straw Yard, on the Eastern side of the Upper Ballyhack Road; thence, Northward, along the Upper Ballyhack Road to the point (F) at which the same meets the Wexford Road; thence, Eastward, along the Wexford Road to the point (G) at which the same is joined by a Road from Irish Town; thence in a straight line to the South-western corner of the Burial Ground (H) at the Eastern extremity of Irish Town; thence along the Western Boundary of the said Burial Ground to the point at which the same meets the Irish Town Road (K); thence, Westward, along the Irish Town Road to the point at which the same is met by a Lane which runs Northward therefrom on the Eastern side of Mr. Sutton's House and Brewery (L); thence, Northward, along the said Lane for about 130 yards to the point at which the same reaches a Stone Stile (M); thence in a straight line to a Gateway (N) on the Mountgarret Road, which Gateway is the first on the Eastern side thereof, to the North of the point at which the said Mountgarret Road is joined by a Road from Irish Town: thence in a straight line, in a North-westerly direction, to the Ruins of a Quay or Wharf on the Western side of the River Barrow (P); thence in a straight line to the point (Q) at which the Kilkenny Road is joined by the first Bye-Road to the West of the Roman Catholic Chapel; thence in a straight line, in a Southerly direction, to the South-western corner of the Garden (R) of the House attached to the Mill on the Western Bank of the River Barrow; thence along the Southern Boundary of the last-mentioned Garden to the Southeastern corner thereof (S); thence in a straight line to the point first described.
