## Please Read Carefully Before Completing Form

- 1. Please complete the application form in **BLOCK CAPITALS**
- 2. All of the questions on the form <u>must be fully answered</u> to enable the Planning Authority to decide whether a reduction is due in accordance with the terms of Section 48 of the Planning and Development Act 2000 as amended by section 30 of the Act of 2010 and as further amended by section 29 of the Urban Regeneration and Housing Act 2015 that a change in the basis for the determination of the contributions is due and shall be applied to the unsold units within the specified development.
- 3. Where information is inadequate the matter will be returned for further elaboration.
- 4. A site layout map showing the relevant houses *(including the house numbering)* <u>plus</u> a site location map should be submitted with the application.
- 5. A list of the house sizes should be submitted and details of what planning permission the levies have been conditioned under.
- 6. A letter from your solicitor <u>must</u> be submitted with all application forms confirming that the relevant houses have not been sold.
- 7. Please note that Wexford County Council will endeavour to process your application within 4 weeks of date of receipt provided that all documentation requested is submitted.
