The proposed grid stability service development consists of the provision of a synchronous condenser within a building circa 13 metres in height; elevated modular containers to house electrical and control equipment and all associated plant/apparatus including: a) a generator circuit breaker, b) transformers, c) outdoor cooler equipment, d) underground cabling (including a connection to the existing substation, e) all associated above ground cabling, piping and electrical connections, f) 1 no. generator and associated diesel tank, g) firewater tank and pumphouse, h) perimeter fencing and 2 no. gates and i) all associated site development works including hardstanding, drainage, gabion wall and landscaping. The proposed site clearance works include the removal of a temporary portacabin and construction rubble from the site. The application relates to an establishment which holds an Integrated Pollution Prevention and Control (IPPC) license and to which the major accident regulations apply.
