Ref. 20221551 to comprise 49,258 sq.m of solar panels to allow for solar panel array height increase from 2.8m to 3.2m; Modifications to the inverter stations to incorporate 3 no. electrical skids to house inverter/transformers; Construction of 1,055m of internal service trackways comprising 679m of new service trackways and use of 376m of permitted internal trackways; Amendment to the associated drainage infrastructure; and Permission to amend the lifespan of the consented development from 25 years to 30 years. A 10 year permission is requested
