A NEW SECTION OF WATER MAIN WILL BE CONNECTED TO THE EXISTING IRISH WATER WATER MAIN AT THE JUNCTION NORTH EAST OF THE HOSPITAL. THE NEW MAIN WILL BE LAID ALONG THE PRIVATE ROAD WITH SERVICE CONNECTIONS PROVIDED TO EACH OF THE 3 HOUSES AND THERAPY UNITS. AN APPLICATION FOR A CONNECTION WILL BE SUBMITTED TO IRISH WATER. IRISH WATER HAVE ALREADY CONFIRMED THAT THE CONNECTION IS FEASIBLE.
