On Sunday, June 5th, Dr. Carl Reiber, GS Provost & VP for Academic Affairs, Dr. Chris Curtis, GS Vice Provost for Research, Ms. Kendria Lee, GS Deputy Chief of Staff, Mr. Trip Addison, GS Vice President for University Advancement and External Affairs, Mr. Bart Gobeil, Executive Director, LTIC [Logistics Technology Innovation Corridor; former COO, State of Georgia], Dr. Dustin Anderson (GS Associate Provost for Student Success [including GS Centre for Global Engagement] arrived in Enniscorthy for a tour of Enniscorthy Castle and a presentation on current initiatives in place and planned for Enniscorthy and Enniscorthy Technology Park.

Town & Village Renewal Scheme 2022

The 2022 Town and Village Renewal Scheme has announced grants from €20,000 to €500,000 to help revitalise towns and villages post-Covid-19. The scheme's focus for 2022 will prioritise tackling vacancy and dereliction in towns and villages. Other regeneration projects that support active and vibrant town or village centres, remote working, upgrading shopfronts and street facades, and green spaces and parks etc will also be considered under this Scheme. The scheme is designed to breathe new life into towns and villages as attractive places to live and work under the Government's 5-year strategy "Our Rural Future" and "Town Centre First Policy".

The maximum number of applications that can be supported by the Town and Village Renewal Scheme 2022 in County Wexford is:

- I. 5 applications between €20,000 to €250,000
- II. 1 application between €20,000 to €500,000
- III. 2 application funding up to €50,000 (New Project Development Measure)
- IV. 1 application funding up to €50,000 (New Marketing Scheme Measure)
- V. 2 applications funding up to €400,000 (New Building Acquisition Measure)

Wexford County Council invited Expressions of Interest from town/village groups and Municipal Districts who may have a suitable project for consideration under the Scheme. A total of 18 EOI's were received from which 11 projects will be selected to submit a full application to DRCD by 22nd July.

2022 Streetscape Enhancement Measure,

This measure has been temporarily paused by DRCD in order to first facilitate the finalisation of the financial closure of the 2021 Streetscape Enhancement Measure based on the final returns which have been received from local authorities in recent weeks.

It is expected that the 2022 Streetscape Measure will commence in the coming weeks once the 2021 Measure has been fully closed.

Wexford County Development Plan 2022-2028

On Monday, 13th June 2022 the Elected Members of Wexford County Council fulfilled one of their principle statutory functions when they unanimously adopted the Wexford County Development Plan 2022-2028. The adoption of the Plan marked the culmination of a prolonged and complex process, completed during a time of unprecedented policy change in Ireland. The Plan has had to address many issues, several of which are complex, with competing expectations and demands.

The preparation and content of the Plan was required to comply with the demands of EU Directives on the protection of the environment and habitats which in itself is a complex and formidable task. County-wide concerns have to be balanced with national and international issues. Individual economic interests have to be balanced against the protection of the environment and the public good. The Elected Members deserve great credit for always seeking to get the balance right, for seeing the bigger picture even when short term solutions appear easier, and it is hoped that the people of Wexford now and in the future will see and appreciate that.

The new Plan was the subject of extensive public consultation engagement in the form of public displays, information evenings, engagement with stakeholders and service providers, consideration of more than 260 written submissions and observations, briefing sessions for Elected Members, and the preparation of Chief Executive's Reports on the various public consultation stages. The Plan was informed and enhanced by this public consultation with key issues raised such as a Healthy Wexford, the need for sustainable communities and social inclusion, climate action and the protection of biodiversity forming underlying themes of the adopted Plan.

The new Plan, which will come into effect on Monday, 25th July 2022, sets out the spatial planning framework for development of the County over the six-year period from 2022 – 2028 and it will provide the backdrop against which all new planning applications will now be considered. The Plan contains a wide range of inter-related objectives from climate action, housing and sustainable communities and economic development to clean energy, transport, clean water, quality education and good health and well-being. In particular, the Plan contains objectives to:

- Ensure that the County's towns and rural areas are invigorated while also recognising the County's strong tradition of rural living.
- Aim to provide people with a choice of housing type, tenure, affordability, and location, and ensure that the design standards required by the Plan will result in attractive environments with a high quality of life.
- Develop a healthy and inclusive County with outstanding amenities for residents and visitors alike.
- Develop sustainable transport modes across the County.
- Develop necessary facilitating physical infrastructure; and
- Prioritise the protection and restoration of biodiversity, landscapes, and heritage.

The Plan will be available for public inspection from Monday, 25th July 2022 via the Council's website and Online Consultation Portal and in hard copy format at the Planning Department, County Hall. Copies of the Plan will also be made available for purchase in due course from the Planning Department.

New Ross Municipal District

The Raheen Family Resource Centre is currently revisiting their project proposals given change in management at the centre.

Enniscorthy Municipal District

Bunclody Day Care Centre and Kiltealy C.D.A are at the stage of costing/ seeking quotations for proposed works.

Gorey-Kilmuckridge Municipal District

Monageer Parish Grotto Group, currently revising proposed works, having found themselves in a position to achieve substantially more works by considering an alternative design approach such was the success of the on-site workshop. Proposals remain outstanding from the following groups Rangers FC, Ballycanew Men's Shed and Ballycanew-Ballyoughter C.D.A.

Rosslare Municipal District

Rosslare Community & Sports Centre (RCSC) & Our Lady's Island C.D.A. have had subsequent follow up meetings/workshops to allow for fine tuning of final proposals. In Rosslare collaboration with the District Engineer to address a public footpath issue outside the centre has been complete. This will assist in the RCSC finalising their proposal. Our Lady's Island C.D.A in tandem with proposals through the DRAF currently we are investigating the opportunity to relocate the Triobike no longer in use in JFK, to develop a collaborative community/cycling/intergenerational programme.

Advanced Digital Access Participation Project, (ADAPP)

This project is currently underway with video footage captured for the following locations:

Gorey Kilmuckridge Municipal District Office, the avenue Gorey included in the footage is the services and facilities of the library facility at this location, which will form its own virtual tour.

Wexford Borough District and Head Office at Carricklawn have had the necessary video footage to develop the virtual tour of these buildings.

New Ross Municipal District is another site which has had footage to develop the virtual tour captured, along with Fethard Castle as one of the Heritage Site chosen.

ADAPP is funded also through the DPAF to provide virtual tours of our main public offices and a selected number of heritage sites, it is expected that this project will be completed by end of July 2022. The Heritage Officer continues to support the development of the virtual tours for the heritage sites providing the essential information to ensure the virtual tour will provide an informative, interactive and a true to life visit albeit virtually.

NATIONAL ROADS

N11/N25 Oilgate to Rosslare Harbour

Tender documents for a geotechnical investigation contract are currently being finalised and it is anticipated that fieldworks could commence in September after the main harvest seasons have ended. Environmental surveys within proposed corridor are ongoing.

Traffic studies and traffic modelling has commenced. Traffic model will be developed to allow for multi-modal approach, which includes consideration of demand responses (Trip Generation, Distribution, Mode Share, etc.)

The design of the development will evolve through the year and will generate increasing engagement with land and property owners. The Project Liaison Officer will engage with all impacted landowners.

N25 Rosslare Europort Access Road

Documentation for a planning application under Section 177AE and Compulsory Purchase Order have been finalised. Approval to commence Statutory Processes has been received on 3rd June 2022. It is anticipated that a Section 177AE planning application & CPO Maps and Schedules will be submitted to An Bord Pleanála by the end of June.

Any submissions or observations may be made to An Bord Pleanála which may at its discretion hold an oral hearing on proposed development.

Letters of Intent, to publish the land acquisition documentation, have been posted by registered post to all affected landowners included in the land acquisition documentation. Public notices on proposed development and land acquisition were published in local papers on 27th June.

A project newsletter, to provide the public with further information on the planning process, is prepared and will be circulated in local outlets and public buildings in Rosslare Harbour immediately after submission of planning documents to An Bord Pleanála is made.

NATIONAL ROAD PAVEMENT SCHEMES

2021 Pavement Schemes

HD28 Pavement Improvement Works N11 Oilgate Village

The scheme was tendered in November.

We received approval from TII to award the on contract on 10th March.

Due to the traffic volumes on the N11 this scheme will need to be carried out at night.

Works should commence by mid-July with a 2-week programme.

2022 Pavement Schemes

N25 Ballykilliane to Orristown Pavement Scheme

(Estimated Total Scheme Cost €1,600,000)

This scheme is 2 km in length and runs between the R739 Kilmore junction to the L7050 Orristown junction on the N25.

Works are being carried out on the contract documents for the scheme with tender planned by mid to late July.

Pavement works should commence by September.

N80 Tomacurry to Ballycarney Phase 1

(Estimated Total Scheme Cost €1,600,000)

The total scheme length is 3.7km. The allocation from TII for 2022 allows for the first 2 km at the southern end to be completed in 2022.

Work has commenced on the design of this scheme, with tender planned in August. Pavement works should commence in September.

N25 Ballygillane Roundabout

(Estimated Total Scheme Cost €2,590,000)

This scheme was tendered in November 2021.

Works commenced on 23rd. May and should be substantially completed by the end of the year.

2022 Additional Maintenance Allocations

N30 Forestwood Pavement Repair €250,000

Wexford County Council applied for and received additional maintenance funding from TII to carry out pavement repairs on the N30 at Forestwood. It is hoped to tender this scheme by the end of July.

Drainage and Verge Maintenance €110,000

Wexford County Council applied for and received additional maintenance funding for drainage and verge maintenance works on the N11, N25 and N30. These maintenance works were completed during May and June.

A consultant will be appointed to carry out a drainage design for a section of the N25 between Barntown and Larkins cross that flooded twice since 25th December 2021

Former National Road - R744 Millpark Road Enniscorthy €350,000

This allocation was for the upgrade of former national roads. This will be used to carry out pavement repairs on Millpark road from Castle Hill to Arnolds Cross. This scheme will be tendered in August.

REGIONAL AND LOCAL ROADS

The Regional and Local Road Grant Allocations were announced on 15 February 2022. Wexford's allocation was €23,749,787 up €4,529,827 on 2021. This allocation included €4,000,000 for Christmas day 2021 flood damage.

Resurfacing/Strengthening

The 2022 strengthening programme (Machinery Yard) commenced in the Enniscorthy District on 31st January 2022 at Bola Beg, Ballindaggan.

Roads completed (macadam surfacing) in the last month were:

Kiltillahan to Ballytarsna; Mountforest to Smiths Cross; Oulartard to Tinnacross; Creagh; (All in Gorey-Kilmuckrdge District); Mulgannon road; Glasganny Castlebridge; Farmhill Crossabeg; (All in Wexford Borough District).

Roads completed (Clause 804 stone) in the last month were:

Abbeydown; (Enniscorthy District); Knocklahaun; Killenagh to Ballyoughna; Monamolin; Baurela towards Kilbride; (All in Gorey-Kilmuckrdge District).

Surface Dressing Works

The 2022 surface dressing programme commenced 10 June in Enniscorthy MD.

The following roads surface dressed in the last month were:

Mocurry East; Carrigunane to Ballybrennan; Macmine; Garrenstackle; Coolree; Rossard \ Ballinacoola; Gorteen; Graigue Beg; Tombrick; (All in Enniscorthy District); Gaurran Lower (Grange Lower); Kilgarvin to Depot; Old Ross to New Bridge; Bushpark to Raheen; Breezemount to Oldcourt Cross; Clonsharragh; Harrylock to Broomhill; Kelly's cross towards Carnivan; Forrestalstown; Shanwole cross roads to Wattle cross roads; Clonleigh Road; Kilmannock; Taulaght; Chapel lane; Raheenakennedy Lane; Pollpeasty to Forralstown; Arnestown to Finshoge; Finshoge to Ballymacar; Finshoge to Ballylane; (All in New Ross District).

Community Involvement Schemes

€614,350 grant has been allocated to County Wexford for 2022. The roads to be completed in 2022 are being finalised.

One road has been resurfaced at Ballyharren in the Wexford Borough District.

Local Improvement Schemes

Wexford County Council has been allocated €431,760 grant to resurface 13 private lanes in the county.

Resurfacing these will start in the next month.

A second application has been submitted to the Department of Rural Community and Development for consideration to fund an additional 14 private lanes.

Bridge Rehabilitation Grant

There are 19 bridges for repair with grant of €603,000. Work has commenced on Abbey Bridge in New Ross District. This excludes bridges funded under Christmas day storm damage.

Work has commenced on 3 of these: Kiltrea Bridge; (Enniscorthy District); Mulmontry Bridge; Glebe Bridge (Rosslare District).

Specific Improvement Works - The Deeps Bridge

The Deeps Bridge Remediation Project – RPS Consulting Engineers Ltd was appointed as Project Supervisor for the Design Process in March 2021. An underwater inspection of the bridge structure was carried out in 2021 and no defects were found below the water.

An Bord Pleanála has granted permission for the project to proceed. The design and tender documents are being developed at present. It is expected to go to tender for construction in September. Works are expected to commence Q 4 of 2022 or Q1 of 2023.

General Maintenance

Drainage, patching and road surface repair works are ongoing in all Districts.

ACTIVE TRAVEL MEASURES

The NTA confirmed an allocation of €4.44m to Wexford County Council for projects in 2022. This funding is largely to complete projects approved in 2021 which are presently in design or construction stage.

A design incorporating 1km of segregated cycle lanes, footpaths and junction improvements is in Part 8 Planning for Newtown Road (Wexford Borough District).

Designs are being developed for cycleways at: Beechlawn/Clonard Avenue (1.7km); Roxborough (3.5km) both in Wexford Borough District; Oaklands to Kents Cross (2km) in New Ross District; Rosslare Harbour to Kilrane (1km) in Rosslare District and the R772 Clogh to county boundary Improvement Cycle Scheme in Gorey-Kilmuckridge MD.

7.3km of new footpath was constructed in 2021.

Over 1.5km of new footpath was constructed to date in 2022.

PUBLIC LIGHTING

LED Upgrade (Non National Roads)

Over 12,000 lanterns have been upgraded to LED since the beginning of 2016.

Design works are completed.

Works are almost complete bar installing Led trays in the Heritage decorative lanterns across the county. It is hoped to complete the upgrade of these remaining lanterns on non-National roads and housing estates by mid-2022.

A plan will be put in place to upgrade the remaining lanterns in housing estates that were taken in charge over the last 4 to 5 years.

Public Lighting Development Fund

Additional public lighting is being installed at the following locations under the Public Lighting Development Fund.

- Ballygarrett Village Works completed. Awaiting ESB connection.
- Balintray, Courtown Works completed. Awaiting ESB connection.

Further works are planned,

North Parade Gorey – infill lighting on ESB Network poles
Clonattin Road Gorey – infill lighting on ESB Network poles
Ramsfort Avenue Gorey – infill along by GAA pitch
Killinick Village
The Ballagh – Church to the school
The Ballagh – Ballagh Cove to regional road
Killenagh Village
Wexford Town – Seamus Kelly roundabout to Spawell Road
Wexford Town – Mulgannon
Rathgarogue Village
Davistown Village

Other locations will follow further to consultations with Municipal District Engineers.

SPECIAL PROJECTS

1.1 Forth Mountain Activity Park – Phase 1 – Trails and Carpark

Final snag works including the water and sewer connections to the site have been completed. Additional works to improve the accessibility along some of the existing trails will be completed in July.

Forth Mountain Activity Park - Phase 2 - Activity Centre Building:

The proposed boathouse and external toilet facility on-site have completed preplanning and the Part 8 planning documents are being prepared. The Part 8 application will be advertised in September.

The activity centre building was lodged for Part 8 planning in March by WCC's Architects Department and the period for public comment closed on 20/04/2022. A response to a request from An Bord Pleanála for further information relating to the project is currently being prepared.

1.2 Min Ryan Park

Sole Sports and Leisure has been appointed to construct the skate park and MUGA on a design and build basis. The MUGA is now complete and open to the public. Recommencement of works on the Skate Park is now overdue. Works are now expected to recommence in early July and will take up to eight weeks to complete. Public lighting at these installations will follow.

1.3 Enniscorthy Technology Park Phase 1

Phase 1 – the development of three serviced sites is substantially complete and the construction of the first building is well under way. Robert Troy TD Minister of State at the Department of Enterprise, Trade and Employment visited the Park in March.

1.4 Gorey District Park

The external area of the park opened to the public on 12th August 2021 and the new playground and adult gym equipment in fully installed and in use. The final landscape planting is now virtually complete. Work on the building has recommenced and is due for completion in July 2022.

1.5 South East Greenway

Contracts for the works on Lots 1, 2 and 3 have been awarded to Glas Civil Engineering and works are nearing completion on-site. Landowner agreements on the accommodation works are progressing well and it is planned that Lot 5A (Ferrybank to Curraghmore) will be tendered for works in July 2022 with Lot 6 (Glenmore) will follow in August.

The detailed design of Lot 4 (New Ross to Mount Elliott) is advancing and we would expect to issue tender documents for works in Q3 2022.

1.6 Trinity Wharf

Due to significant inflation in the market since tenders were received, the original tender process for the access road undertaken in 2021 was abandoned. A revised tender invitation issued in December 2021 and tenders have been received and have been assessed. Works are expected to commence in Q3 2022.

Procurement of consultants for design services for the site development and public infrastructure works is underway. The pre-qualification process is completed, and the successful design firms have been issued with tender documents. Tender submissions were received on 31/03/2022. Appointment is expected in July.

1.7 New Ross Fire Station

The contract to construct the New Ross Fire Station was awarded to Kevin Thorpe Ltd. Works commenced on site in May 2021 and the works are now substantially complete.



1.8 Wexford Arts Centre Extension

The main works contract has been awarded to McKelan Construction Ltd and works commenced on site in May 2021. The works are on-going and substantial completion is now expected in September 2022.

1.9 High Hill, New Ross


The Contract has been awarded to MJS Civil Engineering and works are progressing on-site. Groundworks, drainage and ducting works are now substantially completed within the main section of the park. The installation of the staircases and masonry work is complete. Surfacing works and paving to the landing area are underway and the pedestrian Crossings to North St. & Chapel Lane have been completed. Tree planting and bareroot planting is substantially completed. Herbaceous planting is scheduled to coincide with remaining paving works and Autumn bulb planting will continue after the paving works. Works are expected to be substantially completed by July 2022.



1.11 Monck Street Enhancement Scheme

The main works contract was awarded Tony Kirwan Civil Engineering Ltd in February 2022 and works commenced on site on 21/03/2022.

The works are expected to be substantially completed in August 2022.



1.12 New Ross Public Realm – Phase 1: Removal of Bulk Fuel Storage Tanks

This project consists of removal of the oil tank structures on the Quay and the development of public realm works on the site.

The Advance Works Contract (Removal of Tanks) was completed in July 2021.

A Part 8 development consent application for the development of the public realm space on the site was confirmed at the Council's meeting in March 2022. Tender documents for the works contract are expected to issue in August.

An application for category 1 capital funding under the RRDF scheme was submitted in April 2022.

1.13 Templeshannon Regeneration, Enniscorthy:

The Templeshannon Regeneration Strategy identifies a number of enabling projects required to achieve regeneration, including:

- Improving the public realm and streetscape in Templeshannon area;
- Establishing a new link to the town centre by construction of a new pedestrian bridge;
- The management and progressive transformation of the Leisure Centre Car Park:
- The creation of new urban blocks for infill development.

The site investigation (SI) work for the pedestrian bridge has been completed. The preliminary design and bridge options report has been completed taking account of the results of the SI works and is currently under review.

WCC is engaged with the Department of Housing, Local Government and Heritage in regard to a further funding application to support regeneration in Enniscorthy. The planning Department is working in collaboration with Special projects to develop a strategic plan for Enniscorthy and is currently being drafted.

1.14 John Street Building Regeneration Project

WCC was successful in securing RRDF funding to design a redevelopment of the old grain stores at John Street, New Ross, which will see these buildings converted into a high-quality enterprise hub.

A design team was appointed in April 2019 and initial surveys and investigative works have been completed. A portion of the grain store building has been purchased by agreement. The CPO for the project has been approved by An Bord Pleanála and the acquisition of the outstanding property to facilitate the development is progressing. The CPO is proceeding, the Notice to Entry has been served and the site is now in our possession. The Preliminary design will follow with the Part 8 consent process planned to commence in Autumn 2022.

1.15 Esmonde Street

RPS is progressing with the detailed design. Site investigation works are now completed. Irish Water have now approved proceeding with the design of the sewer upgrade and CCTV and survey works has been completed. The detailed design for the sewer upgrade being finalised.

WCC submitted an application for category 1 funding under the current call for RRDF for this project.

1.16 Gorey Market House

A Part VIII planning application for re-development of the Market House into a multipurpose performance/exhibition/retail space was approved in May 2018.

A call for Expressions of Interest / Tender Proposals from private sector investors was advertised in January 2020 and 2 submissions were received by the closing date of 13/02/2020. This tender process was concluded in May 2021 without the award of a contract.

WCC will prepare new documents seeking expressions of interest from the private sector for developing this project. KPMG has been appointed to advise on this process and requests for tenders will issue in August 2022.

1.17 Mechanics Institute

Consulting Engineers were appointed in March 2020 to undertake design, tendering and construction management services for essential maintenance works at the Mechanic's Institute. The invitation to tender has been re-advertised and tenders received. Tender assessment is underway and it is expected that a works contract will be awarded in Q3 2022. Construction works are scheduled to take 6 months.

1.18 WEXFORDIA – Irish National Heritage Park (INHP), Hook Lighthouse and New Ross Tourism Projects

WCC secured RRDF category 2 funding for the development of a cluster of tourism projects within the county.

The tourism and environmental design teams for the INHP have commenced work on the preliminary design and the environmental assessments. It is planned to submit a planning application for the project to An Bord Pleanála by the end of 2022.

The process of negotiation for tourism design services with the preferred tenderer from the 2017 Hook Heritage Ltd competition has closed without an award of contract following the withdrawal of the preferred tenderer in December. WCC has advertised for tourism coordinator services for the project through the existing multi party and a successful tenderer will in July. The tourism coordinator will assist with the procurement of interpretative design services and we would expect an appointment of interpretive designer by Q3 2022.

The environmental consultant has been appointed and is commencing initial studies and investigative works.

The contract for tourism co-ordination and management services for the New Ross Tourism project was awarded to Alan Sherwood & Associates in November 2021 and he is currently reviewing the outline interpretive design and developing a plan for procurement of detailed design services.

1.19 Enniscorthy Town Centre & Tourism Project:

This project provides for the phased development of a new tourism project of scale centred on Enniscorthy Castle that will have the capacity to significantly increase tourism visitor numbers to the town. The proposed project will link with associated tourism projects to be developed at the Irish National Heritage Park, Hook Lighthouse and the JFK / Dunbrody in New Ross.

The Enniscorthy Tourism Plan report was presented to the Enniscorthy MDC in July 2021.

Tenders for preliminary design and planning consent services have been received for Phase 1 of the project and are currently being assessed.

1.20 Courtown Coastal Protection & Beach Nourishment Scheme

Following a competitive tender process, RPS Ltd has been appointed to undertake the Preliminary Design and Statutory Consents phase of the Courtown coastal protection and beach nourishment scheme.

Priority Geotechnical Ltd. have been appointed to carry out the Marine and Land based surveys and Boreholes at Courtown. They commenced work on the 23rd May the site investigation work is expected to last two to three weeks subject to weather and tides. Marine profiling surveys will also be carried out in parallel at this time and this work is being carried out by Hydrographic Survey Limited.

1.21 Rosslare Europort to Waterford City Greenway

The Economic SPC of Wexford County Council and the Transportation SPC of Waterford City & County Council have written to the Minister for Transport seeking inclusion of the out-of-service Rosslare to Waterford railway line in the up-coming national rail review. The application for planning consent for the Rosslare to Waterford greenway project has been paused, pending a decision from the DOT on the future of the rail corridor.

WCC is reviewing advancing the Rosslare Harbour to Rosslare Strand section as a stand-alone project that could link to the EuroVelo and the Wexford to Rosslare greenway project.

1.23 Wexford Town to Rosslare Greenway

Fehily Timoney and Company has been appointed to provide consultancy services for a feasibility study, route selection, preliminary design and environmental assessments for the development of this project. Constraints have been identified and ecological surveys are on-going.

The scoping and route options process has commenced and a presentation was given to the joint Wexford and Rosslare MDCs in late March on this project. Public consultation on the preferred route corridor options will commenced on 11th May 2022 with the window for receipt of submissions closing on June 10th.

1.23 Oyster Lane Car Park, Wexford

A Part 8 submission has been made for the demolition of existing unoccupied buildings on the old Tesco site and for construction of a temporary surface level car park. The plan was presented to the Wexford MDC September meeting and the Part 8 process commenced formally on 26th October 2021. The Part 8 was confirmed at the march 28th full Council meeting.

O'Connor Sutton Cronin consulting engineers has been appointed to provide design and construction related consultancy services for the project.

Procurement of detailed building surveys is ongoing. Detailed design is programmed to be completed in August with an award of the initial works contract (demolition works) in Q4 2022. The main car park works contract is expected to commence in Q1 2023.

1.24 Crescent Quay – Dredging

An award of contract was made to RPS Consulting Engineers in June 2021 for design services for engineering assessment, environmental and foreshore consent applications in respect of this project. RPS are currently specifying and procuring investigative works to inform the dredging strategy. The tender report for the appointment of a marine sediment sampling contract is expected in September 2022.


1.25 Old Dublin Road Business Park, Enniscorthy

The final masterplan has now been completed and presented at the Enniscorthy MDC's October 2021 meeting. A contract for the initial phase 1 works was advertised in January 2022, these works include new footpath, pedestrian crossings, new entry signage and landscaping. The Phase 1 works contract has been awarded to Hughes and Hennessy. Works will commence in July.

A further application for funding of the masterplan was made to the NTA's active travel programme in January 2022.

1.26 Enniscorthy Sports Hub

O'Leary Sludds Architects were appointed in Feb 2021 for the detailed design, procurement of works contractor and construction management of the Sport Hub building. The tender documents issued to the Department for Tourism, Culture, Art, the Gaeltacht, Sports and Media (DTCAG) have been approved and the works are currently out to tender, with a tender deadline of 6th July. It is expected that a works contract will be awarded in Q4 2022.



1.27 Curracloe Water Sports Activity Facility

WCC has received Stage 2 compliance approval from Failte Ireland for the development of facilities to support water sports activists at Whitegap in Curracloe. The project will include showers, toilets, changing facilities and lockers.

The tender for design services was advertised in Jan 2022, the tender evaluation process is now complete and an appointment of a consultant is imminent.

2. Flood Defence Schemes

2.1 Enniscorthy Flood Defence Scheme:

Statutory Process - The Minister for the Department of Public Expenditure & Reform (MDPER) issued his decision to refuse the scheme on 4th March 2022. Details are available on www.gov.ie. Following the decision, the OPW confirmed their commitment to delivering an effective scheme for Enniscorthy.

The Minister for State, Mr Patrick O'Donovan and senior officials from the OPW & WCC attended a special meeting of Enniscorthy MDC on 4th May 2022 to update the members in relation to the Enniscorthy Flood Defence Scheme.

The minister supported a WCC proposal to progress the new River Slaney Bridge and the Flood Defence Scheme as two separate standalone projects.

Flood Defence Scheme - The scheme alternatives are to be assessed, consulted on publicly and a preferred option identified. MMD have issued a programme of

work – the preferred option report & environmental assessment reports are scheduled to be completed in Q2 2023. At that stage planning options will be reviewed, and the preferred planning route selected.

New River Slaney Bridge - The ecology baseline data is currently being updated. ROD have issued a programme of work – planning is expected to be submitted in Q3 2023."

2.2 Wexford Flood Relief Scheme:

The project brief for design services for Wexford Flood Relief Project was advertised on Etenders in early 2020. Seven tender submissions were received by the extended closing date of the 9th July 2020. Following a detailed tender assessment and evaluation process the decision not to award a contract arising from this tender competition has been advised to all tenderers. A further procurement process has been advertised with tenders due to be returned on July 11th.


UKRANIAN RESPONSE UPDATE

Ukraine Update

The Ukraine Team is led by Ms Amanda Byrne A/Director of Services with the following staff; Mr Ger Mackey SEO (until July 23rd), Mr Michael Sweeney, Senior Staff Officer (commenced June 27th), Ms Olga Bodnaruk, Clerical Officer (commenced June 6th), Mr. Billy Dobbs, Station Officer, Fire Services (commenced March 26th) and Ms Niamh Bolger Assistant, Staff Officer (commenced March 26th).

Information Update

Estimated number of displaced Ukrainians in Wexford as of Friday 24th of June is 1170 of whom 370 are children under 18.



The numbers arriving daily had been reducing from Easter but recent weeks have seen an increase.

There continues to be three main elements to the work;

No.1 Providing support and coordination for the Community Response Forum.

The Forum met on the 15th of June. Access to English classes continues to be an issue and there seems to be a mismatch between classes provided and areas of interest/demand, this will be explored further. Cllr. Barbara-Anne Murphy questioned if Community Employment Schemes could waive the 1year unemployed requirement for Ukrainians in places where posts cannot be filled. This query will be escalated. It was also agreed that a representative of the Friends of Ukraine group will be invited to attend future meetings.

A fund of €187,521 has been made available to the WLD for the delivery of SICCAP supports to displaced Ukrainian nationals through the LCDC.

The team collate information and circulate on a weekly basis.

No.2 Red Cross Pledged Properties

The list of potential self-contained properties has increased to 145 with some local additions. At this point Wexford County Council staff have assessed 128 properties (there are a number we cannot contact), of those 47 are no longer interested/available.

Some 95 beneficiaries have been moved (or are in process of) into 29 properties

A further 20+ properties have been assessed at this point so the focus for the next week(s) will be on family placement. All staff on the team are involved in this process. The properties are generally in rural and remote locations so priority is given to placing families coming into the country via Rosslare as many have their own car.

No.3 Other Accommodation Options

The Department of Housing, Heritage and Local Government are preparing a funding programme for potential longer term communal accommodation projects. We have properties identified and will progress those once the funding mechanism is available.

Other issues - ongoing from last month

Work is being done to develop an accurate information support and currently the best available information for number in the county is that database updated weekly by Wexford Local Development Staff.

There are also displayed Ukraine's the county living with family or in other arrangements independent of IPAS and the Red Cross. Some of these arrangements are breaking down and as a result families now require IPAS accommodation.

Healthy Wexford are supporting the Understanding Radon event at New Ross Library on 28th June, the committee are also working on the Free Period Product initiative, we are collaborating with Wexford PPN to develop a Community Growing Network, and the MWWG have organised SafeTALK training in Wexford on 28th June.

Celtic Routes

Refreshed content has been agreed for the Out of Home publicity campaign beginning in very early June at Cardiff and Bristol airports, motorway service stations in England and Wales, and at Rosslare Europort. The Times on Saturday and The Sunday Times inserts have been agreed and printed ready for distribution. Travel Journalist trips have been agreed and scheduled for July to October. Social Media platforms for Celtic Routes have seen over 72 million people have had an opportunity to see Celtic Routes content. Website realignment will be finalised in early July with the inclusion of over 70 tourism business under the Celtic Experience Collection. Midterm evaluation has been circulated to the Partners and final evaluation parameters have been discussed. Legacy options have also been discussed and are ongoing.

ENVIRONMENT

A. COASTAL MATTERS

Harbours -

Department of Ag, Food & Marine (DAFM) announced funding approval for projects under a new scheme to develop works on LA harbours, called the Brexit Adjustment Local Authority Marine Infrastructure 2022 − 2023. The DAFM approved 23 projects with a total construction cost of €1.4m in Co. Wexford; works are now underway to progress these projects.

Fethard Harbour – New Slipway and Beach Access. Part XI planning was submitted to Planning Department on 5th April 2022. The public planning notice was in the local newspaper on 20th April 2022. This scheme was included in the above DAFM approved projects.

Ports Past and Present: Rosslare Ports Fest took place on 17th and 18th June in Rosslare Harbour, event details in progress – updates available on website. There is ongoing engagement with the Rosslare community, artists and our project partners in University College Cork and two Welsh universities. Regular updates and further information is available at https://portspastpresent.eu/

Beaches -

National Blue Flag Awards 2022 hosted by An Taisce in association with Wexford County Council – held at Curracloe beach on Friday 20th May.

- 6 blue flag beaches: Ballymoney, Morriscastle, Ballinesker, Curracloe, Rosslare, Carne.
- 2 blue flag marinas: New Ross and Kilmore Quay.
- 9 green coast award beaches: Cahore, Oldbawn, Culleton's Gap, St Helen's Bay, Ballyhealy, Cullenstown, Grange, Baginbun, Booley Bay.

Ballymoney – consulting engineers appointed to do a feasibility report on improving accessibility on the path to the blue flag beach. Report will be produced in Q3 2022.

Ballyconnigar Bridge: the pedestrian bridge was washed away during the extreme rainfall on Christmas Day 2021. The contract to build a new bridge was awarded on 17th May; work will commence on site as soon as possible.

Coast -

Rosslare Coastal Erosion and Flood Relief Scheme: Nicholas O'Dwyer Ltd Consulting Engineers was appointed on 13th Dec 2021. Steering meetings with WCC, OPW and the consultants are now underway and will be held on a monthly basis. The process of collecting and reviewing data for the project has commenced.

Seaview, Kilmore: emergency works to protect the access road were completed in Jan 2022. Additional coastal protection works were carried out at the end of the public road.

Environmental surveys are complete. Bathymetric surveys about to commence. This information will provide information for the planning application, to be submitted later in 2022.

Lady's Island Water Level Management Structure – An Bord Pleanala granted planning permission for this development, dated 3rd Sept 2021. Foreshore licence application has been lodged and is under consideration by the Dept of Housing Local Government and Heritage. A public notice for the foreshore was in the local and national papers on 9th February 2022; with comments / submissions to be received by 10th March 2022.

Bike Stands; work is being finalised to install approximately 50 bike stands at 13 beach/coast locations around the coast. This funding for these was received through the Active Travel Scheme.

Morriscastle Dune Restoration: The project involves installation of fencing and maram grass planting to restore and manage the dune system at main beach entrance. WCC received €11,475 in funding for this project under the National Biodiversity Action Plan Funding. Fencing works are completed on site; maram grass planting by the local community was carried out 30th April 2022. An Taisce is carrying out further maram grass planting with the local secondary school on 19th May.

St Helen's Bay Preliminary Coastal Erosion Risk Management Study: Wexford County Council appointed consulting engineers to assess the erosion risk to assets including 23 properties and look at options to mitigate the risk.

Ballyhealy Preliminary Coastal Erosion Risk Management Study: in the process of appointing consulting engineers. This project involves assessing the erosion risk of 5 properties and look at options to mitigate the risk.

Grange, Fethard on Sea: works to protect sections of the public road from coastal erosion went to tender. Arrangements for funding and contract award are being finalised with Roads Department.

B. WATER, AIR & NOISE

1. 91 inspections were carried out in 2021. Work has commenced on selecting areas and sites for Septic Tank Inspections in 2022. 65 inspections have been carried out to date with a further 25 inspections planned before end of May. Wexford have a minimum of 106 inspections to carry out in 2022. All work carried out is external with no requirement to enter a dwelling. Contractors are currently carrying out work on a number of sites in order to close outstanding Advisory Notices.

Progress is being made with closing existing open files. 28 files have been closed for 2021 and 18 extension of time have been granted in 2022. There are currently 97 open files for the years 2016-2021 and 42 open for 2022.

Sixteen new applications have been received this year to date, fifteen of which are paid and one is currently under review.

There are currently 23 cases in the Court system for failing to comply with Advisory Notices. 3 of these are for hearing and 20 are for mention.

All NIP files up to end of 2016 have now been closed off. 2017 have 9 open files with 2 on hold due to new N11 route selection, 5 due to assessment of public sewer for Ramsgrange and 2 are in court. 2018 have 9 open files with good progress on 7 of these, 2 are in court. 2019-2022 figures can be seen in the Table above.

2. Section 4 Discharge Licences:

The Council currently has 99 active Discharge Licences. Two new applications have been received and are currently under review.

Invoices for the annual statutory Fee for discharge licences will be dispatched in June. Reminder invoices were issued in October 2021. Invoicing for outstanding bad debt was issued in March 2022 and accounts adjusted where applicable. Invoicing for 2022 were issued on the 1st of June 2022 with reminders to follow later in the year for those which remain unpaid.

3. Climate Action

The Climate Action and Low Carbon Development (Amendment) Act 2021 requires each Local Authority to prepare their own Climate Action Plan. The plan must cover both mitigation and adaptation measures and must be updated once every five years. Wexford County Council is also tasked with developing a decarbonisation zone which will become the focus for a range of climate mitigation, adaptation and biodiversity measures. Enniscorthy is the proposed Decarbonisation Zone for County Wexford.

The Government of Ireland Climate Action Plan 2021 sets an ambitious target of 50% energy efficiency by 2030 and an absolute reduction in greenhouse gas emissions of 51%. In terms of Energy efficiency, there has been an increase of the organisation performance in 2021 with 42% improvement in energy against 39% in 2020. WCC is ahead of the target glidepath to 2030. The increase of performance is mainly due to a reduction of the public lighting consumption. Carbon emissions in 2021 are 28% below baseline level.

The Local Government Management Agency (LGMA) is now collecting Climate Action KPI data from all local authorities. The data was submitted in April. The main indicators for

Climate action are training completed for staff and elected members and details of the Climate Action team.

The local authority Climate Action Training Programme continues to be rolled out. 392 staff members having completed Climate Training. Training was provided in the areas of Planning, Flood Risk Management, Community Engagement & Championing Leadership. Training under the pillar of Green Public Procurement is currently underway.

The Sustainable Energy Communities (SEC) have applied to the SEAI for funding to complete their Energy master plans. Wexford County Council through a MOU has committed to the provision of Bridge funding for finance applied to the SEAI.

Wexford is involved in two Creative Climate projects to raise awareness and promote behavioural change. The first project through the Wexford County Council Arts Office is on the theme of the pilot Decarbonisation Zone in Enniscorthy and has a biodiversity and rewilding focus. The second project is called Linte na Farraige and is through the Creative Climate Fund and is in collaboration with the Dublin Climate Action Regional Office (CARO) and third level institutions. It aims to connect the public visually to the risks from future sea levels.

4. Agriculture:

Wexford County Council continues to undertake a significant number of farm inspections in accordance with the WFD. A total of 78 farm inspections undertaken as a result of pollution incidents or complaints, 45 of these farms were found to have non-compliances. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 were served upon on nine individuals.

A total of 120 Agricultural related Planning Permission Applications were assessed and a further two planning permissions were queried to assess if the applicant had complied with the conditions of planning permissions granted.

Wexford County Council completed odour monitoring assessments on a two separate sites in 2021 on foot of several hundred complaints from the public. These sites included a pig farm and a composting facility where compost is produced by processing straw and animal wastes. Section 24 & Section 26 notices under the Air Pollution Act 1987 have been served upon these businesses.

5. Duncannon EIP Project

Wexford County Council is currently lead partner in the Duncannon Blue Flag Farming & Communities Scheme. We were successful in receiving funding of €550,000 to run this project for 3 years.

The project is now engaging with 36 farmers covering over 950ha of the 1300ha catchment. To date, engagement with all farmers continue with approximately 4 visits to each farm every year where baseline and final "Pollution Potential Zone" surveys are carried out.

The project runs a results based reward scheme where an annual payment is made to each farmer based on their PPZ survey which ranges from €1,000 & €4,000. The farmer can also avail of a water protection improvement works grant which can be used to carry out like fencing watercourses, establishing arable grass margins, resurfacing clean yard areas, hedgerow establishment, riparian margins etc. To date, the EIP project has paid €130,000 in annual payments to farmers while funding of approx. €25,000 has being paid to farmers that have completed works.

3. New Recycling Items

Soft plastic may include bubble wrap, plastic bags and similar wrapping are included in the new items that may be recycled. As with any other plastics, these should be clean and dry and loose. 2 LITTER MANAGEMENT

The Wexford County Council (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-laws, 2018 came into effect from the 2nd January, 2019. From this date, anyone contravening the bye-laws will be liable to a fixed penalty of €75.

Complaints regarding litter are now being handled through the Customer Service Unit. Environment was the first section to use this central system.

Any evidence collected from littering incidents is used in bringing action under the Litter Pollution legislation. It has been noted that less evidence is being recovered. More transactions have moved online and people are removing waste that may incriminate them. The use of CCTV has been halted due to restrictions imposed by the Data Protection Commissioner. The local press regularly reports on such cases. We will continue to target illegal dumping black-spots and the county's roads throughout the year.

January 2022: We had one successful waste management case under section 18 of the Act with a €250 fine awarded and €550 in legal costs and one litter case whereby €250 fine was awarded with €250 in legal costs.

February 2022: We had five successful cases, one under the Litter Management Act with a fine of €350 euro and €250 in legal costs along with 4 successful cases under the Waste Presentation bye-laws 2018 where we were awarded a total of €400 in fines and €1400 in legal costs.

March 2022: Gorey District Court cases were not heard on the day due to courtroom timeframes and will be heard in April. There were no cases for hearing in Wexford District Court this month.

April 2022: Four cases this month are listed between Wexford District Court and Gorey District courts. Two were listed for hearing and two were listed for mention. Seven cases have been withdrawn, due to defendants obtaining bins or completing necessary works following inspections by our Water Services team. Wexford County council had one case under the Waste Presentation Bye-Laws and were awarded legal costs of €550 and a fine of €120. A defendant pleaded guilty to our case under the Litter Pollution Acts and was given until June to reimburse our Legal costs and pay the litter fine of €150.00

May 2022:

10 cases overall were listed for mention this month between Wexford District court and Gorey District court. There was two cases listed for hearing one of which was adjourned for the defendant to obtain legal aid and a legally binding agreement was made outside the Court in relation to the second case.

Environment Education and Awareness:

Our aim is to promote awareness and active participation in a range of environmental initiatives.

Green Schools: 3 schools, Colaiste Abbain, Selskar College and Catherine McCauley Jnr School were all successful in achieving their first green flag on Litter & Waste. An online awards ceremony was held on 25th May. In total 22 schools were awarded green flags in the following themes; Litter & Waste(3); Water(2); Travel (1); Biodiversity(7); Global Citizenship Litter & Waste (2); Global Citizenship Energy (4): Global Citizenship Marine Environment (3).

School Workshops: 2 schools will participate in a Marine Workshop & Seashore Safari in June. The Marine Explorer workshop is an ideal way for children to learn about nature and the environment. The workshop involves a classroom based talk and a visit to a local seashore. It allow children the opportunity to learn through discovery and exploration, as well as being able to benefit from engaging group work and hands on

activities in the field. A qualified and experienced biologist is on hand to answer any questions that the pupils may have.

Climate Literacy Programme:

The Environment Section are funding 5 schools to participate in a Pilot Climate Literacy Programme. Expressions of interest was sought from all secondary schools. This 10 week course includes in-school teacher training, resources, lesson plans and an interactive student workbook. The costs of the 10 week course are covered by the Environment Section and a different topic is explored each week including climate change, sustainable development, climate justice, biodiversity loss, taking action, fast fashion, sustainable transportation, food, soil and plastic pollution. Students run an action project on the last two weeks of the course. The facilitator leaves the school at the end of the course and the teacher continues to teach the course with a new group of students. This course can be run in schools for many years once the teachers are trained.

National Food Waste Recycling Week: National Food Waste Recycling Week ran from May 30th until the 6th June 2022. It is a new national campaign from MyWaste.ie to encourage people to recycle their food waste. The week was officially launched by Cathaoirleach Cllr. Barbara-Anne Murphy at Enniscorthy Household Recycling Centre on Saturday 28th May. An information day was held on food waste and free food waste caddies were distributed. The event was supported by Enniscorthy Tidy Towns and Sustainable Enniscorthy. The week focused on how segregating food waste was a positive climate action and posts went out on social media over the 7 days.









Community Clean Ups: Registrations and support for community clean ups will continue in 2022. 1331 community cleans ups were supported in 2021.

National Spring Clean: National Spring Clean was extremely busy for march and April and details of the Snap Into action competitions was circulated to all participating groups and all primary schools.

Community Engagement: Community talks are ongoing with virtual meetings and outdoor meetings taking place. A talk on waste prevention was given at Wexford Library on May 10th

Keep Wexford Beautiful Competition: The Keep Wexford Beautiful Competition was officially launched by Cathaoirleach Councillor Barbara-Anne Murphy. Closing date for receipt of all applications is 24th June 2022.

Marram Grass Planting Workshops: A marram grass planting workshop in association with An Taisce Clean Coasts took place on Saturday 30th in Morriscastle. Members of Kilmuckridge Tidy Towns and the local community attended. A second workshop took place on Thursday 19th May with students form Colaiste an Atha, Kilmuckridge.







Local Authority Prevention Network (LAPN): Funding was sought and approved for water refill dispenser at Blue Flag beaches. It is hoped that these will be installed during the bathing season.

Dog Fouling Awareness Campaign: The 'Bag It Bin It' will be reinforced by a social media campaign to run from early March. The campaign is set to firmly emphasize that dog fouling is your responsibility as a dog owner. The campaign will address a range of issues surrounding dog fouling, from its effect on the public who use our streets, parks and beaches, to attitudes to cleaning up as dog owners, from health issues to civic pride. The campaign will reach across social media and local community groups and Tidy Towns groups will be asked to share images on social media.











Green Dog Walker: The Green Dog Walker Campaign is being promoted and registrations are through the website.

LIBRARY SERVICE

Travelling Tales Launch

On Tuesday 14th June a launch was held for the Travelling Tales exhibition. An Cathaoirleach Barbara Anne Murphy officially launched the exhibition and associated

book. Travelling Tales was a multi-generational visual arts and writing project, celebrating the voices of Traveller children in three Co. Wexford schools. The schools involved were Our Lady of Lourdes, Bunclody, Bunscoil Rís, New Ross, and St Fintan's National School in Taghmon. Children from these schools worked with author Caroline Busher and artist John Busher, exploring the heritage and culture of their community.

Beginning in 2019, the project was supported by Wexford Public Library Service and the Dormant Accounts Fund. With John and Caroline, the children wrote stories and poems, created artwork, puppets, ceramics and textiles, and made a short film. All of this formed part of the exhibit and are documented in the Travelling Tales book which has been published by Wexford County Council and is being circulated to primary schools in County Wexford. At the launch the children read some of their stories to the group, they sang songs and the short animated film was screened.

Services to Ukrainian Nationals

Wexford Library Service is part of the County Community Response Forum and is working with agencies and volunteers to support Ukrainian families use all library services. Translators accompany groups and library staff on library tours, to help adults and children join the library and learn to use the library App and all eResources. These eResources include Borrowbox for literacy and reading, Transparent Languages to learn english, Libby and PressReader. The book collection provides fiction for children in the dual languages Ukrainian and English languages. Adults are introduced to the Wexford County Council website translation service Recite. Children are invited to join storytime, the Summer Stars Reading Adventure and to take part in all summer events. A guide to use the library is translated into Ukrainian and is available on the website. Libraries are also used as venues for group and one to one tuition.

IT Literacy

Wexford Libraries' Age Friendly Digital Ambassador Programme continues to grow with training courses returning for older users throughout the libraries. People had the opportunity to ask questions and practice with Tekcentral training providers. This aims to provide senior citizens with help accessing the internet, downloading library apps and accessing our online resources. Local Libraries will provide tutoring sessions over the phone and in person, for older people. Through these tutoring sessions, participants will be

empowered to access the range of online library services, particularly BorrowBox which is used to download books and audio books to a phone, tablet, or laptop/computer.

Health and Wellbeing

The Triple P Lifestyle Seminar "Positive Parenting for Healthy Living" took place in Libraries across the county. These seminars were facilitated by TUSLA CFSN Coordinator Linda McCann. The 90 minute seminar, suitable for all parents of children up to 12 years, focused on supporting parents to learn how to use positive parenting to promote their child's health, development and well-being and to encourage their children to learn the skills they need to develop healthy lifestyle habits.

The Environment

Two public meetings took place in New Ross library on the 28th June on the topic of radon gas. Exposure to radon gas in Ireland is linked to 350 lung cancer cases each year in Ireland so it is a significant public health hazard. The meetings were hosted by Wexford Public Libraries, in partnership with the Environmental Protection Agency (EPA) and supported by Healthy Wexford. Experts in radon provided information on practical ways of protecting your family from radon. Information was also provided about the Digital Radon Monitors loan scheme that you can borrow for free from your local Wexford library to measure radon levels in your home.

Literacy and Children's Services

Summer Stars 2022

Summer stars was launched on countywide in June. Summer Stars is an exciting reading-based programme which is available free of charge to children across the country. Children are invited to register for the adventure and encouraged to enjoy reading many books during the summer holidays. All participants will be given a Summer Stars Reading Card to track their own progress and a library reward stamp will be added to their reading card at the library after each book is read. There will be rewards along the way, and at the end of the adventure, all children who participate are invited to attend an award event at which they will be presented with their own Summer Stars certificate. Many events for children will also be held in the library during the summer. The Reading Adventure is free to join, and all are welcome.

Mobii Vista Interactive Magic Table.

A number of visits to use the Omi Vista magic tables were facilitated in June in New Ross and Gorey Libraries. The Mobii Omi vista magic table is an interactive sensory projection system that can be used for games, music and social activities to motivate all generations on a table or floor surface. The projection system more familiarly known as a Magic Table, is used to provide sessions for children and adults with learning difficulties or people with Dementia and Alzheimer's. It offers fun and interactive floor and table activities and games. The magic table has been designed to provide a diverse selection of meaningful personcentred activities for all adults with learning disabilities, regardless of age or ability, with all the elements necessary to stimulate, engage, relax and provide enjoyment.

Art and Culture

Nature in art - The Master, with Dave Daly

Wexford artist Dave Daly gave an illustrated talk about the great Swedish painter Bruno Liljefors (1860-1939) and his influence on generations of artists and how painting nature has developed over the past century. Dave described how observing nature directly in the field is the key to understanding the natural world and being able to portray it on paper.

Local Studies

In June 32 local studies enquiries were responded to. There were also 23 genealogy enquiries. 28 microfilms were used along with 72 local reference books.

Decade of Centenaries

Professor Diarmaid Ferriter

Professor Diarmaid Ferriter is an Irish historian, broadcaster and university professor in Modern Irish History at University College Dublin. He has written eleven books on the subject of Irish history and co-authored another.

His most recent book is *Between Two Hells: The Irish Civil War*. It was this period of Irish history that he discussed in the library. The lecture covered the background to the Civil War, the devastation wrought by the conflict itself and its troubled and complex legacy. More than 100 people were in attendance.

The Battle of Enniscorthy with Historian in Residence Barry Lacey

At the outbreak of civil war in county Wexford, Enniscorthy Town was a battleground for several days in early July, playing host to heavy fighting between anti-treaty IRA forces and the National Army. Historian in Residence Barry Lacey discussed the build up to the battle, personalities involved and its aftermath in this illustrated talk.

This initiative is funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under the community strand of the Decade of Centenaries 2012-2023 programme.

Decade of Centenaries – Wexford County Archives

'The Treaty 1921: Records from the Archives' exhibition – presented by the National Archives in association with Wexford County Council – which opened in County Hall on 23 May closed to the public on 10 June. Feedback from the invigilators and from visitors to the exhibition was very positive – the exhibition attracted a total of 454 visitors over the 14 days that it was open to the public.

To complement the Treaty exhibition, a talk was delivered by Lisa Dolan, Outreach Archivist from the Military Archives, Dublin in County Hall on the evening of 7 June. Lisa's talk, 'From Truce to Civil War period – sources from the Military Archives relating to County Wexford (1921-23)' attracted an attendance of 58 and was a very useful way of establishing contact with the relatives of participants from the period.

The Archivist delivered a talk in Wexford town library on 30 June on 'The 1921-23 period in County Wexford as reflected in the holdings of Wexford County Archive'. An illustrated presentation, the event was an invaluable means of publicising a number of important collections from the period, some of which are soon to be uploaded to the archive's website for enhanced public access.

Community Projects Funding 2022 – call for applications

Wexford County Council, in association with the Decade of Centenaries Programme of the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media announced community funding available for local groups and local cultural and sporting institutions throughout County Wexford to play their part by developing a project to mark the centenary of historical events in their local area.

The funding will support local and community organisers to develop projects or events that commemorate the Decade of Centenaries: the War of Independence; the Civil War; labour

unrest; social changes; cultural life in the 1920s, local responses to Dáil Éireann; the truce; partition; local connections with the wider world and new political representation at a local level. The following projects were successful.

ARCHIVES

Collections management

In addition to 57 research enquiries via email, telephone and post, a total of 16 researchers visited the Archive during June. Research topics included: research through the Power estate papers (1710-1893); research through extant burial registers for the four municipal burial grounds in Wexford town (1883-1946); research undertaken by the Savannah students (see below).

Outreach

Wexford County Archive welcomed 13 students from the Irish Research & Teaching centre at Georgia Southern University, Savannah in early June. The students whose primary interest was to find further evidence of the links between Savannah and Wexford for the 1847-52 period spent two days in the reading room undertaking detailed research through editions of the *Wexford Independent* and through some relevant handwritten correspondence from the Graves papers for the period.

ARTS

Local Live Performance Programming Scheme (LLPPS)

Round 3 (Jan – June 2022) & Round 4 July – November 2022)

The Arts Department is overseeing the implementation of the LLPPS schemes funded through the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media via all local authorities nationwide.

The aim of this scheme is to provide support the live performance /music industry which has been so badly affected by Covid. Ongoing work is continuing with the five Municipal Districts. A panel of qualified event companies are currently delivering Round 3 in the five districts with the final concerts/ events happening by end June 2022.

June performances included Sharon Shannon & Muireann nic Amhlaoibh in Carrig on Bannow Church, a Ukrainian concert in St Michaels Theatre, New Ross, Billy Roche and his band in the National Opera House, Jack Lukeman in Bunclody Golf club, local live bands in Ferns, Comedy on the Quays in Wexford Town and a series of family fun days took place in Courtown and Gorey.

An Open call for Round 4 was sent to the panel of events companies in June 2022 with closing date Monday 4th July.

Peripheries MEET - Gorey school of Art

The Arts Department was delighted to support Gorey School of Art in 2021/22 correspondence programme with a group Exhibition Peripheries MEET #2 which was opened from 18-25th June. The exhibition revolved around the eight participating artists who discussed their work with mentors and most importantly, between themselves. The mentors tried to question the motives behind the student's artmaking, whether personal, public, or both, and gave them feedback in terms of their motives. This exhibition is the outcome of that questioning.

PLATFORM 31 The Arts Department is delighted to announce visual artist **Serena Caulfield** as the recipient of Platform 31 Artists Support Scheme 2022. This scheme was designed to support and enable career development for 31 mid-career artists – one artist was selected by a national panel from each of the 31 local authorities around Ireland. There are two elements of support for participating artists in this pilot scheme: financial

and developmental. Participating artists receive a bursary of €8,000 bursary to invest in themselves and their practice, combined with participation in a developmental programme which includes coaching, advisory support, and networking opportunities.

Small Arts Festival and Experimental Events Grant Scheme 2022 recipients:

SpringMoves Dance festival -

SpringMoves Dace Festival took place in Wexford town Friday 17 – Sat 18th June – with live outdoor street dance events taking place the Bullring mall, and indoors workshops and dance events in the National Opera House. In addition, the festival included a performance by the highly acclaimed Liz Roche Dance company in the National Opera House and a masterclass in dance meets circus in partnership with ISACS – the Irish Street Arts Circus and Dance Ireland.

Irish-Polish Folk Night, PolskaÉire Festival 2022 in Gorey opened with the Ryszard Tatomir's photography exhibition "The amazing world of salt – Wieliczka Salt Mine' followed by The Irish-Polish Folk Night which was a tuneful return to their musical roots and an opportunity to strengthen Irish-Polish ties through traditional and folk music. On the Saturday a PolskaÉire festival for kids was held with free shows and entertainment in the Civil Square, Gorey.

County Wexford Youth Film Project is based in St. Michael's Theatre, New Ross. The project trains young people aged 13 – 20 in the art of filmmaking and provides them with an opportunity for creative expression through an accessible and exciting medium. In July & August CWYFP will offer free Filmmaking and Animation workshops in St. Michael's Theatre. This workshop is free to teenagers across County Wexford and is funded by The Arts Department, Wexford County Council, and the Creative Community Programme.

CREATIVE IRELAND

Cruinniú na nÓg 2022

On Saturday June 11th young people across County Wexford danced, sang, drummed, juggled and painted as part of the annual Cruinniú na nÓg celebrations. Cruinniú na nÓg, Ireland's national day of creativity for children and young people, was celebrated right across Ireland with thousands of young people participating in the event. Young people dove into the past with writer Caroline Busher, explored early year music at the National

Opera House and launched an art installation created by young artists at the ArtBank in Bunclody. The County Libraries were bursting with creativity from the Big Dig workshop with the Irish School of Archeology, workshops exploring imagination, animation, drumming and Calmast exploring the science of colour.

The rain held off for the most part and allowed young people to explore their surroundings with nature themed events happening in parks, gardens and trails around the County. Kilmokea House and Gardens hosted foraging workshops, The Blackbird Cultur-Lab explored growing and the magic of trees, the biodiversity parade in the Peace park celebrated the local flora and fauna, and the Tara Hill Art Trails organised by Gorey School of Art engaged families with outdoor art activities accessible through QR codes on the day. Amongst all the activity on the day the winners of the *This is Art* competition were announced with a Wexford artist taking the top prize in the 16- 18 year old category. Cruinniú na nÓg is a collaboration between the Department of Culture, Heritage and the Gaeltacht, the Creative Ireland Programme, local authorities and RTÉ.

South-East Greenway Art project

An Open call for artists took place in May 2022 for expressions of interest from visual artists for a public art commission along the South-East Greenway valued at €20,000. Led by the Arts office and Special Projects Team, and funded through Wexford's Creative Ireland programme, the focus of this project is on socially engaged arts practice with a professional artist developing art work in collaboration with local communities and surrounding areas. The work must respond to the context of the South-East Greenway and related themes identified in the artists brief along the Wexford rural route. This process will result in public art presented along the Greenway for visitors to experience and share. Closing date for expressions of interest: Thursday 23 June 2022 and selection panel meets at the end of June.

'Re-Imagining Enniscorthy' Public Art & Community Decarbonisation

To coincide with National Biodiversity Week in May 'Re-Imagining Enniscorthy', a public art & community engagement project, led by visual artist Elaine Harrington and Ciara Roche, aims to develop a local ecology network for people led climate action, based in Enniscorthy. This project is supported Creative Ireland and the Per Cent for Art Scheme and is supported by the Arts Department and Climate Action Team of Wexford County Council.

The project aims to create a local ecology network through differing strands of community food growing, and free community workshops, connecting private, public, and communal green spaces in the town. The project runs from April 2022 – April 2023 and it aims to continue and have a legacy for local communities in Enniscorthy and surrounding districts.

Summer 2022 online training supports for artists

Funded through Creative Ireland and delivered by Visual Artists Ireland (VAI) the Arts Department has arranged *Starting & Re-Starting Your Career* a webinar (via zoom) for Wexford artists to attend on 22nd June. This webinar addressed entering the art world and focused on those artists who may have lapsed practices and wished to re-establish themselves, their studio practice and begin producing work again. Another webinar and in person clinic will be advertised in July.

Creativity in Older Age Scheme – My Place, My Community: A Memoir

My Community: A Memoir is a project where older people from the estates of Belvedere, Ashfield and Ferndale at Coolcotts, Wexford come together to tell the story of their place and the people who lived there through story, film and song over the last 40 years. Some tales will take the reader back in time to when the three estates were first built; others will offer a contemporary perspective on the area's recent history and culture. Many of these stories will reflect how life in the locality has changed dramatically down through the years, particularly for members of the original community. Contributors will include settled people, members of the Travelling community, those from the more recently-arrived 'new communities' and from the diaspora.

Together they will publish a book that documents the collective memory of their community. It will feature photos from the archives, as well as some people's personal photos. A short film will document the creative process involved. It will complement the publication by featuring additional material that may include footage of the local area, footage shot during the song writing workshops, as well as short interviews or vox-pops with the participants. An intergenerational element will be included where possible, to transfer knowledge and skills, to compare experiences then and now and in the final celebration performance.

Budget 2023

The Finance (Local Adjustment Factor) Regulations 2022 are to be issued shortly. It is expected that these regulations will revert the Local Property Tax (LPT) public consultation period and Local variation factor decision timeline to the pre 2021 timelines. The 2021 timelines were amended to facilitate the national LPT revaluation exercise.

It is expected therefore that the 30 day public consultation period will be completed in August.

The results of the public consultation exercise will feed into the first statutory decision in relation to preparation of Wexford County Council's 2023 Budget, the Local Property Tax – Local Adjustment Factor (LAF), which is expected to be included on the agenda for the September meeting. Members will be required to make a decision on the local variation factor for the 2023 Local Property Tax charge in the county and a report will be issued to members in advance of that meeting to facilitate their consideration of this decision. The report will include details of the public consultation and we also expect to have details of the outcome of the national revaluation exercise and its impact on LPT levels in County Wexford from 2023 and will include these in the report together with other relevant information to assist the decision making process.

Rebuilding Ireland Home Loan (RIHL) and Local Authority Home Loan (LAHL)

Circular 20/2022 of 3rd June 2022 has confirmed that due to an increase in the cost of finance from the Housing Finance Agency (HFA)2, the fixed interest rate for all new loans drawn down under the Rebuilding Ireland Home Loan (RIHL) and under the Local Authority Home Loan (LAHL) will increase from 1 July 2022.

This notification will result in changes to customer interest rate which will also increase under both the Rebuilding Ireland Home Loans and Local Authority Home Loans, and these increases also became effective from 1 July 2022. The following table provides a summary of the changes now being applied to all new loan drawdowns

- These HFA interest rate increases will be passed on to new borrowers for new mortgages drawn down from 1 July 2022 onwards.
- The new interest rates will be 2.845% for mortgages up to 25 years and 2.945% for mortgages between 25 and 30 years.
- The interest rates on existing mortgages will not be affected.

Audit of Accounts 2021

In accordance with the Local Government (Financial and Audit Procedures) Regulations 2014, the Local Government Auditor will formally commence the Audit of Wexford County Council Accounts for 2021.

Audit Committee

The next meeting of the Audit Committee is scheduled for October and is expected to include consideration of the 2021 Statutory Audit Report.

Cash Flow/Overdraft

The Council continues to operate with an overdraft facility, Ministerial Sanction is in place for borrowing by way of overdraft in the amount of €20m for the period to the 31st December, 2022.
