Local Enterprise Office

Local Enterprise Development Plan 2021 -2024

The plan has been approved by Enterprise Ireland and copies are available on request. Minister Damien English is planning on visiting Wexford, and we are awaiting confirmation of dates. As part of his itinerary, he will launch the plan, meet a number of client companies and visit the Council Offices – full details of the itinerary will be fleshed out once the date has been confirmed.

Budgets and Metrics for 2022

The budget letter has issued with a total allocation of €1,209,001 for 2022 covering pay, non-pay, training, consultancy and financial aid. Metrics will be agreed over the coming weeks and will be based around seven strategic objectives;

- Provide an enhanced and nationally recognised First Stop Shop referral and advisory service through the network for startup and expanding businesses.
- Fostering and supporting local entrepreneurship.
- Increasing the level of innovation within micro and small businesses.
- Improving competitiveness and productivity of small and micro enterprises through enhancing SME management capabilities
- Enhancing the confidence, ambition and leadership skills of small and micro enterprises.
- Increase the export capabilities of small and micro enterprises, in particular beyond the UK.
- Promoting economic development at local level.

National Enterprise Week

A series of training events took place over National Enterprise Week which ran from the $7^{th}-11^{th}$ March. A highlight event of the week took place in Johnstown Castle celebrating International Women's Day with over 80 in attendance. This is the first networking event that took place since the pandemic started with a very apt theme "Together Again". The guest speaker was Jacinta Kidd. Judging for the county Wexford Student Enterprise Awards also took place during the week and the Awards Ceremony is scheduled to take place on the 22^{nd} March at 6.45 pm in Carricklawn. Six companies were shortlisted and interviewed for the National Enterprise Awards and the winning company that will represent Wexford at the National Awards is Professional Hair Labs. The runner up was Hoop Medical Ltd.

Export Development Advisor

The procurement process has been completed and the contract has been awarded to the winning tender, Marketing Mix Communications. This role will be particularly important in working with our client portfolio to explore and develop export opportunities and assist existing exporters deal with Brexit issues.

Economic

Town and Village Streetscape Enhancement Scheme

Works are continuing across the towns of Enniscorthy, Gorey, Kilmore Quay and New Ross under the Town and Village Streetscape Enhancement Scheme 2021 which was announced by Minister Humphries, Department of Rural and Community Development in August 2021.

Out of 116 successful applications, 28 applicants have completed their works and €71,480 has been

paid to the applicants.

Business in the Community Ireland World of Work



On the 14th February, a group of second year students from Coláiste Abbain, enjoyed a site visit to Wexford Library and Wexford Fire station. This trip gave the students an opportunity to visit a workplace, learn about each facility and ask questions.

The students were given a tour of the library and an overview of all the services that the library has to offer from borrowing books, research, 3-D printing, study, eBooks, eResources, the Wexford Library App and how to sign up. They then went on to visit Wexford Fire Station where the students were shown the Fire Engines and given an explanation about the equipment used by the firefighters such as the self-contained breathing apparatus, hose and cutting tools.

Tourism



Fáilte Ireland unveiled its priorities for 2022 to support the recovery of the tourism industry at an inperson event attended by representatives from tourism and hospitality at the Convention Centre Dublin on Tuesday, 8th February 2022. Fáilte Ireland announced that it is doubling investment in Marketing for Domestic Tourism to €10M this year. Fáilte Ireland are the new sponsor for the weather bulletins on RTE which over the course of a year will see 90% of all adults 15+ watching Television viewing the sponsorship sting advertising at least once which is the equivalent to 3.3M people. The advertisement segments before and after the weather bulletins will feature clips of county offerings throughout Ireland in addition to encouraging domestic visitors to book short breaks for bank holidays, special events etc.



The availability of Staff in the hospitality sector was noted as a major concern. It is estimated that there are 40,000 Vacancies in Tourism Sector, over a quarter of the sectors workforce who were forced to avail of PUP subsequently left tourism and the hospitality sector to work in other industries. To help combat the crisis, Fáilte Ireland has revealed it is tendering for a company to run a new Excellent Employer initiative, which is designed to improve working conditions and make tourism & hospitality business more attractive to potential staff. To receive the Excellent Employer designation businesses must sign up for 3 years, commit for all their managers to receive formal training on staffing issues and allow a formal survey of staff each year.

Ireland: the destination of choice for French school trips 2022/23



On February 3rd Tourism Ireland held a virtual discussion on school trips to the island of Ireland which featured experts in transport, accommodation and attractions from the Island of Ireland. A real concern from a Wexford perspective is the lack of youth hostels and budget hotels/accommodation.





On 12th January 2022 an Inaugural meeting between Rosslare Municipal District and the Urban Community of Dunkirk took place. The meeting was organised to create links, and to look at creating a more formal agreement for collaboration with both regions. Plans are in place for representatives to visit each region and to further enhance the collaboration process.

Outdoor Seating & Accessories for Tourism & Hospitality Businesses (OSAS)

The Outdoor Seating & Accessories for Tourism & Hospitality Business Scheme was funded by Fáilte Ireland and was administered by Wexford County Council. The scheme opened on 12th April 2021 and closed on 8th October 2021. This Scheme is now fully completed. A total of 211 applications have received funding with a value of €566,438.07

Built, Cultural & Natural Heritage

- Wexford County Council has been awarded funding under the Historic Towns Initiative 2022
 for two projects. €250,000 has been awarded for the renovation of a heritage building as a
 food and community hub in Templeshannon, Enniscorthy and €40,000 has been awarded for a
 heritage-led regeneration plan for Wexford. The Historic Towns Initiative is a joint initiative
 between the Heritage Council and the Department of Housing, Local Government and
 Heritage.
- Wexford County Council has received funding from the Heritage Council under the County
 Heritage Plan Projects Scheme 2022 for the three county-wide heritage projects. These
 projects are as follows: a Co. Wexford Thatch Survey; a Co. Wexford World War 2 Defence
 Heritage Recording Project, and a Wexford Wetlands Educational Project for schoolchildren.
- The Irish Walled Towns Network is inviting applications from local authorities who are partners in the network for funding for capital and interpretive projects. Both New Ross and Wexford are partners in the IWTN.
- The Department of Housing, Local Government and Heritage is inviting applications from local authorities for funding for projects under the National Biodiversity Action Plan (NBAP).
- WexBee Aware; In February 2022 apple trees were planted in various locations across the
 county under the Community Apple Orchard project with part-funding from the Department of
 Housing, Local Government and Heritage. Pollinator-friendly planting was also completed at a
 number of council-owned housing estates. A pollinator talk was given to the Green Schools
 Committee in the Presentation Secondary School in Wexford in December 2021.
- Rewilding Wexford; Three sites have been approved for native tree planting by the Forestry Service. The first of the sites, at Cushenstown, was planted in January 2022. The remaining two sites will be planted towards the end of 2022 during the next planting season.
- Website update; Information on heritage is now offered under the umbrella of 'Built, Cultural and Natural Heritage' which can be found in the Planning Section of Wexford County Council's website here <u>Built, Cultural and Natural Heritage | Wexford County Council (wexfordcoco.ie)</u>. Project information and grant schemes will be added to this page as required.


Forward Planning

Enniscorthy Town Centre Urban Design Framework

A second public consultation took place online on 17th February which had over 70 people take part in workshops to give their views on the future of the town centre. The consultation was webcasted from the Enniscorthy Council Offices in Market Square with participants invited into break out rooms where they worked on issues identified from the first public consultation. Earlier in the day the team also ran a consultation with secondary school students who also positively engaged in getting their views across.

completed for the 2nd quarter of this year.

NATIONAL ROADS

N11/N25 Oilgate to Rosslare Harbour

Environmental surveys are continuing throughout the 33km scheme corridor and will continue through 2022 (e.g. mammal, bird and habitat surveys, noise, air quality, landscape & archaeological surveys etc).

Further transport surveys are also planned for April 2022 to analyse traffic demand on the existing corridor and connecting roads. A tender competition for a geotechnical investigation contract will commence in April, with investigation works anticipated during the summer. These separate activities will all inform the design development and environmental assessment of the scheme and will generate increasing engagement with land and property owners.

A project newsletter was published in February to provide the public with further information on the project's plans for 2022.

N25 Rosslare Europort Access Road

Documentation for a planning application and Compulsory Purchase Order are currently being finalised for approval to proceed to the statutory planning processes. Planning documents include the following:

- Planning & Environment Considerations Report
- Natura Impact Statement
- Screening Report for Appropriate Assessment
- Screening Report for Environmental Impact Assessment
- Design Report
- Option Selection Report
- Compulsory Purchase Order Schedule & Maps

It is anticipated that a Section 177AE planning application & CPO will be submitted to An Bord Pleanála in late April following approval to proceed. Copies of the applications will be available to view and notices of the applications, arrangements and further details will be published in advance. Any submissions or observations may be made to An Bord Pleanála which may at is discretion hold an oral hearing into the proposed development.

The project is consulting with directly impacted land and property owners in advance of the submission of the planning application. A project newsletter will also be published in April in advance of the planning application and will be circulated in local outlets and public buildings in Rosslare Harbour as well as the project website and social media to provide the public with further information on the planning process.

2021 Pavement Schemes

N11 Ferns Pavement Scheme

The tender for the construction contract was awarded on the 11th August. Works commenced on 26th October

The surface water pipework, watermain and footpath works have been completed.

The scheme should be completed by the end of March.

HD28 Pavement Improvement Works N11 Oilgate Village

The scheme was tendered in November.

We received approval from TII to award the on contract on the 10th March. Due to the traffic volumes on the N11 this scheme will need to be carried out at night.

Works should commence at the end of April with a 3-week programme.

2022 Pavement Schemes

N25 Ballykilliane to Orristown Pavement Scheme (Estimated Total Scheme Cost €1,600,000)

This scheme is 2 km in length and runs between the R739 Kilmore junction to the L7050 Orristown junction on the N25.

Works are being carried out on the contract documents for the scheme with tender planned for April. Pavement works should commence in June/July.

N80 Tomacurry to Ballycarney Phase 1 (Estimated Total Scheme Cost €1,600,000)

The total scheme length is 3.7km. The allocation from TII for 2022 allows for the first 2 km at the southern end to be completed in 2022.

Work has commenced on the design of this scheme, with tender planned in May.

Pavement works should commence in July/August.

2022 Safety Schemes

N25 Ballygillane Roundabout (Estimated Total Scheme Cost €2,590,000)

This scheme was tendered in November 2021.

A Letter of Intent was issued to the preferred bidder in January.

A Letter of Acceptance will be issued on the receipt of approval from TII.

It is hoped to commence the scheme in April with a 3-month construction period.

Winter Maintenance

The 2021/2022 winter maintenance programme commenced on Monday 18th October 2021. There have been 43 call outs up to Monday 14th March 2022.

REGIONAL AND LOCAL ROADS

Resurfacing/Strengthening

The 2022 strengthening programme (Machinery Yard) commenced in the Enniscorthy District on 31st January 2022 at Bola Beg, Ballindaggan. The road is being resurfaced with macadam. The County's strengthening programme for 2022 is presently being finalised.

108 km of road was strengthened in 2021, including own resources and community involvement schemes funding.

Surface Dressing Works

The 2022 surface dressing programme is presently being prepared. 125 km of road was surface dressed in 2021, including own resources.

Community Involvement Schemes

12 roads (14km total) with a total estimated cost €1.155m for 2022 are under consideration by DOT.

Local Improvement Schemes

22 lanes, totalling 9km in length, were resurfaced 2021 at a cost of €653,786 funded by the Dept of Rural & community Development.

Bridge Rehabilitation Grant

19 bridge rehabilitations for 2022 (excluding those damaged 25/12/2021) at an estimated repair cost of €603,000 are under consideration by DOT.

Specific Improvement Works – The Deeps Bridge

The Deeps Bridge Remediation Project – RPS Consulting Engineers Ltd was appointed as Project Supervisor for the Design Process in March 2021. An underwater inspection of the bridge structure was carried out in 2021 and no defects were found below the water.

A structural inspection of the bridge was completed in 2021. This will inform the detailed design. A Stage 1 Appropriate Assessment Screening was completed, and the planned works did not screen out.

The resultant required Natura Impact Statement was completed and was submitted to An Bord Pleanala in 2021 as part of the planning application. The planning submission is presently being assessed by An Bord Pleanala. Design options will be developed over the coming months. Works are expected to commence Q 2-3 of 2022.

Climate Adaptation & Resilience Works

20 improvement projects for 2022 (excluding those damaged 25/12/2021) of estimated value of €1.134m are under consideration by DOT.

In 2021, Wexford County Council received €650,830 for 13 projects.

Works are complete on 11 projects with 2 projects rolling into 2022 due to design complexities. The 2 projects transferred to 2022 are Grange Beach cliff stabilisation works in New Ross MD and Adhare Bridge works in Gorey-Kilmuckrdge MD.

Active Travel Measures

The NTA confirmed an allocation on 24th January 2022 of €4.44m to Wexford County Council for projects in 2022. This funding is largely to complete projects approved in 2021 which are presently in design or construction stage.

In 2021, Wexford County Council completed 20 projects. There are 29 projects presently under construction. The remaining 22 are at design stage.

Over 7km of new footpath was constructed in 2021 in the county's towns and many of the villages providing important linkages for communities. The total value of work (construction and design) completed in 2021 was €3,145,653.

A design incorporating segregated cycle lanes, footpath and junction improvements has been finalised for Newtown Road (Wexford Borough District).

Designs are being developed for cycleways at: Beechlawn/Clonard Avenue; Roxborough (Wexford Borough District); Oaklands to Kents Cross (New Ross District); Rosslare Harbour - Kilrane Pedestrian and Cycle Scheme (Rosslare District); R772 Clogh to county boundary (Gorey-Kilmuckridge MD).

Flood Damage Christmas Day 2021 - Update

Of the 7 bridges that were severely damaged: Wilton Bridge; Kilcarbry Bridge Ballyroebuck Bridge; Mangan Lane Bridge; (Enniscorthy District); Aughnaglaur Bridge (Chapel, Adamstown); Cullenstown Bridge; Raheen Bridge (New Ross District), 3 are open to vehicular traffic at Mangan, Kilcarbry and Chapel (temporary).

Office of Public Works (OPW) Section 50 consent applications under the Arterial Drainage Act 1945 are being prepared and the design of permanent remediation works is ongoing. Derogation Orders have been received from Inland Fisheries Ireland. Permissions are necessary to undertake the permanent remediation works at Aughnaglaur (Chapel), Cullenstown Little, Wilton, Ballyroebuck Bridges.

Trees and debris lodged in bridges as a result of high-water levels have been removed from several sites with clearance works continuing. Minor damage to other bridges, specifically parapet walls, was experienced throughout the county and this is being assessed and repair works progressing well There was significant damage to over 13km of road throughout the county which is presently being surveyed and repairs are ongoing. €4M was received from the Department of Transport specifically for flood damage repairs in the County.

PUBLIC LIGHTING

LED Upgrade (Non National Roads)

Over 12,000 lanterns have been upgraded to LED since the beginning of 2016.

Design work is completed.

It is hoped to complete the upgrade of the remaining 300 to 400 lanterns on non-National roads and housing estates early in 2022.

Public Lighting Development Fund

Additional public lighting is being installed at the following locations under the Public Lighting Development Fund.

- Ballygarrett Village Contract awarded. Works to commence in March 2022.
- Balintray, Courtown Contract awarded. Works to commence in March 2022.

Just One Life Road Safety Campaign

The Just One Life Road Safety Campaign kicked off with the first demonstration held in the National Opera House on 2nd March. This effective road safety initiative, in partnership with An Garda Siochána and Wexford Rotary, is aimed at all transitions year students throughout the county. Further demonstrations are planned later in the year.

Homeless Services and Support Unit (HSSU)

An integrated Homeless Service Centre (HSSU) was opened in Wexford in 2019 where relevant service providers proactively work in partnership with clients who are homeless or facing homelessness. The Centre offers homeless supports, advice and services in one location, with an emphasis on homeless prevention and supports.

County Wexford Joint Policing Committee

As in line with the rescheduled March Meeting date of Wexford County Council, it has been agreed to defer the Meeting of the Joint Policing Committee to the 28th of March 2022 at 10.00am in the Council Chamber & MS Teams.



The focus of the meeting 'Drug Misuse in County Wexford'.

Wexford Local Economic and Community Plan

The LECP Guidelines were officially launched on the 11th November 2021. The new revised guidelines build on the lessons learned from the current LECP cycle, as well as reflecting the needs of communities as we emerge from the Pandemic. The new approach to the process, with a Framework LECP coupled with Implementation Plans covering a shorter period, will ensure LECPs are more agile and allow for emerging needs.



DRCD in collaboration with DHLGH will continue to support the development of the LECPs through a series of events over the coming months, which commenced with an online Introductory Event which was held in December. This event provided an overview of LECP Guidelines, highlighting what is new and the planned timeframes and is to be followed by a series of training webinars to ensure each LCDC will have the necessary skills to develop and implement their LECP.

LOCAL COMMUNITY DEVELOPMENT COMMITTEE (LCDC)_ -

A hybrid meeting of the Local Community and Development Committee was held on the 03^{rd of} March 2022. Both the Chairperson and the Chief Officer welcomed several new members to the committee and was the first opportunity for the LCDC members to meet in person throughout the Covid period



Agenda items included SICAP, a PPN presentation regarding 'Apprenticeships', Healthy Ireland and Age Friendly, with the members of the Wexford LCDC approving funding of €300k to 194 community and voluntary groups under the Community Activities Fund 2021.





LOCAL ACTION GROUP (LAG) -

A hybrid meeting of the Local Community and Development Committee acting as the Local Action Group, was held on the 03^{rd of} March 2022 with the members approving funding of approx. €219k for 7 projects under the LEADER Transitional Programme and EURI funding.

A regional meeting of the EMRA Chief Officers took place on 10th February 2022. via Microsoft Teams. The main items discussed included - LECP, LEADER, SICAP, Healthy Ireland & PPN. The next meeting is due to take in place in April.

SICAP

The LCDC approved the SICAP 2021 End of Year report and the 2022 Annual Plan at their March meeting. The 2022 SICAP budget allocations for Co. Wexford is €1,945,608, which represent a 11% (€193K) increase on 2021 funding. The LCDC approved Statement of Priorities for the remainder of the programme to the 31^{st of} December 2023 are:



- 1. New communities with particular focus on those living in Direct Provision.
- 2. Traveller and Roma.
- 3. NEET young people aged between 16-25 not in employment, education or training.

Community Activities Fund 2021

Funding of €300,129 was allocated to 194 groups by the LCDC under the Community Activities Fund 2021 during March. This once-off fund is being allocated under the DRCD's Community Enhancement Programme.

- 1. The Community Activities Fund supports groups, particularly in disadvantaged areas, with their running costs such as utility.
- 2. Groups also provided funding to carry out necessary repairs and to purchase equipment.

Burial Grounds

The perimeter wall at the old burial ground at the former St. Senans hospital, Enniscorthy were completed during February.

Playgrounds

Significant works were completed at Duncannon (inclusive roundabout), Cluain Dara, Gimont, Enniscorthy (complete surface replacement) and Mount Carmel, New Ross (new swings).

Age Friendly Strategy 2022-26

Special meetings of the Older People's Council and Age Friendly Alliance were held on 16th February 2022 to discuss and agree on the draft Age Friendly Strategy and action plan for the period 2022 to 2026. It is hoped that the final report will be presented at the April Council meeting for final approval.

Covid Care Concerts in Day Care Centres

Covid care concerts returned to Wexford on week beginning 21st February 2022 this time performing 15 concerts in Day Care centres throughout the county. The concerts featured world renowned tenor Anthony Kearns and musicians Lynda O Connor (Violin), Paul O Hanlon (Violin) and Gerald Peregrine (Cello). Feedback from the older people who attended included:

"that was so emotional, but good emotional. I feel like a new woman!"

A newly diagnosed dementia client said afterwards "My problem is my memory, you know, but I'm so happy that this music actually helped me to forget what is wrong with me. I felt normal again"

"It was without doubt the highlight of the year for our elderly after what has been an awful year for them with covid. Everyone was so engaged and are already asking when it will happen again".





Intergenerational Technology project with Colaiste Abhain



WCC Age Friendly Programme Manager Ann Marie Laffan, and Sergeant Eddie Wilde from New Ross Gardaí recently met with Lisa Farley from the Memory Technology Resource Room to learn more about the service she provides to older people living with dementia or other memory difficulties and their family members and/or carers. A variety of assistive technology is on display and Lisa also

provides information on devices and strategies that promote independence, safety and improve the quality of life for people experiencing memory difficulties. WCC have funded 4 tablets for clients of the service which will enable them to maintain their independence and stay connected with family and friends.



Walkability Report - Enniscorthy Age Friendly Town

A walkability audit of Enniscorthy was carried out in late 2021 with a report on the findings and recommendations to be published shortly. Work has already started on the ground which included the installation of age friendly seating in key locations in the town recently. This was funded by Healthy Ireland.



Telehealth

The Wexford Telehealth Pilot Project has been shortlisted for this year's CIO & IT Leaders Awards, taking place on Thursday, March 24 in The Shelbourne Hotel, Dublin. The category Wexford County Council has been shortlisted for is Pilot Project of the Year.



Phase 2 of the Telehealth pilot project has also commenced with Wexford one of six counties involved in this 2nd phase of the project. A demonstration workshop is planned for 9th March in Kilkenny and on 10th March in Waterford to recruit clinicians from each of the counties involved. Roll out of the project is planned for April or May 2022.

Wexford Dementia Alliance

A meeting of the newly established 'Purposefully Walking Group', a sub-group of the Wexford Dementia Alliance has been set up and met in February to identify solutions to issues identified by members in relation to people living with dementia. Working in partnership the state agencies involved, including the Garda and HSE are working to put processes in place.

Wexford Age Friendly and Comhairle na nÓg Postcard project

Wexford County Council and Comhairle na nÓg have joined forces on an intergenerational project that will connect older people and teenagers by sending a series of postcards to each other. The postcards are designed by local artist John Busher and depict local landmarks and stories from the olden days. Partners on the project include Wexford Gardaí Community Policing, Grantstown Day Care Centre, St. Louis Day Care Centre (Ramsgrange) and St. Bridget's Day Care Centre. The exchange of postcards commences in March 2022.

Accessing medical appointments meeting with relevant partners

A meeting was held on 21st February 2022 with all relevant agencies and voluntary groups to discuss the issue of older people accessing medical appointments. A working group has been established and will look at solutions for the issues identified for older people.

Age Friendly Hospital – Wexford General Hospital

Based on feedback received from the Age Friendly public consultations and Wexford Older Peoples Council, a meeting was held with Wexford General Hospital manager and Deputy Manager, other HSE staff and Local Link Manager to discuss making the hospital site more age friendly. The meeting was very positive with a follow up meeting planned.

Celtic Routes

Over 40 tourism businesses in Ireland have joined the Thematic Groups network, and a number more have expressed interest.

Our end of winter social media video has been viewed 43,000 times in the first week of posting on Facebook - 23rd of February.

The Project Officer presented to both the New Ross Municipal District Council meeting and the Gorey Kilmuckridge Municipal District Council Meetings in February, with a view to presenting to the Rosslare and Enniscorthy Municipal Districts and the Wexford Borough Council Meetings at the next available meetings.

All required Financial Claims and Management Verification Tests have been submitted and approved.



March 2022 Report

Healthy Ireland Fund 2019-2021 - Round 3

Activities under the **Healthy Ireland Fund Round 3** are nearing completion with the final date for fund activity spend 31st March 2022.

Covid impacts in early 2022 have caused some Action Partners to have to review activity but all working to complete by funding deadline. Returns and final reporting is required to Pobal by 6th May 2022, with all action partners required to provide final project reports and outcomes. Healthy County Coordinator will collate for upload along with financial reporting.

No detail has been provided for Round 4 Funding, as yet.

Healthy County Committee

The Healthy County Committee meets quarterly with most recent meeting being held on 8th February, and next due on 10th May. Working groups continue to meet and progress activititis and initiatives to deliver on the Healthy County Plan Strategic Priorities. Below are some updates on current Helathy Wexford Initiatives. The **'Seeds to Success'** community growing series launched online on 27th January. With one episode per week releasing the six episode series runs to 3rd March. Once released all videos remain available to view online at - Healthy Wexford YouTube.

To increase accessibility to those not online a 'boxset' DVD of the series will be created in March and available to borrow through Wexford Libraries.



With the premiere cancellation in January due to Covid, it is hoped to have an event to bring together community growers across the county in Q2, with an aim of increasing networking and knowledge sharing among all.



The 'Not Around Us' committee continue to develop the initiative and early 2022 saw continuation of the roll out of signage to our playgrounds and libraries, and ongoing sign ups and promotion. Beach signage will be the next public space focus.

The time lapse video from the 'Not Around Us' Sand Art Engagement Event featured on the HSE National No Smoking Day webinar on 2nd March.

The Sand Art event photos and time lapse video (https://youtu.be/u8bk3OTIFoE) will be used to highlight the initiative further and encourage additional sign ups across the county.



Continuing the youth engagement and co-creation activity, one of the youth groups signed up to the initiative plan to use 'Not Around Us' as their float theme in the St Patrick's Day Parade.

It is also hoped to encourage youth involving festivals and events to become 'Not Around Us' events. Initially the committee are encouraging this for St Patrick's Day Events.

- Wexford PPN are due to hold their first Plenary meeting in over 2 years in the Street, County Hall, Wexford on Thursday 10th March 2022 with numerous member group having booked a stand to exhibit their works.

ENVIRONMENT

A. COVID-19 RESPONSE

Throughout the third lockdown, work has continued in line with the CCMA's guidance document of 21st October, 2020. Office based staff are now working an alternate teams pattern to minimise attendance, ensuring that the office is covered while increasing physical distancing. All staff have the resources to work remotely while not physically in the office.

Outdoor staff continue to work to ensure the Civic Amenity Centres, Rapid Response Crews, Environment and Dog Warden Services remains operational.

Piers and Harbours staff are maintaining staffing levels in Wexford, Kilmore Quay and New Ross offices to provide support for essential workers.

B. COASTAL MATTERS

Harbours -

Department of Ag, Food & Marine (DAFM) recently announced a new scheme to develop works on LA harbours, called the Brexit Adjustment Local Authority Marine Infrastructure 2022 − 2023, with a total budget of €35m for all coastal local authorities. Wexford County Council is assessing the details of the scheme and will prepare suitable proposals to DAFM for approval. The first application deadline is 8th March 2022.

Fethard Harbour – New Slipway and Beach Access. Part XI planning application is being prepared for submission.

Ports Past and Present: Rosslare Ports Fest is scheduled for 17th and 18th June in Rosslare Harbour, event details in progress – updates available on website. There is ongoing engagement with the Rosslare community, artists and and our project partners in University College Cork and two Welsh universities. Regular updates and further information is available at https://portspastpresent.eu/

ISPS requirements for Marshmeadows Jetty ongoing, the adjoining site has been purchased by GreenBioFuels.

The regularization of the public lighting system on the Barrow has commenced.

Beaches -

Ballymoney – we are looking at options to improve accessibility to the blue flag beach.

Duncannon – bathing water quality has not reached the standard required for blue flag. Works are continuing on the Duncannon blue flag farming and community project and the construction of the wastewater treatment system.

Curracloe – has been voted the Best Beach in Ireland for the third time in the Irish Independent Readers' Awards for 2022.

Coast -

Rosslare Coastal Erosion and Flood Relief Scheme: Nicholas O'Dwyer Ltd Consulting Engineers was appointed on 13th Dec 2021. They will progress the scheme through detailed design, statutory consents, tender, construction and handover. Preliminary surveys and wors are getting underway.

Seaview, Kilmore: emergency works to protect the access road were completed in Jan 2022. Additional coastal protection works were carried out at the end of the public road. The overall coastal protection scheme is progressing with environmental surveys about to commence. Monitoring of this section of the coast is ongoing.

Lady's Island Water Level Management Structure – An Bord Pleanala granted planning permission for this development, dated 3rd Sept 2021. Foreshore licence application has been lodged and is under consideration by the Dept of Housing Local Government and Heritage. A public notice for the foreshore was in the local and national papers on 9th February 2022; with comments / submissions to be received by 10th March 2022.

Bike Stands; work is progressing to install approximately 50 bike stands at 13 beach/coast locations around the coast. This funding for these was received through the Active Travel Scheme.

Morriscastle Dune Restoration: The project involves installation of fencing and maram grass planting to restore and manage the dune system at main beach entrance. WCC received €11,475 in funding for this project under the National Biodiversity Action Plan Funding. Fencing works are completed on site; maram grass planting by the local community is scheduled for Spring 2022.

St Helen's Bay Preliminary Coastal Erosion Risk Management Study: Wexford County Council appointed consulting engineers to assess the erosion risk to assets including 23 properties and look at options to mitigate the risk.

Ballyhealy Preliminary Coastal Erosion Risk Management Study: in the process of appointing consulting engineers. This project involves assessing the erosion risk of 5 properties and look at options to mitigate the risk.

Grange, Fethard on Sea: works to protect sections of the public road from coastal erosion went to tender in Dec; due back mid Jan 2022. Tender recommendation report is being finalised.

C. PUBLIC CONVENIENCES

All public conveniences are now re-opened.

Minor refurbishment works to Curracloe Public Convenience and major refurbishment works to Carne Public Convenience have been completed.

D. WATER, AIR & NOISE

1. Water Framework Directive:

Under the Water Framework Directive every catchment in the county must be assessed to identify required actions to maintain and improve water quality. This work which is being carried out by Wexford Co Co in conjunction of LAWPRO is being supervised by the Sub-Catchment Unit of the EPA.

2. Water Sampling:

A Total of 556 water quality samples are taken by Council Scientists from 85 sampling sites in the county per year with analysis carried out by the EPA. 11 surveillance sites are being sampled 12 times per year.

3. Septic Tank Inspections:

Works have been completed on inspections for 2021. 91 inspections were carried out in 2021. Work has commenced on selecting areas and sites for Septic Tank Inspections in 2022. All work carried out is external with no requirement to enter a dwelling. Contractors are currently carrying out work on a number of sites in order to close the Advisory Notices

Progress is being made with open files. Letters were sent to owners requesting updates on works carried out, to enable the closing of files or offering extensions of time, as appropriate.

9 files have been closed and 1 extension of time have been granted in 2021. 18 Grant applications were paid in 2021. Seven new applications have been received this year to date, five of which are paid and two are currently under review.

There are currently 14 cases in the Court system for failing to comply with Advisory Notices. 5 of these are for hearing and 9 are for mention.

4. Climate Action

Both the Climate Action and Low Carbon Development (Amendment) Act 2021 and the Government of Ireland Climate Action Plan 2021 put additional responsibilities on Local Authorities in terms of Climate Action and moving to a climate neutral economy by 2050.

Local Authorities are identified as having a pivotal role to play in the decarbonisation transition. The Climate Action and Low Carbon Development (Amendment) Act 2021 requires each Local Authority to prepare their own Climate Action Plan. The plan must cover both mitigation and adaptation measures and must be updated once every five years.

Wexford County Council is also tasked with developing a decarbonisation zone which will become the focus for a range of climate mitigation, adaptation and biodiversity measures. Enniscorthy is the proposed Decarbonisation Zone for County Wexford.

In terms of Energy efficiency Wexford County Council achieved a 39.7% energy saving by end of 2020. The target was 33%.

The Climate Action Plan 2021 sets an even more ambitious target of 50% energy efficiency by 2030 and an absolute reduction in greenhouse gas emissions of 51%.

5. Noise and NAP 2019-2023

Noise complaints are dealt with on an ongoing basis. Two complaints of persistent noise pollution are currently under investigation.

The Noise Action Plan (NAP) 2019-2023 relates to general noise nuisance from large infrastructure or from motorways. Since the first plan was produced, Wexford County Council has steadily improved its resources with respect to the management of noise.

Wexford County Council submitted the Annual Noise Action Report describing all actions undertaken within the previous calendar year to the EPA in January 2021.

6. Agriculture:

Wexford County Council continues to undertake a significant number of farm inspections in accordance with the WFD. A total of 78 farm inspections undertaken as a result of pollution incidents or complaints, 45 of these farms were found to have non-compliances. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 were served upon on nine individuals.

A total of 120 Agricultural related Planning Permission Applications were assessed and a further two planning permissions were queried to assess if the applicant had complied with the conditions of planning permissions granted.

Wexford County Council completed odour monitoring assessments on a two separate sites in 2021 on foot of several hundred complaints from the public. These sites included a pig farm and a composting facility where compost is produced by processing straw and animal wastes. Section 24 & Section 26 notices under the Air Pollution Act 1987 have been served upon these businesses.

7. Duncannon EIP Project

Wexford County Council is currently lead partner in the Duncannon Blue Flag Farming & Communities Scheme. We were successful in receiving funding of €550,000 to run this project for 3 years.

The project is now engaging with 36 farmers covering over 950ha of the 1300ha catchment. To date, engagement with all farmers continue with approximately 4 visits to each farm every year where baseline and final "Pollution Potential Zone" surveys are carried out.

The project runs a results based reward scheme where an annual payment is made to each farmer based on their PPZ survey which ranges from €1,000 & €4,000. The farmer can also avail of a water protection improvement works grant which can be used to carry out like fencing watercourses, establishing arable grass margins, resurfacing clean yard areas, hedgerow establishment, riparian margins etc. To date, the EIP project has paid €130,000 in annual payments to farmers while funding of approx. €25,000 has being paid to farmers that have completed works.

1. Landfills:

Holmestown Landfill remains temporarily closed. Environmental monitoring and maintenance of infrastructure continues at both Killurin and Holmestown in accordance with the conditions of our waste licences.

The Household Recycling Centre at Holmestown continues to provide recycling services to members of the public as well as a disposal service for other waste streams such as residual waste, bulky waste, segregated food waste, garden waste and waste paint.

4. New Recycling Items

From September, soft plastics can be recycled through the domestic waste collection service. Soft plastic may include bubble wrap, plastic bags and similar wrapping are included in the new items that may be recycled. As with any other other plastics, these should be clean and dry and loose. For a full list of plastics that may be recycled please see www.mywaste.ie.

5. Enforcement:

The Waste Enforcement Team carries out routine and non-routine inspections of Waste Facilities and problem sites in accordance with the Recommended Minimum Criteria for Environmental Inspections (RMCEI) as required by the EPA. The RMCEI Plan allocates 1,752 routine inspections by 25 Full Time Equivalent staff member. The inspection types cover the WEEE (Waste Electrical and Electronic Equipment) Regulations; ELV (End of Life Vehicles) Regulations; Waste Management (Packaging) Regulations; Household and Commercial Food Waste Regulations; Batteries, Tyres, etc.

The Department of Environment, Climate and Communication have set national waste priorities for 2022 to 2024, a three year target and they are;

- Tackling significant illegal waste activity,
- Construction and Demolition Activity,
- End-of-Life Vehicles (ELV) & the Waste Metal Sector,
- Waste Collection Household & Commercial.
- Producer Responsibility Initiatives and additional local priorities.

Most Court cases are successful, but it can take up to a year or more for a case to be heard in the District Court. Due to ease of COVID restrictions cases are starting to be listed in 2022 sooner than 2021.

Wexford County Council had one successful litter prosecution in November and one in December with both defendants receiving a €150 fine and Wexford County Council awarded legal costs of €250 per case. In January 2022 we have had one successful waste management case under section 18 of the Act with a €250 fine awarded and €550 in legal costs and one litter case whereby €250 fine was awarded with €250 in legal costs.

Control of Dogs & Horses:

The Council employs one Dog Warden and an acting Dog Warden for holidays and relief. The main pound is Pets First Kennels, Ballycarney, Co Wexford.

Environment Education and Awareness:

Our aim is to promote awareness and active participation in a range of environmental initiatives.

Green Schools: Applications for 1st flags on the theme Litter & Waste must be submitted to An Táisce by 1st March. All green school renewal applications and assessments must be completed and submitted to An Táisce by April 1st.

School Workshops: Biodiversity and Leave No Trace workshops are being organised in schools. In total 10 schools will participate in the Leave No Trace and 20 schools in Biodiversity. It has been extremely difficult to timetable all schools due to current pressures on schools. The Leave no Trace workshops explore the 7 Principles of Leave No Trace and highlight the key impacts facing Irelands environment such as dog fouling and littering, and how these impacts can be minimised through the Leave No Trace programme.

Biodiversity workshops are for both primary and secondary and delivered in a manner to suit the school's Covid policy either in-person, online or fully outdoors. Projects range from Biodiversity Bootcamps to Pollinator Projects, Bird Blitzes to Treemendous Trees! Workshops can be tailored to the needs of each school.

Circular Fashion Workshop:

Textile awareness including consumption and disposal will feature significantly in the 2022 national and regional work programme. The Regional Waste Management Office have funded Circular Fashion Ireland, to deliver 1 workshop per County to a second level school.

Trees for Wexford Campaign: The Trees for Wexford Campaign received 154 applications. Trees were distributed to groups on Friday 4th and Saturday 5th February from Holmestown Household recycling Centre. This year the scheme distributed 539 trees, 13,500 saplings. In total since 2014 71,957 trees / saplings have been distributed to voluntary groups.



National Tree Week: National Tree Week takes place from 20th March to 26th March 2022 and the theme is "More forests for a greener future".

Community Clean Ups: Registrations and support for community clean ups will continue in 2022. 1331 community cleans ups were supported in 2021.

National Spring Clean: An Táisce have opened registrations for National Spring Clean.

Community Engagement: Community talks are ongoing with virtual meetings and outdoor meetings taking place.

Sustainable Gardening Course: This 5 week online course will take place on Tuesday mornings from 1st February until 1st March. Due to unprecedented demand and the course filling up in less than 24 hours a second course is being run and is also full.

Tidy Towns: A series of tidy Towns online talks / presentations are being arranged for April and May. Themes will include Biodiversity, Sustainable waste/ Sustainable Development Goals/ Climate Action and litter management.

Local Authority Prevention Network (LAPN): Funding was sought and approved for water refill dispenser at Blue Flag beaches. It is hoped that these will be installed before the bathing season commences.

Dog Fouling Awareness Campaign: The 'Bag It Bin It' will be reinforced by a social media campaign to run from early March. The campaign is set to firmly emphasize that dog fouling is your responsibility as a dog owner. The campaign will address a range of issues surrounding dog fouling, from its effect on the public who use our streets, parks and beaches, to attitudes to cleaning up as dog owners, from health issues to civic pride. The campaign will reach across social media and local community groups and Tidy Towns groups will be asked to share images on social media.











Green Dog Walker: The Green Dog Walker Campaign is being promoted and registrations are through the website.





LIBRARIES, ARTS & ARCHIVES

March 2022

LIBRARY SERVICE

Response to Covid 19

In February the library was open to the public for browsing and borrowing, study, computers, printing and Wi-Fi, and both adult and children's events. From Monday 28th February the wearing of face masks was no longer mandatory on public transport, in taxis, shops, schools and other indoor public areas such as libraries. From Monday 28th also there was no longer a need to book a study space in advance of visiting the library.

Book Call Delivery Service

The Book Call Delivery Service provides books to vulnerable citizens in our community. This service gives an opportunity to request books to be delivered directly to home. The service has seen a decrease in requests as libraries are currently open to the public, although some members still request books in this way. Book requests for this service are taken individually by each local library and processed by Wexford libraries. There were 20 book call requests for the month of February.

Footfall

Over 16,646 persons visited Wexford Libraries in the month of February.

Issues of library materials

25,971 items were checked-out from Wexford Libraries in the month of February.

Study Spaces

Study spaces continued to be used daily in the libraries. In February, there were 174 users with a total of 405 bookings. There was a total of 652 hours of study space booked. From Saturday, 26th February 2022, study space capacity increased in Wexford Libraries and due to this there is no longer the requirement to book a study space at this library.

Literacy and Reader Development

The Art of Reading Online Book Club with new Laureate for Irish Fiction Colm Tóibin, Thursday 24th February.

In partnership with Libraries Ireland, the new Laureate for Irish Fiction, Colm Tóibín, will present The Art of Reading, a monthly book club for library book clubs across the country and offered as an online event for readers everywhere on the last Thursday of every month. Over the course of the year, the Laureate will discuss a selection of titles by Irish writers, highlighting outstanding Irish writing and celebrating the reader and book clubs. The Laureate will be joined by the featured writer in conversations about their books. The first online book club event featured Colm in conversation with Claire Keegan about her recent book Small Things Like These. It is available to view on the Arts Council social media.

Ireland Reads Campaign Public Libraries Initiative in partnership with Healthy Ireland

Ireland Reads was a campaign to get the whole country reading during the month of February, in the lead up to a National Day of Reading on Friday, February 25^{th.} People all over Ireland were invited to get involved by pledging to 'squeeze in a read' on **Ireland Reads** Day.

To coincide with Ireland Reads Day on 25th February, Librarian Imelda Carroll interviewed bestselling and award-winning Irish author and Ambassador for Ireland Reads, Liz Nugent. This is part of a series of "Fully Booked" online literary events available through Wexford Libraries Facebook pages and YouTube channel.

Story Sack day took place in libraries at the end of February, parents and young children joined in this special Ireland Reads day story time.

Online children's Rhyme-times for children were made available for the entirety of Ireland Reads day from the Wexford Libraries Facebook page.

Win a Book Voucher

Wexford Libraries adult members were invited to enter a book token draw to celebrate Ireland Reads day. The winner was drawn from the library receipts collected from adults who returned or borrowed books during the week preceding Ireland Reads day.

Book of the Month Book Club Online met online on Wednesday 23rd February. This month they discussed *The Vanishing Half* novel by Brit Bennett.

Sensory Toys and Assistive Resources (STAR) Collection

The Special Educational Needs (SEN) Book Stock Collection support children with additional needs. It available to borrow from all five library branches. The SEN Books include stories for children with sensory issues, those who face challenges with sight, hearing, speech and language development, children who are non-verbal and books to assist with behavioural issues.

New: Sensory Reader Pens are a new addition to the STAR collection and introduced in February. C-Pens (Reader) were added to the STAR collection. The pen can read words along with full lines of text aloud with a natural speaking voice for independent reading. Suitable for people with dyslexia, reading difficulties or pronunciation, and people learning languages with vision difficulties. The devices have built-in dictionaries, offering users the option to access definitions of the words as they read.

Health and Well-being

The **Healthy Wexford** 'Not Around Us' initiative provides smoke and vape free spaces for young people. New signage was erected in the outdoor areas to the front of Libraries in February to inform the public of this initiative.

Business

Work Matters

The Libraries continued to promote Work Matters Business eResources online in the February e-mail newsletters, giving mention to business and employment eBooks and eAudiobooks on BorrowBox, and business training courses on Universal Class. Customers have also been advised that they can email Wexford Libraries in advance with their business queries for Mintel and Business.ie. Contact was made with a Local Enterprise group to promote the online research facilities available to them Wexford Libraries contributed to the Local Enterprise Office National Enterprise Week Programme with an event by Mintel. On Friday 11 March, Analyst Brian O'Connor gave a Zoom presentation on "Demystifying Market Research". The talk introduced some of basic tenets of market research for new entrepreneurs and start-ups, through the lens of Mintel's own day-to-day research efforts.

History

Wexford Playwright Commission Award

Wexford County Council, in partnership with Wexford Arts Centre, is delighted to announce Eoghan Rua Finn as the recipient of the Wexford Playwright Commission Award themed around commemoration of the period 1916-23. This award provides a €10,000 bursary to the playwright to research and develop a new theatre work, addressing themes of commemoration of the period 1916 – 23. This commission forms part of Wexford County Council's Decade of Centenaries Programme (2012- 2023) and is funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under their Community Strand. The aim of this new work is to respond, with sensitivity, to the historical context of the revolutionary period in County Wexford and to promote a deeper understanding of the significant historical events of one hundred years ago. The new work will encourage reflection today about the multiple identities, traditions and perspectives that are part of the overall Irish historical experience. Over the year Eoghan will further research and develop his script in relation to historical context of the period in County Wexford and will have full access to Wexford County Council Library and Archives with their extensive digital archives relating to this period.

Online Talks

The Transfer of Power in County Wexford in 1922 with Historian-in-Residence Barry Lacey 25th February at 10.00am. Historian-in-Residence Barry Lacey discussed County Wexford in the context of the months following the ratification of the Anglo-Irish treaty in January 1922, the transfer of power and the lead up to the Irish Civil War.

Local Studies

During the month of February there were 50 local studies enquiries and 20 genealogy enquiries. There were 17 sessions on the microfilm readers and 36 microfilms issued, along with 46 books and other hardcopy reference material issued.

ARCHIVES

Collections management

In addition to 32 research enquiries via email, telephone and post, a total of 5 researchers visited the Archive during February. Research topics included:

Research through the Edward Roe archive and a training log manual belonging to Richard Hanrahan for references to members of New Ross and Cushinstown companies of 1st Battalion, South Wexford Brigade, IRA who were active during the 1922-23 period; research through the burial registers of

Crosstown cemetery for family history purposes (1912-70); research in the Wexford Festival Opera archive for production photos, posters, publicity materials and press cuttings for the period 1968-79.

Acquisition

A small leather pocketbook was deposited in the Archive which recorded handwritten genealogical details of the Barringtons of Ballycogley (1740-1776) and which accompanied a detailed pedigree of the family researched by a descendant (1661-present).

Preservation

A recent acquisition of three auction posters were conserved during the month. Originally pasted unto a wooden board, the printed posters had sustained adhesive damage and paper tears – the conservation project involved their removal from the board and minor paper repair. The auctions, dated 1881, 1900 and 1912 detailed house properties in the Faythe, Clifford and Bride Street in Wexford town and in Clonard Great on the town's outskirts.

ARTS

Spring 2022 online training supports for Artists

Wexford County Council Arts Office are currently supporting and delivering *Friday Fix 2022* an online training initiative for artists. These informal sessions will take place on the last Friday of each month on Zoom and present an opportunity for Wexford artists and members of Artlinks to connect whilst also participating in sessions aimed at helping develop their career. Hosted by curator and mentor Eamonn Maxwell, the programme over the next few months will feature sessions on working in the public realm, promoting yourself online, writing about your work, residences, artists copyright, and studio visits.

Artlinks- Open call Artists' Bursaries

The closing date for applications was 28th February and applications are currently under review. Artlinks offers professional development support for emerging and professional artists in the Southeast Region with Wexford, Carlow, Kilkenny and Waterford art offices. Total fund for Wexford is €25,000 for artists across all artforms. The Artlinks award in Wexford has average grants of €1,000 - €3,000 max. Another element of Artlinks, an additional Collaborative Award for artists from two or more Artlinks counties worth €10,000 and will be announced in March 2022.

Small Arts Festival and Experimental Events Grant Scheme 2022

Closing date was Tuesday 22nd February 2022 applications are being collated and reviewed. This grant scheme aims to promote and support a diverse range of small arts festivals and experimental events throughout Wexford County. The focus is on festivals/events of high artistic quality that are innovative and have a strong emphasis on public engagement. The total award fund is €25,000 with an average of 12 festival/ events awarded per year with grants between €1,000 - €3,000 max.

Screen Wexford Full time Film/ TV Coordinator

Interviews for film coordinator took place on 10th February 2022 following a procurement process. This contract is co funded by Arts and Economic Development Departments.

Screen Wexford- The Peggy Walsh Award for Female Camera Talent

This mentorship programme is aimed at supporting female cinematographers and camera operators by arranging a key mentor from the Irish film and television industry to advise on professional career advancement through development of technical and creative skills over a period of six months. The programme will run for three years and is open to Wexford based female camera talent or those who are originally from the county. The total value of the award is €4000. The successful applicant will be chosen by Wexford native Jessica Drum – camera op and Chief Executive of the Screen Guilds of Ireland.

The Irish Society of Cinematographers will be involved in recruiting the Cinematographer who will provide mentorship, with the mentor receiving a fee of €1000 to cover their time. The mentee will receive a bursary of €2000 to support the making of work during the mentorship. They will also receive €1,000 in support from 24-7 Dramakit rental company as well as a sponsored annual membership with Women in Film & Television Ireland who promote greater representation of women on screen and behind the camera. Local Live Performance Programming Scheme Phase 3 (LLPPS) (February-June 2022) Wexford County Council Arts Department is overseeing the implementation of the LLPS scheme funded through the Department of Tourism, Culture, Arts, Gaeltactht, Sport and Media. The aim of this once-off scheme is to provide up to 100% of costs for events which had been cancelled, postponed or curtailed. As part of LLPSS 2022 some of the funding would be applied, where appropriate, by the local authorities to assist community and voluntary pantomime productions which had to be curtailed or cancelled in December 2021 and/or January 2022 as a result of the additional public health restrictions. In July 2021 Wexford County Council held an open call for professional events companies to be part of a panel for delivery of services for the Local Live Performance Programme Scheme across the 5 municipal districts.

Youth Film Coordinator appointed

Wexford County Council appointed Therese Dalton to the role of Youth Film Coordinator which was advertised in January. Her role will be to facilitate and manage the County Wexford Youth Film programme. This programme is based in St. Michael's Theatre in New Ross and is a core arts office programme which offers film workshops in developing new film skills to young people around county Wexford aged 13-18.

North Wexford Traditional Signing Féile

North Wexford Traditional Singing Féile was a recipient of the Small Arts Festival and Experimental Events Grant Scheme 2021 this was postponed due to Covid19. However, the festival this year happened on 11th – 13th March with a series of traditional signing events, traditional song workshops and an online screening of the short Documentary Á n Scéal.

Platform 31

Following on from its successful pilot in 2020-21, the Association of local authority Arts Officers (ALAAO) is again collaborating with the Arts Council to present Platform 31. This is a nationwide scheme for artists in all art forms which includes an €8,000 bursary to the artists and invaluable developmental and mentoring supports for the awarded artist over the course of one year. The nationwide invitation went out to artists of any discipline and practice, based in Ireland, as well as multi-disciplinary practice. This scheme is envisioned as a platform for the participants to value their time, to showcase their work and their collaborations, sharing their learnings locally and nationally as a legacy of the project. Closing Date is 30th March.

Cultural Companions

The Arts Dept. & Community Dept. of Wexford County Council with the Age Friendly Co Coordinator encourages older people to attend arts and cultural events. The Cultural Companions are continuing to attend their 'Coffee and Chat' in Clayton Whites Hotel on the first Thursday of every month. The next 'Coffee and Chat' will take place 3rd March 2022 where the members will compile a calendar of events they wish to attend in the coming months.

Music Generation

A partnership between WCC, WWETB, and the national agency Music Generation promoting access to high quality performance music education for young people in Wexford county working in preschool, primary school and youth work/ community settings.

Ongoing Primary School Programmes: 22 primary schools to date have reaffirmed their work with Music Generation Wexford and have committed to developing their programme within the school over this academic year. Most of these schools maintained their works over the previous eighteen months, either through video, online or in person.

Yellow Bellows are back, live and weekly in the Presentation Arts Centre. This is a new Wexford County Singing Group for young people aged 12-18 years. The young people explore singing and performing dynamic songs in a range of styles including rock & pop. Currently there are 14 young people signed up. Musician educators Anita Mahon and Diarmuid Comerford are visiting schools in Enniscorthy, both primary and secondary, doing taster workshops with young people to encourage attendance.

A social media plan also highlights the ongoing experiences of the **CAMHS Ukulele Workshops**. Music Generation Wexford partnered with CAMHS to deliver an introductory series of four ukulele workshops conducted by musician educator, Gayle Murphy, with a group of young people from Nov – Dec 2021. Such was the positive feedback from these workshops from the young people, their parents and the support team in CAMHS it resulted in these workshops continuing for a further five weeks, leading into the CAMHS Songwriting Workshops that were held in the February mid-term break.

CREATIVE IRELAND

Calmast and the Seashell Girl Guides from Ballygarrett/Cahore participated in the "Fish or Foul?" project. Over the five-week project, the Girl Guides will explore printmaking, drawing and monoprinting by using materials found on the local beaches. Items collected will be used to create a set of collagraph prints and the final works will be exhibited and sold as a fundraiser for Seal Rescue Ireland.

The Traveller Wellbeing through Creativity pilot initiative is a call to relevant groups and organisations to deliver three impactful pilot initiatives. Grant funding up to €50,000 will be provided for each of the projects in 2022 under this initiative. To apply contact Creative Ireland programme via their online application.

Cruinniú na nÓg, will take place on Saturday, 11th June 2022. Wexford County Council has advertised an open call to creative practitioners, artists, and organisations to deliver an event/programme or project for the 2022 Cruinniú programme. Closing date for applications is Wednesday 16th of March 2022, 5pm.

Special Projects:

1.1 Forth Mountain Activity Park – Phase 1 – Trails and Carpark

This project is practically complete. Final snag works including the water and sewer connections to the site will be completed by end of February.

Forth Mountain Activity Park - Phase 2 - Activity Centre Building:

The proposed boathouse and external toilet facility on-site has completed pre-planning and revisions to the proposal are being prepared prior to submission of a Part VIII planning application.

The activity centre building was lodged for Part 8 planning in March by WCC's Architects Department and the period for public comment will close on 20/04/2022.

1.2 Min Ryan Park

Sole Sports and Leisure has been appointed to construct the skate park and MUGA on a design and build basis. The MUGA is now complete and open to the public. Work on the Skate Park was to commence the end of March, however the contractor has identified a supply issue in relation to materials. Wexford County Council is following up the matter with the contractor as a priority. Public lighting at these installations will follow.

1.3 Enniscorthy Technology Park Phase 1

Phase 1 – the development of three serviced sites is substantially complete and the construction of the first building is well under way, and due for completion this year.

1.4 Gorey District Park

The external area of the park opened to the public on 12th August 2021 and the new playground and adult gym equipment in fully installed and in use. The final landscape planting has re-commenced this month, to be completed in 2 weeks. Works on the building are to recommence in April.

1.5 South East Greenway

Contracts for the works on Lots 1, 2 and 3 have been awarded to Glás Civil Engineering and works are nearing completion on-site. Lots 1 and 2 are the urban sections at Rosbercon & Ferrybank and Lot 3 extends from Raheen to Glenmore. Works on Lots 1 & 3 are scheduled for substantially completed by the end of March 2022.

Landowner agreements on the accommodation works are progressing well and it is planned that Lot 5A

(Ferrybank to Curraghmore) will be tendered for works in May 2022. The detailed design of on Lot 4 (New Ross to Mount Elliott) will be finalised by the end of May and we would expect to issue tender documents for works in June

The current expected date for the full completion of the Greenway is Q1 2024.



1.6 Trinity Wharf

Due to significant inflation in the market since tenders were received, the original tender process for the works contract for the new access road to the site has been abandoned. A revised tender invitation issued before Christmas and tenders have been received. Works are now expected to commence in Q2 2022.

Procurement of consultants for design services for the site development and public infrastructure works is underway. The pre-qualification process is completed and the successful design firms have been issued with tender documents. Tender submissions are due by end of March.

1.7 New Ross Fire Station

The contract to construct the New Ross Fire Station has been awarded to Kevin Thorpe Ltd. Works commenced on site on May 6th following lifting of Level 5 restrictions and will take 9 months to complete. The construction is approximately 75% complete, the main building with second fix M&E well underway. The drill tower has been erected and the installation of the utility services are almost complete.

Completion is expected in April 2022.



1.8 Wexford Arts Centre Extension

The main works contract has been awarded to McKelan Construction Ltd and works commenced on site on May 6th following lifting of Level 5 restrictions. The works are on-going and substantial completion is planned for August 2022.

1.9 High Hill, New Ross

The Contract has been awarded to MJS Civil Engineering and works are progressing on-site. Groundworks, drainage and ducting works are now substantially completed within the main section of the park. The installation of the staircases and masonry work is complete.

Pedestrian road crossings and surfacing works have yet to commence.

Some tree planting and bareroot planting is currently underway in the current planting season. Herbaceous planting is scheduled to coincide with paving works and Autumn bulb planting will continue after the paving works. Works are expected to be substantially completed by July 2022.



1.10 Monck Street Enhancement Scheme

The contract has been awarded for the advance supply of natural stone paving materials. Delivery commenced in January 2022 and progressing.

Tenders for the main works contract have been assessed and a contract for works has been awarded to Tony Kirwan Civil Engineering Ltd.

Street works are scheduled to commence on site the first week of April and will take 4 months to complete.

1.11 New Ross Public Realm – Phase 1: Removal of Bulk Fuel Storage Tanks

This project consists of removal of the oil tank structures on the Quay and the development of public realm works on the site.

The Advance Works Contract (Removal of Tanks) was completed in July 2021. A Part 8 development consent application for the development of the public realm space on the site has being completed and was advertised on 21st December 2021. The date for public submission is now closed and Planning will prepare a report for Council.

1.12 Templeshannon Regeneration, Enniscorthy:

The Templeshannon Regeneration Strategy identifies a number of enabling projects required to achieve regeneration, including:

- Improving the public realm and streetscape in Templeshannon area;
- Establishing a new link to the town centre by construction of a new pedestrian bridge;
- The management and progressive transformation of the Leisure Centre Car Park;
- The creation of new urban blocks for infill development.

The site investigation (SI) work for the pedestrian bridge has been completed. The preliminary design and bridge options report has been completed taking account of the results of the SI works and is currently under review.

WCC is engaged with the Department of Housing, Local Government and Heritage in regard to a further funding application to support regeneration in Enniscorthy. The planning Department is working in collaboration with Special projects to develop a strategic plan for Enniscorthy and is currently in the consultation process.

1.13 John Street Building Regeneration Project

WCC was successful in securing RRDF funding to design a redevelopment of the old grain stores at John Street, New Ross, which will see these buildings converted into a high-quality enterprise hub.

The CPO process to acquire outstanding property required for the project has been approved. The Notice to Treat and to Enter, under the CPO, have been served and the Part 8 development consent process will commence by early Summer.

1.14 Esmonde Street

RPS is progressing with the detailed design. Priority Geotech Ltd undertook site investigation works in September. Irish Water have now approved proceeding with the design of the sewer upgrade and CCTV and survey works has been completed. The detailed design is due to be completed by June 2022 and the award of a works contract by Q4 2022.

WCC will submit an application for category 1 funding under the current call for RRDF.

1.15 Mechanics Institute

Consulting Engineers were appointed in March 2020 to undertake design, tendering and construction management services for essential maintenance works at the Mechanic's Institute. Tenders will be re-advertised in Q1 2022 and it is expected that a works contract be awarded in Q2 2022. There is a timeframe of 6 months for completion of construction works.

1.16 WEXFORDIA – Irish National Heritage Park (INHP), Hook Lighthouse and New Ross Tourism Projects

WCC secured RRDF category 2 funding for the development of a cluster of tourism projects within the county.

The tourism and environmental design teams for the INHP have commenced work on the preliminary design and the environmental assessments. It is planned to submit a planning application for the project to An Bord Pleanála by the end of 2022.

The process of negotiation for tourism design services with the preferred tenderer from the 2017 Hook Heritage Ltd competition has closed without an award of contract following the withdrawal of the preferred tenderer in December. WCC will advertise for tourism coordinator services this month for the project. The tourism coordinator will assist with the procurement of interpretative design service and we would expect an appointment by mid-2022. The environmental consultant has been appointed and will commence initial studies and investigative works in the coming month.

The contract for tourism co-ordination and management services for the New Ross Tourism project was awarded to Alan Sherwood & Associates in November 2021 and he is currently reviewing the outline interpretive design and developing a plan for procurement of detailed design services.

1.17 Enniscorthy Tourism Project:

This project provides for the phased development of a new tourism project of scale centred on Enniscorthy Castle that will have the capacity to significantly increase tourism visitor numbers to the town. The proposed project will link with associated tourism projects to be developed at the Irish National Heritage Park, Hook Lighthouse and the JFK / Dunbrody in New Ross. The Enniscorthy Tourism Plan report was presented to the Enniscorthy MDC in July 2021.

Tenders for preliminary design and planning consent services have been received for Phase 1 of the project and are currently being assessed.

1.18 Courtown Coastal Protection & Beach Nourishment Scheme

Following a competitive tender process, RPS Ltd has been appointed to undertake the Preliminary Design and Statutory Consents phase of the Courtown coastal protection and beach nourishment scheme.

Tender for the intrusive site investigation works and the environmental and marine surveys required to develop the preliminary design for the project have been received and are currently being assessed. The investigative works and surveys are commencing in early Q2 2022.

1.19 Rosslare Europort to Waterford City Greenway

The Economic SPC of Wexford County Council and the Transportation SPC of `Waterford City & County Council have written to the Minister for Transport seeking inclusion of the out-of-service Rosslare to Waterford railway line in the up-coming national rail review. The application for planning consent for the Rosslare to Waterford greenway project has been paused, pending a decision from the DOT on the future of the rail corridor. WCC is reviewing the advancing the Rosslare Harbour to Rosslare Strand section as a standalone project that could link to the EuroVelo and the Wexford to Rosslare greenway project.

1.20 Wexford Town to Rosslare Greenway

Fehily Timoney and Company has been appointed to provide consultancy services for a feasibility study, route selection, preliminary design and environmental assessments for the development of this project. Constraints have been identified and ecological surveys are ongoing.

The scoping and route options process has commenced and it is planned to make a presentation to the joint Wexford and Rosslare MDCs in March on this project.

1.21 Oyster Lane Car Park, Wexford

A Part 8 submission has been made for the demolition of existing unoccupied buildings on the old Tesco site and for construction of a temporary surface level car park. The plan was presented to the Wexford MDC September meeting and the Part 8 process commenced formally on 26th October 2021 with a report to go to the March Wexford MDC March meeting initially and then to the full Council.

Tenders have been received for detailed design services and are currently being assessed. It is planned to appoint a design team in April 2022.

Detailed design is programmed to be completed in July with an award of the works contract in October 2022.

1.22 Crescent Quay - Dredging

An award of contract was made to RPS Consulting Engineers in June 2021 for design services for engineering assessment, environmental and foreshore consent applications in respect of this project. RPS are currently specifying and procuring investigative works to inform the dredging strategy.


1.23 Old Dublin Road Business Park, Enniscorthy

The final masterplan has now been completed and presented at the Enniscorthy MDC's October 2021 meeting. A contract for the initial phase 1 works was advertised in January 2022, these works include new footpath, pedestrian crossings, new entry signage and landscaping. The tender evaluation process is underway, it is expected Phase 1 works will commencing in Q2 2022.

A further application for funding of the masterplan was made to the NTA's active travel programme in January 2022.

1.24 Enniscorthy Sports Hub

O'Leary Sludds Architects were appointed in Feb 2021 for the detailed design, procurement of works contractor and construction management of the Sport Hub building. Tender documents are now complete and have been issued to the Department for Tourism, Culture, Art, the Gaeltacht, Sports and Media for approval. Tender advertisement will follow DTCAG approval and it is expected that a works contract will be awarded in Q2 2022.



1.25 Curracloe Water Sports Activity Facility

WCC has recently received Stage 2 compliance approval from Failte Ireland for the development of facilities to support water sports activists at Whitegap in Curracloe. The project will include showers, toilets, changing facilities and lockers.

Tenders for design services was advertised in Jan 2022, the tender evaluation process is underway, it is expected a consultant will be appointed for design services in April 2022.

2. Flood Defence Schemes

2.1 Enniscorthy Flood Defence Scheme:

Statutory Process - The scheme confirmation documents required for ministerial consent were submitted to the Department of Public Expenditure and Reform (DPER) in March 2020. In April 2021, WCC issued supplementary environmental information to the OPW and DPER to support the approval process. The Minister for the Department of Public Expenditure & Reform (MDPER) issued his decision to refuse the scheme on 4th March 2022. Following the decision, the OPW confirmed their commitment to delivering an effective scheme for Enniscorthy to provide the community with much-needed protection from extreme flood events, both now and into the future.

Next Steps - WCC, OPW & lead consultant Mott McDonald (MMD) met on the 11th March to discuss the ministers decision and agree the next steps. The ecology baseline data is to be updated. The

scheme alternatives are to be assessed, shortlisted and consulted on publicly, and the EIAR & NIS updated for the preferred option. MMD are to issue a programme of work.

A special meeting of the EMD was held on the 15th March to update councillors on the ministers decision and the next steps for the scheme."

2.2 Wexford Flood Relief Scheme:

The project brief for design services for Wexford Flood Relief Project was advertised on Etenders in early 2020. Seven tender submissions were received by the extended closing date of the 9th July 2020. Following a detailed tender assessment and evaluation process the decision not to award a contract arising from this tender competition has been advised to all tenderers. A further procurement process will be advertised in Q1 2022.


