#### **ECONOMIC DEVELOPMENT**

#### **Economic**

#### Fisheries Local Action Group (FLAG)

The development of Fisheries Local Action Groups (FLAG) for all regions is underway. BIM has over the past number of months been assisting in building a FLAG Board for the South East region which will comprise representatives from PPN (Community, Environmental, PPN), State Agency or Public Body, Industry - Commercial Fishing / Aquaculture, Blue Economy, i.e. Marine leisure, Marine Tourism and/or Marine Sport, Education and others. Annette Rowsome, Senior Enterprise Development Officer is the newly appointed Board member representing Economic Development.

Grant Thornton has been contracted by BIM to assist the board in developing independent local development strategies for each region. They have begun collating current data from census, fisheries, aquaculture, Pobal and any other sources relevant to the development of such a strategy. A series of board and public consultation meetings with Grant Thornton have taken place. Grant Thornton is following up with a survey which will be circulated to stakeholders by the end of October to provide a further opportunity for people to offer their views and suggestions. They will then begin to draft the actions for the strategy.

#### Georgia Savannah University (GSU)

In early October, a seven person high level academic delegation including the Provost visited Wexford. The focus was on developing relationships and research opportunities with SETU as well as discussions with WCC Environment Department and the EPA regarding collaborative research opportunities. Work is progressing on the design and planning of the student accommodation with Stephen Carr Architects (SCA) who was formally appointed to the Adoration Convent Student Accommodation Project. The economic section continues to support GSU around the needs of their faculty members and students while in Wexford.

#### **Tourism**

Visit Wexford has just finalised it's Christmas Radio Campaign which will air week commencing the 13<sup>th</sup> November on Today FM with an associated competition and digital adverts.

Failte Ireland's Local Experts Programme returns on the 29<sup>th</sup> March, 2024 with two workshops taking place in the Talbot Hotel, Wexford. The interactive workshops will cover what there is to see and do in County Wexford and how to promote same. It is free of charge and is open to participants from B&Bs, hotels, restaurants, pubs, taxi companies or volunteers on tourism initiatives in local communities.



A delegation comprising the management team from

Failte Ireland are visiting Wexford on the 7<sup>th</sup> and 8<sup>th</sup> November staying in Clayton White's Hotel. This is the second group to visit the County in the last month. Visit Wexford and WCC are utilising this as a marketing opportunity to promote the county.

#### **Local Enterprise Office**

#### National Women's Enterprise Day 2023





On Thursday 19<sup>th</sup> October almost 100 female entrepreneurs, women in business and female-led businesses from across County Wexford gathered in Newbay House Hotel Wexford to celebrate National Women's Enterprise Day 2023. Key note speaker on the day was Wexford town native, Theresa Grant OBE, who previously worked with Wexford County Council and the Irish National Heritage Park as manager before moving to several management roles in England. Theresa's story of delivering high-value outcomes for communities and local governments across the UK and working on diverse projects such as the Sydney Olympics and the Commonwealth Games provided inspiration and compelling listening.



Pauline Dunne of Killowen Farm, who is this year's **Women's Enterprise Ambassador for County Wexford** also spoke at the event.



Pauline shared her story of growing a small family dairy farm to a major producer of both yogurt and cream cheese. She gave inspiration and encouragement to businesses of all sizes in the room. Also speaking on the day were Deborah Brock of Nua Fertility and MC Rosemary Lyons of Brightspark Consulting – both sharing their stories of success and challenges. Feedback from the day was very positive, with new members of the LEO Women In Business Network recruited, and a call for more networking events to be held.

As Chair of NWED 2023 national committee, Wexford County Council's Head of Enterprise & Economic Development, Breege Cosgrave, supported the national LEO communications team in the run up to and on the morning of the event when she was interviewed on Morning Ireland. With 14 events nationally (local and regional), NWED received extensive coverage for the event through a National Photocall in Dublin, Partnerships with Ireland AM, The Journal and Silicon Republic along with sponsorship of the Goss.ie Women of the year. Ireland AM also featured NWED on 4 occasions in the leadup to the event including a live broadcast from a Dublin NWED event on the day.

#### **The National Ploughing Championships**

In September, the LEO network hosted an Enterprise Village at the National Ploughing Championships, showcasing over 30 LEO clients from around the country. Wexford's client representative was award winning business Holos Skincare from Enniscorthy. LEO staff were on hand to assist with enquiries from small businesses from around the country.

#### Blás na hEireann

On 29<sup>th</sup> and 30<sup>th</sup> September fourteen Wexford food producers, shortlisted from thousands of entries across the country competed for the Blás na hEireann Food Awards in Dingle. This year 11 Wexford food producers took home an array of gold, silver and bronze medals from these awards. Wexford LEO sponsored an "Eat Wexford" stand in the Food Village at Blás where finalists had the opportunity to display, sample and sell their produce meeting both domestic and international food buyers.

#### Sustainability

#### Making Sustainability Happen Seminar

On 16<sup>th</sup> November, LEO Wexford is holding a regional seminar and information event in Wexford County Council aimed at encouraging businesses to take the first or next step to improve their sustainability credentials. The MC, Eanna Ni Lamhna, an Irish biologist, environmental consultant, radio and television presenter with a profound passion for sustainability, will guide attendees through the event, featuring speakers Ankush Shirsath from Enterprise Ireland, Amanda Stewart, CEO of the High Performance Building Alliance and Green Cluster co-ordinator for the South East. Guest speakers Simon Lynch, Wicklow Wolf Brewery, Catherine Murphy Brady, Brady's Coffee and Michael Griffin, Griffin Group, will provide insights into the practical steps they have taken to incorporate sustainability into their very unique businesses.

Funding supports from a broad range of agencies will be outlined on the day, including the *Energy Efficiency Grant* launched in May by Minister Simon Coveney TD, Minister for Enterprise Trade & Employment. The grant which is administrated by LEO and provides grant aid of 50% of eligible costs up to a maximum of €5,000. The LEO team and sustainability mentors will be available on the day to support companies to apply for same. There will also be a launch of the Green Cluster at the Business briefing with companies operating in the Green Economy.

#### **LEO National Marketing Campaign Promoting Efficiency Supports**

A national marketing and lead generation campaign was launched in September to increase awareness and highlight the range of efficiency and competitiveness supports available from Local Enterprise Offices. The Campaign "All in a days work" is due to run to the end of November initially. The campaign is running on national radio, national print advertisements including the Irish Times, Independent, Business Post, Examiner and Sunday Times. The campaign will also run on YouTube Pre-Roll and VOD, Display & Programmatic Advertising, promoted social posts on LinkedIn, Facebook and Instagram. It has also been supported by a PR push by Enterprise Ireland's PR agency to maximise media opportunities. Wexford LEO is currently following up on leads generated by the marketing campaign and converting this interest into participation onto the Lean, Digital Start and Green for Business Programmes.

#### National Winner for Wexford: SME Pharma Company of the Year



Biostór Ireland based in Kilrane Business Park, a client of LEO Wexford recently won the 'SME Pharma Company of the Year' at the Pharma industry awards in Cork. Biostór Ireland are Ireland leading EU-licensed cell bank/biobank that offer certified storage and worldwide distribution of biological materials for scientific research and clinical applications. They store life-saving products such as bone marrow, peripheral blood stem cells and lymphocytes for transportation. They also store highly controlled human biospecimens for clinical research and the advancement of cures. They employ the latest cloud-based sample management systems for the administration of international, multi-centre clinical trials, in addition to offering expert guidance in the standardization of sample donation, procurement, processing, testing, preservation, storage and cold-chain distribution.

# **TOWN REGENERATION**

The Regeneration Unit was established on the 31<sup>st</sup> October 2023 and resides under the Economic Directorate within the Town Regeneration Office

The Unit consists of the Town Regeneration Officer, Vacant Homes Officer(Croi Conaithe) and an Assistant Staff Officer. Given the synergies between the roles of Vacant Homes Officer and Town Regeneration Officer it was decided to amalgamate both functions and create a Regeneration Unit within Wexford County Council. As we now have a more concentrated focus on Regeneration and vacancy activation through various Government programmes it was agreed to realign these roles into a new "Regeneration Unit"

This Unit will initially be focused on progressing Town Centre First objectives along with Vacant homes objectives with a strong focus on Regeneration within the County.

Both New Ross and Enniscorthy Town Centre First Plans are now complete and the New Ross pathfinder Town Plan has now been forwarded to the DRCD. Both Plans have been reviewed by the National Town Centre Office and positive feedback has been received on both. We are currently procuring designers to professionally design these Plans prior to local and National Launch.

The Town Centre First Teams are meeting Monthly in both Enniscorthy and New Ross developing ideas and contributing to the finalisation of Plans and discussing how best to progress the interventions outlined in their respective Plans.

Discussion is ongoing at National Level on future Town Centre First Plans for more Towns and Villages with details expected to emerge on this in the coming weeks.



#### Forward Planning

#### **Wexford Town Local Area Plan**

The report on the pre-draft consultation stage is currently being completed. The report will provide an overview of the public consultation undertaken, and a summary of the issues raised in the 73 submissions and observations that were received.

Work on the Infrastructural Assessment Report continues. This is a significant piece of work which requires a review of all lands in the plan area to determine if the lands are currently serviced or could be serviced during the plan period. The outputs of this assessment will be an important consideration in the spatial planning and approach to land use zoning in the Draft LAP.



The Social Infrastructure Audit is nearing completion. The audit, which is also a significant piece of work, will provide the evidence-base to identify where there is a current under provision of social infrastructure/spatial deficits. The outputs of the audit will be an important consideration in determining future social infrastructure requirements, and in the spatial planning of the town including the implementation of the 10-minute town concept.

The Local Transport Plan is progressing well with the Baseline and Context Reports almost complete. Work has commenced on the Options Report.

The Pre-draft Consultation Report, the Social Infrastructure Audit Report and the progress on the Local Transport Plan will be discussed with the Members of the Borough District of Wexford at a special meeting to be held on Monday, 20<sup>th</sup> November 2023.

The Strategic Flood Risk Assessment is also underway. The consultants have carried out their initial review and walk over of the town. They have also been informed of flooding events that occurred during recent weather events.

The tenders received for the Urban Design Strategy (including Master Planning) and the Rainwater Management Plan and Green Blue Infrastructure Strategy are currently being evaluated.

#### **Enniscorthy Town Local Area Plan**

Consultants have been appointed to carry out the Strategic Environmental Assessment and Appropriate Assessment of the Local Area Plan. The Planning Section is also working with the Active Travel Team on the evaluation of tenders for the Local transport Plan which will inform the plan.

#### **Submissions**

The Forward Planning Section prepared submissions in response to the public consultation on the Draft Sustainable and Compact Settlements Guidelines for Planning authorities and the South Coast Offshore Renewable Energy Designated Maritime Area Plan Proposal.



#### **Wexford County Development Plan Monitoring**

The implementation of the Wexford County Development Plan 2022-2028, which was made by the Members of Wexford County Council on the 13 June 2022, is a key strategic focus for the Council. The Council is required to monitor the implementation of the plan for a number of reasons including to:

- 1. Monitor the effects of implementing the plan under the SEA Directive.
- 2. Monitor the implementation of the Core Strategy as required in the Development Plan Guidelines for Planning Authorities; and
- 3. Ensure that the objectives of the plan are met as required under the Planning and Development Act 2000.

The Chief Executive must also submit a report to the Members on the achievement of the objectives of the plan two years after the plan is made.

The Forward Planning Team are in the process of setting up a system to monitor the various elements of the plan and have also commenced gathering monitoring data.

#### **Built, Cultural & Natural Heritage**

#### **Community Monuments Fund**

Wexford County Council received capital funding totalling €200,000.00 for works at Tellarought and Mountgarrett castles. Following a procurement process contractors were appointed and works have now been completed at Mountgarrett and are near completion at Tellarought. In addition the council is also assisting a community group with the processes for conservation works at Barrystown Mine through the Community Monuments Fund and these works are also nearing completion.



#### **County Heritage Plan Scheme funding**

Wexford County Council recieved funding from the Heritage Council for the following projects under the County Heritage Plan scheme: A phase 1 audit of the historic church and graveyard sites of Co. Wexford (€17,850.00), and a conservation management plan for St. Nicholas' of Clonmines (€12,915.00). The phase 1 audit of historic church and graveyard sites is complete and the conservation management plan for St. Nicholas's is nearing completion.

#### **Historic Towns Initiative funding**

Wexford County Council has received funding from the Heritage Council and the Department of Housing, Local Government and Heritage for the undertaking of a heritage-led regeneration plan for Enniscorthy totalling €40,000.00. Following the procurement process, a consultant has been appointed and this project is now at draft stage under review by the heritage section.

#### **Local Biodiversity Action Fund**

Wexford County Council received €25,000.00 in grant funding through the Local Biodiversity Action Fund 2023 for the undertaking of a Phase 2 Wetland Survey following on from the Phase 1 survey in 2022. This project is now complete. Funding was also received to produce a Tree and hedgerow Strategy for Co. Wexford and following a procurement process consultants have been appointed and this process is on-going. A barn owl booklet is being produced by Birdwatch Ireland in conjunction with five other local authorities under this fund, and this will be available for distribution throughout the county in the coming weeks.

#### **Irish Walled Towns Network**

Wexford County Council received €80,000.00 in capital funding from the Irish Walled Towns Network for conservation works at Wexford Town Wall, in the Bride Street and Ropewalk carparks. These works have now been completed and the wall is fully conserved and accessible to members

of the public.

  - Initial assessment is that a new storage tank is not the best solution.
  - GWS have reviewed and discussed at committee and have confirmed they are agreeable to recommended option.
  - Currently engaging suppliers and contractors regarding obtaining a quotation for the installation of a bypass with prv.
  - Reservoir Bypass -WCC have been informed of potential additional costs required to carry out works.
  - A report has been compiled and submitted to the Dept.; the Dept. requested further information.
  - Additional reports were completed and submitted to the Dept. in December.
  - The Dept. have approved request for increased funding.
  - The Group Scheme, Employer's Representative (TJ O'Connor's) and contractor (EPS) have all been informed of the Department's decision and are progressing with the proposed works.

# N11/N25 Oilgate to Rosslare Harbour

  International level.
- Preparation of Environmental, Planning, Design and other reports required by the TII's Project Management Guidelines and Project Appraisal Guidelines is ongoing.
- Engagement with the ESB/EirGrid, Irish Rail, Gas Networks Ireland, Irish Water and other stakeholders is ongoing.
- Preparation of the Periodic Report in relation to the Connecting Europe Facilitates (CEF) funding is ongoing.

# **N25 Rosslare Europort Access Road**

- An Bord Pleanála has approved Planning Application for the development of N25 Rosslare Europort Access Road. The decision was made on the 4<sup>th</sup> October 2023 and was received by Wexford County Council on 6<sup>th</sup> October 2023.
- Currently, the project is in the standstill period of 8 weeks from the date of when the decision was made.
- At the end of the standstill period, and if there are no objections to An Bord Pleanála's decision, the Project Team will be finalising the Phase 4 deliverables and processes and will be seeking TII's approval to progress to the Phase 5 of the Project.

# **NATIONAL ROAD PAVEMENT SCHEMES**

#### **2022 Pavement Schemes**

N25 Ballykilliane to Orristown Pavement Scheme

(Estimated Total Scheme Cost €2,000,000)

This scheme is 2 km in length and runs between the R739 Kilmore junction to the L7050 Orristown junction on the N25.

Pavement works commenced in May and were substantially completed by 16 June. Line marking was completed by the 30 June.

#### **2022 Safety Schemes**

N25 Ballygillane Roundabout - (Estimated Total Scheme Cost €2,590,000)

This scheme was tendered in November 2021.

Works commenced on 23 May 2022. The roundabout is substantially completed.

Works outstanding:

Landscaping works to be completed in October, subject to weather conditions.

N30 Ballymackesy – (Estimated Total Scheme Cost €23,000)

Retexturing Works was tendered in June with works arranged for week ending 2<sup>nd</sup> November.

#### **2023 Pavement Schemes**

N80 Tomacurry to Ballycarney Phase 2 - (Estimated Total Scheme Cost €1,600,000)

This scheme has been tendered and is under review now. Construction is expected to commence in early 2024.

N25 Orristown to Ashfield Cross Pavement Scheme - (Estimated Total Scheme Cost €1,600,000)

This scheme is being designed at present with expected tender in November. and construction to commence in 2024.

<u>HD28 N25 Blackhorse to Ballykelly Pavement Scheme</u> – (Estimated Total Scheme Cost is €1,000,000).

This has been tendered, the contractor has been appointed, construction expected in March 2024.

#### **2023 Additional Maintenance Allocations**

Wexford County Council has applied for additional maintenance funding from TII in 2023.

This includes a section on the N30 at Moneytucker, which has been tendered with construction expected to be completed in Quarter 4 2023.

Wexford County Council secured additional maintenance funding for drainage and verge maintenance works on the N11 and N25.

Verge and hedge cutting is completed on sections of the N11 and N25. A section of the M11 at Scurlocksbush roundabout and the Frankfort junction were included and completed.

A consultant has been appointed to carry out a drainage design for a section of the N25 between Barntown and Larkins cross that flooded twice since 25 December 2021. A preliminary meeting was held with the consultant on site in January. Design report due in September.

# **Former National Roads Grant 2023**

2 applications were made under this scheme for 2023.

- R772 Tinnock to Gorey (1.4km)
- R723 Rosbercon (0.8km).

Funding of €500,000 was received for the R772 Tinnock scheme, amounting to 50% of the scheme. A consultant has been appointed to look at the possibility of including a cycle facility as part of the scheme.

This allocation will be assigned to Rosbercon R723 as a former National Road currently under design. This is currently out to tender.

# **REGIONAL AND LOCAL ROADS**

Wexford's Regional and Local Road Grant Allocations were announced on 14 February 2023 to be €22,811,650. This allocation included €1,000,000 for Christmas day 2021 flood damage and €1,500,000 for the Deeps Bridge remediation works. The strengthening programme received an additional €822,816 allocation on 3 July 2023.

#### **Resurfacing/Strengthening**

The 2023 strengthening programme (Machinery Yard) commenced in the Enniscorthy District on 25 January 2023 at Bucks Bridge, Ballindaggan.

Roads resurfaced in the last month were:

Raheenahoon; Coolgarrow; (Ennicorthy MD); Esmonde Street; Carrig Ballythomas; (Gorey-Kilmuckridge MD); Brocorrow; Nunnery Lane; Ballagh/ Templeshelin/Old Court (New Ross MD); Forth Mountain; Brownes Casltle Taghmon; Cower Road Carne; Tullycanna to Racks Cross; Kisha; Bridgetown North; (Rosslare MD) Johns Gate; Rowe Street; (Wexford Borough MD).

# **Surface Dressing Works**

The surface dressing programme (Machinery Yard) commenced in Enniscorthy District at Tomanoole, on the 12 June. The surface dressing programme is complete.

#### **Community Involvement Schemes**

€502,650 was allocated in 2023 for 7 roads.

6 Roads complete at present as follows: Madoran and Ballinure; (Both in Enniscorthy MD); Glen Lane; (Gorey-Kilmuckrdge MD); Nook Lane; (New Ross MD); Rowestown Lane & Lannagh/Grange Lane; (Rosslare MD).

# **Bridge Rehabilitation Grant**

Wexford County Council was allocated €610,000 to repair 17 bridges in 2023.


9 bridges are complete at; Tomgarrow Bridge & Carley's Bridge; (Both in Enniscorthy MD); Boley Upper Bridge; (Gorey-Kilmuckrdge MD); Kings Bridge, Cullenstown; Newcastle Bridge; Ambrosetown Bridge: (Rosslare MD); Abbey Bridge & Barmoney Bridge (New Ross MD); Badgers Hill Bridge; (Wexford Borough MD).

#### **Christmas Day 2021 - Flood Damaged Bridges**

Temporary Bailey Bridges are in place at Chapel and Cullenstown Little in the New Ross District.

Detailed designs are in progress to construct 2 new concrete beam bridges. Both are submitted for Part 8 Planning and it is hoped work will commence works early next year.

Wilton Bridge in Enniscorthy District - Glas Civil Engineering commenced work 30 June 2023. The bridge was repaired to its original form of masonry arches. Repair works are expected to be completed and the road opened 17 November.

#### <u>Specific Improvement Works – The Deeps Bridge</u>

The Deeps Bridge Remediation Project – RPS Consulting Engineers Ltd was appointed as Project Supervisor for the Design Process in March 2021.

Glas Civil Engineering commenced work 9 January 2023. All concrete repairs are complete. Steel painting is ongoing to the steel part of the bridge. There was a substantial increase in the number of concrete and steel repairs required. This led to the temporary road closure being extended from 31 August to 17 November. It is anticipated the works will be fully complete by the end of November 2023.

# **Climate Change Adaptation & Resilience Works**

Wexford County Council was allocated €682,000 for 15 projects in 2023.

8 projects are complete, and the remainder are in progress.

## **Local Improvement Schemes**

€411,705 was allocated to County Wexford in Round 1, 2023. A second allocation of €619,230 was received 28 July bringing the total to €1,030,9354 for 2023.

All 21 lanes have been resurfaced.

# **General Maintenance**

Drainage, patching and road surface repair works are ongoing in all Districts.

## **ACTIVE TRAVEL**

#### Pathfinder Project

#### Newtown Road

The sod turning on the Newtown Road Cycle Scheme will take place on the 7<sup>th</sup> of November followed by construction commencing on site. The tender for this project was awarded to Glas contractors who will mobilise to be on site. The expected duration of the construction phase will be nine months. The project will result in the delivery of protected cycle paths and footpath upgrades on both sides of the road from the Maldron Hotel to the Racecourse on Newtown Road.

Following on from this first phase of the Newtown Road Cycle Scheme, the second phase will include the section from the Racecourse to the Hospital Junction with Newtown Road/Beechlawn/Clonard. This is currently on public display as a Section 38 and went live on the 27<sup>th</sup> of September. The closing date for submissions has now passed and the intention is to bring the proposals before the Elected Members in the November Council meeting.

The third phase will be the junction outside Wexford General hospital – the junction of the Newtown Road with Carriglawn/Beechlawns to town, terminating at Wygram. This section of the route went to Section 38 earlier this year and received the approval of the Elected members.

#### Roxborough Cycle Scheme

The proposed cycle lane upgrade in **Roxborough** has now moved onto Preliminary design following approval from the NTA to develop the preferred option as part of the options assessment process. Consultants DBFL are now working with the Active Travel team to prepare documents to proceed to Part 8 planning towards the end of 2023.

#### SAFE ROUTES TO SCHOOL (SRTS)

Construction outside St. Mary's National School Rosslare is well advanced resulting in reduced car parking in front of school, improvements to walking infrastructure and safe crossings of the public road, all with the aim of encouraging more walking to school and less car dependence.

Contractors are currently on site and making good progress.

WX/21/0015 Safe Routes to School - Scoil Naomh Abbain, Adamstown National School – works are well underway and approximately 95% complete. Significant improvements have been made to footpaths, reduction of parking to the front of school and introduction of pedestrian crossings. Planting will take place in newly created green areas when the weather improves. Planting will assist in holding on to surface water run-off and releasing it slowly to the drainage network, thereby reducing flood risk in times of heavy rain.

St. Aidan's, Enniscorthy, Safe Routes To School scheme is also well under way with works the school to enhance the environment for pedestrians, thereby encouraging more walking to school. Many people live within walking distance of the school, and it is hoped that these safety measures will encourage less car dependence for short journeys and will lead to less congestion around the school zone.

#### **Area Based Transport Assessment (ABTA)**

Enniscorthy ABTA – The successful tenderer has been identified and communications are underway with the NTA prior to engaging the consultants to initiate the assessment.

Wexford Town ABTA is currently underway by Atkins Consulting Engineers and at Options
Development stage. A meeting with the Planning Department of Wexford County Council was held
in late October to examine proposals and findings in relation to the Options Development and
Baseline reports. Since these reports will ultimately feed into the development of the Local Area
Plan for Wexford.

#### Public eBike sharing scheme

On the 6<sup>th</sup> of October the Cycling and Walking Officer in conjunction with Sports Active gave several demonstrations on using eBikes for Active Aging week. This course was particularly aimed at older adults who were returning to cycling after some time and for those who needed to gain confidence again to cycle on a public road. Demos were held in County Hall which allowed participants a safe place to cycle to familiarise themselves with the eBikes. This course was well received and well attended. It was delivered as a result of requests received from those who attended an ALL-Adult Literacy for Life programme in Wexford town library which focused on using the technology behind the bikes.

# **PUBLIC LIGHTING**

# **LED Upgrade (Non-National Roads)**

Over 12,000 lanterns have been upgraded to LED since the beginning of 2016.

Design works are completed.

A plan will be put in place to upgrade the remaining lanterns in housing estates that were taken in charge over the last 4 to 5 years.

Lighting stock should be fully LED by the end of 2024.

#### **Public Lighting Development Fund**

Additional public lighting will be installed at the following locations under the Public Lighting Development Fund in 2023.

- Ramsfort Avenue Gorey infill along by GAA pitch. Lighting design completed with tenders under review.
- The Ballagh Church to the school Lighting design complete and contractor appointed for works to commence in November.
- The Ballagh Ballagh Cove to regional road. Lighting design completed and contractor appointed for works to commence in November.
- Wexford Town Seamus Kelly roundabout to Spawell Road. 2 quotations received.
   Contractor appointed and works to commence in November.
- Wexford Town Kennedy Park. 2 quotations received. A contractor has been appointed for these works and works to commence in October.

Other locations will follow further to consultations with Municipal District Engineers.

Work has commenced on 3 National Public Lighting Energy Efficiency Programme (PLEEP) contracts across the country. This is leading to a delay in getting our Development Fund lighting contracts designed, tendered and completed.

#### **Gorey Town Park**

The public lighting to the walking track was completed in June.

#### **CAPITAL PROJECTS**

# 1. Projects at Planning Stages

#### 1.1 Enniscorthy Town Centre & Tourism Project:

The Planning Department in collaboration with Special Projects has developed a strategic plan for Enniscorthy town centre, which was adopted at the Enniscorthy MD meeting in December 2022.

Regeneration works to the Market Square, Enniscorthy Castle Quarter and Templeshannon will form part of the Call 4 URDF application expected in Q3 2023.

The Part 8 process for Market Square and town centre street enhancement was commenced on 4<sup>th</sup> October 2023, which was designed by Moloney O'Beirne Architects & Roughan & O'Donovan Consulting Engineers. Preliminary design work on the Enniscorthy Castle Quarter project has now also commenced and it is intended to submit a Part 8 planning application for this in Q1 2024.

ODKM Architects have been appointed to undertake concept masterplanning design services for the Templeshannon Regeneration Project. This masterplan will be completed in time for the forthcoming URDF application.





#### 1.2 Forth Mountain Activity Park – Phase 2 - Activity Centre Building:

Phase 1 – Forth Mountain Activity Park, Trails and Carpark is complete.

The activity centre building was lodged for Part VIII planning in March 2022. In response to a request from An Bord Pleanála for further information relating to the project was completed and submitted to the Board. The Part VIII planning application was withdrawn in October 2022. A process to procure a consulting team to prepare an EIAR and prepare a planning submission to ABP is now required.

The part VIII for the proposed boathouse and external toilet facility on-site was approved by WCC in February 2023. Tenders for works were received on May 31<sup>st</sup> and have been assessed. Contract award is subject to confirmation of funding.



#### 1.3 Gorey District Park

The park is substantially completed and is now fully open to the public. The second invitation to tender for the Changing Places unit did not result in an award of contract. A third invitation to tender for the Changing Places unit was advertised on eTenders. Tenders have been received and a contract awarded. The Changing Places unit will be on site for the first week of December & completion is expected before the end of December.



#### 1.4 John Street Building Regeneration Project, New Ross

A portion of the grain store building has been purchased by agreement and the CPO for the remaining sections is now formally complete. ODKM Architects are appointed and undertook a preplanning meeting for the building in February, with the Concept Design Report being presented to the New Ross MDC at the May meeting. Preliminary design is ongoing with Part 8 expected to commence in December, subject to the outcome of a screening for appropriate assessment and Site Specific Flood Risk Assessment.

# 1.5 WEXFORDIA – Irish National Heritage Park (INHP), Hook Lighthouse and New Ross Tourism Projects

WCC secured RRDF Category 2 funding for the development of a cluster of tourism projects within the county.

#### Irish National Heritage Park: INHP

The tourism and environmental design teams for the INHP have commenced work on a preliminary design and the environmental assessments. It is planned to submit a planning application for the project to An Bord Pleanála in Q2 2024.

#### **Hook Lighthouse**

The tender competition for interpretative design services for the Hook Lighthouse was advertised in February with closing date for tenders on 30/03/23. Tandem Design have been identified as the successful tenderer and have been formally appointed.

The Brief for the associated architectural and related design services will be issued in Q1 2024 as part of the framework created for architectural services focused on tourism and recreation projects. It is expected that the preliminary design will be completed in 2024 and submitted to ABP in Q2 2025.

#### New Ross Tourism Project

Tenders for the interpretive fitout on the Dunbrody Visitor Centre Experience have been received and a contract awarded to EPIC Design, based in Dublin who have completed the detailed design for the development. The procurement for works will take place shortly. Installation and fit out works on this project are planned to be completed by Q2 2024.

Tenders for the Interpretive and exhibition design of the Norman Visitor Centre have been completed and an apparently successful tenderer has been identified. Preliminary Design on this will begin in the coming weeks.

A framework for architectural services for tourism projects has been advertised with stage 1 submissions received and assessment now complete. Tenders will be invited from shortlisted candidates in November for the Norman Centre project, with award of contract anticipated in January 2024.

#### 1.6 Esmonde Street, Gorey

An on-site meeting took place with the Members in Gorey – Kilmuckridge MDC in February 2023 and proposals for the street were discussed. A presentation was made to the Members in April 2023. The Members advised to proceed to detailed design with the proposed plans, with works expected to commence on-site in January 2024. €2m of own funds is committed to the Esmonde Street project. The scope and phasing of this project is currently under review.

#### 1.7 Rosslare Europort to Waterford City Greenway

The application for planning consent for the Rosslare to Waterford greenway project was paused, pending the publication of the All-Ireland Rail Review. The draft report issued in July 2023 appears to promote reopening of the train line in future.

The Rosslare Harbour to Rosslare Strand section is now being advanced as part of the Wexford Town to Rosslare greenway project.

#### 1.8 Wexford Town to Rosslare Greenway

Fehily Timoney & Co has been appointed to provide consultancy services for a feasibility study, route selection, preliminary design and environmental assessments for the development of this project. Constraints have been identified and ecological surveys are ongoing. The scoping and route options process is ongoing. Public consultation on the preferred route corridor options commenced on 11th May 2022 with submissions closing on June 10th 2022. It is now expected to confirm a preferred route in Q1 2024. Submission to An Bord Pleanala is likely to happen in early 2025.

Fehily Timoney & Co has been appointed to review the route options for the proposed Rosslare Harbour to Rosslare Stand greenway in light of the significant coastal protection works that have been carried out over the past two years by Irish Rail. It is planned to confirm a preferred route in Q1 2024, with an expected Part 8 application (subject to

screening) to follow.

#### 1.9 Old Dublin Road Business Park, Enniscorthy

In May 2021, outline proposals for the Old Dublin Road were presented to the Enniscorthy Municipal District. This was followed by a public consultation process in late June on the draft plan. The masterplan was presented to the Enniscorthy MDC's October meeting. The initial phase 1 works commenced in July/August 2022 and are now substantially completed.

An application for further funding has been prepared and submitted to the NTA, in conjunction with the Roads & Transportation Section, for the active travel elements of the masterplan. No funding was forthcoming for 2023.

#### 1.10 Courtown Coastal Protection & Beach Nourishment Scheme

Following a competitive tender process, RPS Ltd was appointed to undertake the Preliminary Design and Statutory Consents Phase of the Courtown coastal protection and beach nourishment scheme.

Priority Geotechnical Ltd. is appointed to carry out the marine and land-based surveys and boreholes at Courtown. They commenced work on the May 2022 and the site investigation work is complete.

Marine profiling surveys will also be carried out in parallel at this time and this work is being carried out by Hydrographic Survey Limited. An application to the Marine Foreshore Dept., was submitted in December 2022, for permission to carry out benthic grab samples. This work will commence once approval is granted.

It is planned to submit an application to An Bord Pleanála for development consent in Q1 2024.

#### 1.11 Crescent Quay – Dredging

RPS Consulting Engineers have been appointed to provide design services for dredging works at Crescent Quay. The sampling and testing of the proposed dredge material, to inform the statutory consent process, is complete and results have been assessed. Further to a Preliminary design report issued by the consultants in August 2023, the scope of the project is currently under review.

#### 1.12 Enniscorthy Sports Hub

O'Leary Sludds Architects were appointed in Feb 2021 for the detailed design, procurement of works contractor and construction management of the Sport Hub building. A competition to award a works contract for the sports hub building was advertised in May 2022. The lowest price tender opened for the project exceeded the available budget and no contract was awarded. Further 'top-up' funding has now been being sought under the LSSIF scheme and it is intended to retender the project in December 2023.

#### 1.13 Curracloe Water Sports Activity Facility

WCC received Stage 2 compliance approval from Fáilte Ireland for the development of facilities to support water sports activities at Whitegap, Curracloe. The project will include showers, toilets, changing facilities and lockers.

Following the tender process for design services in Jan 2022, Neville Conroy Architects was appointed. Surveying works and detailed design commenced in January 2023. It is planned to tender for works in November 2023 with works to commence in early 2024.

#### 1.14 Ferndale Gymnasium, Wexford:

Sports Capital funding of €300,000 has been secured for this project, supporting a donation of €500,000 from William Neville and Sons for this project. Part VIII approved was received in 2022 and a design team has been appointed to prepare detailed designs and tender documents for the works. The works were tendered in August and the tender period ended on 4<sup>th</sup> September. Tender assessment is ongoing.

Sole Sports and Leisure Ltd. have been awarded the contract, following public tender, for the construction of two MUGAs at an adjacent site, following confirmation of €100,000 in grant funding through the 2023 Community Recognition Fund. Works commenced on site in August 2023.

#### 1.15 Adoration Convent Wexford

Part VIII is in place for this project to convert the old convent into accommodation for students of Georgia Southern University Wexford campus. A design team appointment has been approved by GSU and preliminary design and associated survey works are underway. It is intended to tender out these works out in Q1 2024 with works to commence in Q2 2024.



## 2. Projects Under Construction

### 2.1 South East Greenway

Contracts for the works on Lots 1, 2 and 3 were awarded to Glás Civil Engineering and works are now complete.

Fencing, public lights ducting and temporary car parks works for the greenway section from New Ross to Glenmore, i.e. Phase 1, are complete.

Phase 1 of the South East Greenway - New Ross to Glenmore was officially opened on the 25<sup>th</sup> of July 2023.

The process to procure replacement technical advisors for the completion of the Southeast Greenway project has commenced. The first consultancy contract for a technical advisor to act in the role of Employer's representative for the works contract lot 5A has been awarded to Roughan and O'Donovan.

The second appointment will be for a technical advisor for all remaining components of the Southeast greenway project. Lot 4 – Mount Elliot will be their first priority to complete and issue for tender. It is planned to issue this service contract for tender in November.

The works contract tender for Lot 5a – Ferrybank to Curraghmore (5.5KM) was advertised in March. Tenders have been received and assessed and the contract has been awarded to Glas Civil Engineering Ltd. The works will commence on site in nearly November.



## 2.2 Trinity Wharf

The contract for the construction of the access road was awarded to Glás Civil Engineering Ltd, in January 2023 and works commenced on site in late February. The sod turning took place on site on 2<sup>nd</sup> March with Minister Darragh O'Brien and elected representatives. Works are ongoing on site with completion expected in Q4 2023.

Procurement of consultants for design services for the site development and public infrastructure works is underway. The preferred tenderer is identified, and the standstill period has expired. The formal appointment of the design services consultant is imminent.



#### 2.3 New Ross Emigrants' Park – Oil Tanks Site

This project consists of removal of the oil tank structures on the Quay and the development of public realm works on the site. The Advance Works Contract (Removal of Tanks) was complete in July 2021.

RRDF funding of €814,393 for the project was announced in November 2022. The works are now complete and the park was officially opened by Minister Heather Humphrey's on 26<sup>th</sup> October 2023.



#### 2.4 Mechanics Institute, Wexford

The works contract for essential maintenance works at the Mechanics Institute has been awarded to Roger Doyle Contractors and works commenced on site in January 2023.



Completion is expected in December.

#### 2.5 Oyster Lane Site, Wexford

A Part VIII submission has been made for the demolition of existing unoccupied buildings on the old Tesco site, including the construction of a temporary surface level car park. The Part VIII was confirmed at the March 2022 County Council meeting. A further Part 8 submission has been made for erection of a temporary performance structure and public realm area, instead of a surface carpark.

O'Connor Sutton Cronin consulting engineers have been appointed to provide design and construction related consultancy services for the project.

The demolition contract was awarded to John Tinnelly & Sons (Ireland) Ltd, with works on the initial contract for the old Tesco site now largely complete. WCC has also agreed an extension to the main works contract to undertake the demolition of the former Dun Mhuire Theatre, which is now complete.

#### 4. Flood Defence Schemes

#### 4.1 Enniscorthy Flood Defence Scheme

Statutory Process - The Minister for the Department of Public Expenditure & Reform (DPER) issued his decision to refuse the scheme on 4th March 2022. Details are available on <a href="https://www.gov.ie">www.gov.ie</a>. Following the decision, the OPW confirmed their commitment to delivering an effective scheme for Enniscorthy.

Flood Defence Scheme – The project baseline data is to be updated, scheme alternatives are to be assessed, consulted on publicly and a preferred option identified. It will then be necessary to decide on the most appropriate planning route for the scheme. The hydrology and environmental baseline data is currently being updated; ecology survey reports are to be completed in Q4 2023.

New River Slaney Bridge - It is intended to obtain planning consent for the construction of the new bridge as phase 1 of the flood defence scheme. The baseline data is currently being updated. Traffic surveys are complete, ecology survey reports are to be completed in Q4 2023. The planning application is to be submitted in Q1 2025.

A flood event occurred on the 24<sup>th</sup> October 2023. WCC's Flood Plan was activated. River Level gauges upstream were monitored, WCC crews were on standby, and sandbags were ready for deployment. Fortunately, flood levels receded on the 25<sup>th</sup> October, residential and commercial properties in the town were not flooded by the river on this occasion.

#### 4.2 Wexford Flood Relief Scheme

The contract for engineering and environmental services for the Wexford Town & Environs contract was signed by WCC and Nicholas O'Dwyer Ltd on 23rd March. Officials from the OPW, the sponsoring agency for the scheme, including the Minister Mr Patrick O'Donovan, attended. A preliminary cost estimate of €9.52m has been approved by the OPW for scheme, which will be fully funded.


The appointment includes flood risk modelling; assessment of options for flood prevention; preliminary design; the preparation of planning and other statutory consent applications; detailed design; tendering for works contractors and construction management services. The first project Steering Group meeting was held on the 17/10/23.

#### **UKRAINIAN RESPONSE UPDATE**

#### Offer a Home

The team continue to place displaced Ukrainian families in properties across Wexford, in both rural and urban areas. To date some 160 properties have been allocated, housing 555 Ukrainian people who are Beneficiaries of Temporary Protection Orders (BOTP's).

Below is an infographic showing the location of both Offer A Home properties and Irish Red Cross pledged properties currently housing Ukrainian people (BOPT's) in Wexford.



#### Irish Red Cross (IRC) Pledged Accommodation

The Team also assists Ukrainian families in pledged accommodation. There are 60 IRC pledges accommodating 205 Ukrainian people.

#### **Ukrainian Community Response Forum**

The next meeting of the Ukrainian Community Response Forum will be held on the 15<sup>th</sup> November 2023. The Forum has been asked to review the initial Terms of Reference to incorporate the work of the Local Authority Integration Team and future meetings of the Forum will include this new remit.







## HOUSING

#### **Housing Strategy & Services**

Under the Housing for All Programme 2022 to 2026, Wexford County Council must deliver a minimum of 1,161 new housing units within the programme timeframe. The status of overall programme delivery is contained in the diagram below.



It is the Councils intention to continue to deliver new housing, above the target provided under the programme, where demand exists and Department funding is available.

The following tables outline the current delivery pipelines and status on projects. For LA Direct Build information, please refer to the Capital Development section of the Chief Executives Report. All below are currently under construction (except\*). The report details 600 approved units of which 514 are currently on-site and under construction. A further 490 units have received support.

#### Turnkey Delivery

The Housing Section periodically seek Expressions of Interest for the provision of social housing units via Turnkey Acquisition. There is currently an Expression of Interest open which is due to close on the 24<sup>th</sup> November, 2023. All calls are seeking targeted delivery of smaller unit types (1 & 2 beds) in areas of need identified in the Housing Delivery Action Plan (HDAP). In addition, the process also seeks proposals for purchase of land in areas of need. All proposals received by Wexford County Council under the turnkey process are assessed by an Internal Assessment Committee.

#### **Energy Efficiency Retrofitting Programme**

Energy Efficiency Retrofit Programme 2022 was the second year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets set by the Department for Wexford to date.

The range of works undertaken in the properties include external wall and attic insulation, new doors, new windows, blocking of fireplaces, low energy lighting, high efficiency boilers, and upgraded heating system and controls. All properties received a minimum of a B2 BER rating after the works were completed.

Of all targets, the Housing Maintenance Section completed energy upgrades to 37 properties in 2022. We propose to complete the balance of our 2021 to 2023 targets in 2023. The value the grant funded works planned for completion in 2023 will exceed €3.1 million.



#### Riverchapel Freecycle Shop

SAW in collaboration with Men's Shed Wexford, organised a Scooch Tournament on Monday the 2nd of November in St Joseph's Community Hall. 16 men participated from different Men's Sheds, Ramsgrange, Mayglass and Wexford Town. Frank Fahey from FIT Walk Ireland made a guest appearance and all participants enjoyed sandwiches and a cup of tea to finish off the event.

#### Positive Aging Week - Bolt Electric Bike Taster

SAW in collaboration with Wexford Coco, cycling officer Claire Goodwin organised a Bolt Electric Bike Try Out in County Hall on Friday the 6th of October for Positive Aging Week. Georgina Gaul, Sheilbaggan Outdoor Instructor carried out the cycling demonstrations. Education

information regarding utilising the Bolt Bike app was also carried out. 16 participants attended.

#### Yoga Autumn Series

A yoga Autumn series programme finished during Positive aging week on Wednesday the 4th of Oct in partnership with Wexford Town Library. This four-week programme has had 10 female participants sign up along with additional numbers on a waiting list.

#### Strong and Steady - Coolcotts

On Wednesday the 4th of October SAW in partnership with the HSE started Strong and Steady in Coolcotts Community Centre. This is a 20-week falls prevention programme for older adults. HSE Physiotherapist leads the first 6 weeks and SAW staff and Tutor then take over for the final 14 weeks.

#### Age Friendly Awards- Judges Visit

The Strong and Steady programme has been shortlisted for the 'Active and Healthy Ageing Award'. The judges visited on the 2nd of October and the Award Ceremony will be hosted on the 30th of November.

#### Positive Ageing Week - Photo Map Orienteering

SAW in partnership with Orienteering Ireland organised a 'Photomap Orienteering' event in Wexford town on Wednesday 4th October. 12 participants took part over either the short course (2.0km) or long course (4.3km) equipped with maps and photographs of landmarks around Wexford town.

#### Positive Ageing Week - Health Checks Wexford Library

SAW in conjunction with the HSE and Healthy Wexford provided Physical Health Checks in Wexford Library on the 5th October. Physical fitness measures were taken and participants were given their scores compared with their aged-matched normative values. Participants were provided with an exercise advice booklet and a dietary advice thanks to HSE dieticians. There were 16 participants, 14 female and 2 male.

#### Residential Nursing Home Exercise Classes

Tuesday the 17th October saw the start of a 9-week exercise programme in 4 nursing homes being run by SAW in conjunction with Age Friendly Wexford (Kerlogue, Knockeen, Cherrygrove and Castlegarden)

This will continue until the 14th of December.

#### Activators

A six-week activators programme was delivered in Wexford Library. Ten women attended the programme along with an additional 5 participants on the waiting list.

A 3-week programme was delivered in Castletown GAA in conjunction with the GAA Healthy Communities Club. The programme concluded on October 19th with 13 participants attending; 12 female and 1 male.

A taster session was delivered for the New Ross Active Retirement Group on the 6th of October. There were 56 participants in attendance; 22 males and 34 females.

#### Inclusive Adapted T.Y Module

SAW has begun delivery of an inclusive adapted module for transition year students in Our Lady of Lourdes on the 4th of October. The module covers different types of disabilities, assessing suitability of facilities in their local area, adapting games and sports tailored to different abilities. The module takes place over 6-weeks.

#### Health and Well-being Event

SAW will attend a Health and Well-being event in Bunclody on Thursday 26th of October to showcase the inclusive activities we deliver and also to connect with locals in the area.

#### Teenage Girl Adventure Programme

A teenage girl adventure programme for girls in Direct Provision centres began on Saturday 7th of October. The programme is delivered over three days;

Day One; Carrickbyrne Hill – learning flora/fauna, map reading, leave no trace.

Day Two; Curracloe Beach/Ravenwoods – Climate action, sound mapping by an artist and musician.

Day Three; Min Ryan Park & Creative Art Centre; the girls will complete a collage of their memories and of the programme.

10 teenage girls are attending the programme. Programme was funded through Creative Ireland.

#### <u>Traveller Women's Exercise Groups</u>

A traveller women's exercise group started in New Ross on the 25th of September for 4-weeks. Attendance ranged from 1 to 4 participants.

A 6-week yoga programme for traveller girls in Clonroche started on Monday 25th of September. The attendance ranged from 6 to 8 participants.

#### Syrian Community Exercise Group

A three-week programme was arranged for women in the Syrian Community in New Ross. However, due to unforeseen circumstances the programme has been rescheduled until next year.

#### **IPP** Badminton

An 8-week badminton programme started on Tuesday 10th of October for individuals in Cedar Lodge and Slaney Manor Direct Provision Centres. The attendance for this programme ranged from 23 participants to 32 participants. So far 19 females and 13 males have registered with Badminton Ireland.

#### Social Soccer

A 6-week social integration soccer for Slaney Manor and Cedar Lodge began on Thursday the 19th of October in Barntown FC.

Safeguarding 14 x Safeguarding 1 Courses have been completed in 2023 with a total of 1196 participants.

#### **Staff Pilates**

SAW Tutor June Molloy is running a 4-week Beginner Pilates programme in Wexford County Hall for Wexford Coco staff. This programme started on the 18th of October with 10 participants registered.

## **ENVIRONMENT**

## A. COASTAL MATTERS

#### Harbours -

Brexit Adjustment Local Authority Marine Infrastructure (BALAMI) 2022 – 2023. The DAFM approved 25 projects under this scheme with total construction cost of €1.79m. A number of the projects are completed, some are ongoing and some are about to commence. Note that WCC must pay all non-construction costs including design, environmental reports etc.

#### **Operations -**

The regularization of the public lighting system on the Barrow is ongoing, new lights have been fitted to Marshmeadows access road and Jetty. Further lighting upgrades on the site have commenced in September to facilitate new business activities.

A new traffic management system and weighbridge upgrade is due to commence in October / November.

KIMO AGM was held in Falkenburg Sweden 4<sup>th</sup> – 6<sup>th</sup> October, Wexford County Council was represented. KIMO have tentatively enquired about Wexford hosting the next international board meeting in May 2024.

#### Beaches -

Bathing water: weekly bathing water samples ended on 3<sup>rd</sup> September. The water quality results are published on beaches.ie website. There were 6 water quality incidents – at Courtown (2 no.), Carne, Duncannon, St Helen's and Baginbun. These incidents were followed up with investigations and discussions with HSE.

Ballymoney Blue Flag Beach – Access for All and Age Friendly Improvement Works. Design and tender works for the access path are ongoing, with the works expected to go to tender before the end of the year..

#### Coast -

The Environment Dept monitors the coastline regularly, focussing on erosion risk areas.

Rosslare Coastal Erosion and Flood Relief Scheme: Nicholas O'Dwyer Ltd Consulting Engineers is appointed to progress the scheme. Key design parameters for the scheme are being finalised. The project website and project email are now live and can be accessed at <a href="https://www.floodinfo.ie/rosslarefrs/">https://www.floodinfo.ie/rosslarefrs/</a>

There is provision on the website to email the project team with specific queries. Public consultation days will be held later in 2023.

<u>Seaview, Kilmore:</u> Preplanning application was submitted to Wexford CC Planning Dept in August 2023, with application for full planning permission to follow. Preplanning meeting was held with Planning Dept on 29<sup>th</sup> August. A planning application will be submitted over the coming weeks. Further correspondence was issued to OPW in order to progress the funding of the scheme.

<u>Lady's Island Water Level Management Structure</u> – An Bord Pleanála granted planning permission for this development, dated 3rd Sept 2021. Foreshore licence application has been lodged and is under consideration by the Dept of Housing, Local Government and Heritage (DHLGH). The application is now under consideration by the DHLGH.

Kilmannock Drainage Scheme – this is a land reclamation and drainage scheme dating from mid 1800s; draining approx 1,000 acres of land near the Great Island Power Station. Maintenance works including the installation of new outlet valves on the drainage channel were installed in early August 2023. Site inspections have confirmed that the operation of the drainage scheme has improved significantly since the valves were installed. This will be monitored closely over the coming months.

## C. WATER, AIR & NOISE

#### 1. Water Framework Directive:

Under the Water Framework Directive every catchment in the county must be assessed to identify required actions to maintain and improve water quality. This work which is being carried out by Wexford Co. Co. in conjunction of LAWPRO is being supervised by the Sub-Catchment Unit of the EPA.

### 2. Water Sampling:

A Total of 344 water quality samples are taken by Council Scientists from 78 sampling sites in the county per year with analysis carried out by the EPA. 8 surveillance sites are being sampled 8 times per year.

## 3. Septic Tank Inspections:

139 inspections were carried out in 2022. Wexford had a minimum of 106 inspections to carry out in 2022. All work carried out is external with no requirement to enter a dwelling. Contractors are currently carrying out work on several sites to close outstanding Advisory Notices. A minimum of 130 inspections will have to be carried out in 2023. 88 inspections have taken place up to the end of September with 45 passes and 43 fails. A further 30 inspections will take place in October/November of 2023.

Progress is being made with closing existing open files. All files up to the end of 2016 have been closed. 62 files have been closed during 2023 so far. 25 extensions of time were granted in 2023. There are currently 57 open files for the years 2017-2022 and 29 open for 2023, a total of 86 open cases. 62 files have been closed in 2023.

Twenty one applications for grant assistance have been received this year to date of which sixteen have been processed/ have been sent for payment. It is understood that the grant to support improvement works on registered systems will be increased from 5K to 12K from 1/1/2024.

There are currently 10 cases in the Court system for failing to comply with Advisory Notices. 2 of these are for hearing and 8 are currently for mention.

10 verification inspections were carried out in April 2023 on sites which have Advisory Notices open over 2 years.

#### 4. Section 4 Discharge Licences:

The Council currently has 92 active Discharge Licences. Six new applications have been received in 2023 to date. Three applications were received in 2022, two of which are under review and one was formally granted in March 2023. Six discharge licences have been revoked in 2023 at present and a few more are under review.

#### 5. Air Quality:

Wexford County Council enforces air quality requirements for 3 specific types of facilities, which must be registered with Wexford County Council. These Certificates must be renewed every 3 years. On-going enforcement action is carried out to ensure sites remain certified. Wexford has a 100% compliance record in this regard for all 3 below categories in 2022.

**Vehicle Refinishers:** At end of 2022, 59 facilities were registered with Wexford County Council under the "Deco Paints" Regulations, which is now the largest number in the country. WCC issues Certificates of Compliance to these facilities and issues "On the Spot Fines" of €500 where illegal operators are identified on foot of enforcement investigations – see Table below. The additional facilities were identified on foot of targeted enforcement action in 2022.

**Dry Cleaners:** At end of 2022, 8 Dry Cleaners and 1 Medical Device Company were registered with Wexford County Council under the "Solvents" Regulations. WCC issues Certificates of Compliance to these facilities – see Table below. Due to targeted enforcement action in Q3/Q4 of 2022, a new category of facility is due to be added to this register in Q2 of 2023.

**Petrol Stations:** At end of 2022, 80 sites were registered with Wexford County Council under the PVE Regulations, which is the largest number in the country. WCC also issues Certificates of Testing to these facilities under these Regulations – see Table below.

A national working group was established in January 2021, to develop Guidance Documents for Local Authorities to assist with the implementation of new certifications to Petrol Stations under Stage 2 Petrol Vapour Emissions Regulations 2011.

Wexford County Council is co-chair of this group, along with Waterford County Council. The WG produced two separate Guidance Documents for Local Authorities, including specific guidance on processing certifications for Petrol Stations under Stage 1b Petrol Vapour Emissions Regulations 1997 and Stage 2 Petroleum Vapour Emissions Regulations 2011. Stage 2 certifications for relevant sites is required to be implemented, as are significant changes to Stage 1b certifications for all sites.

#### **Low Smoke Fuel Areas**

The Air Pollution Act 1987 (SOLID FUELS) Regulations 2022 was signed by the Minister for the Environment, Climate and Communications Mr Eamon Ryan and came into effect on the 31<sup>st</sup> October 2022. Spot inspections have been carried out to ensure compliance with the 2022 Regulations.

#### 6. Agriculture:

Wexford County Council continues to undertake a significant number of farm inspections in accordance with the WFD. A total of 65 farm inspections undertaken because of pollution incidents or complaints, 30 of these farms were found to have non-compliances. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

Section 12 & 23 notices under the Local Government Water Pollution Act 1977-1990 were served upon on 4 individuals where 2 of these farms were cross reported to DAFM.

A total of 95 Agricultural related Planning Permission Applications were assessed.

#### 8. Water Quality

Water Quality in the South East – meeting of regional committee with a focus on agriculture A regional meeting of government agencies with a role in water quality management or sectors potentially impacting on water quality met in Gorey, Co Wexford on Oct 5<sup>th</sup> 2023. The meeting was chaired by Wexford County Council and hosted by the Local Authority Waters Programme and Teagasc. Delegates met to discuss and work through issues raised by the agencies, that are impacting on water quality in the South East; including Wexford, as part of Irelands River Basin Management Plan. Over 55 people were present from 18 different agencies.

Key issues also raised were the continued decline in water quality within the region; the need for better oversight, including updating the register of Section 4's discharge licenses across the country; the need for a working group to be set up to focus specifically on coastal water quality and the shellfish industry; and better supports and focus for agriculture sector.

Opportunities: the meeting specifically focused on Agriculture and developing better ways to communicate with the farming sector including highlighting the following programmes:

- The new €60m National Water European Innovation Programme was highlighted where farmers will get payments to assist in addressing water quality issues on their farms. more <u>information</u> is available from Teagasc.ie or by emailing info@lawaters.ie
- Recent changes in Department of Agriculture Food and Marine eligibility rules for accessing basic
  farm payments, were also discussed and how they will help address drivers resulting in biodiversity
  loss (such as the perceived need to remove river bank vegetation and scrub in areas of high nature
  value or where they are features protecting water quality or reducing flood risk). These are naturebased solutions providing important services protecting water quality downstream more information

A field excursion was also organised by Teagasc to the Agricultural Catchment Programme farms in Ballycanew and the delegates talked first hand with farmers about the challenges that farmers face with the changes to derogation and other rules. This offered a great opportunity for the agencies and the farmers to better understand and develop strategies going forward that work to protect water quality and farm incomes.

#### 3. Waste Facility Permits:

We currently have sufficient permitted facilities throughout the county, such as Clean Soil and Stone, construction and demolition sites, ATF's / End of Life Vehicles and Pay to Use Waste Compactor Unit. The full list of Waste Facility Permits and Certificates of Registration can be viewed on the Council's website.

Altogether there are 68 registered operational Waste Facility Permits and Certificates of Registration for premises involved in waste management activities in the County.

#### 4. Enforcement:

The Waste Enforcement Team carries out routine (planned) and non-routine inspections of waste facilities and problem sites or site where we have received complaints. This work is done in accordance with the Recommended Minimum Criteria for Environmental Inspections (RMCEI) as submitted to the EPA on 28 February 2023. The 2023 RMCEI Plan allocates 6,597 routine inspections by 22 Full Time Equivalent staff members. The inspection types cover the WEEE (Waste Electrical and Electronic Equipment) Regulations; ELV (End of Life Vehicles) Regulations; Waste Management (Packaging) Regulations; Household and Commercial Food Waste Regulations; Batteries, Tyres, Mercury etc.

The Department of Environment, Climate and Communication have set national waste priorities for 2022 to 2024, a three-year target and they are.

- Tackling significant illegal waste activity,
- Construction and Demolition Activity,
- End-of-Life Vehicles (ELV) & the Waste Metal Sector,
- Waste Collection Household & Commercial.
- Producer Responsibility Initiatives and additional local priorities.

## F. CLIMATE ACTION

The Climate Action Plan is required under the "The Climate Action and Low Carbon Development (Amendment) Act 2021." The plan incorporates both mitigation and adaptation measures. It will also include the development of a Decarbonisation Zone (DZ) which will be the focus for a range of climate mitigation, adaptation, and biodiversity measures. Enniscorthy is the Decarbonisation Zone for County Wexford. Minister Eamon Ryan requested Wexford County Council to commence its Climate Action plan on 24<sup>th</sup> February 2023 with 12 months to prepare, complete and fully adopt the plan. The Plan will set an ambitious target of an absolute reduction in greenhouse gas emissions of 51% and 50% energy efficiency by 2030. Wexford County Council will be responsible for reducing greenhouse gas emissions from across its own assets and infrastructure, whilst also taking on a broader role of influencing, facilitating and advocating others to meet their own targets.

The draft Wexford County Council Climate Action Plan went before the elected members at the October monthly meeting and approved for public consultation.

Wexford County Council will be requesting views, observations and recommendations for consideration on the draft Climate Action Plan from 10<sup>th</sup> October to 21<sup>st</sup> November 2023 through the online Portal or in writing to Climate Action Team, Environment Section, Wexford County Council.

#### **Community Climate Action Programme**

The Community Climate Action Programme funding scheme is due to open shortly to support and build low carbon communities across County Wexford. The fund is open to not-for-profit community groups and clubs.

Funding for 100% of the cost of a climate action project is available through this scheme, up to a maximum of €100,000. Project examples could be insulation of community buildings, solar panels, bicycle parking, rainwater harvesting, community gardens / allotments, etc.

Our aim is to promote awareness and active participation in a range of environmental initiatives.

**Green Schools:** Preparations are underway for the 2023/2024 academic year. **Planting Grant:** 84 applications were approved under the 2023 planting grant scheme and closing date for groups to redeem their grant was Friday 29<sup>th</sup> September. A reminder text message was sent out to all groups in early September.

**Trees for Wexford:** Applications opened for the Trees for Wexford Scheme week commencing 11<sup>th</sup> September with a closing date of 6<sup>th</sup> October @ 4 p.m.

**Heritage Stewardship Fund/ Hedgerow Survey:** An information talk took place on Saturday 23<sup>rd</sup> September at 2.30 pm in Wexford Library. The talk which was well attended explored the importance of the hedgerows in our landscape and their role in helping biodiversity in County Wexford. The talk shared some of the key findings of the survey, the species that make up our hedges, how they can be manged and protected for everyone's benefit.

### Wexford Festival Opera 2023, 24th October to 5th November

Wexford Branch Library contributed a wide programme of events to coincide with Wexford Festival Opera with poetry, lectures, an art exhibition and musical events.

### **Wexford Volunteer Centre – One Million Stars Project**

Wexford Volunteer Centre brought the One Million Stars Ireland Project to Bunclody Library. This inclusive community arts project connects communities across Ireland in solidarity against domestic abuse and all forms of violence. Stars are woven from paper and represent light, hope and solidarity against violence, promoting the projects 8 points of healthy love within relationships. Stars are curated into the travelling 'LOVE' installation, spreading love and hope for a future free from violence for all.

### **Happy to Chat**

The 'Any News' conversation group has been replaced with the 'Happy to Chat' initiative in Wexford library. A new pilot initiative to increase social engagement and reduce loneliness and isolation in the community, 'Happy to Chat' is supported by Healthy Wexford and Wexford County Council.

### **Wexford Volunteer Centre Information Sessions**

These information sessions on volunteering continued in library branches over October.

### 'Animal Life'

Camphill Wexford Day Service mounted an art exhibition "Animal Life" in the foyer on of Gorey Library this month. The exhibition included several pieces created by service users in the local community.

### My Open Library

My Open Library Service continues at New Ross and Gorey Libraries.

After an induction, members of this enhanced service can access the library on a self-service basis from 8am-10pm, 7 days a week. Fully staffed library opening hours remain in place Monday to Saturday. During My Open Library hours, all library services are available, My Open Library users can use the study space, use a public PC or laptop, avail of printing services, the internet and Wi-Fi and borrow and return items and collect requests.

### **Sensory Friendly Hour**

The Sensory Hour continued Saturday afternoons from 4.00pm-5.00pm. This hour supports library users, both adults and children who have sensory and/or extra needs.

### **Book Buddies**

The second meeting of "Book Buddies", an intellectual disability inclusive book club was held on Monday 9<sup>th</sup> October in Gorey Library. This club was launched in support of Down Syndrome Ireland.

### **Bunclody Day Care Centre**

Bunclody Library staff visited the Age Action group in Bunclody Day Care Centre and gave an informative talk on all library services particularly digital resources.

### **Movies Memories**

'Movie Memories' which is part of Gorey Library's official Age Friendly Event programming took place on Monday 23<sup>rd</sup> October. As requested on the Age Friendly comment cards two analogue clocks were recently installed in the library.

### The Nursing Home Project

Folklore collector Rachel Uí Fhaoláin hosted a special in-conversation event discussing old cures in Irish folklore in Gorey Library. The event included informative first-hand accounts from residents involved in The Nursing Home Project. The audience included residents and family members from local nursing homes.

# **Learning and Information**

### **Digital Help Hub**

The Digital Help Hub continued in October with Enniscorthy Library being one of the community locations. Digital Help Hub is an initiative of the ALL-Adult Literacy for Life national strategy. WWETB, WLD, and Wexford County Council Library Service have worked together to bring this Pop-Up initiative to County Wexford. WWETB tutors were available to help the public on a one-to-one basis. There were demonstrations on how to use devices such as phones, tablets and laptops, how to get online and use apps and how to access multiple services like eGov, MyWelfare, the National Childcare Scheme, Revenue, SUSI, Choice Based Letting and more.

### **Digital Ambassador Sessions**

By appointment each week, Enniscorthy Library staff are available for half hour tutoring sessions, participants will be shown how to access the range of online library services, particularly BorrowBox which is used to download e-books and e-audiobooks to a phone, tablet or laptop/computer.

Each session will help familiarise participants on how to access the internet, assist them to download apps and help them participate in other online activities.

### **Digital Skills Class**

Age Friendly Digital Literacy Weekly classes for the over-55s take place each week for older people in Enniscorthy and New Ross libraries. A WWETB tutor facilitates the classes.

### **Reach Ability**

Currently four groups from the local Reach Ability programme visit Enniscorthy Library each week to use the IT suite and exchange books. A member of the Reach Ability community started a work experience block in Enniscorthy Library during October, for one hour per week over a nine-week period. The Reach Ability Group, Castlebridge attended the IT Suite in Wexford branch for classes over a six-week period.

### **Health and Well Being**

Activator Poles Sessions and Yoga Sessions with Sports Active Wexford continued in libraries this month.

### **Local History**

A total number of 26 local studies enquiries were responded to and a total of 22 genealogy enquiries were completed in Wexford Library in October.

### **Services to Ukrainian Nationals**

Ukrainian English Classes continue in Wexford and Gorey branches. New weekly information, help and guidance meetings called Outreach to Ukrainian Families started in Wexford Branch this month. The Community Support Officer with Wexford Local Development held English language classes for Ukrainian adults twice weekly in Gorey Library. New Ross Library provided Outreach for Ukrainian Nationals each Monday during October.

### **Environment and Climate Action**

### **Climate Action Plan Drop in Session**

The public were invited to drop into libraries this month and talk to members of Wexford County Council's Climate Action Team in relation to the Draft Wexford County Council Climate Action Plan.

### A "Library of Things" - Circular Economy

A **biodiversity kit** is available to borrow from Wexford Library. The kit can be borrowed for up to three weeks and is free to borrow with a library membership card.

The **Home Energy Saving Kit** is available to borrow for two weeks with library membership card.

### **Digital Radon Monitor Loans Scheme:**

New Ross Library supported the Healthy Wexford series of four programmes with Campile Area Development Group in October. As part of session 2, The Air that we Breathe, in Campile Hall on 18<sup>th</sup> October, the EPA spoke about Radon, and how it impacts the home and health. 18 Digital Radon Monitors were loaned to residents in the Campile area on the night from New Ross Library. Wexford Libraries are the first Public Library Service in Ireland to offer Digital Radon Monitors for loan and attended a seminar in Cork in October when the scheme was extended to Cork County Library Service. Digital Radon Monitors are currently available to borrow for free to library members in all five library branches in the county.

# Reading and Literacy: Right to Read at Your Library

### **Childcare Seminar**

Wexford Library Service for Children and Young People attended the Wexford County Childcare Committee seminar entitled 'Understanding Challenging Behaviour' which focused on children from birth to 12 years. Wexford Library Services had two large table displays of new childcare books and associated brochures. The new book collection was sourced in consultation and close collaboration with local teachers, families, organisations supporting families and SETU. Resources were selected to support the work of educators, families, healthcare professionals and childcare students living and/or working in County Wexford. In addition to attending the seminar, Wexford Library's services and resources were promoted to all attendees and questions and queries from childcare professionals and childcare students were addressed. The collection of books will be housed in Wexford Library will be available to borrow soon from any library or mobile library in the county.

### National Children's Book Festival 2023

Wexford Library Services, in association with Libraries Ireland, have been organising Children's Book Festival for many years. The promotion and support of the Children's Book Festival is a central tenet of the *Right to Read* initiative and this programme continues to be a central focus for library services to children each October.

All branches in Wexford Library Service held a highly successful programme of events for schools and families throughout the county. Visits from award winning Irish children's authors and illustrators offered schools and families the opportunity to meet some of the very best writers and artists. There were events for children from pre-school to 12 years of age. Sensory events for children with intellectual disabilities were offered in each library to ensure that there were book related events to engage all ages and abilities. Altogether Wexford Libraries hosted 30 events and feedback was excellent.

### Little Book at Bedtime

This initiative from Roderic O'Gorman, Minister for Children, Equality, Disability, Integration and Youth and Heather Humphreys, Minister for Rural and Community Development, in collaboration with public libraries and the LGMA, aims to encourage all parents of young children to read stories with them at bedtime. The initiative looks to promote reading for pleasure and to improve children's literacy. From the 6th of October, parents and children under 4 could pop into their local library to pick up their free bedtime story book and join the library. Bedtime story books are available in English and Irish. There has been significant uptake of this initiative so far, with many families joining several new members to the library on receiving the free books.

### **Dormant Account Fund (DAF) Literacy Support Programmes**

A range of literacy support programmes provided to schools and the community by the library include: TTRS, Nessy Reading and Spelling, Reading Eggs, Mathseeds. All literacy and numeracy programmes are in great demand by the public and primary and secondary schools. Windmill Therapeutic Centre attend the IT Suite in Wexford Library every Monday for TTRS. LOTE4Kids is being promoted particularly to Ukrainian Nationals.

# Decade of Centenaries The End of the Irish Civil War and the 1923 Election in County Wexford

Historian in Residence Barry Lacey visited libraries this month and discussed the end of the Irish Civil War in County Wexford and the election which took place afterwards in August of 1923, which was the first election since the foundation of the Irish Free State. The talk looked at the candidates involved in the election and how they lost or won seats to represent the people of the county.

Historian in Residence with Westmeath Co. Council Dr. Ian Kenneally lectured on Fake News and Irish Freedom: The years 1919-1923 in New Ross Library.

### Collections management

In addition to 47 research enquiries via email, telephone and post, a total of 13 researchers visited the Archive in October. Research topics included family history research through the Boyse estate rentals (Bannow) and the Lorna Rosbottom collection (1800s); research through the Wexford Festival Opera archive on The Rose of Castile opera (1951); deaths recorded in issues of *The Wexford Chronicle* (1830s-50s); research through the archive's Civil War collections for a forthcoming exhibition (1922-23); research on the formative years of Ros Tapestry (1990s); family history research through extant rentals of the estate of Raymond Rowe, Wexford town (1872-79).

### **Exhibitions:**

IRISH GOTHIC A solo exhibition by Patricia Hurl In association with IMMA

opened in County Hall on 19<sup>th</sup> October 2023. This exhibition, selected from a major retrospective hosted by IMMA earlier this year, presents one of Ireland's most accomplished artists. Hurl's work is by its nature political, and traverses the disciplines of painting, multi-media and collaborative art practice. Since the 1970s, she has created work that deals with loss, pain, frustration and loneliness. The Exhibition is open to the public from 16th October – 29<sup>th</sup> November 2023 Open Monday – Friday, 9am-5pm. Free public and school tours are offered.

**Wex-Art** – a visual arts festival to coincide with Wexford Opera Festival was launched on 14<sup>th</sup> Oct. Wex Art is coordinated by Tom Mooney and supported by the Arts office. The Wex-Art Map features over 20 exhibitions taking place in Wexford town from Oct 14- Nov 6 showcasing the work of over 70 artists based in Wexford. In addition, the Wex Arts Festival guide highlights arts and cultural events taking place over the course of the festival until November 6 and is supported by Wexford Borough.

Wexford County Council Arts Department and Wexford Arts Centre in partnership with South East Technological University launched *LOOP A solo exhibition by Emma Roche*, recipient of the 2021 EMERGENCE Visual Art Award. This launched on 14<sup>th</sup> October in Wexford Arts Centre and runs until 24<sup>th</sup> November. This award supports visual artists with the development and promotion of their practice.

### **Music Generation**

Is an ongoing partnership between Wexford County Council and WWETB supporting performance music education of young people in primary, post primary and youth work contexts countywide.

**Schools programme –**vocal and instrumental workshops in 25 Primary schools countywide which is ongoing Sept 2023- May 2024.

**The Bunclody Music Hub** located in Bunclody Vocational College provides a number of places for after-school group instrumental and vocal tuition for children and young people aged 7 -18 years in addition to group lessons which will be available in October in Guitar - acoustic and electric, and Piano Keyboard.

### Music Generation trip - Creative connections - Sitges Spain

Ten young people from Music Generation's **The Yellow Bellows**, a singing group for teenagers 12-18 years, travelled to Sitges in Catalonia Spain 26 – 30 October to take part in their annual Celtic festival titled Creative Connections, which is funded through Culture Ireland. They were accompanied by their music educators and Music Generation team.





**Wexford Wind Jammers & HFC Youth Band** is a new initiative started in October for young people from 6th Class to 6th Year and led by musician educators Jenna Larsen & Geraldine Mahon in Scoil Mhuire, Coolcotts.

### **County Wexford Youth Film Project**

The CWYFP, supported by the Arts Office, is running a 4 day Documentary Filmmaking Workshop in October/November which will focus on the power of the documentary. The workshops are free to teenagers across County Wexford.

#### Screen Wexford

Funded by the Arts and Economic Departments of Wexford County Council to develop film industry in Wexford, Screen Wexford held a coffee and networking morning at the Presentation Centre on 22nd September to welcome new and emerging crews to Screen Wexford. Screen Wexford provides ongoing support to the screen industry for film permits etc and provides ongoing support to the winners of the three New Voices Film bursary awards 2023. All three films are now completed and will be screened in Wexford Arts Centre in November.

### **Arts Festival Grant Scheme 2023 recipients:**

The Eugene O'Neill International Festival – is a recipient of the Fáilte Ireland Festival Grant Scheme for County Wexford. The festival took place in St. Michael's Theatre, New Ross on 12-15th October. This niche festival was very well attended by local and national audiences.

### **CREATIVE IRELAND**

### Creative Ireland - Open Call Arts Awards 2023

Nine cultural organisations and artists' collectives throughout the county have been awarded funding through Creative Ireland Wexford Open Call 2023. These awards are for innovative programmes that develop creative thinking in addressing the key strategy areas of well-being, placemaking and climate action. The Creative Ireland Programme feeds directly into our County Development Plan, and people from all over Wexford will benefit from these awards. A total of €70,751 was invested in local communities.

Successful applications include:

- X-Gap (The Gap Arts Festival): a new Christmas performance piece developed between North Wexford communities and artists Honor Heffernan and Garrett Keogh.
- Cartlann na nDaoine (North Wexford Traditional Singing Circle): an intergenerational exploration of living and evolving local song traditions.
- The Fishermen of Wexford (artist Helen McLean): the design and creation of a large new mosaic with the Wexford Tidy Towns group, to be installed at the Crescent, Wexford Quay.
- Invitation to a Conversation (Sown Society): a series of multidisciplinary workshops that explore innovative and sustainable practices relating well-being to nature, creativity and community.
- Trailblazers A Way with Words (Purple and Gold Writers Collective): a trail of innovative and engaging poetry events in daytime, Wexford Town café venues from 21-29 October.
- The Ways of Water (artists Andi McGarry, Jeni Roddy, Lynn Haughton, Conall Geoghegan: boat building workshops at Kilmore Quay Community Gardens and Stella Maris Centre that use found and natural materials to address sustainable living within the adjacent watery landscape.
- The Enniscorthy Time Machine (Festival in a Van): an exploration of Enniscorthy's past and future through new poems, stories and songs, focusing on social justice and climate change.
- Ghost House (Spooky Before): a county-wide storytelling project that draws from supernatural, spiritual and unexplained experiences in the home to explore mental health and wellbeing.

The May Bush and The Coming of Summer (artists Michael Fortune and Aileen Lambert): an
archival project that celebrates traditional May-time festivities and underlines the importance
these festivities have in creating a sense of place and pride in belonging to a community.

### Creative Ireland - Evolve

Throughout the summer of 2023 Creative Ireland Creative communities programme supported the Child and Adolescent Mental Health Services (CAMHS) in North Wexford to run an art-based programme that focused on the recovery and wellbeing of young people. Artists Sonya Weston and Deirdre Travers worked with a group of teenagers to produce a publication of their own design, using lino printing, mono printing, collage, painting, digital photography, and alternative photography. An exhibition of the work produced was held on Thursday 19<sup>th</sup> October at the Wexford Mental Health Association Building.

### **Creative Ireland – Opera Festival Events**

- 1. The Purple and Gold Writers Collective delivered a trail of innovative and engaging poetry events in daytime café venues from 21-29 October. Taking place during the busy Opera Festival period, these relaxed sessions increased the creativity and fun that enveloped the town at that time. Themed around place and community, workshops will engage participants in a unique yet familiar way of looking at Wexford and provide a fresh way in to developing positive placemaking action.
- 2. Led by Tom Mooney, Wexford Festival Literary Trail was an exploration of its historic laneways and the harbour vistas which have inspired Wexford based writers for centuries. During the Opera Festival period, participants explored the town, stopping at points of literary interest. A paper guide that functioned as an anchor to the literary heritage of Wexford Town was also published.

### Creative Ireland - Puchaiocht/Shapeshifting

Púcaíocht/Shapeshifting is a bilingual publication of poetry by the Wexford born poet Máire Ní Bhriain. The book describes Irish words that remain in the vernacular of County Wexford and relates to logainmeacha and aspects of the culture and nature of the county. Púcaíocht/Shapeshifting was launched on October 12<sup>th</sup> at Wexford Library. Eileen Morrissey, County Librarian and lead for Creative Ireland Wexford opened the launch *as Gaelige*. Speakers included Brian O'Clérigh and author Máire Ní Bhrian, who shared some excerpts from her book. Some Sean Nós singing from Máire's friend enriched the evening for all.

### Creative Ireland - Halloween Extreme Beat

Throughout September and October innovative percussionist Nicky Bailey from Extreme Rhythm held 10 drumming workshops each for FDYS Coolcotts and Taghmon FRC. Nicky used his extremely visual style helped the participants to develop their drumming rhythm and sense of beat in a fun relaxed atmosphere. At the end of October, each group showcased their skills with a performance on stage with their family and friends joining in. This event helped to develop awareness of the local Youth Projects, Family Resource Centre and the support services that are available.

### Creative Ireland - Nursing Home Music and Poetry Programme

Wexford was awarded Creative Ireland Age Friendly funding to develop a workshop programme of music and poetry to four nursing homes in Wexford in 2023 over a 5 month period. The last of the 'Swing Song' workshops took place in mid-October. Musician Melanie O'Reilly, two members of her jazz band with poet and spoken word artist Stephen James Smith collaborated interweaving live swing jazz songs with poetry readings. The aim of the workshops is to entertain and develop conversations and social interaction with the audience. The workshops took place in nursing homes county wide.

### **Audit**

- <u>Audit of Accounts 2022</u> The Audit of Wexford County Council's 2022 Accounts is now complete. The Statutory Audit Report for 2022 has been submitted by the Local Government Auditor and is listed on the agenda for consideration of members together with the final audited version of the 2022 Annual Financial Statement.
- <u>Audit Committee</u> The next meeting is scheduled for 13<sup>th</sup> December 2023, and the committee will meet with the Local Government Auditor to discuss the 2022 Audit and Accounts. Following their meeting with the Local Government Auditor the Audit Committee will prepare their report for the council on the Annual Accounts and Audit process.

### Cash Flow/Overdraft

The Council continues to operate with an overdraft facility, Ministerial Sanction is in place for borrowing by way of overdraft in the amount of €20m for the period to the 31st December, 2023. An application seeking ministerial sanction for the extension of the overdraft facility at the same level for the period 1st January 2024 to 31st December 2024 has been submitted to the DHLGH following council approval at the October meeting.
