ECONOMIC DEVELOPMENT

Economic

Tradebridge

The next trade mission is scheduled for the 22nd October 2023 which will see three Wexford companies participating; Wexbury, MachineLab and Scurri. The CEO of Tradebridge will accompany the group of 5 companies to Savannah. A detailed itinerary has been organised in conjunction with Chris Ahern, Director for Research & Trade Development at the World Trade Centre Savannah where Irish companies will meet with up to 7 potential buyers. The Tradebridge programme funded by Enterprise Ireland is working to develop trade and investment opportunities between the South East and the State of Georgia. Companies that participated on the previous trade mission included Harte Outdoor Lighting, Icon Windows and Emagine and we expect to see contracts coming on stream in the near future and the programme is on track to achieve its key performance indicators for 2023.

Georgia South University (Wexford Campus)

An academic delegation from GSU including the Chairs of the Political Science & International Studies Department and the Interim Chair of the Department of Criminal Justice and International Studies arrived in Wexford on the 30th August to view the facilities at GSU, the Adoration Convent and attend the Economic Forum as part of the Kennedy Summer School.

Work is progressing on the design and planning of the student accommodation with Stephen Carr Architects (SCA) having been formally appointed to the Adoration Convent Student Accommodation Project.

Kilmore Quay

Work is progressing on the masterplan for the 11-acre council owned site at Kilmore. The Economic section are engaging with potential clients for the site and once the masterplan has been finalised planning permission will be submitted under part 8 and expressions of interest will be sought for the development of the site. The Economic Department will also work on marketing collateral for promotion of the site to potential clients.

Kennedy Summer School – Economic Forum

Chief Executive Tom Enright will be one of the speakers at an Economic Forum entitled 'The South East Region and a new relationship with the EU post-Brexit' as part of this years' Kennedy Summer School. Highlighting the local authority economic investment programme for both Wexford and the South East region.

Local Enterprise Office

Training

One of the Local Enterprise Offices key strategic objectives is the provision of quality capability building supports to startup and micro enterprises in the County. The LEO anticipates an increased demand for training and enterprise development supports following the extension of the LEO mandate to support businesses employing up to 50 staff. Following a detailed tendering process, a total of 374 individual proposals were received from 44 suppliers in respect of 166 courses/workshops/clinics. All tender submissions have been received and evaluated and contracts awarded and our full training schedule for the Autumn/Winter will be advertised in early September. The overarching objective is to strengthen businesses by supporting management development, promoting efficiency via the implementation of lean manufacturing and digital processes and the targeting of new markets by building export capability while also meet the challenge of transitioning to a low carbon economy.

Youth Entrepreneurship

The Local Enterprise Office has appointed a new Student Enterprise Co-ordinator to support the rollout of the Student Enterprise Programme to 1st, 2nd 3rd and 5th Years students in post primary schools across the county. The strategic aim of the programme is to foster a culture of entrepreneurship among this cohort and to encourage them to consider self-employment as a career option by giving them first hand experience of running their own mini- business.

National Women's Enterprise Day (NWED) 2023 - 19th October 2023

The Head of Enterprise, LEO Wexford is again chairing NWED 2023, Ireland's largest female enterprise event which encourages and stimulates female entrepreneurship across Ireland. It is designed and led by women and is an annual highlight in promoting entrepreneurship to women in Ireland. A total of 14 local/regional events will take place across the country and the Wexford event will take place in the Newbay House Hotel on the 19th October. This year's theme is "Empowering Business Together". The Wexford event has an exciting lineup of speakers with MC, Mary Rose Lyons, Brightspark Consulting, Keynote speaker Theresa Grant, OBE, and panellists Kate Dempsey, Acqualicense, Deborah Brock, Nua Fertility and Wexford's Female Ambassador 2023, Pauline Dunne, Killowen Farms.

Intellectual Property Workshop - 15th September 2023

Enterprise Ireland, the Local Enterprise Office and SEBIC will be reiterating the important role that intellectual property has in play in developing a unique product proposition, exploiting competitive advantage, fostering customer loyalty, and protecting market share at a regional training event for female led enterprises of scale to be held in Wexford County Council Offices on Friday 15th September.

Tourism



Thirty two Roses from the International Rose of Tralee Festival began a 3-day Wexford Rose on the 11th August with our Wexford Rose, Bronagh Hogan representing the County. The Tour was an outstanding success with the Roses visiting key attractions and towns across the county, experiencing the very best that Wexford has to offer. From an economic perspective, the earned PR value to County Wexford at the 25th August was €310,734, for the same period last year the PR value was €118,000. The Wexford Rose Tour featured heavily in the 2-minute showreel which was shown on the final night of the Rose of Tralee Festival which was broadcast on RTE One. The broadcast viewership figures will be available in the coming weeks and the overall PR value will increase as the coming months with continuing social media engagement. Coinciding with the Wexford Rose Tour, Visit Wexford created a Rose Tour landing page on their website which also encouraged visitors to download the 3-day tour and follow in the Footsteps of the Roses in the Official 2023 Wexford Rose Tour and we are awaiting impact details. The five Municipal Districts played a key role in supporting the event.

Forward Planning

Wexford Town Local Area Plan



The pre-draft public consultation period commenced on Thursday, 8th June 2023 and **ended at 4.00pm on Tuesday**, 8th August 2023. It was a very successful public consultation with in excess of seventy submissions and observations received. The submissions and observations are available to view on the Council's online consultation portal https://consult.wexfordcoco.ie/en/node/1470/submissions. A report on the issues raised in the submissions and observations is currently being prepared and will be submitted to the Elected Members for their consideration during the preparation of the Draft Local Area Plan.

Work is progressing well on the Local Transport Plan and the baseline report is almost complete. The team is currently preparing a Social Infrastructure Audit and an Infrastructural Assessment Report and other background work to inform decisions on land use and zoning. Requests for Tenders to prepare an Urban Design Strategy (including Master Planning) and a Rainwater Management Plan and a Green Blue Infrastructure Strategy were published on eTenders in August.

The Strategic Environmental Assessment Draft Scoping Report was circulated to the Environmental Authorities. The submissions received are being reviewed and incorporated into the final Scoping Report.

The Draft Planning and Development Bill 2022 has been published and this will impact the format of the plan. The Planning section are reviewing the revised requirements of the Draft Bill and will advise further as soon as possible.

Enniscorthy Town Local Area Plan

Quotations have been received for the Strategic Environmental Assessment and Appropriate Assessment of the Local Area Plan. It is anticipated that a consultant will be appointed in the coming weeks.

Wexford County Development Plan Monitoring

The implementation of the Wexford County Development Plan 2022-2028, which was made by the Members of Wexford County Council on the 13 June 2022, is a key strategic focus for the Council. The Council is required to monitor the implementation of the plan for a number of reasons including to:

- 1. Monitor the effects of implementing the plan under the SEA Directive.
- 2. Monitor the implementation of the Core Strategy as required in the Development Plan Guidelines for Planning Authorities; and
- 3. Ensure that the objectives of the plan are met as required under the Planning and Development Act 2000.

The Chief Executive must also submit a report to the Members on the achievement of the objectives of the plan two years after the plan is made.

The Forward Planning Team are in the process of setting up a system to monitor the various elements of the plan and have also commenced gathering monitoring data.

Built, Cultural & Natural Heritage

Heritage Week

Heritage Week 2023 took place from 12th – 20th August 2023 and over 50 events took place across Co. Wexford, organised by both Wexford County Council and local community groups and organisations. Wexford County Council projects included the everpopular Wexford Walled Towns Day, a family fun-day celebrating our medieval heritage, and a public consultation event for the Enniscorthy heritage-led regeneration plan.

Community Monuments Fund

Wexford County Council received capital funding totalling €200,000.00 for works at Tellarought and Mountgarrett castles. Following a procurement process contractors have been appointed and works are commencing on these projects.



County Heritage Plan Scheme funding

Wexford County Council has received funding totalling €37,223.00 from the Heritage Council for the following projects under the County Heritage Plan scheme: A phase 1 audit of the historic church and graveyard sites of Co. Wexford (€17,850.00), a conservation management plan for St. Nicholas' of Clonmines (€12,915.00), and facilitation for public consultation of the County Heritage Plan (€6,458.00). The historic church and graveyard survey is currently underway following a competitive tender process.

Historic Towns Initiative funding

Wexford County Council has received funding from the Heritage Council and the Department of Housing, Local Government and Heritage for the undertaking of a heritage-led regeneration plan for Enniscorthy totalling €40,000.00. Following the procurement process, a consultant has been appointed and the project is on-going.

Irish Walled Towns Network

Wexford County Council received €60,000.00 in capital funding from the Irish Walled Towns Network for conservation works at Wexford Town Wall, in the Bride Street and Ropewalk carparks. Following a procurement process a contractor has been appointed and the works have commenced.

Local Biodiversity Action Fund

Wexford County Council received €25,000.00 in grant funding through the Local Biodiversity Action Fund for the undertaking of a Phase 2 wetland survey following on from the Phase 1 survey in 2022. Following a procurement process consultants have been appointed and field surveys have commenced.

Access Related Items

NDIS Reporting & Monitoring System

We are in the final drafting stages of the report for the end of life of Wexford County Council's Disability Inclusion Strategy for Services 2019-2022. This final report is using the Power Bi System initiative which will not only provide an overarching organisation review of our compliance level with the associated actions of the National Disability Strategy, but it provides the opportunity for each individual Department or Directorate of WCC to have oversight on activity in relation to their respective activities to ensure proactive and positive actions for accessible and inclusive service provision.

Compliance requirements for Communications including Website and media methods.

The Access Section recently informed a meeting of relevant departments and stakeholders of WCC of the key notes, findings and best practice examples taken from the National Disability Authority Seminar on Accessible Web and Communication Methods, which was attended in May this year.

Submissions- NOAC

Following request from DoS Amanda Byrne for submissions for the NOAC Good Practice Event 2023 - Nomination of Projects by CCMA Committees

The Access Section prepared a submission based on the successful Innovative Community Engagement (I.C.E) project, a collaborative project engaging community groups and organisations which was completed in February of this year. What made this project unique is it presented an alternative process of funding communities to ensure the funding provided and the individual community group projects had accessibility at their core. The methods use in delivering the project elevated awareness around the needs of people with a disability and through ongoing supports, information and site visits from the Access team, options and possibilities for inclusion and access were fully supported throughout the milestones of each of the community groups projects.

Also, the approach used in the project bridged a gap of knowledge and know-how, by in the first instance, raising awareness of the needs of people with a disability and secondly by supporting groups in taking the knowledge and applying it to their proposals for works while also directly engaging people with a disability in the project.

TOWN REGENERATION

The Town Centre First Policy aims to create Town Centres that function as viable, vibrant and attractive locations for people to live, work and visit, while also functioning as the service, social, cultural and recreational hub for the local community.

The Enniscorthy Town Team are meeting regularly. A first draft of the Enniscorthy Digital Town blueprint is expected to be ready by early Sept and will be presented to the Enniscorthy Town Team and Enniscorthy MD for review. This will be incorporated into the Town Centre First Plan. Working with Elected Members and the DRCD an official launch of the Enniscorthy Town Centre First Plan will take place in the coming weeks.

Working closely with Consultants Cunnane Stratton Reynolds the New Ross Town Centre First Plan is approaching first draft stage and is progressing very well. It is planned to have the first draft presented to the New Ross Town Centre First team on the 4th Sept and then to the Elected Members of NRMD on the 7th Sept getting feedback at both stages. It is then proposed to have a public consultation Town hall type event in the Tholsel on the 21st Sept.

N11/N25 Oilgate to Rosslare Harbour

- Ground Investigation on-site works are near completion.
- Environmental surveys, traffic studies and traffic modelling are ongoing.
- Pre-application consultation process with An Bord Pleanála in relation to Strategic Infrastructure Development has commenced. 1st Pre-Application Meeting was held on 26th July 2023.
- Archaeological Geophysical Survey Tender has been awarded.
- Additional Topographical Survey Tender is due to be awarded in early September 2023.
- The overall design of the development, including bridge options is substantially completed.
- Preparation of Environmental, Planning, Design and other reports required by the TII's Project
 Management Guidelines and Project Appraisal Guidelines has commenced.
- Engagement with the ESB/EirGrid, Irish Rail and other stakeholders is ongoing.

N25 Rosslare Europort Access Road

The position on this project remains unchanged.

The decision from An Bord Pleanála, has not been received as anticipated (i.e., on or before the 26^{th of} May 2023). Correspondence from the Bord has been received, that application 177AE for N25 Rosslare Europort Access Road is currently at Board level awaiting a decision and no estimated date has been given for when this is hoped to be decided.

NATIONAL ROAD PAVEMENT SCHEMES

2022 Pavement Schemes

N25 Ballykilliane to Orristown Pavement Scheme (Estimated Total Scheme Cost €2,000,000)

This scheme is 2 km in length and runs between the R739 Kilmore junction to the L7050 Orristown junction on the N25.

Pavement works commenced in May and were substantially completed by 16 June. Line marking was completed by the 30 June.

2022 Safety Schemes

N25 Ballygillane Roundabout - (Estimated Total Scheme Cost €2,590,000)

This scheme was tendered in November 2021.

Works commenced on 23 May 2022. The roundabout is substantially completed.

Works still to be completed: Minor accommodation works and landscaping. Works to be completed in September.

2023 Pavement Schemes

N80 Tomacurry to Ballycarney Phase 2 - (Estimated Total Scheme Cost €1,600,000)

This scheme has been tendered and is under review now. Construction is expected to commence in October.

N25 Orristown to Ashfield Cross Pavement Scheme - (Estimated Total Scheme Cost €1,600,000)

This scheme is being designed at present. It is expected to tender this scheme in October and potential construction in 2024.

<u>HD28 N25 Blackhorse to Ballykelly Pavement Scheme</u> – (Estimated Total Scheme Cost is €1,000,000).

This has been tendered and is under review, construction expected in April 2024.

2023 Additional Maintenance Allocations

Wexford County Council has applied for additional maintenance funding from TII in 2023. This will relate to pavement repairs on sections of the N30 at Moneytucker.

Wexford County Council has secured additional maintenance funding for drainage and verge maintenance works on the N11 and N25. Verge and hedgecutting on these roads will commence in early September.

A consultant has been appointed to carry out a drainage design for a section of the N25 between Barntown and Larkins cross that flooded twice since 25 December 2021. A preliminary meeting was held with the consultant on site in January. Design report due in September.

Former National Roads Grant 2023

2 applications were made under this scheme for 2023.

- R772 Tinnock to Gorey (1.4km)
- R723 Rosbercon (0.8km).

Funding of €500,000 was received for the R772 Tinnock scheme. This amounts to 50% of the scheme. A consultant has been appointed to look at the possibility of including a cycle facility as part of the scheme.

This allocation will be assigned to Rosbercon R723 as a former National Road and it is currently under design. It is hoped to tender this work in the third quarter of 2023.

REGIONAL AND LOCAL ROADS

The Regional and Local Road Grant Allocations were announced on 14 February 2023. Wexford's allocation was €22,811,650. This allocation includes €1,000,000 for Christmas day 2021 flood damage and €1,500,000 for the Deeps Bridge remediation works. The strengthening programme received an additional €822,816 allocation on 3 July 2023.

Resurfacing/Strengthening

The 2023 strengthening programme (Machinery Yard) commenced in the Enniscorthy District on 25 January 2023 at Bucks Bridge, Ballindaggan.

€502,650 was allocated in 2023.

Nook Road was resurfaced in New Ross District in May.

Bridge Rehabilitation Grant

Wexford County Council was allocated €610,000 to repair 17 bridges in 2023. Five bridges are complete at; Boley Upper Bridge; (Gorey-Kilmuckrdge MD); Kings Bridge, Cullenstown; Newcastle Bridge; (Rosslare MD); Abbey Bridge & Barmoney Bridge (New Ross MD).

Christmas Day 2021 - Flood Damaged Bridges

Temporary Bailey Bridges are in place at Chapel and Cullenstown Little in the New Ross District. Detailed designs are in progress to construct 2 new concrete beam bridges. They both in Part 8 Planning and it is hoped work will commence in quarter 4 of this year.

Wilton Bridge in Enniscorthy District - Glas Civil Engineering commenced work 30 June 2023. The bridge will be repaired to its original form of masonry arches. Repair works are expected to be complete in September.

Specific Improvement Works – The Deeps Bridge

The Deeps Bridge Remediation Project – RPS Consulting Engineers Ltd was appointed as Project Supervisor for the Design Process in March 2021.

Glas Civil Engineering commenced work 9 January 2023. The project is on schedule. All concrete repairs are complete on the piers and the east half of the bridge. Concrete repairs are in progress on the west side. Over 300 concrete repairs are complete out to date. It is anticipated the road will be open by 20 October and the works fully complete by the end of November 2023. The temporary road closure was increased from the 31 August to 20 October to complete additional works required.

Climate Change Adaptation & Resilience Works

Wexford County Council was allocated €682,000 for 15 projects in 2023. Four projects are complete to date:

- Road edge protection on Regional Road at Lucas Park (Enniscorthy District).
- New Culvert at Tomnalossett (Enniscorthy District).
- Upgrade a culvert near Ballywilliam (New Ross District).
- Upgrade a culvert to relieve flooding on Duncannon Line (New Ross District).

Local Improvement Schemes

€411,705 was allocated to County Wexford in Round 1, 2023. A second allocation of €619,230 was received 28 July bringing the total to €1,030,9354 for 2023.

21 lanes will be resurfaced in 2023 and 4 lanes have been resurfaced to date.




Newtown Road (Part of the Pathfinder Project)

Newtown Rd light segregation (Hospital to Bayview) is currently at detailed design stage, and we are narrowing in lane widths to 3.25m following a request from the NTA. Proposal is for main contractor on Newtown Rd to install extruded kerb and Council to undertake bollard installation and line marking in house. Junction tightening works will then proceed following confirmation that speed has been reduced by the initial measures.



Newtown Road from Maldron Road Roundabout to Applegreen. Tender assessment report currently nearing completion. We had concerns regarding abnormally low rates issued by Lowest Priced tenderer. Meeting took place with Tenderer/ RPS QS's and Wexford AT to review Works Proposal in detail /review the schedule of high/low rates and whether TM/ Works proposal fully considers avoiding overspill onto N11/N25 and discussed how they envisage the works will progress when the site constraints are taken into account. Road resurfacing is proposed to be undertaken by night. Minutes of this meeting with Lowest priced tenderer and RPS Consultant will feature in Tender assessment report.

Newtown Road Racecourse (Racecourse to Hospital). A third phase of works from the Applegreen to the Hospital junction is currently at concept development and changes to lane widths are currently underway. Propose to meet Aldi and Racecourse as part of this process. Propose to have a completed design and commence section 38 statutory process over 4 weeks and present completed report for presentation at council meeting in October.




Safe Routes to School

Three Safe Routes to School Schools schemes (SRTS Round 1) which involve traffic calming at front of school to encourage active travel are being designed in house in consultation with schools.


The Construction phase of the <u>Adamstown Scoil Naomh Abbann</u> is well underway by Paddy McGees Wexford Ltd, and works are due to be completed in mid-November.



Section 38 consultation process was successfully passed by councillors on 21 June for **Scoil Mhuire Rosslare**. Construction is expected in Sept 2023 after the busy summer period in Rosslare. The lowest priced tenderer Gary Murphy of GJM contracts confirmed in writing that he was declining this contract. Paddy McGees who were second lowest were then awarded the contract of PSCS and main contractor. We propose to undertake all the proposed works this year.

Roxborough Cycle Scheme (Part of the Pathfinder Project)

The proposed cycle lane upgrade in **Roxborough** has now moved onto the final stages of the Concept development and options selection stage with the completion of DBFL's final draft report -R730 Roxborough Cycle Lane Wexford. Once NTA approve we can then start the Part 8 Statutory process.




Figure 1-1 Scheme Location Map (Google ©)

Area Based Transport Assessment (ABTA)

Enniscorthy ABTA – Tender assessment report final draft completed. Sent to Planning for their review prior to forwarding the ABTA section of NTA for their sign off prior to awarding contract. Winning tenderer priced at €90,760 EX vat.

Wexford Town ABTA is currently underway by Atkins Consulting Engineers. Baseline report up for review internally.

Walking and Cycling

The public E Bike Sharing Scheme is going from strength to strength with big demand for the bikes, particularly from residential areas to travel to the town centre. A further 20 bikes were recently introduced to meet demand and a further three parking locations provided on Whiterock Hill to facilitate residents in this area. This trail is to take place for one year to ascertain its

benefits to Wexford. Early indications are that it is very popular and reducing the number of short car journeys in and around the town.

On the 8th of September the Cycling and Walking Officer will give a talk in Wexford town library as part of the ALL-Adult Literacy for Life programme in Co Wexford. The talk will be aimed at those who may require assistance with the technology to enable them to access the bikes.

In association with Sports Active to mark Active Aging week there will also be a number of training sessions in how to use the bikes. The training will take place in County Hall grounds to ensure people feel comfortable using them before they cycle on the public streets.

Car Free Day this year takes place on the 22nd of September as part of the wider European Mobility Week <u>EUROPEAN MOBILITY WEEK | Home</u>. An event is currently being planned for Gorey town to encourage communities to engage in more Active Travel as part of their day-to-day local journeys.

PUBLIC LIGHTING

LED Upgrade (Non-National Roads)

Over 12,000 lanterns have been upgraded to LED since the beginning of 2016.

Design works are completed.

A plan will be put in place to upgrade the remaining lanterns in housing estates that were taken in charge over the last 4 to 5 years.

Lighting stock should be fully LED by the end of 2024.

Public Lighting Development Fund

Additional public lighting will be installed at the following locations under the Public Lighting Development Fund in 2023.

- Ramsfort Avenue Gorey infill along by GAA pitch. Lighting design being carried out and quotations received and under review.
- The Ballagh Church to the school Lighting design complete and contractor appointed for works to commence in October.
- The Ballagh Ballagh Cove to regional road. Lighting design completed and contractor appointed for works to commence in October.
- Wexford Town Seamus Kelly roundabout to Spawell Road. 2 quotations received. Works to commence in September/October.
- Wexford Town Kennedy Park. 2 quotations received. A contractor has been appointed for these works.

Other locations will follow further to consultations with Municipal District Engineers.

It should be noted that quotations are sought from the four recognised public lighting contractors in the country for these public lighting schemes.

All four contractors are now working on the 3 National Public Lighting Energy Efficiency Programme (PLEEP) contracts across the country. This is leading to a delay in getting our Development Fund lighting contracts designed, tendered and completed.

Gorey Town Park

The public lighting to the walking track was completed in June.

UKRANIAN RESPONSE UPDATE

Offer a Home

The team have successfully managed to retain most of the holiday homes pledged under Offer a Home, giving the property owners back their homes for the summer period whilst temporarily relocating the Ukrainian families. This gives continuity for the Ukrainian family and the property owner.

Ukrainian Community Response Forum

A meeting of the Ukrainian Community Response Forum was held on the 4th of September 2023. Members reported on activity in their respective areas and highlighted some particularly difficult cases. Wexford County Council staff member Alla Kauklina gave a presentation on the Local Authority led Offer a Home programme, she highlighted in the presentation that the team are meeting an increasing number of both Ukrainian and Irish families who entered informal pledges and are now seeking support on advice.

When the Local Authority Integration Team is appointed more quantitative research will be undertaken to document the work of the Forum and its impact.

Ukraine Refurbishment Programme

Three new centres will open in the coming months;

Each centre will provide family accommodation in 2,3 & 4 bedrooms. Residents will share common kitchen, dining, living areas and bathrooms. All projects will be developed to the Temporary Accommodation Standards and under the Planning provisions outlined in the temporary exemption (S.I 306 of 2022).

- Wexford Garda Station, capacity 50
- Borromount Lodge, Edermine, Enniscorthy, capacity 38
- 22 Rafter Street Enniscorthy, (over Ulster Bank) 15

The projects will be contracted by the Department of Children (DCEDIY), subject to the works being completed to satisfactory standard.

Local Authority Integration Programme - The overall objective of the integration programme is to enable applicants to live independently in the community. Within this overall objective, a set of measurable actions will guide the development, delivery, and monitoring of the programme. The interviews for the posts will be held in early October.



SPECIAL PROJECTS

1. Projects at Planning Stages

1.1 Enniscorthy Town Centre & Tourism Project:

The Planning Department in collaboration with Special Projects has developed a strategic plan for Enniscorthy town centre, which was adopted at the Enniscorthy MD meeting in December 2022.

Regeneration works to the Market Square, Enniscorthy Castle Quarter and Templeshannon will form part of the Call 4 URDF application expected in Q3 2023.

Moloney O' Beirne is preparing preliminary designs and Part VIII planning application for the Market Square and the Castle Quarter. Roughan & O'Donovan is undertaking the design for town centre traffic alterations. A Part 8 application for Market Square will be submitted in September, with preliminary design work on the Enniscorthy Castle Quarter project commencing thereafter to support a Part 8 submission before end of 2023.

ODKM Architects is undertaking a concept masterplanning design for the Templeshannon Regeneration Project. This masterplan will be completed in time for the forthcoming URDF application also.

1.2 Forth Mountain Activity Park – Phase 2 - Activity Centre Building:

Phase 1 – Forth Mountain Activity Park, Trails and Carpark is complete.

The activity centre building was lodged for Part VIII planning in March 2022. In response to a request from An Bord Pleanála for further information relating to the project was completed and submitted to the Board. The Part VIII planning application was withdrawn in October 2022. A process to procure a consulting team to prepare an EIAR and prepare a planning submission to ABP is now required.

The part VIII for the proposed boathouse and external toilet facility on-site was approved by WCC in February 2023. Tenders for works were received on May 31st and have been assessed. Contract award is subject to confirmation of funding.

1.4 Gorey District Park

The park is substantially completed and is now fully open to the public.

The second invitation to tender for the Changing Places unit did not result in an award of contract. A third invitation to tender for the Changing Places unit was advertised on eTenders. Tenders have been received and a preferred tenderer identified. Work expected to commence in September 2023.

1.5 John Street Building Regeneration Project, New Ross

A portion of the grain store building has been purchased by agreement and the CPO for the remaining sections is now formally complete. ODKM Architects are appointed and undertook a preplanning meeting for the building in February, with the Concept Design Report being presented to the New Ross MDC at the May meeting. Preliminary design is ongoing with Part 8 expected to commence in October, subject to the outcome of a screening for appropriate assessment.

1.6 Gorey Market House

As agreed at the December meeting of Gorey - Kilmuckridge MDC, WCC publicly invited Expressions of Interest for the re-development of the Market House. A Competitive Dialogue procurement process to identify the best option for a town centre development, including a performance space, was advertised on eTenders and OJEU in February 2023. Following tender assessment, no suitable candidate was identified to proceed to the negotiation stage. The tender process has now been concluded and closed out.

1.7 WEXFORDIA – Irish National Heritage Park (INHP), Hook Lighthouse and New Ross Tourism Projects

WCC secured RRDF Category 2 funding for the development of a cluster of tourism projects within the county.

Irish National Heritage Park: INHP

The tourism and environmental design teams for the INHP have commenced work on a preliminary design and the environmental assessments. It is planned to submit a planning application for the project to An Bord Pleanála in Q1 2024.

Hook Lighthouse

The tender competition for interpretative design services for the Hook Lighthouse was advertised in February with closing date for tenders on 30/03/23. Tandem Design have been identified as the successful tenderer and will start work on the project shortly.

The Brief for the associated architectural and related design services will be advertised in July as part of the framework created for architectural services focused on tourism and recreation projects. It is expected that the preliminary design will be completed in 2023 and submitted to ABP in 2024.

New Ross Tourism Project

Tenders for the interpretive fitout on the Dunbrody Visitor Centre Experience have been received and a contract awarded to EPIC Design, based in Dublin who have prepared the preliminary design for the development, this is being reviewed at present.

Tender documents for the development of the Norman Themed Visitor Centre in the Old Bank/Murphy buildings for interpretive design have been advertised with an appointment expected in July 2023. A framework for architectural services for tourism projects has been advertised with stage 1 submissions received and assessment ongoing. The Norman Visitor Centre will be the first project from this framework, with award expected in Q4 2023.

1.8 Esmonde Street, Gorey

An on-site meeting took place with the Members in Gorey – Kilmuckridge MDC in February 2023 and proposals for the street were discussed. A presentation was made to the Members in April 2023. The Members advised to proceed to detailed design with the proposed plans for public realm improvement with works expected to commence on-site in early 2024.

1.9 Rosslare Europort to Waterford City Greenway

The application for planning consent for the Rosslare to Waterford Greenway Project was paused, pending the publication of the All-Ireland Rail Review. The draft report issued in July 2023 promotes reopening of the train line in future.

The Rosslare Harbour to Rosslare Strand section is now being advanced as part of the Wexford Town to Rosslare Greenway Project.

1.10 Wexford Town to Rosslare Greenway

Fehily Timoney & Co has been appointed to provide consultancy services for a feasibility study, route selection, preliminary design and environmental assessments for the development of this project. Constraints have been identified and ecological surveys are on-going. The scoping and route options process is ongoing. Public consultation on the preferred route corridor options commenced on 11th May 2022 with submissions closing on June 10th 2022. It is now expected to confirm a preferred route in Q1 2024. Submission to An Bord Pleanala is likely to happen in early 2025.

Fehily Timoney & Co has been appointed to review the route options for the proposed Rosslare Harbour to Rosslare Stand greenway in light of the significant coastal protection works that have been carried out over the past two years by Irish Rail. It is planned confirm a preferred route in Q1 2024, with an expected Part 8 application (subject to screening) to follow.

1.11 Old Dublin Road Business Park, Enniscorthy

In May 2021, outline proposals for the Old Dublin Road were presented to the Enniscorthy Municipal District. This was followed by a public consultation process in late June on the draft plan. The masterplan was presented to the Enniscorthy MDC's October meeting. The initial phase 1 works commenced in July/August 2022 and are now substantially completed.

An application for further funding has been prepared and submitted to the NTA, in conjunction with the Roads & Transportation Section, for the active travel elements of the masterplan. No funding was forthcoming for 2023.

1.12 Courtown Coastal Protection & Beach Nourishment Scheme

Following a competitive tender process, RPS Ltd was appointed to undertake the Preliminary Design and Statutory Consents Phase of the Courtown coastal protection and beach nourishment scheme.

Priority Geotechnical Ltd. is appointed to carry out the marine and land-based surveys and boreholes at Courtown. They commenced work on the May 2022 and the site investigation work is complete.

Marine profiling surveys will also be carried out in parallel at this time and this work is being carried out by Hydrographic Survey Limited. An application to the Marine Foreshore Dept., was submitted in December 2022, for permission to carry out benthic grab samples. This work will commence once approval is granted.

It is planned to submit an application to An Bord Pleanála for development consent in Q1 2024.

1.13 Crescent Quay - Dredging

RPS Consulting Engineers have been appointed to provide design services for possible dredging works at Crescent Quay. The sampling and testing of the proposed dredge material, to inform the statutory consent process, is complete with results currently being assessed. A draft report with recommendations is expected in Q4 2023.

1.14 Enniscorthy Sports Hub

O'Leary Sludds Architects were appointed in Feb 2021 for the detailed design, procurement of works contractor and construction management of the Sport Hub building. A competition to award a works contract for the sports hub building was advertised in May 2022. The lowest price tender opened for the project exceeded the available budget and no contract was awarded. A redesign process for the project is now ongoing.

1.15 Curracloe Water Sports Activity Facility

WCC received Stage 2 compliance approval from Fáilte Ireland for the development of facilities to support water sports activities at Whitegap, Curracloe. The project will include showers, toilets, changing facilities and lockers.

Following the tender process for design services in Jan 2022, Neville Conroy Architects was appointed. Surveying works and detailed design commenced in January 2023. It is planned to tender for works in 2023 with works to commence in early 2024.

1.16 Ferndale Gymnasium, Wexford:

Sports Capital funding of €300,000 has been secured for this project, supporting a donation of €500,000 from William Neville and Sons for this project. Part VIII approved was received in 2022 and a design team has been appointed to prepare detailed designs and tender documents for the works. The works contract is currently out to tender with a submission deadline of September 4th. It is intended to commence works on site in Q4 2023.

Sole Sports and Leisure Ltd. have been awarded the contract, following public tender, for the construction of two MUGAs at an adjacent site, following confirmation of €100,000 in grant funding through the 2023 Community Recognition Fund. Works commenced on site in August 2023.

1.17 Adoration Convent Wexford

Part VIII is in place for this project to convert the old convent into accommodation for students of Georgia Southern University Wexford campus. A design team appointment has been approved by GSU and preliminary design and associated survey works are underway. It is intended to tender out these works out in Q1 2024 with works to commence in Q2 2024.

2 Projects Under Construction

2.1 South East Greenway

Contracts for the works on Lots 1, 2 and 3 were awarded to Glás Civil Engineering and works are now substantially complete. Snagging works are now nearing completion.

The works are ongoing on site for fencing, public lights ducting and temporary car parks for the greenway section from New Ross to Glenmore. The expected completion date is July 2023.

The works contract tender for Lot 5a – Ferrybank to Curraghmore (5.5KM) was advertised in March. Tenders have been received and assessed and a contract award is expected within the coming month.

Wexford County Council's Arts Office, in partnership with the Southeast Greenway Project Team, has commissioning designers 'Elements Of Action' with visual artist Aoife Banville, to develop a pilot creative public art project for the Raheen to Glenmore section of the greenway. This works is expected to complete prior to the opening of this section.

The process to procure replacement technical advisors for the completion of the Southeast Greenway project has commenced. The first appointment will be for the technical advisor to act in the role for Employer's Representative duties for the works contract lot 5A. Tenders have been received and assessed and appointment is expected within the coming month.

The second appointment will be for a technical advisor for all remaining components of the Southeast Greenway Project. Lot 4 – Mount Elliot will be their first priority to complete and issue for tender. It is planned to issue this service contract for tender in September.

Phase 1 of the South East Greenway - New Ross to Glenmore was officially opened on the 25th of July 2023.

2.2 Trinity Wharf

The contract for the construction of the access road was awarded to Glás Civil Engineering Ltd, in January 2023 and works commenced on site in late February. The sod turning took place on site on 2nd March with Minister Darragh O'Brien and elected representatives. Works are ongoing on site with completion expected in Q4 2023.

Procurement of consultants for design services for the site development and public infrastructure works is underway. The preferred tenderer is identified, and the standstill period has expired. The formal appointment of the design services consultant is imminent.

2.3 New Ross Emigrants' Park – Oil Tanks Site

This project consists of removal of the oil tank structures on the Quay and the development of public realm works on the site. The Advance Works Contract (Removal of Tanks) was complete in July 2021.

RRDF funding of €814,393 for the project was announced in November 2022. The main works contract has been awarded to MJS and works are at an advanced stage. Completion is expected in October.

2.4 Mechanics Institute, Wexford

The works contract for essential maintenance works at the Mechanics Institute has been awarded to Roger Doyle Contractors and works commenced on site in January 2023. Completion is expected in September.

2.5 Oyster Lane Site, Wexford

A Part VIII submission has been made for the demolition of existing unoccupied buildings on the old Tesco site, including the construction of a temporary surface level car park. The Part VIII was confirmed at the March 2022 County Council meeting. A further Part 8 submission has been made for erection of a temporary performance structure and public realm area, instead of a surface carpark.

O'Connor Sutton Cronin consulting engineers have been appointed to provide design and construction related consultancy services for the project.

The demolition contract was awarded to John Tinnelly & Sons (Ireland) Ltd, with works on the initial contract for the old Tesco site now largely complete. WCC has also agreed an extension to the main works contract to undertake the demolition of the former Dun Mhuire Theatre. This work has commenced onsite and is expected to last 10 weeks.

4. Flood Defence Schemes

4.1 Enniscorthy Flood Defence Scheme

Statutory Process - The Minister for the Department of Public Expenditure & Reform (DPER) issued his decision to refuse the scheme on 4th March 2022. Details are available on www.gov.ie. Following the decision, the OPW confirmed their commitment to delivering an effective scheme for Enniscorthy.

Flood Defence Scheme – The project baseline data is to be updated, scheme alternatives are to be assessed, consulted on publicly and a preferred option identified. It will then be necessary to decide on the most appropriate planning route for the scheme. The hydrology and environmental baseline data is currently being updated; ecology survey reports are to be completed in Q4 2023.

New River Slaney Bridge - It is intended to obtain planning consent for the new bridge as a separate project in advance of the flood defence scheme. The baseline data is currently being updated. Traffic surveys are complete, ecology survey reports are to be completed in Q4 2023. The planning application is to be submitted in Q1 2025.

4.2 Wexford Flood Relief Scheme

The contract for engineering and environmental services for the for the Wexford Town & Environs contract was signed by WCC and Nicholas O'Dwyer Ltd on 23rd March. Officials from the OPW, the sponsoring agency for the scheme, including the Minister Mr. Patrick O'Donovan, attended. A preliminary cost estimate of €9.52m has been approved by the OPW for scheme, which will fully funded.

The appointment includes flood risk modelling; assessment of options for flood prevention; preliminary design; the preparation of planning and other statutory consent applications; detailed design; tendering for works contractors and construction management services.

The Housing Dept. continue to periodically seek Expressions of Interest for the provision of social housing units via Turnkey acquisition. All proposals received by Wexford County Council are assessed by an Internal Assessment Committee.

Energy Efficiency Retrofitting Programme

Energy Efficiency Retrofit Programme 2022 was the second year of a new 10-year Energy Efficiency/Retrofit Programme to retrofit local authority housing stock. The new programme provides for a significant upscaling in the level of funding available and focuses on ensuring that the fabric of the home is upgraded, and an energy efficient heating system is provided. The table below outlines the targets set by the Department for Wexford to date.

The range of works undertaken in the properties include external wall and attic insulation, new doors, new windows, blocking of fireplaces, low energy lighting, high efficiency boilers, and upgraded heating system and controls. All properties received a minimum of a B2 BER rating after the works were completed.

Of all targets, the Housing Maintenance Section completed energy upgrades to 37 properties in 2022. We propose to complete the balance of our 2021 to 2023 targets in 2023. The value the grant funded works planned for completion in 2023 will exceed €3.1 million.

Vacant Homes

A Vacant Homes Officer was appointed during 2022, whose role is:

- To actively promote and lead the uptake within the local authority area of various initiatives, schemes, and funding programmes to address vacancy and bring vacant properties into residential use.
- To collect, monitor and assess vacancy data locally and use that data to actively engage with property owners and promote schemes to encourage activation of properties.
- Play a communication, promotion, and advisory role both internally within the local authority and externally as a contact point for members of the public and key interested parties on vacant homes/properties.

Croí Cónaithe (Towns) Fund - Towns & Village Property Refurbishment Fund aims to tackle property vacancy & dereliction and will provide new choices for people to live in towns and villages. It is a €50 million fund and is targeted at delivering 2000 homes by 2025 across the country.

- A maximum grant of €50,000 is available for refurbishment of a vacant property.
- A top up grant of €20,000 is available where the property is confirmed as derelict (i.e., structurally unsound, and dangerous) or listed on the derelict property register.

The project which is open to people living in the parish of Taghmon Camross will get underway shortly and it is aimed primarily at people who no longer are able to drive or those who have no access to transport in their homes.

The project received 100% funding from the Department of Health's Sláintecare Healthy Communities Programme which is managed locally by Wexford County Council. It is hoped that people can start making bookings in September onwards. Bookings can be made via a phone number which will be advertised shortly. AGE FRIENDLY WEXFORD -

Remaining SLAs will be completed in guarter four.



An engaging quiz, colouring competition and temporary tattoo resulted in a busy stand for those who ran it on the day from Healthy Wexford, Comhairle nan Og and FDYS

Embedding the Not Around Us Supporting Event requirements in the Local Authority events system has

completed and sections have been advised of the requirement. More events, which include children or young people, held on Local Authority property or supported by the Local Authority will now become 'Not Around Us' Supporting Events providing smoke and vape free spaces for the children and young people attending.

The **Period Dignity** project continues with free products for those that need them provided at 11 locations across the county via libraries county hall and Family Resource Centres.

Mid-year department reporting was provided in July and the project remains funded by Department of Health in 2023.

The Project Officer has closed down and handed over the Project as the Ireland Wales Co-Operation came to an end on 31st August 2023. Information and project resources will continue -

PPN Updates



ANGIENT CONNECTIONS

Meetings:

Various project close meetings were held in this period, including a Stakeholder and Ancient Connections Board 'Lessons Learned' exercise, which was recorded as part of the project's Monitoring and Evaluation process, by Wavehill & Assocs.

Events:

- A very successful Festival of Ferns was held on the June Bank Holiday weekend: a two day festival, concert event and fringe pub music festival, as the final large outdoor event for Wexford, with an estimated 2,500 attendees.
- Traditional Skills training and workshops in Ferns, by Carrig Conservation, attended by 120no
- Irish Archaeological Field School archaeological dig, attended by 25no. American students and the St. Aidan's Monastery Family Fun Day, attended by local school children
- Online Creative Camino Documentary Film screening and Q&A

Enterprise & Innovation:

SLR Consulting continued to provide training, mentoring and support to the Ferns community, to achieve well formulated business plans for enterprises involved, providing a road map and support in business development as the enterprises move forward. The Ferns Medieval Experience has now matured to become an excellent example of a community-run heritage attraction. During this reporting period they have completed the series of heritage-themed lectures, had a new mural painted on the Ferns Boxing Club, had a new coat of paint on the community centre façade, installed signage above the main entrance and soon to have a Digital Information Kiosk, to attract visitors and local community to the social enterprise.

Destination Marketing:

Ferns and the <u>Wexford Pembrokeshire Pilgrim Way</u> route place branding leaflet is currently being designed and printed, to promote the route in Wexford, to raise the profile of its benefits to the local tourism industry and for overseas visitors who have travelled to Wexford. Travel Writer. Dutch writer and journalist Francine Postma was commissioned to walk the route and write about it. She did this over 9 days in late May 2023. She has completed an article in Dutch which will be printed in the Dutch walking magazine 'Wandel' in early Spring 2024 and translated to English, for use across trade magazines.

Volunteer Hours:

In Claim 9 there were **4,319** volunteer hours at various hourly rates, contributing **€64,164.00** benefit in kind. Over the course of the entire project, Ancient Connections has generated **14,394** volunteer hours, equating to **€186,451** in-kind support.

Project Close:

For the remaining 4 weeks of the project, we have been working on storage and archiving our digital assets as well as editing the Ancient Connections website to act as a public facing archive for the project. The joint partners have committed to funding the website's maintenance fees for 3 years post-project.

The Wexford Project Officer has started the process of handing over and closing off the Project as the Ireland Wales Co-Operation funding and employment contract have come to an end. Final Financial claims, Management Verification Tests and relevant Audits will be completed by Pembrokeshire County Council, in conjunction with the Finance Team at Enniscorthy Municipal District.

Safeguarding

PAP report

We have had 65 applications for our Physical Activity Promotion Grant with a total of €39,000 approved for Wexford clubs and organisations.

Information Evenings

Two information evenings were held regarding the application process for the Sports Capital and Equipment scheme (2023) as deadlines for application close on 8th September. These were held in collaboration with Sports Active Wexford, Gorey/Kilmuckridge Municipal district, Rosslare Municipal district, and Dr Yvonne Byrne. 24 groups attended.

ENVIRONMENT

A. COASTAL MATTERS

Harbours -

In April 2022, Department of Ag, Food & Marine (DAFM) announced funding of 23 projects with a total construction cost of €1.4m in Co. Wexford under a new scheme to develop works on LA harbours, called the Brexit Adjustment Local Authority Marine Infrastructure (BALAMI) 2022 – 2023. The DAFM approved a second tranche of funding in December 2022, with a total between first and second tranches of 25 projects with total construction cost of €1.79m. The DAFM funding has increased from 85% to 95%, with Wexford County Council paying the 5% match funding on construction. Note that WCC must pay all non-construction costs including design, environmental reports etc.

Fethard Harbour – New Slipway and Beach Access. Consulting engineers are appointed to progress the detailed design. A planning application was lodged with An Bord Pleanala, a decision date of 24th August 2023 was published on their website; however following correspondence from ABP this decision date is likely to extend by a number of weeks.

Ports Past and Present: This 4 year project started in 2019 and officially ended on 31st July 2023. A presentation to members on the achievements and legacy of the project was given to Rosslare MD in July.

Operations -

ISPS approval for both dry and liquid cargoes has now been achieved for Marshmeadows Jetty.

Beaches -

Bathing water: weekly bathing water samples are ongoing with water quality results published on beaches.ie website. To date there have been 6 water quality incidents – at Courtown (2 no.), Carne, Baginbun, Duncannon and St. Helens. These incidents were followed up with investigations and discussions with HSE.

Bathing water: An Taisce carried out inspections of blue flag and green coast beaches throughout 2023 bathing season. The inspector had a positive experience at all beaches he visited in Wexford and noted in his report... "very impressed with all of the beaches I visited in Wexford this year, keep up the good work."

Ballymoney Blue Flag Beach – Access for All and Age Friendly Improvement Works. Works on the accessible toilet are now complete and toilets are open.

Design and tender works for the access path are ongoing, with the works expected to go to tender in Sept 2023.

Coast -

The Environment Dept monitors the coastline regularly, focussing on erosion risk areas.

<u>Rosslare Coastal Erosion and Flood Relief Scheme</u>: Nicholas O'Dwyer Ltd Consulting Engineers is appointed to progress the scheme. Key design parameters for the scheme are being finalised.

<u>Seaview, Kilmore:</u> Preplanning application was submitted to Wexford CC Planning Dept in August 2023, with application for full planning permission to follow. Further correspondence was issued to OPW in order to progress the funding of the scheme.

<u>Lady's Island Water Level Management Structure</u> – An Bord Pleanála granted planning permission for this development, dated 3rd Sept 2021. Foreshore licence application has been lodged and is under consideration by the Dept of Housing, Local Government and Heritage (DHLGH).

C. WATER, AIR & NOISE

1. Water Framework Directive:

Under the Water Framework Directive every catchment in the county must be assessed to identify required actions to maintain and improve water quality. This work which is being carried out by Wexford Co. Co. in conjunction of LAWPRO is being supervised by the Sub-Catchment Unit of the EPA.

2. Water Sampling:

A Total of 344 water quality samples are taken by Council Scientists from 78 sampling sites in the county per year with analysis carried out by the EPA. 8 surveillance sites are being sampled 8 times per year.

3. Septic Tank Inspections:

A minimum of 130 inspections will have to be carried out in 2023. 67 inspections have taken place up to the end June with 37 passes and 30 fails. 21 further inspections have been pre booked for July 2023.

Fourteen applications for grant assistance have been received this year to date of which twelve have been processed for payment.

There are currently 15 cases in the Court system for failing to comply with Advisory Notices. 7 of these are for hearing and 8 are currently for mention.

10 verification inspections were carried out in April 2023 on sites which have Advisory Notices open over 2 years.

4. Section 4 Discharge Licences:

The Council currently has 92 active Discharge Licences. Four new applications have been received in 2023 to date. Three applications were received in 2022, two of which are under review and one was formally granted in March 2023. Six discharge licences have been revoked in 2023 at present and a few more are under review.

5. Air Quality:

Wexford County Council enforces air quality requirements for 3 specific types of facilities, which must be registered with Wexford County Council. These Certificates must be renewed every 3 years. On-going enforcement action is carried out to ensure sites remain certified. Wexford has a 100% compliance record in this regard for all 3 below categories in 2022.

Vehicle Refinishers: At end of 2022, 59 facilities were registered with Wexford County Council under the "Deco Paints" Regulations, which is now the largest number in the country. WCC issues Certificates of Compliance to these facilities and issues "On the Spot Fines" of €500 where illegal operators are identified on foot of enforcement investigations – see Table below. The additional facilities were identified on foot of targeted enforcement action in 2022.

Dry Cleaners: At end of 2022, 8 Dry Cleaners and 1 Medical Device Company were registered with Wexford County Council under the "Solvents" Regulations. WCC issues Certificates of Compliance to these facilities – see Table below. Due to targeted enforcement action in Q3/Q4 of 2022, a new category of facility is due to be added to this register in Q2 of 2023.

Petrol Stations: At end of 2022, 80 sites were registered with Wexford County Council under the PVE Regulations, which is the largest number in the country. WCC also issues Certificates of Testing to these facilities under these Regulations – see Table below.

6. Agriculture:

A total of 65 farm inspections undertaken because of pollution incidents or complaints, 30 of these farms were found to have non-compliances. Wexford County Council engage with landowners to undertake the necessary rectifications works through encouragement of improvement of farming infrastructure and farming practices.

7. Planning

4. Waste Facility Permits:

We currently have sufficient permitted facilities throughout the county, such as Clean Soil and Stone, construction and demolition sites, ATF's / End of Life Vehicles and Pay to Use Waste Compactor Unit. The full list of Waste Facility Permits and Certificates of Registration can be viewed on the Council's website.

Altogether there are 67 registered operational Waste Facility Permits and Certificates of Registration for premises involved in waste management activities in the County. There is 1 renewal application being processed at present.

5. Enforcement:

The Waste Enforcement Team carries out routine (planned) and non-routine inspections of waste facilities and problem sites or site where we have received complaints. This work is done in accordance with the Recommended Minimum Criteria for Environmental Inspections (RMCEI) as submitted to the EPA on 28 February 2023. The 2023 RMCEI Plan allocates 6,597 routine inspections by 22 Full Time Equivalent staff members. The inspection types

cover the WEEE (Waste Electrical and Electronic Equipment) Regulations; ELV (End of Life Vehicles) Regulations; Waste Management (Packaging) Regulations; Household and Commercial Food Waste Regulations; Batteries, Tyres, Mercury etc.

The Department of Environment, Climate and Communication have set national waste priorities for 2022 to 2024, a three-year target and they are.

- Tackling significant illegal waste activity,
- Construction and Demolition Activity,
- End-of-Life Vehicles (ELV) & the Waste Metal Sector,
- Waste Collection Household & Commercial.
- Producer Responsibility Initiatives and additional local priorities.

May 2023:

In Gorey District Court the judge awarded €500 of a fine and €250 contribution towards Legal costs to Wexford County Council for a litter case. Three parties prior to court complied with agreements made to pay their fines, Legal costs or to provide proofs before hearing and were therefore struck from the hearing list in May 2023.

June 2023:

Wexford County Council had 7 successful litter prosecutions in June 2023 under the Litter Pollution Act, total fines of €1650 were awarded and €1750 in Legal costs.

July 2023:

Wexford County Council had 4 successful prosecutions in July 2023, two under the Litter Pollution Act and two under the Waste Presentation Bye-Laws 2018. F. CLIMATE ACTION

Preparation work on the development on the Local Authority Climate Action plan continues. The plan is required under the "The Climate Action and Low Carbon Development (Amendment) Act 2021", and will include both mitigation and adaptation measures. Minister Eamon Ryan requested Wexford County Council to commence its Climate Action plan on 24th February 2023 with 12 months to prepare, complete and fully adopt the plan.

The Plan will set an ambitious target of 50% energy efficiency by 2030 and an absolute reduction in greenhouse gas emissions of 51%. Wexford County Council will be responsible for reducing greenhouse gas emissions from across its own assets and infrastructure, whilst also taking on a broader role of influencing, facilitating and advocating others to meet their own targets.

A significant element of the Climate Action Plan is to encourage the public and various stakeholder groups to contribute to the preparation of the plan. A stakeholder engagement event was held on the 1st June at Wexford County Council Headquarters and covered the themes of Agriculture, Biodiversity and Food, Transport and Energy.

All the presentations are uploaded to the website and have been circulated to all those who signed up via Eventbrite.

Two pre-draft submissions were received from the online portal and 159 surveys were completed following the Climate Action Event.

Community Climate Action Programme

A Community Climate Action Officer has been appointed to the Climate Action Team, with responsibility for the rollout of the Community Climate Action Programme. The programme funding scheme is due to open shortly to support and build low carbon communities across County Wexford. The fund is open to not-for-profit community groups and clubs.

Funding of up to 100% of the cost of a climate action project is available through this scheme, up to a maximum of €100,000. Project examples could be insulation of community buildings, solar panels, bicycle parking, rainwater harvesting, community gardens / allotments, etc.

Environment Education and Awareness:

Our aim is to promote awareness and active participation in a range of environmental initiatives.

Green Schools: 32 schools were awarded their green flag at an Awards Ceremony in Kilkenny on May 10th. St Edan's NS, Ferns, New Ross Educate Together National School and Colaiste Bride, Enniscorthy received their first Green Flag on the Litter & Waste theme. This year 3 schools were awarded on the Water flag; 7 schools on Travel; 8 schools on Biodiversity; 4 schools on Global Citizenship Litter & Waste; 3 schools on Global Citizenship Energy, 3 schools on Global Citizenship Marine Environment and 1 school on Global Citizenship Travel. Great work has been completed by all the schools.











Climate Action School Workshops: 5 secondary schools participated in the Rubbish Film Festival as a pilot and due to its success we will continue in September with another 5-6 secondary schools. Each school creates a short 1 minute film and a poster on an environmental issue of their choice. 5 secondary schools participated this year and a County Award of Best Film, Best Runner Up Film and Best Poster was chosen. The County winners were announced on April 18th online. Colaiste an Atha received Best Film Award for their film 'You Can't Run and Selskar College win Best Runner Up Film for their film 'Would You Like it'. Gorey Community School received the award for Best Poster. The County winners were forwarded to the National Awards which were held on the 3rd May in Solstice Arts Centre, Navan, Co Meath.

Linte Na Farraige Workshop: A Linte na Farraige (Lines of the Sea Project) workshop was held with students from Presentation Secondary School. The workshop was facilitated by the Caro (Climate Action Regional Office) and Trinity researchers and is based around a game idapt.

Annual Artwork Competition: The awards for the annual artwork competition took place on 25th May. The artwork competition is an initiative run by the Environment Section of Wexford County Council in conjunction with Wexford Naturalists' Field Club. The theme of this year's competition was 'Wildflowers.' Councillor George Lawlor, Cathaoirleach Wexford County Council, presented prizes to 40 school children representing both primary and secondary schools.

Community Engagement: A family drop-in session on Waste Prevention, household recycling and waste segregation took place on Saturday 6th May in Enniscorthy Library from 10.30 – 11.30 am.

Heritage Stewardship Fund: Application was submitted for a baseline hedgerow survey of Co. Wexford to the Heritage Council under the Heritage Stewardship Fund. Our application was successful with an award of €27,675. Flynn Furney Environmental Consultants were awarded the contract and a team of ecologist started surveying in early June.

National Food Waste Recycling Week: Now in its second year, the National Food Waste Recycling Week ran from the 5th until the 11th June 2023. The aim of this year's campaign was to raise awareness that food waste needs to be fully separated from all packaging such as plastic or other containers to prevent contamination at the compost and anaerobic digestion facilities leading to higher quality recycling.

Events were held at the four Household Recycling Centres and an information stand at the Climate Action Event in County Hall on June 1st.

The campaign will reach across social media and local community groups and Tidy Towns groups will be asked to share images on social media.

Public Consultation

The Public Consultation Strategy for the Wexford Town Local Area Plan was discussed in Wexford Library in July. The public were invited to make written submissions and observations on the new plan between this date and 4:00pm on Tuesday, 8th August 2023.

Blacktown City Delegation Visit

Blacktown City Delegation Visit and tour of Wexford Library took place in August. The proposed partnership with Wexford County will enhance cross-cultural understanding and help build vibrant and connected communities, generating mutual benefits.

South East Technological University Pop UP Stand

The South East Technological University provided a Pop UP Stand in Wexford Library with information on their full and part time courses for the coming academic year 2023-2024 on Wednesday August 16th.

Into Europe Exhibition

Into Europe is an exhibition commissioned by the Department of Foreign Affairs and produced by the Royal Irish Academy as part of the ongoing Documents in Foreign Policy series (led by Dr Michael Kennedy). It focuses on various aspects of Ireland's relationship with the European Union over the past 50 years. The exhibition was displayed in Wexford Branch over July and August.

Ireland in Transformation: A lecture with Gerard Arthurs, lecturer in International Relations & Politics with South East Technological University, discussed Ireland's 50 years of EU membership and how that has coincided with the radical transformation of our country.

Community Fun Day: Enniscorthy Library staff were invited by Oaklee Housing, Wexford Local Development and the residents of Fearach Cnoic Estate to join them for their Community Fun Day in August. This was a great opportunity to meet the residents and tell them about the library services available to them.

Heritage Week 12th to 30th August

Events for Heritage Week in Wexford Libraries were varied included a Hedgehog Adventures Art Workshop and information on Borris Lace - Past, Present and Future. Representatives from Wexford Walking Trails presented an overview of Sport Ireland accredited walking trails throughout County Wexford. A talk on Rails Through County Wexford and Haketown - The History of Ballyhack also took place.

Decade of Centenaries

The End of the Civil War and the 1923 Election in County Wexford

This talk with Historian in Residence Barry Lacey discussed the end of the Irish Civil War in County Wexford and the election which took place afterwards in August of 1923, the first election since the foundation of the Irish Free State.

Learning and Information

Work Matters at Your Library

Interview Preparation with Alan Maher: In Bunclody Library Alan Maher from Maher Consulting shared his tips and views on how to present the best and most authentic version of yourself at a job interview.

Environment

Talks during July and August in Wexford libraries included a talk from Swift Conservation Ireland, the Flora of Old Graveyards in Co. Wexford and An Introduction into The World of Bats delivered by New Ross Wexford Bat Group. New Ross Library also presented Finding Medicine and Magic in Your Garden with Feebee Foran.

Home Energy Kit.

The Home Energy Saving Kit and Digital Radon Monitors are available to borrow for two weeks with library membership card.

Health and Well Being

New Ross Library, in association with Sports Active Wexford, hosted a 4-week series of Yoga classes for adults in New Ross Library Park. Activator Poles continue to be borrowed from libraries across the county.

Age Friendly

Wexford town library had an Age Friendly walkability audit as part of their Age Friendly recognition process. Wexford Library staff along with members of Wexford older person's council, Wexford Active Retirement Association, Wexford County Council Age Friendly programme manager attended the walkability audit. Feedback was very positive.

Movies Memories: part of Gorey Library's official Age Friendly Event programming continued in July and August.

IT Literacy

The Digital/IT Help Hub, a stand-alone pop-up service point in Wexford Branch with two tutors from WWETB, invited all adults who have questions on how to make best use of their device to drop into them on 31st of August.

Services to Ukrainian Nationals

Any News Adult Conversation Group continued throughout the summer with themed conversations for adults who want to improve English language.

Local History

A total number of 45 local history requests and 47 genealogy enquiries were completed and responded to in Wexford Branch in July and August.

Reading and Literacy: Right to Read at Your Library

Summer Stars Reading Adventure

Summer Stars 2023 continued throughout the summer. Summer Stars is an important summer library initiative which encourages children to keep reading to maintain and improve their reading skills while on their summer break from school. Children receive a reading card and can collect incentives such as bookmarks, pencils and medals for reading books throughout the summer months. Every child taking part receives a Summer Stars certificate of achievement at the end of the reading adventure.

Libraries across the county held many well attended events to celebrate Summer Stars and reading. All usual children's events, story time, rhyme time and Lego Freeplay continued over the months of July and August. Harry Potter's birthday on July 31st was also celebrated in library branches.

My Little Library Bag

The 'My Little Library Book Bag' initiative is a collaboration between libraries, the Department of Rural and Community Development, and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy. The My Little Library School Starter Book Bags are available for collection in the library. Each child receives a library card wallet and families are encouraged to join the library if not already members. Library staff talk through the bags with the families, introducing the three picture books and resources in every bag and inform families about the services and resources available for free in libraries. Families continued to collect their My Little Library Bag throughout the summer months.

DEIS/Summer Provision School Visits

Libraries were delighted to welcome visits from National School Summer Provision and DEIS Summer Camps throughout July and August for library tours, Lego Freeplay and story time.

ARCHIVES

Collections Management

In addition to 63 research enquiries via email, telephone and post, a total of 19 researchers visited the Archive over July and August. Research topics included a study of Clonmines and Tintern through extant rentals and maps (1700s-1880); death notices and obituaries through issues of the *Wexford Journal* (1814-20); publicity material on the National Opera House, Wexford (2005-20); advice on the preservation and conservation of a small family autograph book from the early 1900s; plans and drawings of the Adoration Convent, Wexford (1966); maps relating to the Portsmouth estate in Enniscorthy (1750-1900); six enquiries relating to historical adoptions in County Wexford (1893-1950).

Acquisition

A series of historic charts of approaches to Wexford harbour were deposited in the Archive in late July. Dated 1882 and 1894, they complement an existing chart of the harbour dated 1845 which is housed in the Archive.

Outreach

The Archive loaned a selection of objects and documents to Enniscorthy Castle in July for a new exhibition on pre-electrification entitled 'Power to the people – how electricity changed the world'. Items featured in the exhibition from the Archive's holdings include an enamel water carrier for household use; a domestic smoothing iron; a portable paraffin lamp; and copies of promotional materials from an anti-nuclear power show that took place at Carnsore Point, Wexford in August 1979. The exhibition will run from July to October 2023.

As part of the Comóradh 225 commemorations across County Wexford, the Archivist participated in an afternoon series of 1798 talks in McCall's Community Centre, Rathangan on 12 August which was organised by Rathangan/Cleariestown Heritage Group. An illustrated talk on holdings in the county archive of 1798 relevance was given to the public gathering. Many of the artefacts were showcased for the first time and will form part of a newly revamped exhibition in the National 1798 Rebellion Centre, Enniscorthy next year.

Crossabeg parish church liaised with the Archive to host a display centred around a replica carving of St Maelruain on 12 and 13 August. Maelruain was Bishop of Tallaght (Dublin) who died in 792.

ARTS

Reimagining Enniscorthy Exhibition

Reimagining Enniscorthy is public art and community decarbonisation project, that took place in 2022-23 throughout Enniscorthy town facilitated by artist Elaine Harrington. The Reimagining Enniscorthy exhibition ran in the Presentation Arts Centre from the 17th of June to 1st July 2023. This project is funded through Creative Ireland and the Per Cent for art programme.

'Seedlings' Music Generation Youth Opera

A futuristic climate change opera based on environmental themes came to the National Opera House on Friday, July 14. Music Generation Wexford, in partnership with Wexford Festival Opera, presented Seedlings, a production developed as part of a series of collaborative workshops with young people from across the county. Seedlings was written and directed by Elizabeth Drwal and composed by Andrew Synnott. The project would not have been possible

without the support of Wexford Festival Opera, Waterford and Wexford Education and Training Board, The National Opera House and Wexford County Council.

Music Generation 'Cool School of Rock' Coolcoots

Musician educators Peter McCamley, Louise Malone, Emily Jane Furlong and Justin Cullen from Frankenstein Bolts facilitated workshops from the 14th to18th August at Scoil Mhuire, Coolcotts. The workshops were attended by young people aged between 10 and 18 years old. The workshops focused on learning new music and skills with instruments while also developing the skills needed to play in a band.

Arts Festival Grant Scheme 2023 recipients:

GAP Arts Festival – The GAP Arts Festival is a voluntary, non-profit, community and artist-led festival, located in the hills of North Wexford which took place on the 12th to the 13th of August in Ballythomas.

2 Many Dance Moves – Flow Youth Dance Festival took place in New Ross on the 29th and 30th of July. The festival provided opportunities to young people aged from 10 to 25, exposing them to dance as an artform. The festival also connected rural dance companies across the Southeast.

New Ross Guitar Festival – This exciting Guitar Festival took place on the 10th to the 13th of August and welcomed Irish and International guitarists of the highest calibre to New Ross to promote the various genres of guitar and inspiring a new generation to experience the benefits of pursuing a dynamic instrument.

Fuddle Fest – Fuddlefest took place on the 26th and 27th of August on the Millers farm in Killinick presenting a complete mix of styles from leading Irish and international musicians performing classical and contemporary music, to trad sessions and singer-songwriters, intertwined with sonic installations and topped off with rock music for dancing the night away. **Wexford Arts Centre One Voice Festival –** a festival of short ten minute plays for one voice to be written and performed by local Wexford County resident writers and performers took place on the 10th to 12th of August at Wexford Arts Centre.

Failte Ireland Festival Recipients 2023

Rockin Food & Fruit Festival – the Rockin Food and Fruit Festival took place between the 4th and 7th of August in Enniscorthy. The town saw Artisan Food stalls, Drink stalls, Crafts Market and free Live Outdoor music around the town.

Duncannon Village Renewal Group – Hooked on Folk included musicians from the New Ross District and south Wexford and beyond to come together to play in the pubs of Duncannon, Ramsgrange, Arthurstown and Ballyhack over the August Bank holiday weekend period. **Leo Carthy Weekend –** The village of Our Lady's Island hosted the Leo Carthy Festival over the August bank holiday weekend. The festival showcased many different types of musical genres, story-telling and art workshops.

Bannow Folk & Traditional Society – hosted the 31st Phil Murphy Weekend between the 27th and 30th of July in Carrig on Bannow. The village welcomed visitors from far and wide showcasing the culture of the area through workshops, concerts and singing gatherings.

Light & Shadow Exhibition – Streets

The Arts Department is delighted to present an exhibition from Light and Shadow Art Studios in County Hall, showcasing work from children and young adults produced during workshops and classes at the studios under the guidance of artist Jonathan Murphy.

The exhibition will be in-situ at Wexford County Council from Wednesday 9th August until Wednesday 27th of September and opening hours are Monday-Friday, 9am to 5pm.

Creative Places Coordinator Enniscorthy

Wexford Arts Centre in association with Wexford County Council Arts Office and a steering committee has been awarded a Creative Places Award from the Arts Council for a three-year developmental arts programme in Enniscorthy, Co. Wexford from 2023 to 2026. The Creative Places Enniscorthy Project Coordinator was advertised in July and will be responsible for consulting with stakeholders and community representatives for the development, implementation and delivery of the Creative Places Enniscorthy programme.

CREATIVE IRELAND

Creative Ireland - Open Call Arts awards 2023

In early August, the Arts Department invited applications for creative awards funded under the Creative Ireland Programme for 2023.

These awards will provide support to cultural organisations and artists collectives to provide innovative arts programmes and events that foster cultural participation in communities throughout County Wexford.

Closing date for applications is Monday 18th September 2023 at 4pm.

Creative Ireland - Eco Showboat

On the 5th of August, the Eco Showboat arrived on the Dunbrody Famine Ship for an evening of music, poetry and performance by Wexford artists Joe Brennan, Suzanne Walsh and Ben Mac Caoilte. The Eco Showboat Journey to the East is a five month arts expedition along the Shannon, Grand Canal and Barrow, aboard the Mayfly, flagship of the Eco Showboat project. Setting off from the town of Askeaton on the River Deel, just off the Shannon estuary in the last week of April, the boat will arrive in Dublin in early September before a final event in Howth on the Irish Sea. The Eco Showboat is an art project aimed at raising awareness of climate change, supported by the Arts Council, SFI Discover, Creative Ireland, Lawpro and Waterways Ireland.

Creative Ireland – The Lighthouse Project

The Lighthouse Project is a collaborative artistic response to lighthouses around Ireland, curated by Dani Gill. Working with local artists Sasha Terfous and Richard Carr, and Basciville over July and August Gill has developed a site-specific project for Hook lighthouse involving sound and spoken word performance. RTE filmed a 3 minute promo of this event in Hook Lighthouse in August which will be broadcast in advance of Culture night. The new work will be performed for the first time on Culture Night, Friday 22nd September, where audiences will follow a free guided soundscape experience into the lighthouse, culminating in a live performance by Sasha Terfous.

Creative Ireland – Nursing Home Music and Poetry Programme

Wexford was awarded Creative Ireland Age Friendly funding to develop a workshop programme of music and poetry to four nursing homes in Wexford in 2023 over a 5 month period. The first of the 'Swing Song' workshops commenced in early August. Musician Melanie O'Reilly, two

members of her jazz band and poet and spoken word artist Stephen James Smith, collaborated by interweaving live swing jazz songs with poetry readings. The aim of the workshops is to entertain and develop conversations and social interaction with the audience. The workshops have commenced in Castlebridge Nursing Home, St John's Enniscorthy and Middleton House Gorey.

Finance:

Q2 Finance Report - to 30th June 2023

The Q2 Finance Report has been circulated to members. There is a modest surplus reported for Q2 of €42,585, but this mid-year figure should be considered with a note of caution, especially in light of the ongoing pressures from inflation and increased energy costs. The financial position of the council continues to be monitored very closely to ensure, in as far as possible, there is no slippage back into a deficit position. Within the reported financial position to the end of June, there are a number of income accruals which include grant income in respect of storm damage and Government support in respect of exceptional inflation/energy costs.

Budget 2024

Preliminary work has commenced on the preparation of the 2024 budget. There will be no decision required by members to vary the LPT rate for 2024.

Section 20 of the Finance (Local Property Tax) Act 2012, as amended, states that a local authority may, as a reserved function, resolve to vary the basic rate of the Local Property Tax within its functional area by a maximum of +/- 15%. The Local Property Tax (Local Adjustment Factor) Regulations 2022 provided updated requirements for local authorities who may wish to vary their local property tax rates for a specified period, in accordance with section 20 of the Act. At the Council meeting in September 2022 members approved the adoption of a Local Adjustment Factor to vary the LPT rate by + 15% for a period of 2 years i.e. 2023 and 2024.

Therefore, the next decision of the council in respect of a local adjustment factor for the Local Property Tax and the associated public consultation process will not need to be undertaken until August/September 2024 in advance of the 2025 Budget process.

The prescribed periods for the holding of the statutory budget Meeting and GMA Meetings in the districts have also been notified with the issue of Circular Fin 06/2023. A draft schedule of meetings has been included in the Update report for members for discussion and agreement at the September meeting.

Cash Flow/Overdraft

The Council continues to operate with an overdraft facility, Ministerial Sanction is in place for borrowing by way of overdraft in the amount of €20m for the period to the 31st December, 2023. The requirement for ongoing overdraft facilities into 2024 will be reviewed in the coming weeks as a formal application will need to be submitted to members in October to secure council approval and ministerial sanction for any extension of the facility into 2024.

Audit

In accordance with the Local Government (Financial and Audit Procedures) Regulations 2014, the Local Government Auditor has formally commenced the Audit of Wexford County Council Accounts for 2022 on the 21st August 2023.

Vacant Homes Tax (VHT)

The Minister for Finance announced the introduction of a **Vacant Homes Tax** (VHT) in his Budget statement on 27 September 2022. The legislation providing for VHT is contained in Part 22B of the Taxes Consolidation Act 1997. This legislation was introduced in the Finance Act 2022 and the first chargeable period for VHT will be 1st October 2022 to 31st October 2023. The amount of VHT chargeable for this period is three times the basic rate of LPT payable for 2023. The Local Adjustment Factor (LAF) does not apply to the Vacant Home Tax.

VHT will be a self-assessed tax and it will be the responsibility of the property owner to assess their liability and submit a VHT return for their property to Revenue where they deem a liability to exist. Where a property owner assesses that they have no liability for a vacant property in their ownership they are required to gather and retain evidence of their reasons for making this assessment as they may still be asked by Revenue to justify the reason for determining there is no liability. The Revenue website indicates that the evidence must be kept for a period of six years commencing from the end of the year in which the chargeable period ends or the date of completion of any enquiries made by Revenue.

VHT is an annual tax that applies to residential properties in use as a dwelling for less than 30 days in a 12-month chargeable period. An exemption may be available in certain circumstances. Any liability to VHT is in addition to a liability to LPT. Further details on the Vacant Homes Tax are available at <u>Vacant Homes Tax (VHT) (revenue.ie)</u>

To date, the Council have not been notified of any role in the determination of VHT and no information has been received about any additional income that might arise from this tax for local government. Members will be kept informed as soon as any such information comes to hand.
